Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:15 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

The Open Public Meetings Act was enacted to ensure the right of the public to have advance notice of and to attend the meeting of public bodies at which any business affecting their interest is discussed or acted upon.

In accordance with the provisions of this Act, the State Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted in the Department of Education (Department), Secretary of State's Office and notice also having been given to the State House Press Corps, the Governor's Office and the State Board agenda subscribers.

And seeing there was a quorum, the meeting of January 7, 2026, was called to order.

Adjourn to Executive Session

President Goldenberg then read the resolution pertaining to the executive session of the State Board meeting as it complies with the Open Public Meetings Act.

Whereas, in order to protect the personal privacy and to avoid situations wherein the public interest might be disserved, the Open Public Meetings Act permits public bodies to exclude the public from that portion of a meeting at which certain matters are discussed, now therefore be it

Resolved, that consistent with the provision of N.J.S.A. 10:4-12.b, the State Board Education will now adjourn to executive session to discuss personnel and legal issues. The State Board immediately adjourned to executive session on January 7, 2026.

Reconvening

President Goldenberg reconvened the open meeting at 10:25 a.m. with the reading of the resolution pertaining to the resumption of the public session of the State Board meeting as it complies with the Open Public Meetings Act.

President Goldenberg introduced the Honorable Robert Lougy, a judge of the New Jersey Superior Court in Mercer County. Judge Lougy administered the oath of office to State Board member Mary Bennett of Essex County, and new State Board member James C. Williams, IV of Camden County. Ms. Bennett's term expires June 30, 2030. Mr. Williams' term also expires June 30, 2030.

President's Reports

Public Testimony

President Goldenberg stated that the State Board will receive testimony from registered members of the public on any educational topic of their choice today as January is an Open Topic Public Testimony Session. She stated the proposed amendments to Chapter 9B related to school nurse endorsements also is a topic for January. She further stated that she, Vice President Nedd Johnson, State Board members Ron Butcher, Ahmed Shehata, and Claudine Keenan, will hear public testimony today.

President Goldenberg stated the State Board will also be receiving regional testimony on the draft revisions to the New Jersey Student Learning Standards. She stated the first session will be in the southern region on Tuesday, January 13, at Camden County College in the Connector Building. She further stated State Board members Jeanette Peña and Claudine Keenan are scheduled for public testimony and registration for this session closes tomorrow at noon.

President Goldenberg stated the second session will be in the northern region on Wednesday, January 28, at Essex County Donald M. Payne Sr. School of Technology in the Father D. Leahy Auditorium. She stated State Board members Mary Bennett and Ahmed Shehata are scheduled for public testimony and registration for this session closes January 22 at noon.

President Goldenberg stated the third session will be in the central region session and will be held here at the Department on February 4. She stated State Board members Arcelio Aponte, Claudine Keenan and Joseph Ricca and she are scheduled for public testimony and registration for this session will close at noon on January 29.

Permanent Student Representative

President Goldenberg stated that this year's student representative to the board is Kailynn DuRose, a junior at East Brunswick High School in Middlesex County, and that her advisor is Bonnie Benkard.

Miss DuRose spoke about end of semester exams and potential solutions for alternative formats that would be beneficial to students.

Resolution in Honor of New Jersey School Board Recognition Month

President Goldenberg requested that the State Board adopt a ceremonial Resolution in Honor of New Jersey School Board Recognition Month. The State Board unanimously adopted the following resolution read by State Board member Claudine Keenan recognizing January as School Board Recognition Month.

Resolution in Honor of New Jersey School Board Recognition Month

Whereas, the New Jersey State Board of Education has established rigorous standards through its promulgation of the New Jersey Student Learning Standards, which set the expectations of academic achievement for 1.3 million public schoolchildren; and

Whereas, New Jersey's locally elected and appointed boards of education play a vital role in ensuring that their local school districts meet state standards and adhere to state and federal education statute and regulations, with the goal of preparing all students for college and the workplace, thereby enabling them to compete in a global economy; and

Whereas, New Jersey's 5,000 non-partisan district board of education members and charter school trustees are public servants who dedicate their time, without pay or benefit, to the oversight of school district operations, through sound financial practices and comprehensive policies on curriculum, staffing and other areas to ensure the well-being and academic achievement of all students in the district; and

Whereas, local boards of education, in conjunction with state education officials and local educators, have built a foundation of success that has led to New Jersey's status as a leader in student achievement, as evidenced by the National Assessment of Educational Progress scores; and

Whereas, the New Jersey School Boards Association has declared January 2026 to be School Board Recognition Month; now, therefore, be it

Resolved, that the New Jersey State Board of Education and the Commissioner of Education recognize the contributions of the state's local boards of education to the academic success of public school students and expresses its sincere appreciation to local board of education members for their continued focus on the achievement of children throughout New Jersey; and be it further

Resolved, that the New Jersey State Board of Education and the Commissioner of Education encourage qualified New Jersey citizens to consider serving as members of their local boards of education.

Resolution for Appointment

State District Superintendent for the State-Operated School District of the City of Camden

Whereas, on June 5, 2013, the New Jersey State Board of Education issued an Administrative Order creating the State-Operated School District in the City of Camden effective June 25, 2013; and

Whereas, upon State intervention, and pursuant to N.J.S.A. 18A:7A-15 and N.J.S.A. 18A:7A-15.1, the Commissioner of Education may recommend to the State Board of Education the appointment of a State District Superintendent of schools in the State-Operated School District of the City of Camden; and

Whereas, Dr. Davida Coe-Brockington, was appointed Acting State District Superintendent on July 2, 2025, while a comprehensive search for a full-time State District Superintendent was undertaken; and

Whereas, after a national and comprehensive search for a new State District Superintendent, the Commissioner of Education has identified Alfonso Q. Llano Jr. as the candidate best suited to serve as the Camden State District Superintendent; and

Whereas, the Commissioner of Education hereby recommends the appointment of Alfonso Q. Llano to serve as the Camden State District Superintendent; now therefore be it

Resolved, that, subject to an employment contract, the New Jersey State Board of Education hereby approves the appointment of Alfonso Q. Llano Jr. as the State District Superintendent of the State-Operated School District of the City of Camden effective March 1, 2026.

Resolution to Accept Donated Funds

Whereas, the New Jersey Department of Education, Marie H Katzenbach School for the Deaf is the recipient of donations from Paul N. Gould and Lou Parnas; and

Whereas, N.J.S.A. 18A:4-26 requires the approval of the New Jersey State Board of Education in order for the Commissioner of Education to accept donated funds; and

Whereas, donations were made by Paul N. Gould and Lou Parnas in the amounts of \$50 and \$100, respectively. These funds are intended to provide the Department of Education, Marie H. Katzenbach School for the Deaf student activity resources which are for the sole use of supporting student activities such as field trips, yearbooks and student clubs; now therefore be it

Resolved, that the New Jersey State Board of Education approves the acceptance of the donated funds to the aforementioned specified purposes.
