Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:26 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

The Open Public Meetings Act was enacted to ensure the right of the public to have advance notice of and to attend the meeting of public bodies at which any business affecting their interest is discussed or acted upon.

In accordance with the provisions of this Act, the State Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted in the Department of Education (Department), Secretary of State's Office and notice also having been given to the State House Press Corps, the Governor's Office and the State Board agenda subscribers.

And seeing there was a quorum, the meeting of May 6, 2026, was called to order.

Adjourn to Executive Session

President Goldenberg then read the resolution pertaining to the executive session of the State Board meeting as it complies with the Open Public Meetings Act.

Whereas, in order to protect the personal privacy and to avoid situations wherein the public interest might be disserved, the Open Public Meetings Act permits public bodies to exclude the public from that portion of a meeting at which certain matters are discussed, now therefore be it

Resolved, that consistent with the provision of N.J.S.A. 10:4-12.b, the State Board Education will now adjourn to executive session to discuss personnel and legal issues. The State Board immediately adjourned to executive session on May 6, 2026.

Reconvening

President Goldenberg reconvened the open meeting at 9:58 a.m. with the reading of the resolution pertaining to the resumption of the public session of the State Board meeting as it complies with the Open Public Meetings Act.

Whereas, consistent with the provision of N.J.S.A. 10:4-12.b, the State Board will now adjourn from executive session to resume the open session of this meeting.

President's Reports

Public Testimony

President Goldenberg stated that an Open Topic Public Testimony will be held today, meaning registered members of the public may speak on any educational topic of choice. She also stated that State Board members Jeanette Peña, Ronald Butcher, Ahmed Shehata, and Mary Beth Berry were scheduled for public testimony and that she and James Williams would also stay for public testimony today.

President Goldenberg stated that public testimony will not be held for the month of June as there are no topics scheduled.

Permanent Student Representative

President Goldenberg stated that this year's student representative to the State Board, Kailynn DuRose, is not present today as she is currently taking her State assessments.

Selection of the State Board Nominating Committee

President Goldenberg announced the members of the State Board Nominating Committee. She stated State Board member Jeanette Peña will serve as Chair of the committee and State Board members Claudine Keenan and Ahmed Shehata will serve on the committee. She stated the committee will present the slate of

officers for the 2026-2027 school year at the June 3, 2026, meeting and, in accordance with the bylaws, the elections for the State Board leadership will be held after June 30.

State Board Annual Calendar Announcement

Petition for Rulemaking

President Goldenberg stated the State Board received a petition for rulemaking from Jennifer Dollinger-Woods on February 24, 2026. She also stated the petitioner requested the State Board amend N.J.A.C. 6A:14-3.5 and 3.6 to change the criteria for eligibility for special education and related services for students with communication impairment. She further stated she and Commissioner Laux have reviewed the petition and determined the petition be denied as outlined in the notice of action, which is posted on the Department of Education’s webpage for anyone who would like to read the specific details.

State Board Committee Reports

Instructional Policy Committee Meeting

President Kathy Goldenberg, ex-officio member of the Instructional Policy Committee, stated that the committee met on April 28, 2026, to discuss the 2024-2025 School Performance Reports and Graduation Data. She stated they also discussed the School Performance Report Redesign, College and Career Readiness Highlights, and Attendance and Discipline Highlights. She further stated that since this presentation is on today’s agenda, she will forego a report.

School Visits

President Goldenberg stated that State Board members had the opportunity to accompany Commissioner Laux on visits to schools across the State. She stated she would like to offer her thanks to the Commissioner for the invitation and to the host school districts of Union Township, Elizabeth and Union City. She further

stated that State Board members had the opportunity to visit various career and technical education (CTE) schools across the State and offered her gratitude to the host schools of Union County Technical School and Cape May Vocational Technical School for warmly welcoming the members and to Jackie Burke and Anne Nicolas from the New Jersey Council of County Vocational Technical Schools for serving as liaisons with the schools and assisting the State Board Office in setting up the visits. President Goldenberg extended her gratitude to Vice President Johnson and to State Board members Berry, Bennett, Keenan, and Peña for attending the school visits.

Commissioner's Reports

Milken National Educator Recognition in Honor of Teacher Appreciation Week

Commissioner Lily Laux stated that this week is Teacher Appreciation Week and today we are honoring one outstanding teacher in the State.

Commissioner Laux stated that, this past November, the New Jersey Department of Education and State Board member Mary Bennett had the pleasure to surprise an extraordinary New Jersey teacher with a Milken award of \$25,000. The educator honored today is Ms. Jeanette Capritti, an exceptional seventh grade English language arts teacher at Lawrence Middle School in the Lawrence Township School District.

Dr. Jordan Schiff, Assistant Commissioner for the Division of Teaching and Learning, provided brief remarks. Commissioner Laux and President Goldenberg presented 2025 Milken award winner Ms. Jeanette Capritti with an obelisk.

Model World Language and Dual Immersion Language Programs Presentation

Commissioner Lily Laux stated that today she is honored to recognize five school districts for their exceptional commitment to dual language immersion and world language education.

Dr. Jordan Schiff, Assistant Commissioner for the Division of Teaching and Learning, provided brief remarks. Commissioner Laux and President Goldenberg presented Hoboken Dual Language Charter School, North Plainfield School District, West Windsor-Plainsboro Regional School District, Egg Harbor Township School District and Summit Public School District with certificates.

2024-2025 School Performance Reports and Graduation Data Presentation

Commissioner Laux presented data from the 2024-2025 School Performance Reports scheduled to be released later this month. Dr. Kimberly Murray, Acting Assistant Commissioner for the Division of Educational Services, and Ms. Jessica Merville, Director of the Office of Performance Management, provided the report.

Monthly Literacy Update

Commissioner Laux stated that the literacy screener data for mid-year is currently being collected and the Department is beginning to receive reports from some of the grantees supporting literacy in the field. Commissioner Laux also stated she will be bringing more details at the June 3, 2026, State Board meeting.

***C. Religious Holidays Calendar Resolution**

- That the State Board adopt the resolution pertaining to the annual calendar of religious holidays for the 2026-2027 school year as established at N.J.A.C. 6A:32-8.3(j), pursuant to N.J.S.A. 18A:26-14 to 16.

Resolution

The List of Religious Holidays Permitting Student Absence from School

Whereas, according to N.J.S.A. 18A:36-14 through 16 and N.J.A.C. 6A:32-8.4(e)1i, regarding student absence from school because of religious holidays, the Commissioner of Education, with the approval of the State Board of Education, is charged with the responsibility of prescribing such rules and regulations as may be necessary to carry out the purpose of the law; and

Whereas, the law provides that:

1. Any student absent from school because of a religious holiday may not be deprived of any award or of eligibility or opportunity to compete for any award because of such absence;
2. Students who miss a test or examination because of absence on a religious holiday must be given the right to take an alternate test or examination;
3. To be entitled to the privileges set forth above, the student must present a written excuse signed by a parent or person standing in place of a parent;
4. Any absence because of a religious holiday must be recorded in the school register or in any group or class attendance record as an excused absence;
5. Such absence must not be recorded on any transcript or application or employment form or on any similar form; and
6. The Commissioner, with the approval of the State Board of Education, is required to:
 - (a) prescribe such rules and regulations as may be necessary to carry out the purposes of this act; and
 - (b) prepare a list of religious holidays on which it shall be mandatory to excuse a student. The list, however, is to be a minimum list. Boards of education, at their discretion, may add other days to the list for the schools of their districts; and

Whereas, the New Jersey Department of Education makes every attempt to ensure the accuracy of the dates using the lunar, Gregorian and Julian calendars; and

Whereas, the district board of education has the right to add any bona fide religious holiday to the list for its own schools;

Whereas, dates within this resolution may not be fixed before the State Board adopts the annual calendar and may require additional revision; now therefore be it

Resolved, that the State Board of Education permits the Commissioner of Education, after annual adoption by the State Board of Education, to revise the dates provided in list of religious holidays; and be it further

Resolved, that the State Board of Education adopts the following list of religious holidays for the 2026-2027 school year:
