**CONVENING**

State Board of Education Vice President Andrew Mulvihill convened the public meeting at 9:00 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

The Open Public Meetings Act was enacted to insure the right of the public to have advance notice of and to attend the meeting of public bodies at which any business affecting their interest is discussed or acted upon.

In accordance with the provisions of this Act, the State Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted in the Department of Education, Secretary of State's Office and notice also having been given to the State House Press Corps, the Governor's Office and the State Board agenda subscribers.

And seeing there was a quorum, the meeting of August 2, 2017, was called to order.

**ADJOURN TO EXECUTIVE SESSION**

## **PRESIDENT'S REPORT**

### **Public Testimony**

President Aponte stated public testimony would be held today at 2 pm. He also stated that the topics for the August 2 public testimony session included the readoption with amendments to chapter 32, Evaluation of the Performance of School Districts; amendments to the Educational Facilities regulations; the readoption with amendments to the Regulatory Equivalency and Waiver regulations; and amendments to the Standards and Assessment regulations. He further stated that the State Board would hear feedback from members of the public on what they would like to see included in the Jersey City School District Local Control Transition Plan.

President Aponte stated that registration for the September 13, 2017 public testimony session would open on Thursday, August 17, 2017 and close at noon on Thursday, September 7, 2017. He also stated that the topics for the September 13, 2017 public testimony session include the amendments to chapter 19, Career and Technical Education Programs regarding Private Career Schools; and the readoption with amendments to chapter 21, Marie H. Katzenbach School for the Deaf regulations. He further stated that the September 13, 2017 public testimony is an Open Topic opportunity and registered members of the public may present testimony before the State Board on any educational topic of their choice.

President Aponte stated that anyone interested in speaking at or also attending the public testimony session must register so the State Board staff can make proper arrangements for space. ## **Permanent Student Representative**

He stated that the book inspired an entire educational program for high-school students to gain and learn the necessary skills for exploring careers, finding internships and jobs, starting a business, being a leader, and living a happy life.

**A RESOLUTION SUPPORTING SOCIAL AND EMOTIONAL **LEARNING** COMPETENCIES FOR NEW JERSEY SCHOOLS**

**WHEREAS**, students come to school with a variety of experiences, barriers and abilities that may impact readiness to learn; and

**WHEREAS**, schools that foster positive climates are characterized by people feeling socially, emotionally and physically safe; students and staff [that] are held to high expectations; and **students are provided with** access to supportive programs and initiatives to assist [students] **them** to reach their full potential; and

**WHEREAS**, social and emotional learning supports a positive school climate, reduces barriers to learning, increases school connectedness and is critical to success in school and life; and

**WHEREAS**, social and emotional learning skills, knowledge and attitudes can be acquired and are an integral part of education from preschool through Grade 12; and

**WHEREAS**, social and emotional learning is necessary for students to understand and manage emotions, set and achieve positive goals, feel and show empathy for others, establish and maintain positive relationships, and make responsible decisions; and

**WHEREAS**, research demonstrates that social and emotional learning increases students' attendance; decreases conduct problems; improves grades and test scores; and reduces at-risk behaviors; and

**WHEREAS**, schools that embed and teach social and emotional learning skills across all subject areas facilitate students' academic success and social development; and

**WHEREAS**, the New Jersey Department of Education and stakeholders from across the State collaboratively developed the *New Jersey Social and Emotional Learning Competencies* to support school districts in their efforts to build and deepen positive school climates; now therefore be it

**RESOLVED**, that the Commissioner of Education and the New Jersey State Board of Education recommend school districts implement the *New Jersey Social and Emotional Learning Competencies* to promote safe, supportive and challenging learning environments.
