Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:10 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

The Open Public Meetings Act was enacted to insure the right of the public to have advance notice of and to attend the meeting of public bodies at which any business affecting their interest is discussed or acted upon.

In accordance with the provisions of this Act, the State Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted in the Department of Education, Secretary of State's Office and notice also having been given to the State House Press Corps, the Governor's Office and the State Board agenda subscribers.

And seeing there was a quorum, the meeting of May 6, 2020, was called to order.

Adjourn to Executive Session

President Goldenberg then read the resolution pertaining to the executive session of the State Board meeting as it complies with the Open Public Meetings Act.

Whereas, in order to protect the personal privacy and to avoid situations wherein the public interest might be disserved, the Open Public Meetings Act permits public bodies to exclude the public from that portion of a meeting at which certain matters are discussed, now therefore be it

Resolved, that consistent with the provision of N.J.S.A. 10:4-12.b, the State Board Education will now adjourn to executive session to discuss personnel and legal issues. The State Board immediately adjourned to executive session on May 6, 2020.

Reconvening

President Kathy Goldenberg reconvened the open meeting at 10:20 a.m. with the reading of the resolution pertaining to the resumption of the public session of the State Board meeting as it complies with the Open Public Meetings Act.

Whereas, consistent with the provision of N.J.S.A. 10:4-12.b, the State Board will now adjourn from executive session to resume the open session of this meeting.

Approval of Minutes of The Meetings

On a motion duly seconded and carried, the State Board members approved the minutes of the public meeting conducted on April 1, 2020.

President's Reports

Announcements

President Goldenberg welcomed everyone to the State Board's virtual meeting and extended her best wishes on behalf of the State Board that all are safe and healthy.

Public Testimony

President Goldenberg stated that the State Board would receive written testimony on the proposed readoption with amendments to the Educator Effectiveness Regulations. She also stated that going forward the State Board would only accept written testimony on administrative code items currently pending before the State Board.

Resolution in Honor of Physical Fitness and Sport Month

President Goldenberg introduced a resolution to recognize Physical Fitness and Sport Month in NJ.

On a motion duly seconded and carried, the State Board unanimously approved the following resolution read by State Board member Elaine Bobrove:

Resolution to Recognize May 2020 as Physical Fitness and Sport Month

Whereas, childhood obesity has reached epidemic proportions in the United States and New Jersey has the highest obesity rate in the nation among low-income children; and

Whereas, today's childhood obesity rates are putting our children on course to be the first generation in this country to live shorter and less healthy lives than their parents; and

Whereas, children spend many of their waking hours at school and therefore need to be active during the school day to meet the recommendations of the Physical Activity Guidelines for Americans; and

Whereas, the U.S. Department of Health and Human Services recommends that young people aged 6–17 years participate in at least 60 minutes of physical activity daily; and

Whereas, N.J.S.A.18A:35-7 and 8 require all students in grades 1-12 to participate in at least 150 minutes per week of health, safety and physical education; and

Whereas, research shows that physically active children are more likely to thrive academically and have improved behavior in school; and

Whereas, schools can promote physical activity through comprehensive school physical activity programs, including recess, classroom-based physical activity, intramural physical activity clubs, interscholastic sports, and physical education; and

Whereas, participation in sports teams and physical activity clubs, can improve grade point average, school attachment, educational aspirations and the likelihood of graduation; and

Whereas, higher physical fitness achievement is associated with better school attendance rates and fewer disciplinary incidents involving drugs, alcohol, violence or truancy;

Whereas, the New Jersey State Board of Education strongly supports efforts to increase physical education, physical activity and participation in youth sports, recognizes the month of May as National Physical Fitness and Sport Month; now therefore be it

Resolved, that the New Jersey State Board of Education designates the week of May 1-7, 2020, as National Physical Education and Sport Week and recognizes National Physical Education Fitness and Sport Month and the central role of physical education and sports in creating a healthy lifestyle for all children in the State of New Jersey.

Selection of State Board Nominating Committee

President Goldenberg announced the members of the State Board Nominating Committee. Mary Beth Gazi will serve as Chair of the committee and State Board members Arcelio Aponte and Mrs. Sylvia Sylvia will serve on the committee. President Goldenberg stated the State Board nominating committee will present the slate of officers for the 2020-2021 school year at the June 3, 2020 meeting. She also stated that in accordance with State Board bylaws, the elections for the State Board leadership will be held after June 30.

State Board Calendar of Meeting Dates

President Goldenberg presented to the State Board members the proposed list of State Board meeting dates for 2020-2021. She asked the State Board members to review and share any concerns they may have about the dates. She also stated that the State Board will vote on the resolution to adopt the 2020-2021 Calendar at the June 3, 2020 public business meeting. She further stated that the Ad Hoc Committee will also meet to discuss the proposed calendar prior to the June State Board meeting.

State Board Committee Report(s)

Fatimah Burnam-Watkins, chair of the Social Emotional Learning Committee stated that the Social Emotional Learning Committee met on April 29, 2020 with Department staff to learn about the various initiatives that are taking place designed to support students, teachers and school districts in an effort to promote social and emotional learning that enhance the building of positive school climates and the healthy development of young people.

Commissioner's Reports

Commissioner Repollet welcomed everyone to today's meeting and requested a moment of silence in honor of all who have recently passed away due to COVID19.

Resolution in Honor of Mrs. Margit Feldman

Commissioner Repollet introduced a resolution in honor of Mrs. Margit Feldman. He also requested a moment of silence in memory of Margit and Harvey Feldman, who both recently passed away.

On a motion duly seconded and carried, the State Board unanimously approved the following resolution read by State Board President Kathy Goldenberg:

Resolution in Honor of Mrs. Margit Feldman

Whereas, longtime New Jersey resident Mrs. Margit Feldman survived imprisonment in a series of Nazi concentration camps in her youth, where she was forced to perform hard labor and had the identification "A23029" tattooed on her arm; and

Whereas, Mrs. Feldman was liberated from the Bergen-Belsen concentration camp in Germany on April 15, 1945; and

Whereas, Mrs. Feldman emigrated to the United States approximately two years later and eventually settled in New Jersey; and

Whereas, Mrs. Feldman shared her remarkable story of surviving the Holocaust by speaking to many students over the years and through her 2003 memoir "Margit: A Teenager's Journey Through the Holocaust and Beyond" and the 2016 documentary "Not A23029"; and

Whereas, Mrs. Feldman helped pass the state laws that created the New Jersey Holocaust Education Commission and mandated that curricula in New Jersey's public elementary and secondary schools include instruction about the Holocaust and genocide; and

Whereas, Mrs. Feldman was an original member of the New Jersey Holocaust Education Commission and a founding member of the Holocaust and Genocide Institute at Raritan Valley Community College; and

Whereas, the Commission was such personal and important work to Mrs. Feldman that it became a family affair and she recruited her husband Harvey, who also recently passed away, to photograph New Jersey Holocaust Education Commission events; and

Whereas, Mrs. Feldman, a mother of two and grandmother of three, was active in her synagogue and with organizations like the Jewish Federation of Somerset, Hunterdon and Warren Counties; and now therefore be it

Resolved, that the New Jersey State Board of Education and the Commissioner of Education recognize and posthumously honor Mrs. Margit Feldman and her commitment to teaching students about the Holocaust and ensuring the atrocities of genocide will never be forgotten.

***D Religious Holidays Calendar Resolution**

- Adopted the following resolution pertaining to the annual calendar of religious holidays for the 2020-2021 school year as established at N.J.A.C. 6A:32-8.3(j), pursuant to N.J.S.A. 18A:36-14 through 16.

Resolution

The List of Religious Holidays Permitting Student Absence from School

Whereas, according to N.J.S.A. 18A:36-14 through 16 and N.J.A.C. 6A:32-8.3(j), regarding student absence from school because of religious holidays, the Commissioner of Education, with the approval of the State Board of Education, is charged with the responsibility of prescribing such rules and regulations as may be necessary to carry out the purpose of the law; and

Whereas, the law provides that:

1. Any student absent from school because of a religious holiday may not be deprived of any award or of eligibility or opportunity to compete for any award because of such absence;
2. Students who miss a test or examination because of absence on a religious holiday must be given the right to take an alternate test or examination;
3. To be entitled to the privileges set forth above, the student must present a written excuse signed by a parent or person standing in place of a parent;
4. Any absence because of a religious holiday must be recorded in the school register or in any group or class attendance record as an excused absence;
5. Such absence must not be recorded on any transcript or application or employment form or on any similar form; and
6. The Commissioner, with the approval of the State Board of Education, is required to:
 - (a) prescribe such rules and regulations as may be necessary to carry out the purposes of this act; and
 - (b) prepare a list of religious holidays on which it shall be mandatory to excuse a student. The list, however, is to be a minimum list. Boards of education, at their discretion, may add other days to the list for the schools of their districts; and

Whereas, the New Jersey Department of Education makes every attempt to ensure the accuracy of the dates using the lunar, Gregorian and Julian calendars; and

Whereas, the district board of education has the right to add any bona fide religious holiday to the list for its own schools;

Whereas, dates within this resolution may not be fixed before the State Board adopts the annual calendar and may require additional revision; now therefore be it

Resolved, that the State Board of Education permits the Commissioner of Education, after annual adoption by the State Board of Education, to revise the dates provided in list of religious holidays; and be it further

Resolved, that the State Board of Education adopts the following list of religious holidays for the 2020 - 2021 school year:
