### Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:12 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

#### **Public Testimony**

### Welcome of the Permanent Student Representative

President Goldenberg introduced the State Board of Education's permanent student representative, Miss Nilanjana (Nillie) Ghosh. Miss Ghosh is a rising junior at West Windsor Plainsboro High School North.

Ms. Nilanjana Ghosh spoke about her experience attending the NJASC Fall Conference on October 10 at The College of New Jersey and her experience delivering the keynote speech at the New Jersey School Boards Association Workshop held on October 24 in Atlantic City. She further spoke about her school choir taking part in their annual Kristallnacht Commemoration on November 8 at a local synagogue, an event which marks the remembrance of the "Night of Broken Glass" and the beginning of the Holocaust.

President Kathy Goldenberg stated that on Tuesday, October 24, 2023, she along with Vice President Andrew Mulvihill, and State Board members Ron Butcher and Nedd Johson attended and participated in a panel discussion at the New Jersey School Boards Association Workshop 2023 at the Atlantic City Convention Center in Atlantic City, New Jersey.

# **Commissioner's Reports**

#### In Case You Missed It

Acting Commissioner Allen-McMillan stated that in early October, she gave remarks in Morris School District to kick off a partnership between Morristown High School and the County College of Morris, which is committed to helping motivate middle and high school students gain access to tutoring, mentoring, and other preparatory programs at no cost. She stated this is a significant milestone in our commitment to education and the future of our youth and she is excited to see the transformational efforts of this collaboration and the positive impact it will have on the lives of countless students. She further stated the Department of Education had the pleasure to join in the awarding of three Milken Foundation awards in October and congratulated these exemplary teachers: elementary teacher Taylor Trost of Grace Norton Rogers Elementary School in East Windsor Regional School District; high school mathematics teacher Riley Gartland of Cinnaminson High School in Cinnaminson Township School District; and high school science teacher Virginia Fasulo of Lodi High School in Lodi Public Schools.

Acting Commissioner Allen-McMillan stated many department staff attended the annual NJPSA Fall Conference themed "Making Excellence Happen," held in October in Atlantic City. She stated that Assistant Commissioner Dr. Jorden Schiff gave welcome remarks and presented honored attendees with the Dr. Ernest L. Boyer Outstanding Educator award and the Visionary awards. She further stated commissioners Dr. Irving, Ms. Ehling, Dr. Schiff, and Mr. Booker participated in a panel discussion that fostered open dialogue with state education leadership.

Acting Commissioner Allen-McMillan stated that on October 18, Assistant Commissioner Cary Booker and she joined Acting Governor Tahesha Way in announcing new funding for statewide preschool services. She stated the \$25 million in funding will be used to expand access to high-quality preschool programs across New Jersey, adding 1,715 seats across 26 districts which ensures over 190 districts will now have access to these vital resources.

Acting Commissioner Allen-McMillan stated that on October 24th, she was the keynote speaker at the NJSBA Workshop themed "Today's Students ... Tomorrow's Superheroes." She stated the focus was on how we can nurture a positive collective legacy of education at every grade band: high school, middle school, and elementary school that includes pre3-k.

Acting Commissioner Allen-McMillan stated our social media campaigns in October included National Principals Month, Careers in Construction Month, and Cybersecurity Awareness Month, and they also promoted the New Jersey Week of Respect, National Stop Bullying Day, and the challenge coin contest for the upcoming commissioning of the USS New Jersey submarine.
