Convening

State Board of Education President Kathy Goldenberg convened the public meeting at 9:12 a.m. with the reading of the statement pertaining to the public session of the State Board meeting as it complies with the New Jersey Open Public Meetings Act.

The Open Public Meetings Act was enacted to ensure the right of the public to have advance notice of and to attend the meeting of public bodies at which any business affecting their interest is discussed or acted upon.

In accordance with the provisions of this Act, the State Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted in the Department of Education (Department), Secretary of State's Office and notice also having been given to the State House Press Corps, the Governor's Office and the State Board agenda subscribers.

And seeing there was a quorum, the meeting of October 8, 2025, was called to order.

Adjourn to Executive Session

President Goldenberg then read the resolution pertaining to the executive session of the State Board meeting as it complies with the Open Public Meetings Act.

President Goldenberg reconvened the open meeting at 10:07 a.m. with the reading of the resolution pertaining to the resumption of the public session of the State Board meeting as it complies with the Open Public Meetings Act.

President's Reports

Public Testimony

President Goldenberg stated that for the month of October, the State Board will not hold public testimony as there are no educational topics for discussion.

President Goldenberg stated that for the month of November, the State Board will not hold public testimony as there are no educational topics for discussion.

Permanent Student Representative

President Goldenberg stated that this year's student representative to the board is Kailynn DuRose, a junior at East Brunswick High School in Middlesex County, and that her advisor is Bonnie Benkard.

Miss DuRose spoke about the differences between traditional and block scheduling in high school and the benefits to a block schedule.

State Board Committee Reports

Instructional Policy Committee Meeting

Dr. Nedd Johnson, Chair of the Instructional Policy Committee, stated that the committee met on September 15, 2025, to discuss the readoption with amendments of Chapter 8, Standards and Assessments. Dr. Johnson stated that he would forego his report as the topic was on the meeting's agenda at adoption level.

Introduction of Maude Dahme

President Goldenberg introduced Maude Dahme, a former President of the New Jersey State Board of Education who was present during the meeting.

National Association of State Boards of Education Delegate Election and Ballot for Resolution on Proposed Bylaws Change

President Goldenberg stated that the elections for the Chair-elect of the National Association of State Boards of Education (NASBE) will take place at the annual business meeting during NASBE's conference this October in Austin, TX. President Goldenberg stated that she may serve as the State delegate to the conference this year and will submit the selection by proxy. She further stated that unless the State Board objects, and as there is only one candidate for each open position, Ms. Shoener will submit New Jersey's votes for Chair-Elect of the Board of Directors as Fern Desjardin of Maine, New Jersey's vote for Secretary-Treasurer as Matt Donaldson of (Georgia), and New Jersey's vote for Northeastern Area Director as Nisha Lodhavia of Delaware, along with the ballot supporting the proposed changes to the NASBE Bylaws to NASBE by October 13, 2025.

Petition for Rulemaking - Rosemary Catton

President Goldenberg stated that the State Board received a petition for rulemaking from Rosemary Catton on May 5, 2025. She stated the petitioner requested amendments to Chapter 9B to allow holders of a multistate registered professional nurse license issued by a state board of nursing that participates in the Nurse Licensure Compact (NLC) to qualify for a substitute school nurse/non-instructional credential or an educational services certificate with a school nurse endorsement. She further stated that, at the August State Board meeting, she announced that she and Commissioner Dehmer determined that an additional 90 days was needed to deliberate to allow time for consultation with the New Jersey Board of Nursing. President Goldenberg stated those issues have been thoroughly discussed and it has been determined that the best course of action is to approve the petitioner's requested amendments with additional necessary changes at N.J.A.C. 6A:9B-14.4. She stated the Department will be discussing the amendments at N.J.A.C. 6A:9B-7.5, 14.3 and 14.4 later today during Items for Consideration at Item D. She further stated that, in order to meet the OAL and State Board requirements for timely processing of rules related to approved petitions, the State Board will be expediting this rulemaking and moving to Proposal Level next month. President Goldenberg stated she strongly encourages interested parties to submit written testimony comments on the proposed rules and reminded everyone that in-person public testimony will be received in January 2026.

Commissioner's Reports

Presentation of the 2025-2026 New Jersey State Teacher of the Year

Dr. Jorden Schiff, Acting Assistant Commissioner, Division of Teaching and Learning Services, introduced Ms. Gillian Ober, an English as a Second Language (ESL) teacher at Freehold Intermediate School in Freehold Borough School District, as the 2025-2026 New Jersey State Teacher of the Year.

Representatives from the following organizations celebrated Ms. Ober with a presentation of these items for a one year term: New Jersey Education Association (NJEA) - a car equipped with EZ Pass, complimentary access to all NJEA major workshops and training opportunities, \$1,500 clothing allowance, media training and communications support, and a trip to Washington, DC, to meet with other State Teachers of the Year; and Educational Testing Service – \$50,000 in funding for the New Jersey State Teacher of the Year's salary and benefits during her six-month sabbatical.

President Goldenberg requested and the State Board members approved a 10 minute recess following the conclusion of the presentation.
