

# NJSLEDS Special Education Scenarios

While the Special Education Student Data Handbook outlines the data elements and validation rules, this document outlines some of the common scenarios in the Special Education Submission and provides explicit clarification to some of the common misconceptions related to the Special Education Submission.

# Students to Include in the Special Education Submission:

- 1. All students with an IEP in effect on the snapshot date (October 15, 2025) for whom the district has CST responsibility. This includes out-of-district placement students.
- 2. All currently active students who were included in the district's Special Education submission last year and were declassified or determined ineligible after the previous year's snapshot date (October 15, 2024).
- 3. All students with a parental consent to evaluate date between July 1, 2024, and June 30, 2025.
- 4. All children referred for evaluation before their third birthday with a referral date between July 1, 2024, and June 30, 2025.

## Students to Exclude from the Special Education Submission:

- 1. Special education students who have been parentally placed in non-public schools. Parentally placed students are those found eligible for special education and related services by your district but whose parents are paying tuition for their children to attend a private school.
- 2. Students for whom the district does not have CST responsibility.
- 3. Students whose new referral was withdrawn, or for whom the Child Study Team (CST) found that evaluations were not warranted, or for whom parents refused or revoked their consent to evaluate.
- 4. Students who leave the district after being referred and prior to receiving an eligibility determination.
- 5. Students who attend a vocational school full time.
- 6. Special education students who are not receiving services because they are home school students for whom the district does not provide services.
- 7. Special education students who transferred into the district after this year's snapshot date (October 15, 2025).
- 8. Two-year-olds referred from Part C after June 30, 2025, whose eligibility has not yet been determined. These children should be reported in following year's Special Education Submission (i.e., Fall 2026).

## **New Referrals**

Data to be reported (in addition to the student demographic information of LID, SID, First Name, Last Name, Date of Birth, and grade level)

Scenario: New referral from Part C, Early Intervention Services, child is found eligible, IEP implemented, no annual review.

**Description:** The child was served by Part C Early Intervention services and referred to Part B prior to their third birthday; the referral was made between 7/1/24 and 6/30/25; the child was found eligible for special education and related services and had an IEP developed and implemented by the 10/15/25 snapshot date. The child has not yet had an annual review meeting.

**Description:** The student was 3 or older at the time of referral; has a parental consent to evaluate date between 7/1/24 and 6/30/25, was determined eligible for special education and related services and had an initial IEP developed and implemented as of the 10/15/25 snapshot date. Student had an annual review meeting.

## **Exited Students**

Students who were new referrals (referred on or after 7/1/24) or found eligible after the previous year's snapshot date of 10/13/24, but exited **special education** before the current year's snapshot date of 10/15/25 because of one of the following reasons need to be included in the EOY snapshot (if they exited on or before 6/30/25) or the fall survey (if they exited after 6/30/25) with the classification code "99" and the appropriate transfer code:

- Dropped out
- Deceased
- Reached maximum age
- Moved and are known to continue
- Moved and known not to continue
- Graduated

## **Transfer Students**

#### Students Transferred Out

**Scenario:** A student was found eligible for services after the previous year's snapshot date (10/15/24) and transferred out of the district to another school district after the end of the previous school year but on or before the current year's snapshot date of 10/15/25.

These students need to be included as inactive students in the current year's Special Education Submission for the NJDOE to have a record of their referral and evaluation process, which is required under IDEA Part B Section 618.

**Scenario:** A continuing special education student (one found eligible prior to the previous year's snapshot date of 10/15/24) transferred out of the district to another school district on or before the current year's snapshot date of 10/15/25.

**Description:** Student is eligible for services but transferred out of the district after the end of the previous school year but on or before the current year's snapshot date of 10/15/25.

**DO NOT INCLUDE** in your district's submission file –this student will be reported by the district with CST responsibilities for the student. Include the student as inactive in the fall Student Management submission.

### Students Transferred into a District

**Scenario:** A continuing special education student (one found eligible prior to the previous year's snapshot date of 10/15/24) transferred into the district from another school district after 10/15/24 but on or before 10/15/25.

**Description:** Student was eligible for services last year and reported by the other district in the 10/15/24 submission file but has since transferred to the district on or before 10/15/25.

The new district (the one the student transferred into) will report the student, including any reevaluation or annual review dates that occurred between 10/15/24 and 10/15/25, even if those meetings were held by the original district.

**Scenario:** A student, who was referred in another district on or after 7/1/24 and found eligible for services, is transferred into the district on or before 10/15/25.

**Description:** Student was eligible for services but transferred into this district between 7/1/24 and 10/15/25.

The new district (the one the student transferred into) will report the student as an active student and also include all information pertaining to the referral and evaluation process, even if those meetings were held by the original district.

## Two Referral Chains

Scenario: Two referrals, both processes completed.

**Description:** Student was referred and found either eligible or ineligible after the previous year's snapshot date of 10/15/24. Student is then either declassified (if found eligible) and then re-referred, or re-referred (if originally found ineligible). The student is then found eligible with this new referral.

Data reported would use the data from the second referral (use the most recent referral date, consent to evaluate, eligibility determination, etc.).

**Scenario:** Two referrals, one process completed the other in progress.

**Description:** Student was referred and found eligible on or after 7/1/24. Student received services and was declassified (e.g. 5/2/24). Student is then re-referred several months later (e.g. (9/1/24) and consent to evaluate is received two weeks later (e.g. 9/15/24). Eligibility meeting won't occur until after 10/15/25.

Data reported would use the most recent referral and consent dates.

**Scenario:** Two referrals, one process completed, the other in progress, student receiving services on 10/15/25 based on the first referral.

**Description:** Student was referred and found eligible for Speech/Language on or after 7/1/24. Student has an IEP in effect for Speech/Language on 10/15/25 and is receiving services. Student was referred for Special Ed/Related

services on 9/1/24. Consent to Evaluate was received on 9/15/24. Eligibility Determination meeting will not be held until after 10/15/25.

Data reported would be only the current referral for Special Ed/Related services, **not** the Special Ed services from the Speech Evaluation.

#### **Concurrent Chains**

**Scenario:** Two referral processes, both open and occurring within the same time frame.

**Description:** Student is referred for Speech/Language on or after 7/1/24 and also has a Consent to Evaluate. Eligibility Determination meeting will not occur until after 10/15/25. Student also has a referral for Special Education and Related Services on or after 7/1/24 and also has a Consent to Evaluate. Again, The Eligibility Determination will not occur until after 10/15/25.

Data reported would be only the current referral for Special Ed/Related services, **not** the Special Ed services from the Speech Evaluation.
