#### **Notes:**

- 1. **Authority for Placement**: The Department of Children and Families (DCF), as a state agency defined in N.J.A.C. 6A:17-1.2, only has the authority to place children who are in DCF's care, custody or control pursuant to N.J.S.A. § 9:6-8.54, N.J.S.A. § 30:4C-12, and N.J.S.A. § 30:4C-20. Students placed by parent through DCF Children's System of Care does not result in "State Agency" authority. Additionally, other state agency involvement, including but not limited to the New Jersey Department of Corrections and the New Jersey Juvenile Justice System, does not automatically imply "State Agency" authority for placement.
- 2. **Transportation (provides)**: The fiscally responsible district is also responsible for including the student in the annual District Report of Transported Students (DRTS) submission.
- 3. Transportation (pays): The fiscally responsible district is also responsible for including the student in the annual District Report of Transported Students (DRTS) submission.
- 4. Out-of-home Placement—State-Facility: Entities contracting specifically with DCF's Office of Education constitute a "State Facility" as defined in N.J.A.C. 6A:17-1.2. Table 1: Out-of-Home Placement
