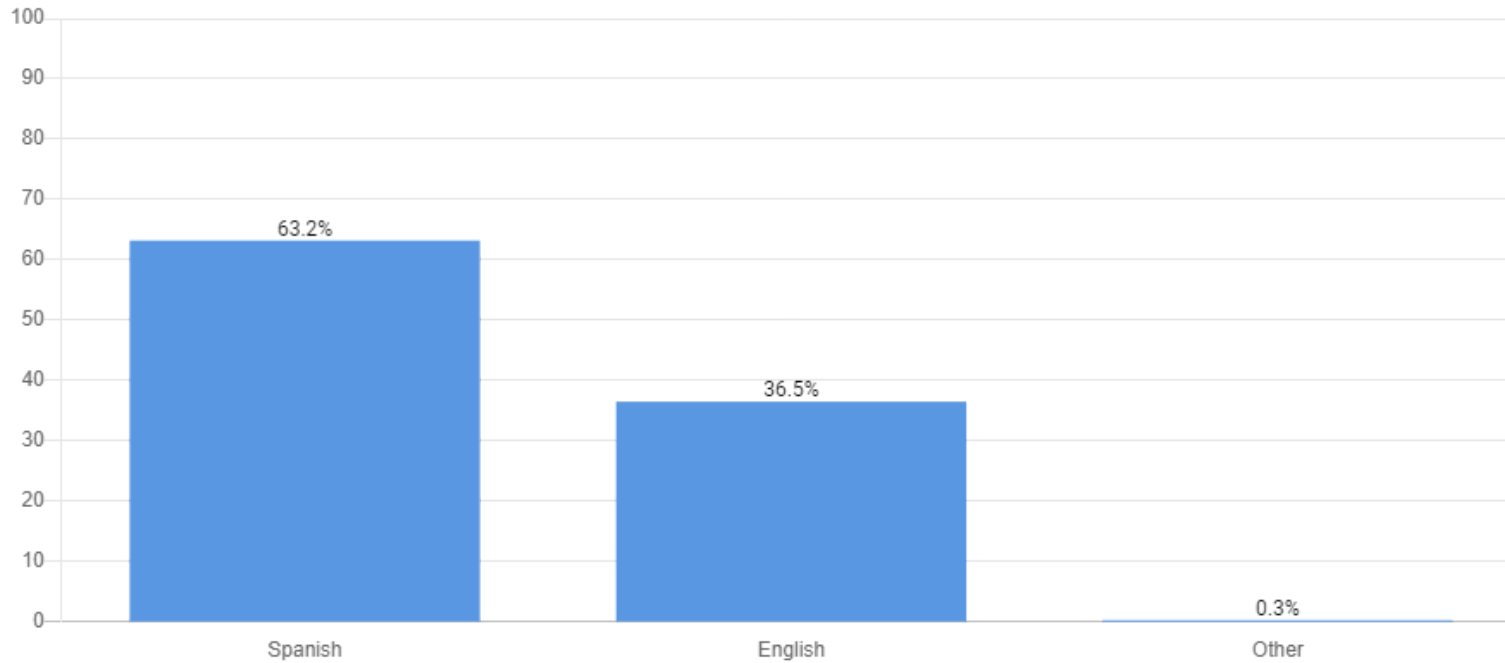

## Student Growth

Student growth is a measure of how much students are learning each year. Each student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7 that explains their progress compared to students who had the same test scores in previous years.

A student's SGP falls between 1 and 99 and can be grouped into three levels:

**Low Growth:** Less than 35

**Typical Growth:** Between 35 and 65

**High Growth:** Greater than 65

If the student growth percentiles for all students in the school are ordered from smallest to largest, the median student growth percentile (mSGP) for the school is the percentile in the middle of that list. 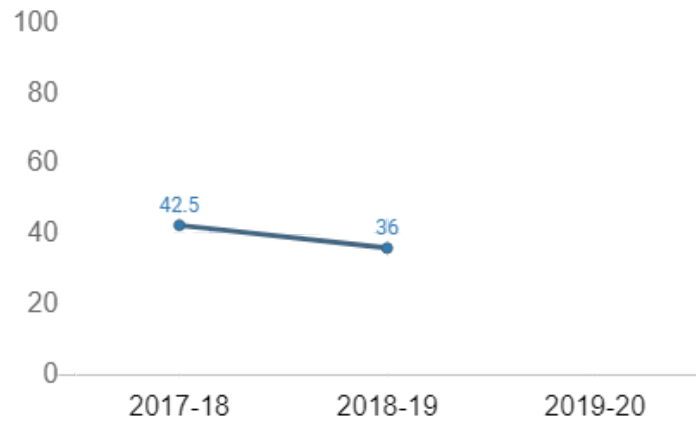

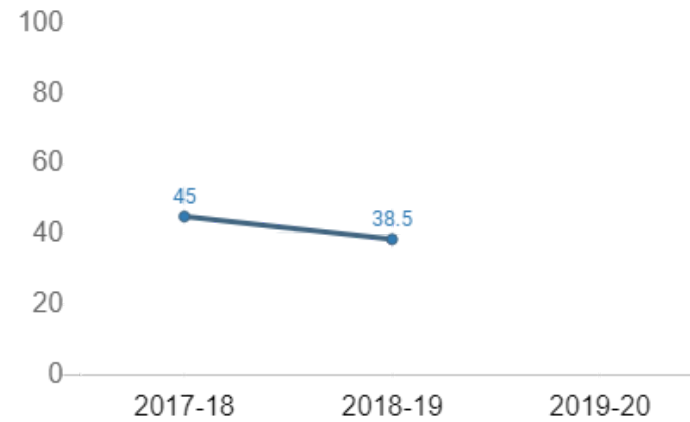

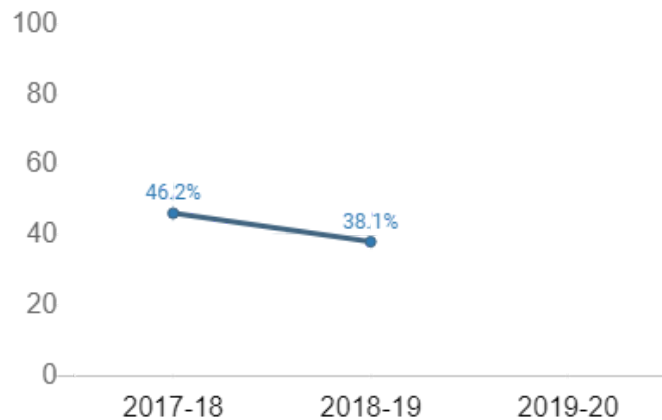

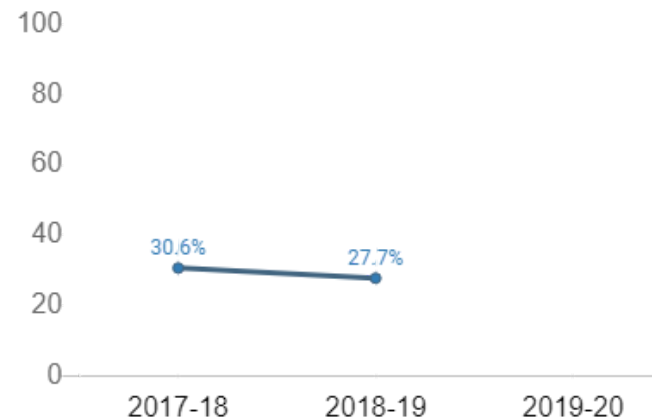

The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

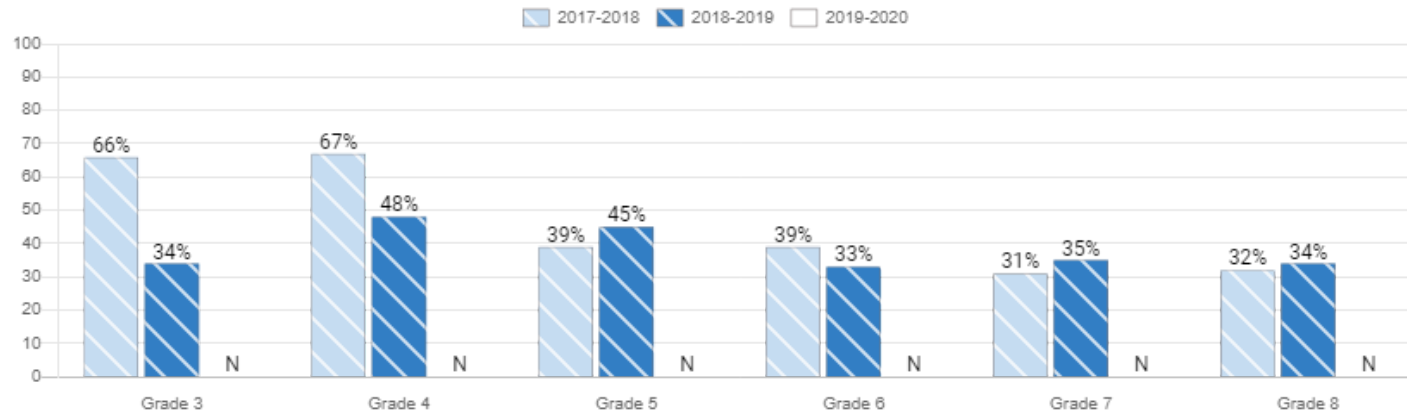

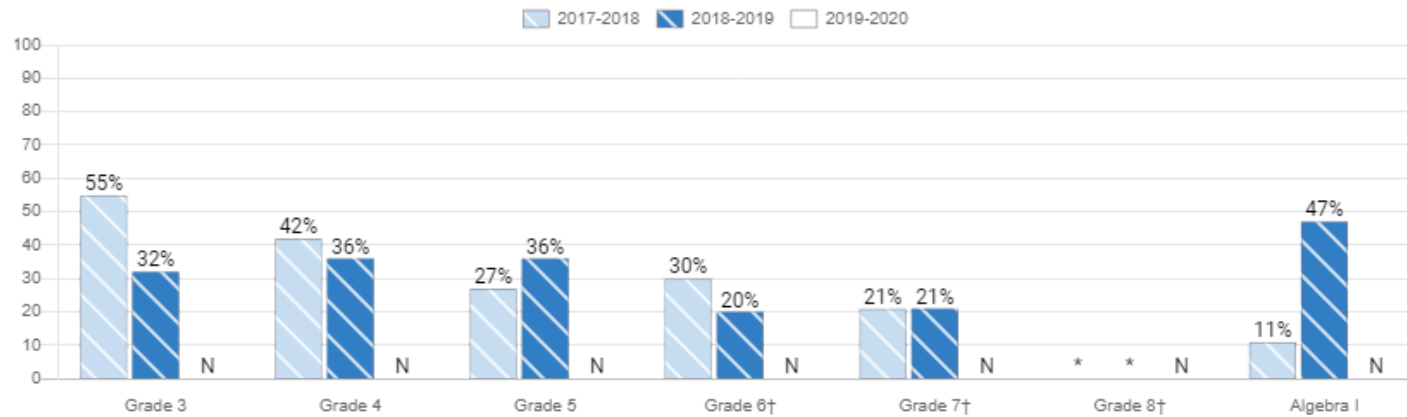
### Mathematics Assessment – Performance Trends

### DLM Alternate Assessment - Participation

### English Language Progress to Proficiency

A student's expected growth is based on the student's initial year proficiency level and student growth expectations are increased by equal intervals each year so that the student meets the proficiency cut score of 4.5 within five years. 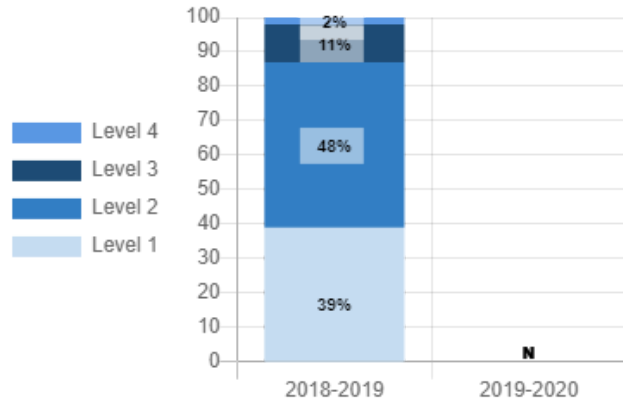

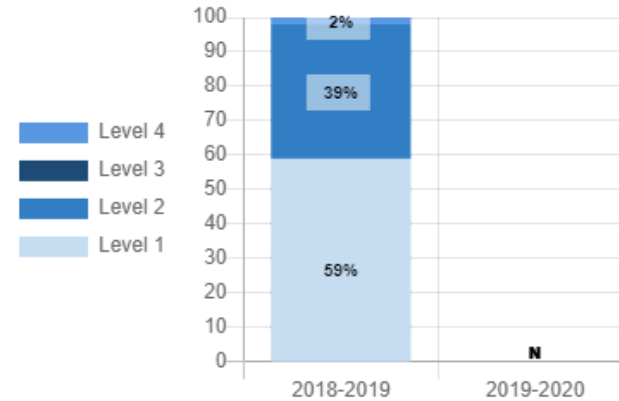

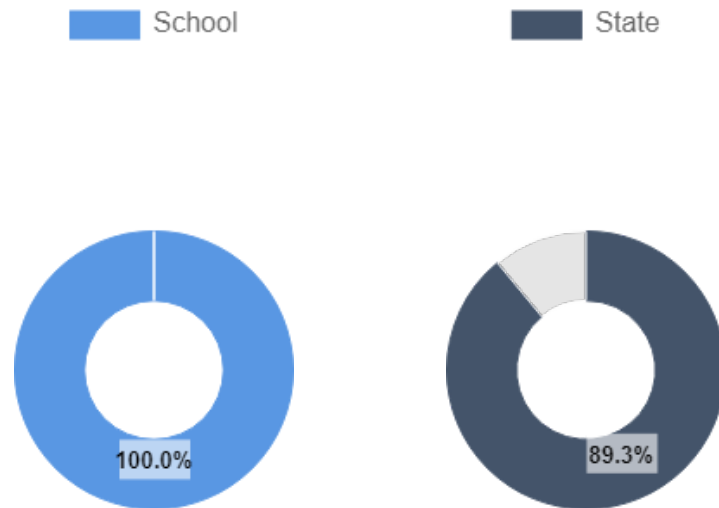

## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The New Jersey Department of Education used input from New Jersey communities to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

**Important Note for 2019-20:** Due to the COVID-19 pandemic, NJDOE received a federal waiver which removed the requirement to report on chronic absenteeism and related accountability measures for the 2019-20 school year. As a result, NJDOE will not report on chronic absenteeism and other attendance data for 2019-20. Tables showing 2019-20 attendance data will be hidden in this report.

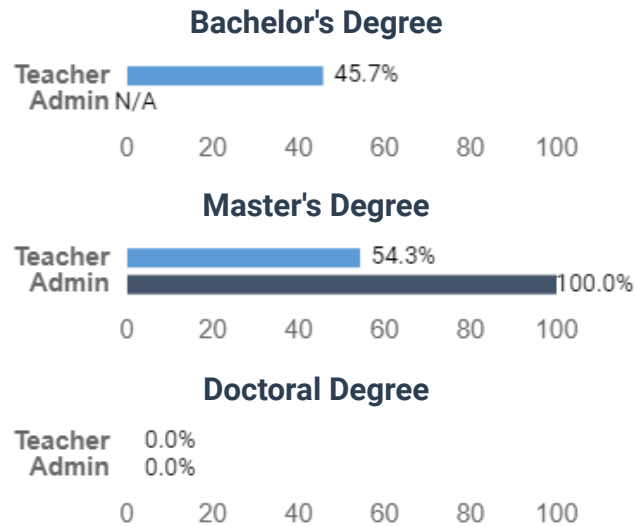

**Important Note for 2019-2020:** Due to the COVID-19 pandemic, New Jersey received a [waiver from the United States Department of Education \(USED\)](#) in March 2020 to waive statewide assessment, accountability, and reporting requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 school year. This removes the requirement to:

- Calculate indicator scores and summative scores for the 2019-2020 school year;

For the annual identification of schools for Targeted Support and Improvement: Consistently Underperforming Student Group, no schools will be identified during the 2020-2021 school year as a result of the March 2020 waiver. New Jersey has submitted a request to USED to waive the next identification in the 2021-2022 school year due to the lack of two consecutive years of data.

Teachers have daily planning time with their teaching teams. Teachers and administrators have two hours of whole school collaboration on Wednesdays for professional development, teacher-to-teacher workshops, data analysis, co-teaching planning, classroom preparations, curriculum development, book clubs, and more. We also have seven full days spread throughout the school year for professional development. Our teacher evaluation model includes peer observers.

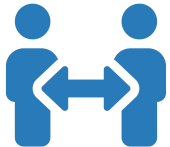

### Technology and STEM:

We have one-to-one Chromebook laptops for students in grades 2-8. We have one-to-one iPads for students in grades K-2. Each classroom is equipped with a Promethean board or a SmartBoard. In addition, our Media Center is outfitted with fifty MacBooks for student, staff, and family use. Our Media Center also includes classroom sets for Lego Robotics.



### Learning During COVID-19:

GBCS has adapted to the COVID-19 Global Pandemic in a multitude of ways. The school has 1) Transformed our food service program, making food available to all families and community members with children eighteen and younger. We have collaborated with New Brunswick Public Schools to allow easier access for families who live in closer proximity to one of their food distribution sites or our site. 2) Established a Wellness team who makes calls to check in with families, daily. This team connects families to supports and resources they may need. 3) Provided Chromebook laptops to all students in grades 2-8 and iPads to all students in grades K-2. 4) Modified our program for distance learning. This includes Google Classroom, Zoom, and many online teaching tools and applications. 5) Continued to collaborate with community agencies to offer support and services for families. This includes food deliveries by Rutgers staff and Youth Corps.

### Other Information:

Our Dual Language education program integrates native English speaking students with native Spanish speaking students for academic instruction, which is presented in both languages, in Kindergarten-Fifth Grade. Social and academic learning occurs in an environment that values the language and culture of all students and sets high standards to ultimately achieve academic success in Spanish and English. The language used for instruction is broken down by a 50/50 ratio. Fifty percent of classroom instruction is provided in English and fifty percent of classroom instruction is provided in Spanish. The goal is for all students to read, write, listen, and speak two languages equally well by the end of the program. The dual-language model creates an additive bilingual environment, which allows students to acquire a second language while maintaining and developing their native language. Reading, language arts, math, science, and social studies, are taught in both Spanish and English. The diversity at GBCS provides an ideal platform for all students to have the opportunity to learn and develop a second language. Through the dual language program, students are exposed to a rigorous curriculum and given the opportunity to learn a second language. In 2018 all Kindergarten, First Grade, Second Grade, and Third Grade classes are dual language, not monolingual. Grades Four and Five remain mixed, one class of each grade being dual language and the other monolingual. Dual Language Program Goals: One of our goals is "To prepare all students to become productive, responsible and contributing members of our changing global society by providing a nurturing environment that rigorously promotes the realization of individual potential." Students in the dual-language program are presented with the social and cognitive benefits of bilingualism. They gain a second language, a broader vocabulary, and multiple views of the world (Cazabon, Lambert, & Heise-Baigorria, 2002).
