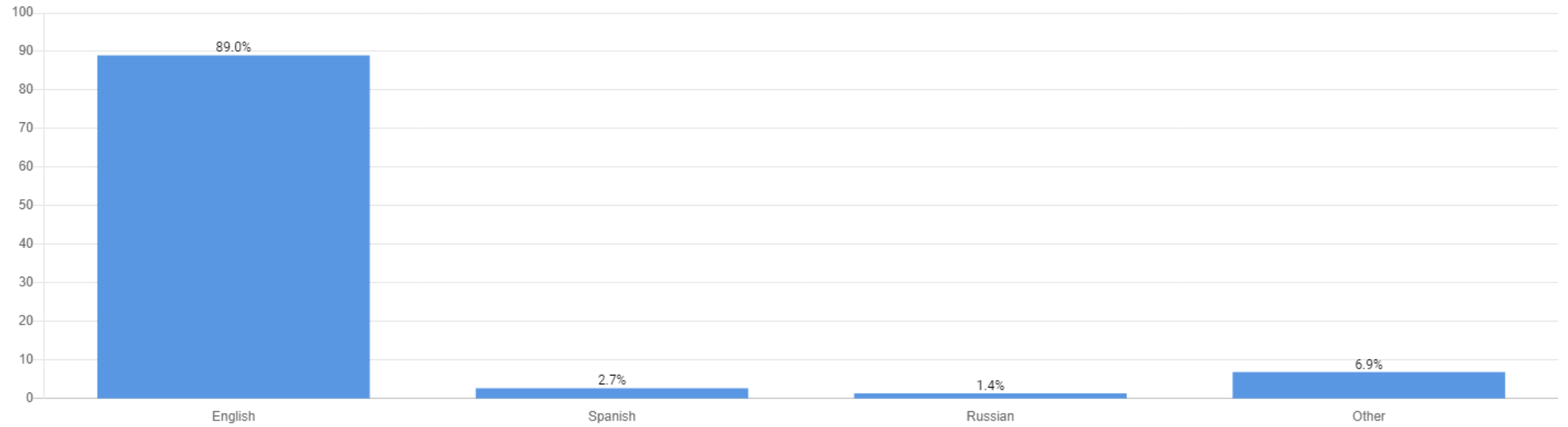

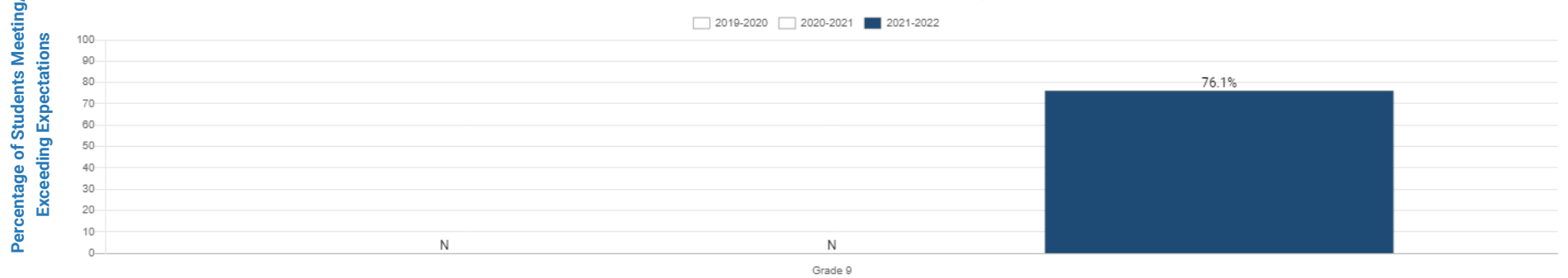

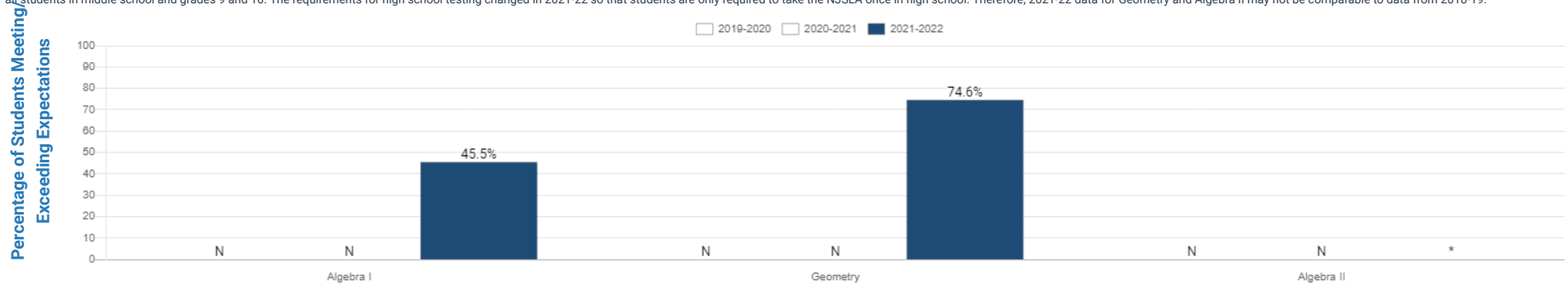

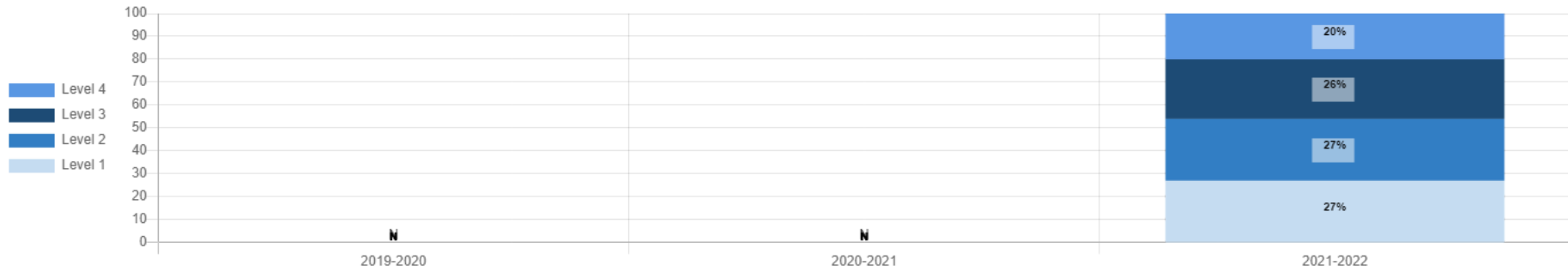

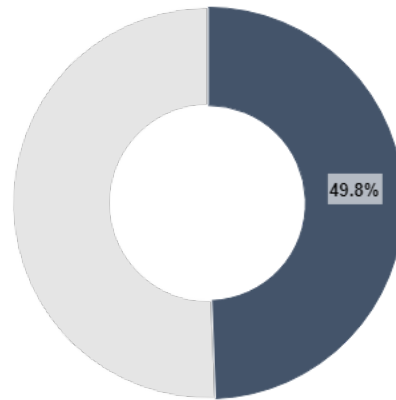
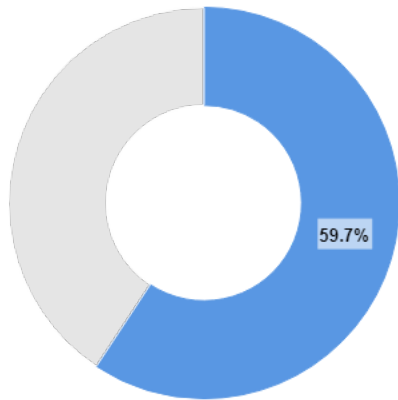

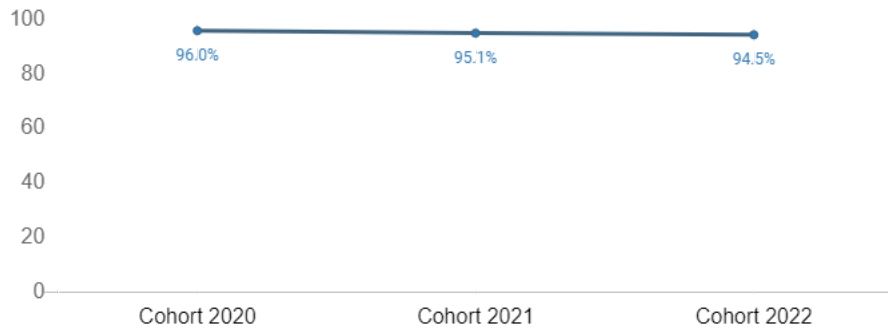
For the "federal version" of the 2022 graduation rates, students with disabilities who did not meet either the state course requirements, local attendance requirements, and/or state graduation assessment requirements for graduation because of a modification or exemption in their IEP were not included in the graduates count (the numerator), but they will remain in the adjusted cohort (the denominator). Because graduation assessment requirements were waived for 2021 graduates, the "federal version" of the 2021 graduation rate only excludes students with disabilities who did not meet either the state course requirements and/or local attendance requirements.

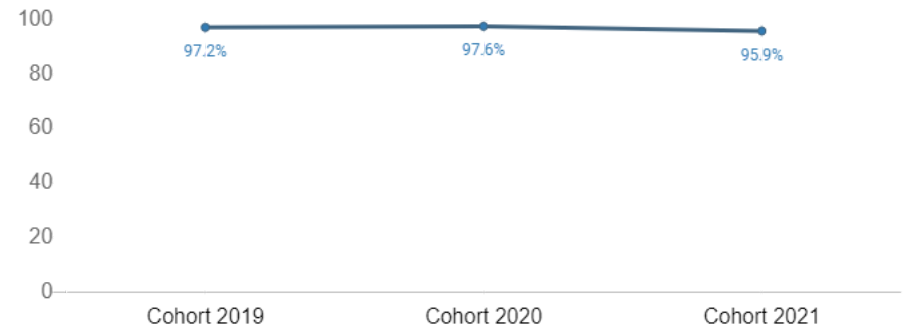

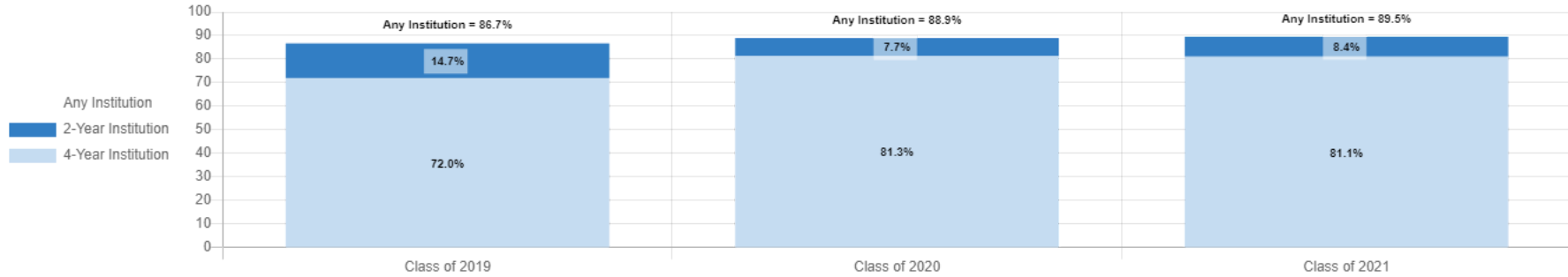

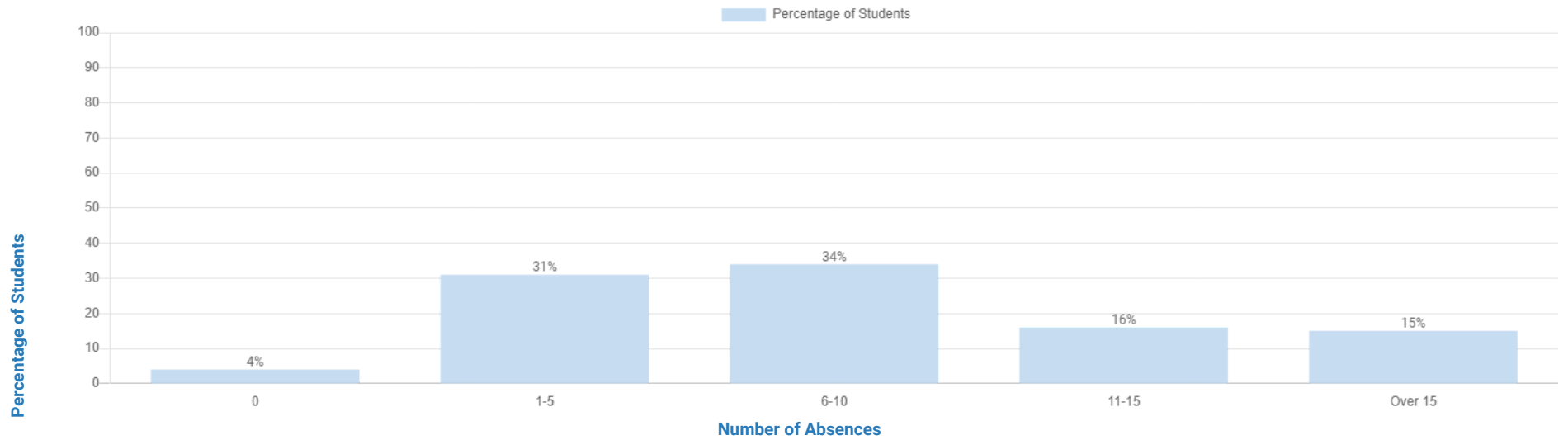

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.



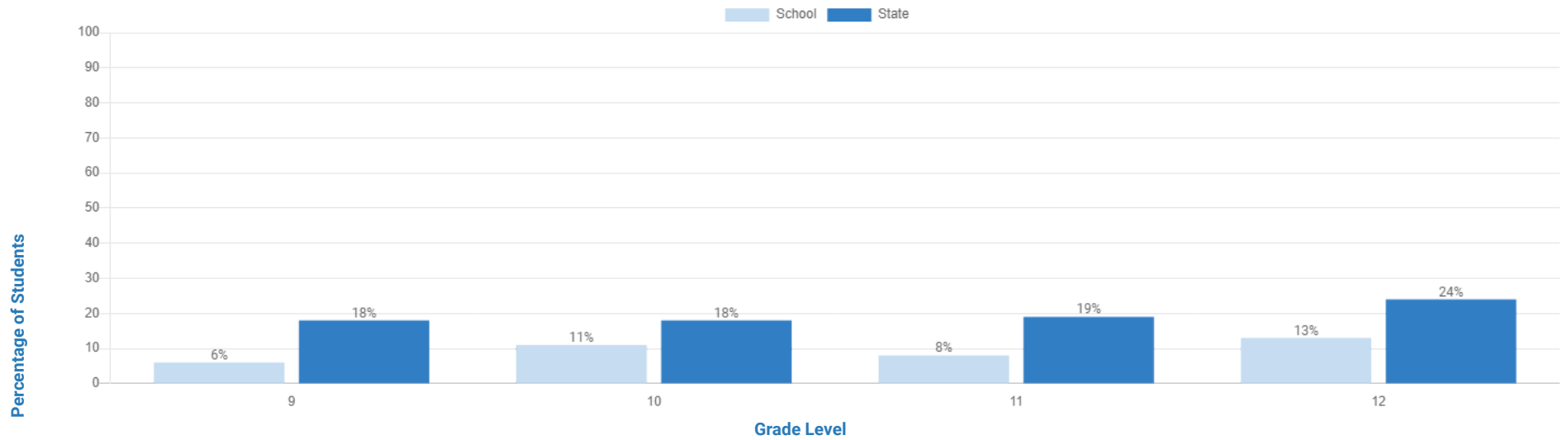

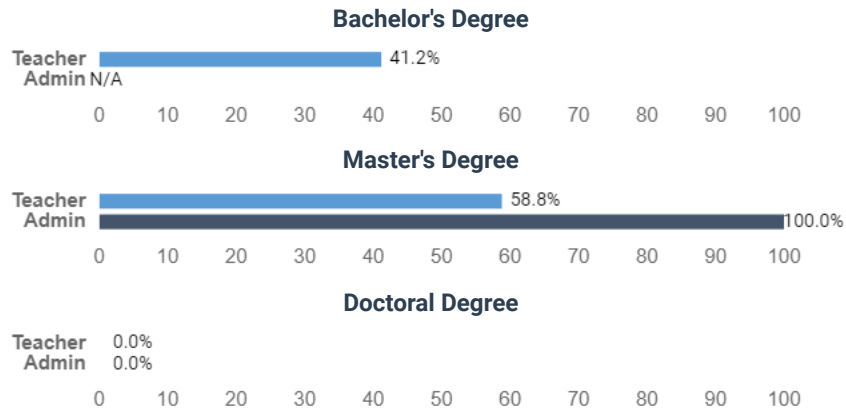

## Accountability

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools that are in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - High schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
  - Schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e. ATSI schools that do not meet exit criteria.
  - The NJDOE has not yet identified schools in this category as no ATSI schools have been in status for three or more years.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
  - Schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

**Important Note for 2021-2022:** Due to the COVID-19 pandemic, New Jersey received waivers from the United States Department of Education (USED) in both [March 2020](#) and [March 2021](#) that waived accountability-related requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 and 2020-2021 school years. These waivers removed the requirements to:

- Calculate indicator scores and summative scores for the 2019-2020 and 2020-2021 school years;
- Measure progress toward long-term goals and measures of interim progress for accountability indicators for the 2019-2020 and 2020-2021 school years; and
- Identify schools for comprehensive and targeted support and improvement during the 2020-2021 and 2021-2022 school years (based on 2019-2020 and 2020-2021 data, respectively).

As a result of these waivers, any school that was identified for comprehensive or targeted support and improvement during the 2019-20 school year will retain the same status for the 2021-22 and 2022-23 school years.

The NJDOE identified schools across four categories during the 2022-23 school year (based on 2021-22 data):

- CSI: Overall Low Performing;
- CSI: Low Graduation Rate;
- ATSI; and
- TSI.

For the TSI identification that occurred during the 2022-23 school year, status in meeting annual targets for the 2018-19 and 2021-22 school years were used since data was not available for two consecutive years.

Additionally, all schools that were previously identified were eligible to exit status at the end of the 2022-23 school year if the NJDOE's Exit Criteria were met.

The NJDOE received approval to make a one-time change to the identification timeline under the COVID-19 State Plan Addendum. Under the approved Addendum, the NJDOE will identify schools for CSI and ATSI status in both fall 2022 and fall 2023. Schools identified for CSI or ATSI status in fall 2022 will be eligible to exit status in fall 2023 if all exit criteria are met. Schools identified for TSI status will be eligible to exit annually if exit criteria are met.

## Accountability

### Accountability Summary by Student Group - 2021-22 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) and Additional Targeted Support and Improvement (ATSI). ### Facilities:

Our centrally air conditioned high school & Thunderbird Think Tank has Wi-Fi access point in every classroom allowing us to use over 1200 wireless laptops throughout the building for instructional purposes. Every classroom is equipped with a multimedia presentation system connected to the Internet. Students and staff received state of the art ProBook 440 G8 Touch screen laptops. Our media learning commons has been reorganized to better suit the needs of 21st Century Readers. Fiction books are being generified (separated into genres, like mystery, dystopian, historical, etc.) so that students can browse more easily, instead of a traditional library where all of the fiction books are just organized by author's name. This gives the media learning commons a more modern style, similar to a Barnes and Noble, so students can more independently find reading materials that appeal to their interests. Our media learning commons has been fully renovated for student use.



### School Safety:

MHS prioritizes the safety and wellbeing of students and staff through comprehensive security measures and emergency preparedness procedures. Security measures and related plans are updated annually based on best practices as well as recommendations from experts in the field including local law enforcement. Our SRO Officer is a career law enforcement officer with sworn authority who is deployed by an employing police department or agency in a community-oriented policing assignment to work in collaboration with one or more schools. In addition to prioritizing physical safety, MHS prioritizes school safety through school counseling and an array of support services to target and support social, emotional, and mental health.



### Technology and STEM:

S.T.E.A.M. courses include: Computer Programming/Design, Interior & Structural Design using AutoCAD, Advanced Interior & Structural Design, Advanced Placement Computer Science Principles, Computer Animation 3-D, Humanoid Robotics, AP Computer Science A, Technology and Engineering Principles, Data Structures, Computer Modeling, Honors STEAM Capstone Research/Internship, Honors STEAM Design and Research, T3 Innovations and Inventions. The FIRST Robotics Club combines the excitement of a varsity sport with the rigors of science and technology. Under strict rules, limited resources, and time limits, teams are challenged to raise funds, design a team brand, hone teamwork skills, and build and program robots to perform prescribed tasks against a field of competitors. Many of our students begin their post-secondary careers having already earned college credit through our partnerships with Ramapo College of New Jersey, Farleigh Dickenson University, Seton Hall University, Saint Thomas Aquinas, Saint Elizabeth University, NJIT, and Bergen Community College. Others receive credit by scoring well on the Advanced Placement tests. Last year Mahwah High School offered 24 Advanced Placement (AP) courses spread over seven major curricular areas. Two-hundred forty-one students took five hundred sixteen AP Examinations in 24 subjects. We are proud of our one National Merit Scholarship Finalist, 12 National Merit Commended Students, 30 Presidential Education Recipients, 66 Seal of Bi-literacy candidates, 35 members of the NHS, 25 Principals Award Recipients, 15 Platinum Thunderbird Scholars (all grades in all courses were greater than 90% for all four years at MHS), and 8 Presidential Fitness Award Recipients. Further, we are implementing Effective Schools Solutions, a wraparound program for at risk students who require therapeutic and academic support services within their home school. The Option Two programs include: Thunderbird Career and Academic Internship Program, community service, and co-curricular activities such as Marching Band, PE through athletic participation, dance, and virtual distance learning programs.
