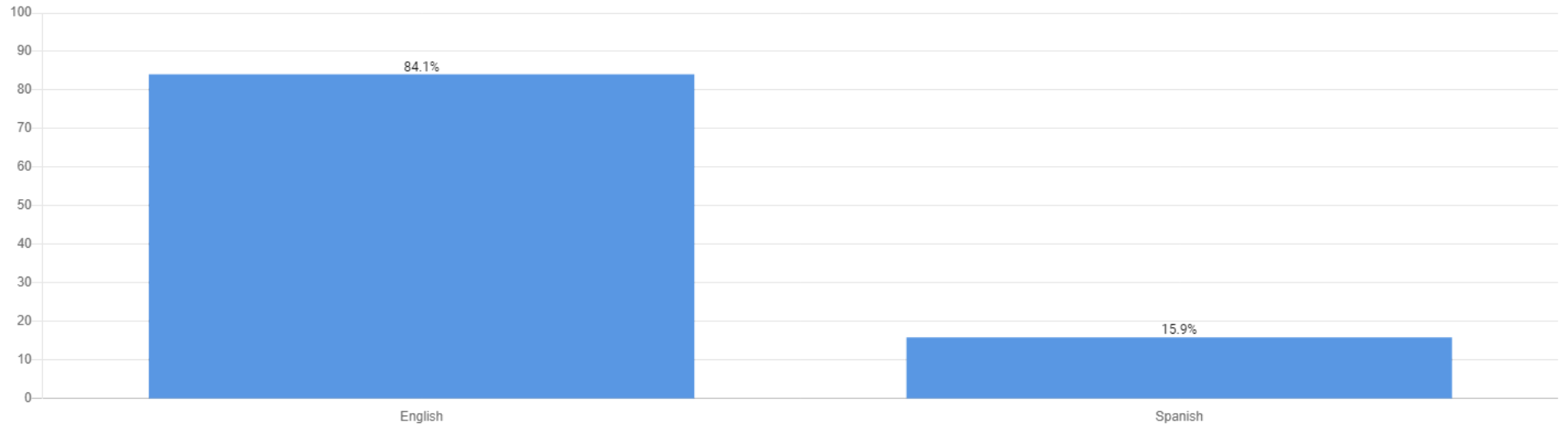

## Student Growth

Student growth is a measure of how much students are learning each year. New Jersey's ESSA state plan outlines that academic progress will be measured with school's median student growth percentile (mSGP) on statewide ELA and mathematics assessments. Each individual student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7. The SGP measures their academic progress from one year to the next compared to other students with similar prior test scores (academic peers).

A student's SGP falls between 1 and 99 and can be grouped into three levels. An mSGP below 35 indicates low growth, an mSGP between 35 and 65 indicates typical growth, and an mSGP greater than 65 indicates high growth. If the SGPs for all students are ordered from smallest to largest, the mSGP is the percentile in the middle of the list.

**Important Note for 2022-23:** Student growth data is not available for the 2019-2020, 2020-2021, and 2021-2022 school years due to federal waivers and assessment cancellations. An alternate measure of academic progress, or growth, called Relative School Improvement Measure (RSIM) was used for the 2021-2022 school year only.

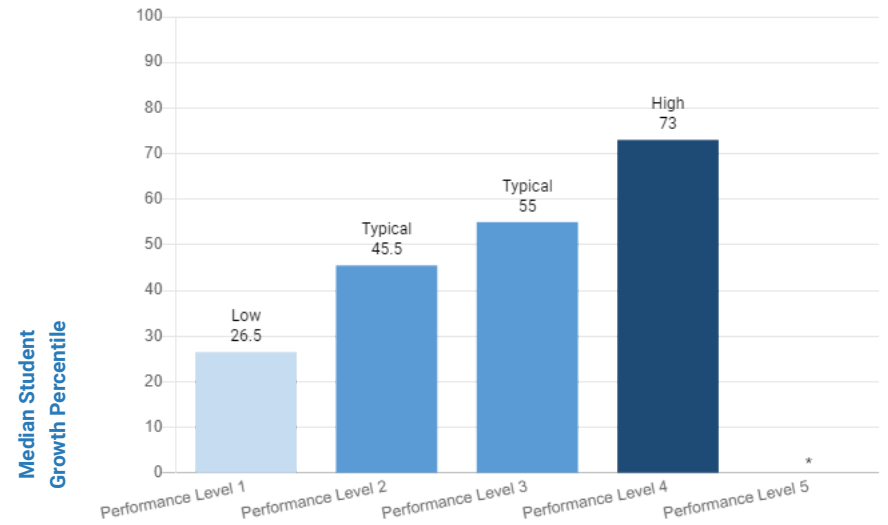
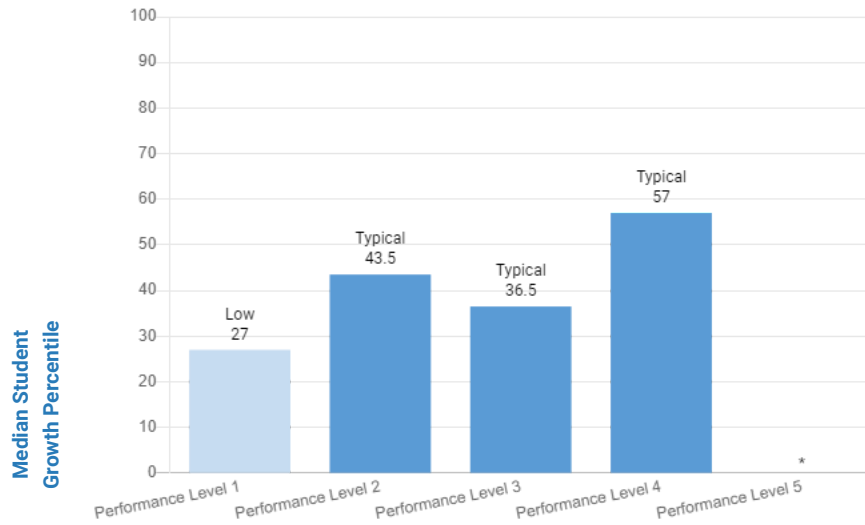

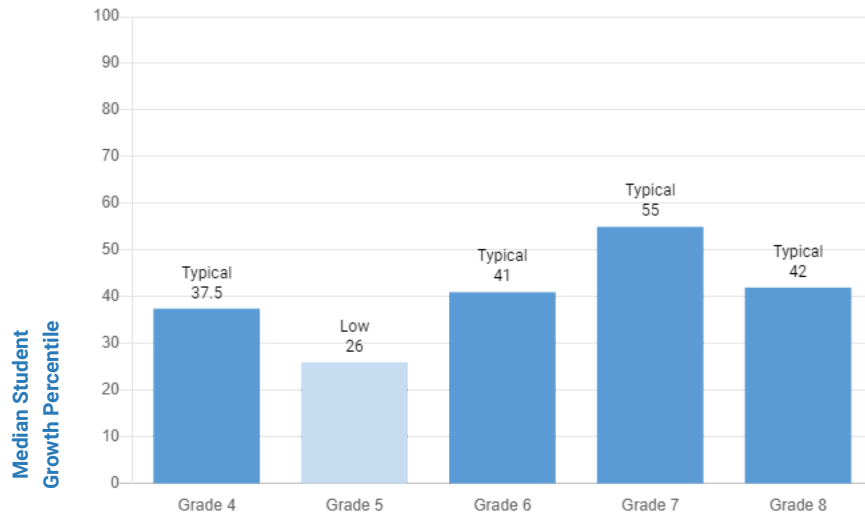

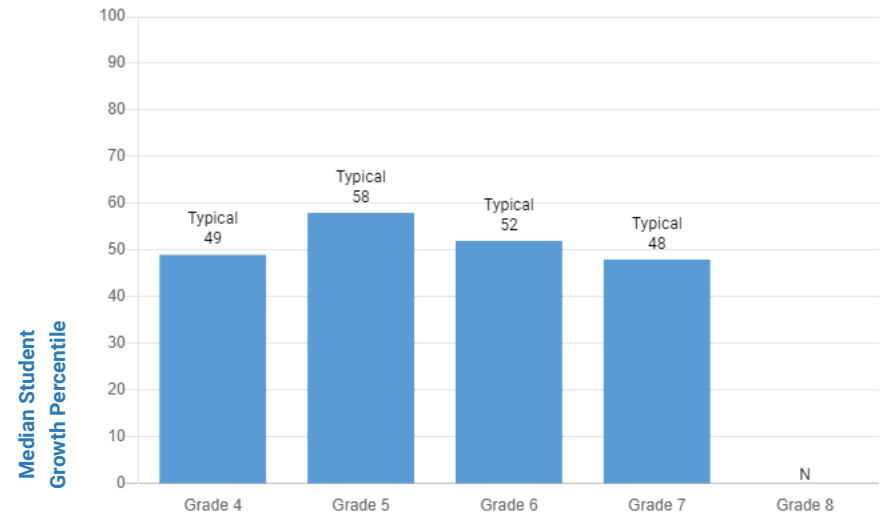

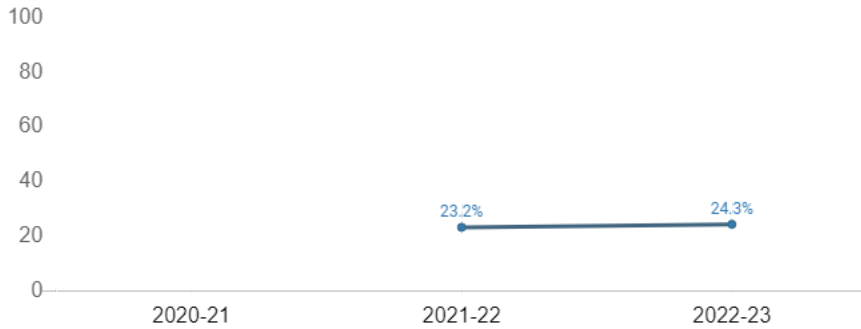

### English Language Arts and Mathematics Performance Trends

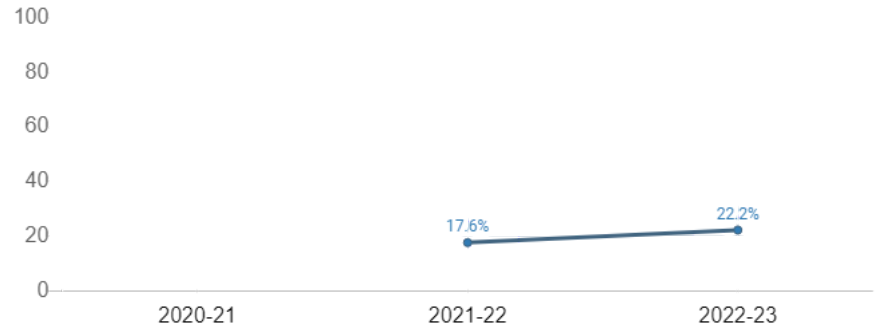

The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. ### English Language Arts Assessment - Participation and Performance

This table shows performance on statewide assessments for English language arts (ELA) both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include only students in grades 3 through 9. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM.

This table shows both the percentage of students who met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long-term goal of 80% proficiency by 2032. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long-term goal. Student groups where the annual target fields are grayed out are not required to meet annual targets under ESSA accountability. 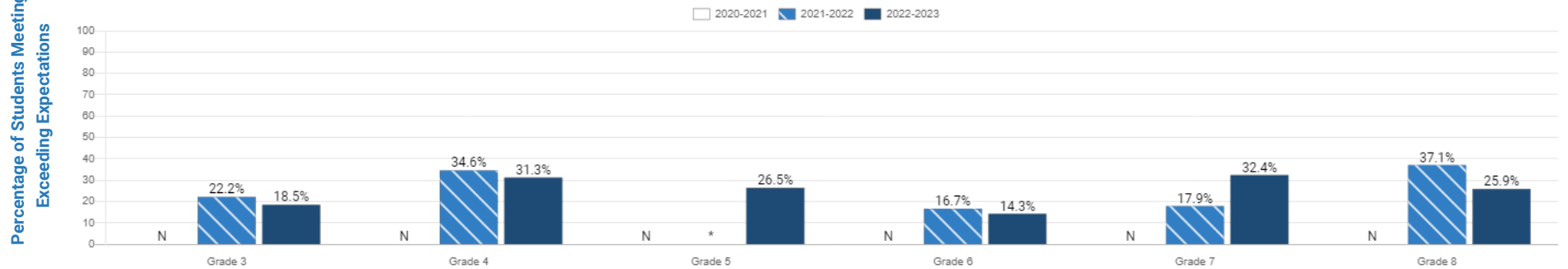

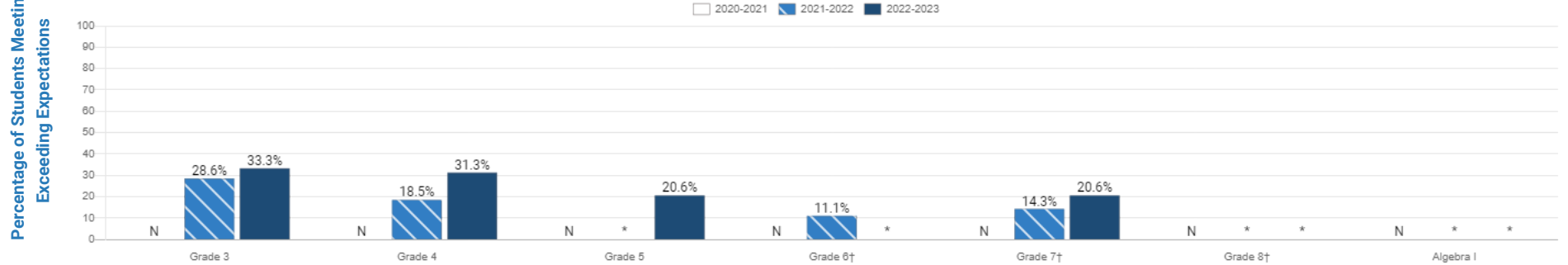

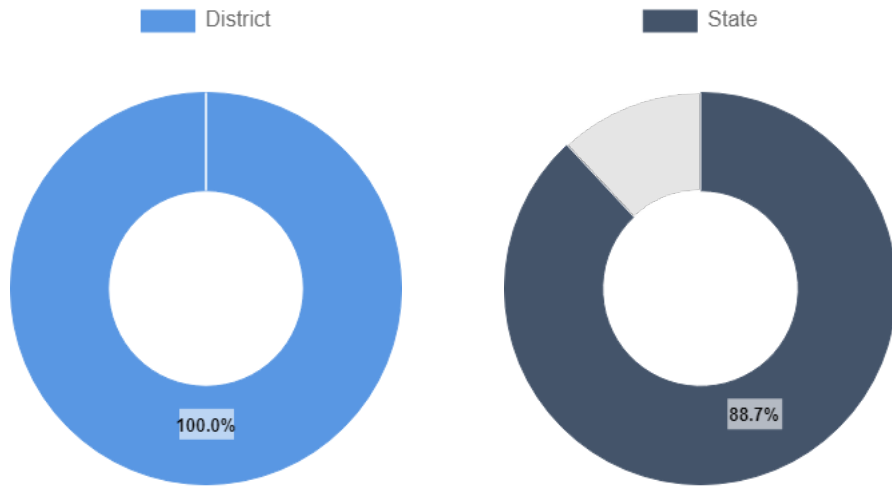

**Grades 6-8: Students enrolled in one or more visual and performing arts classes**



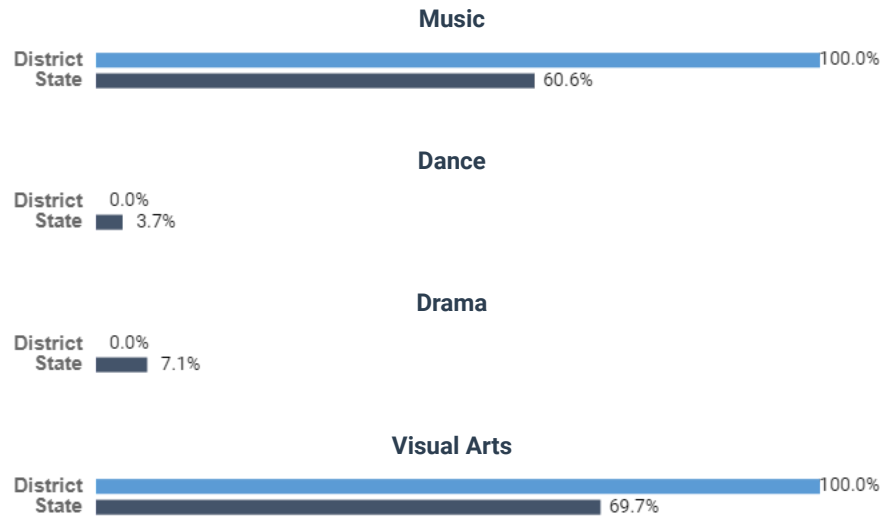

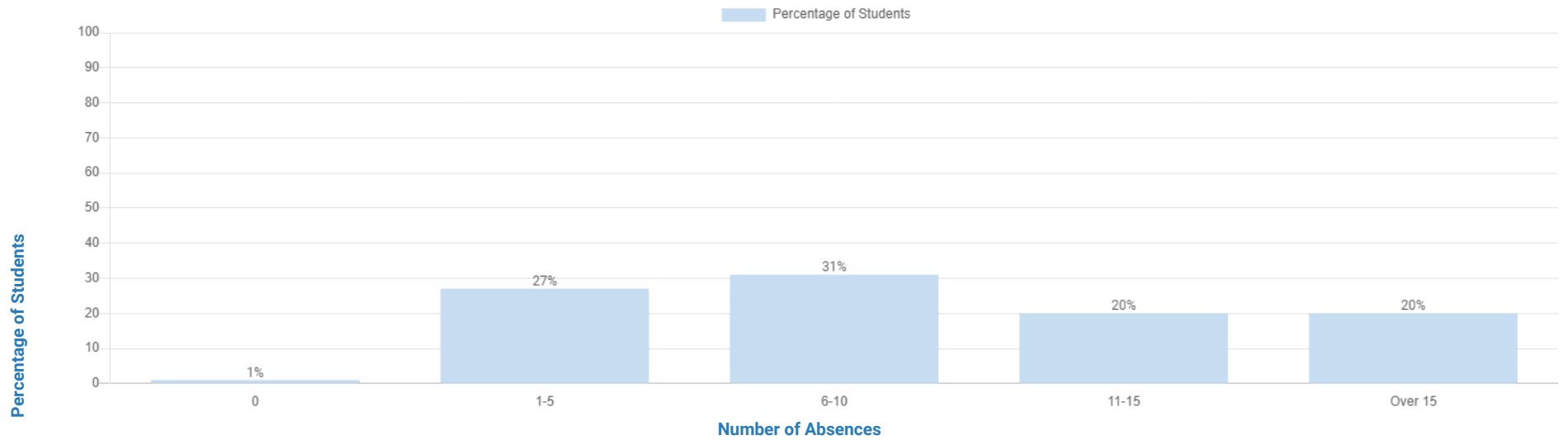

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.



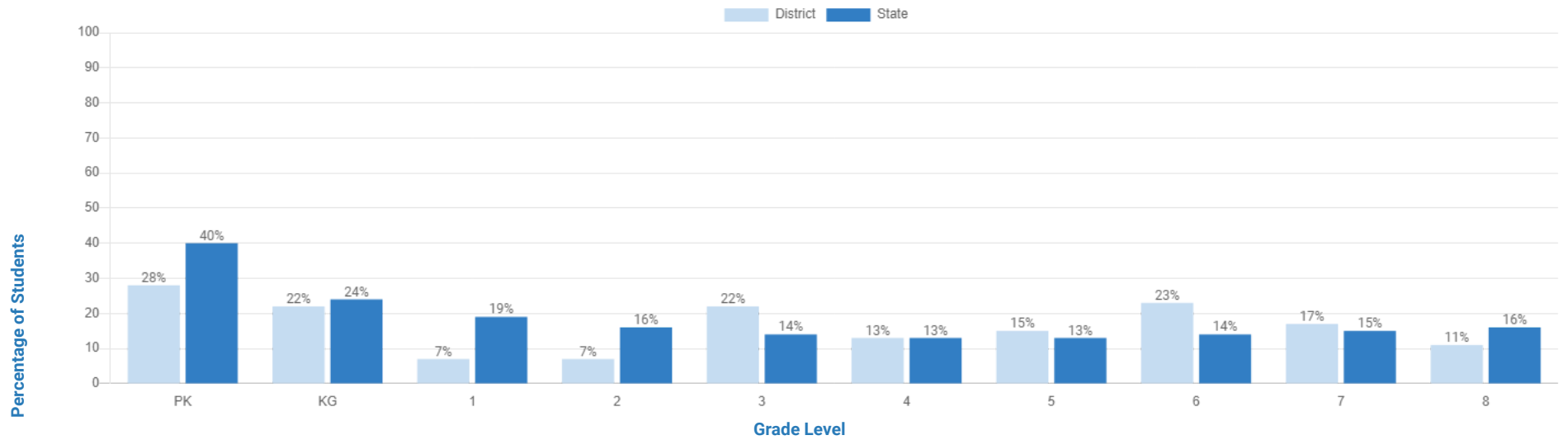

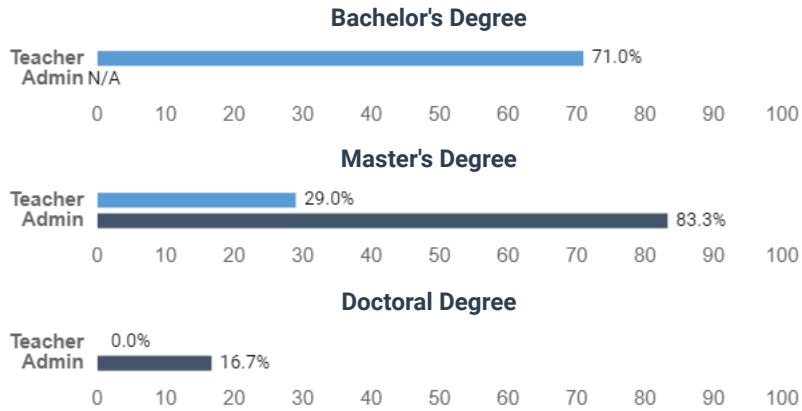

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools that are in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). **Important Note for 2022-23 Reports:** The NJDOE received approval to make a one-time change to the identification timeline under the [COVID-19 State Plan Addendum](#). Under the approved Addendum, the NJDOE identified schools for CSI and ATSI status in both fall 2022 and fall 2023. Schools that were identified for CSI or ATSI status in fall 2022 were eligible to exit status at the end of the 2023-2024 school year if all exit criteria were met. Schools that were identified for CSI or ATSI status in fall 2023 will be eligible to exit status at the end of the 2026-2027 school year if all exit criteria are met. Schools identified for TSI status are eligible to exit annually if exit criteria are met.

The NJDOE resumed using median student growth percentiles (mSGPs) to measure academic progress, or growth, for the 2022-2023 school year. The growth measure used for 2021-22 was an alternate measure used because median student growth percentiles were not available for 2021-22 and the NJDOE resumed using mSGPs for 2022-2023, so growth data for 2021-22 to 2022-23 should not be compared. As data over the last three years was impacted by the pandemic in various ways, the NJDOE recommends caution in comparing data from year to year.

### Courses, Curriculum, Instruction:

Our district is part of the CRHS Curriculum Consortium to ensure our students are prepared for high school. The consortium works collaboratively to share resources, professional development opportunities and curricula (when possible) to ensure that students are "on track" when they transfer to another school within the consortium. For ELA, we use Journeys for our K-5 and novel-based instruction for 6-8. For Math, K-8 uses Big Ideas. To help close gaps of foundational skills, students work an individualized learning path through the iReady program. We offer two advanced middle school math classes: Accelerated Math for grade 7 and Algebra I for grade 8. In addition to the core academic areas, students receive instruction in the following special areas: Art, Health/PE, STEM, Financial Literacy, Performing Arts and Spanish. In the fall of 2023, the consortium aligned Math curriculum to include the Achieve3000 technology platform.



### Clubs and Activities:

Our school offers Choir, Academic Lab, Yearbook Club, Drama Club, Safety Patrol, NJHS, Student Council, Lego League, Fun Zone, soccer, softball, basketball, volleyball and more.



### Before and After School Programs:

Clubs and activities are offered after school for students in grades 1 - 8. DTS offers Academic Lab, an after school tutoring program, to any student who wishes to receive the additional support. YMCA provides a before and after school care program on site for all students.

### Staff and Professional Learning:

Teachers work collaboratively in PLCs weekly to build capacity and increase student achievement. Our district collaborates with the CRHS Consortium to broaden the PD available and offer teachers the opportunity to collaborate with teachers from other districts. Staff are encouraged to attend professional development opportunities and turnkey the information to the staff.



### Student Supports and Services:

Our I&RS Team and CST support students who are having academic, behavioral or social difficulties. We also have a guidance counselor and social worker to assist students in the acquisition and development of social skills. Our staff members provide classroom based character education/health lessons in all grade levels, including instruction in social and emotional learning through the Second Step curriculum and program. Additional services are provided in the areas of behavioral support, speech, OT, and PT. The Barton Reading Program is used in our BSI program to support students in ELA.



### Student Health and Wellness:

A breakfast program is offered to all students. We have a Life Skills Curriculum which is delivered to all students in grades PK-8. SNAP-ED works with the students to share ways to eat healthy, maintain physically active lifestyles, and ways to build a healthier community. This is done through direct instruction and hands-on activities, including recipes based on locally grown produce.

PTO provides activities for our students and their families including, but not limited to: Trunk-or-Treat, school dances, family fun nights, movie night, family paint night, and field day. Our PTO also holds a Winter Gift Shop and a Book Fair in an effort to raise funds and provide students and parents the convenience and opportunity to purchase low cost holiday gifts and books. Our parents are encouraged to attend special school functions such as concerts, Student Showcase Night, and orientation/registration programs. Families of students in grades K-2, are invited to attend classroom celebrations. Families are encouraged to attend board meetings where we recognize several students each month. We also offer opportunities for parent involvement on committees and advisory groups (i.e. Special Education Parent Advisory Group, Early Childhood Advocacy Committee, School Safety Team, Governor's Educator of the Year and Educational Services Professional of the Year Committee, etc.).



### Climate Surveys:

### Facilities:

The school has a middle school science lab, library, gymnasium and art room. The preschool and kindergarten wing each have their own fenced in play yard. There are also playgrounds, baseball, and soccer fields for the older students. Continual improvements in technology include building wide updated wireless internet access and in 2021, the district added a complete 1:1 initiative that provided each student with their own chromebook. Central air conditioning in all areas of the school allows for a more conducive learning environment.

### School Safety:

Security cameras have been installed in locations both inside and outside of the building to enhance safety and security measures. Visitor procedures and other safety/security measures and procedures are in place. Student drop off and pick up procedures allow for a more structured routine which prevents students from entering busy traffic areas, increases staff visibility, and improves the overall timeliness of the process. The main entrance security vestibule project was recently completed. In 2021, the district added school safety officers to the school during hours of student attendance. These officers are all SRO trained.



### Technology and STEM:

Technology STEM: All students have STEM as a special area class. We also have an after school STEM Club/Lego League. We are a 1:1 district that provides every student with their own Chromebook. Every classroom was equipped with a smartboard projector at the end of the 2022-2023 school year.



### Early Childhood Education:

DTS has four full day Pre-K classrooms that use the Connect4Learning curriculum. The classrooms are a mix of 3 and 4 yr olds.
