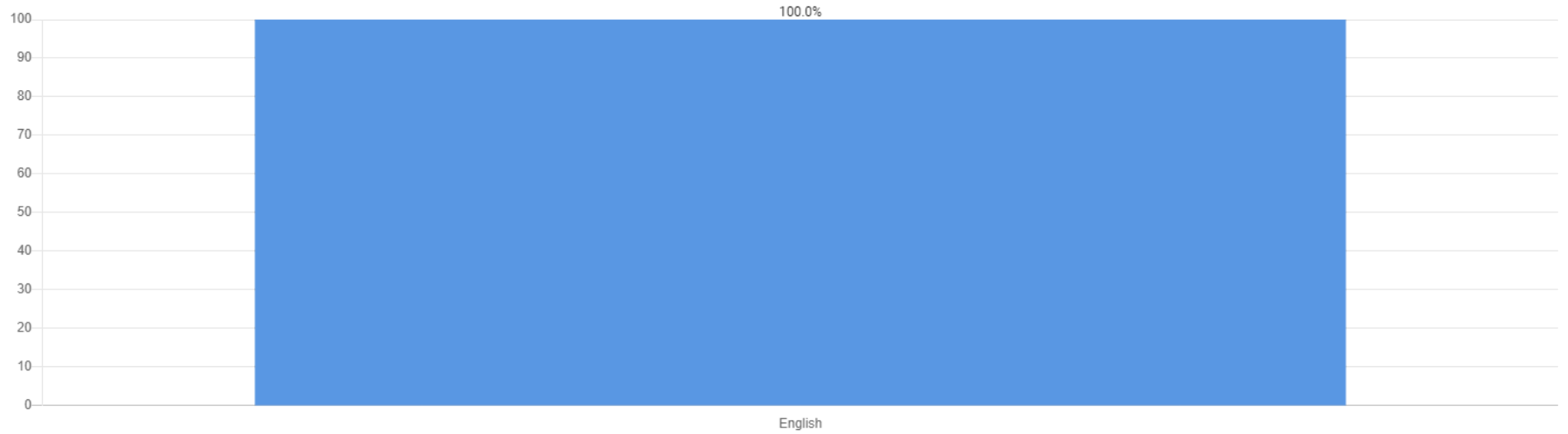

## Student Growth

Student growth is a measure of how much students are learning each year. New Jersey's ESSA state plan outlines that academic progress will be measured with school's median student growth percentile (mSGP) on statewide ELA and mathematics assessments. Each individual student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7. The SGP measures their academic progress from one year to the next compared to other students with similar prior test scores (academic peers).

A student's SGP falls between 1 and 99 and can be grouped into three levels. An mSGP below 35 indicates low growth, an mSGP between 35 and 65 indicates typical growth, and an mSGP greater than 65 indicates high growth. If the SGPs for all students are ordered from smallest to largest, the mSGP is the percentile in the middle of the list.

**Important Note for 2022-23:** Student growth data is not available for the 2019-2020, 2020-2021, and 2021-2022 school years due to federal waivers and assessment cancellations. An alternate measure of academic progress, or growth, called Relative School Improvement Measure (RSIM) was used for the 2021-2022 school year only.

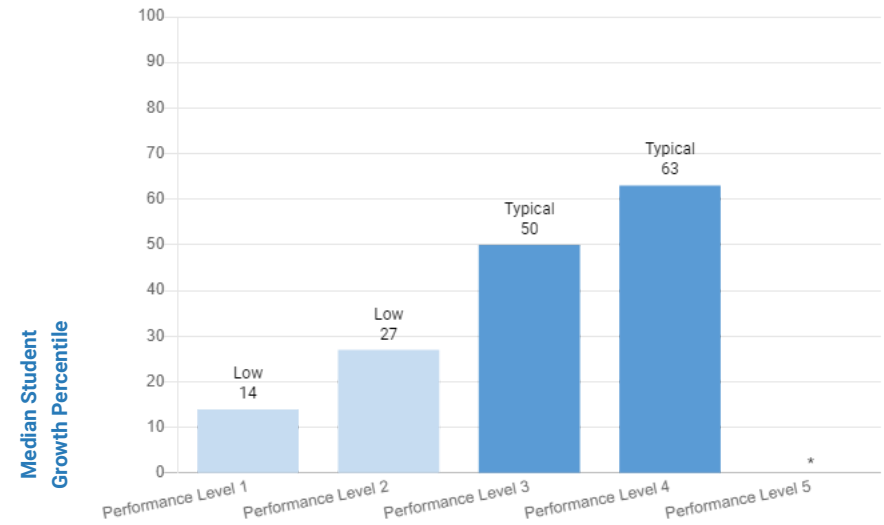
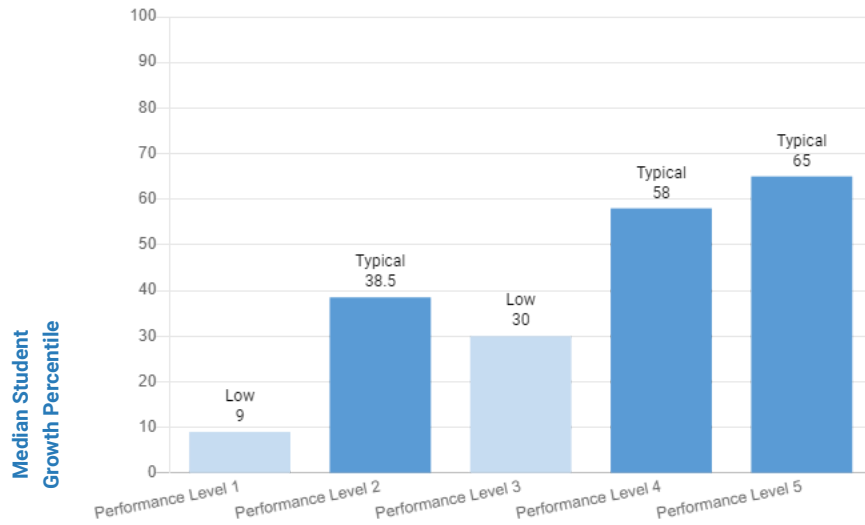

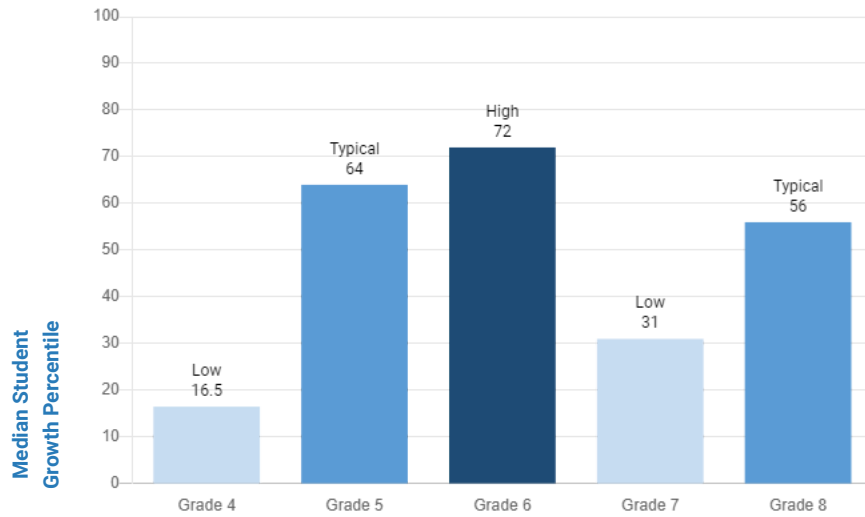

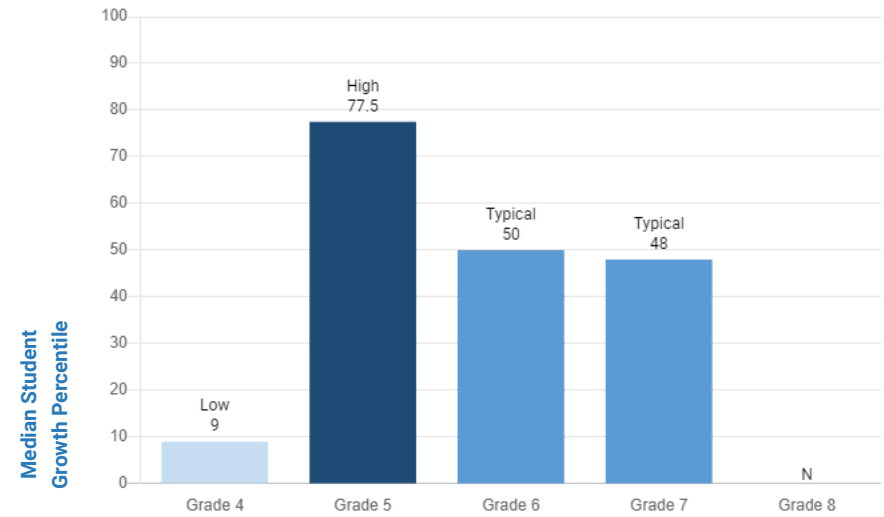

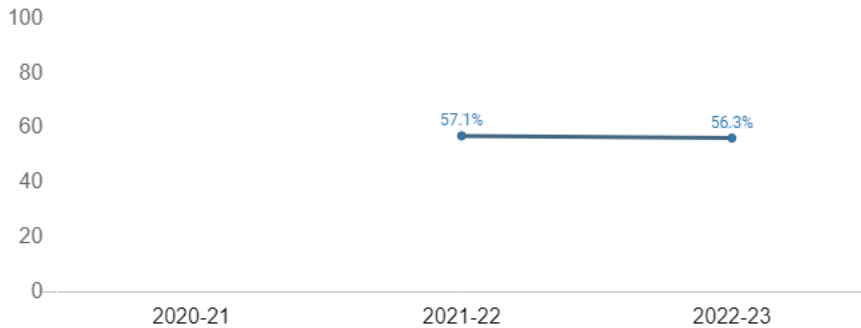

### English Language Arts and Mathematics Performance Trends

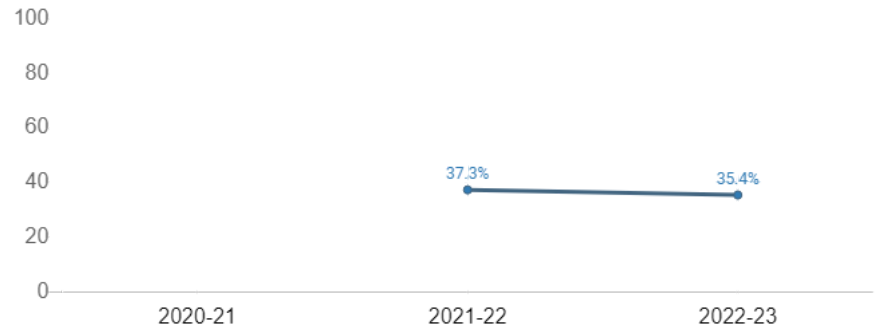

The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

### English Language Arts Assessment - Participation and Performance

This table shows performance on statewide assessments for English language arts (ELA) both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include only students in grades 3 through 9. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM.

This table shows both the percentage of students who met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long-term goal of 80% proficiency by 2032. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long-term goal. Student groups where the annual target fields are grayed out are not required to meet annual targets under ESSA accountability. 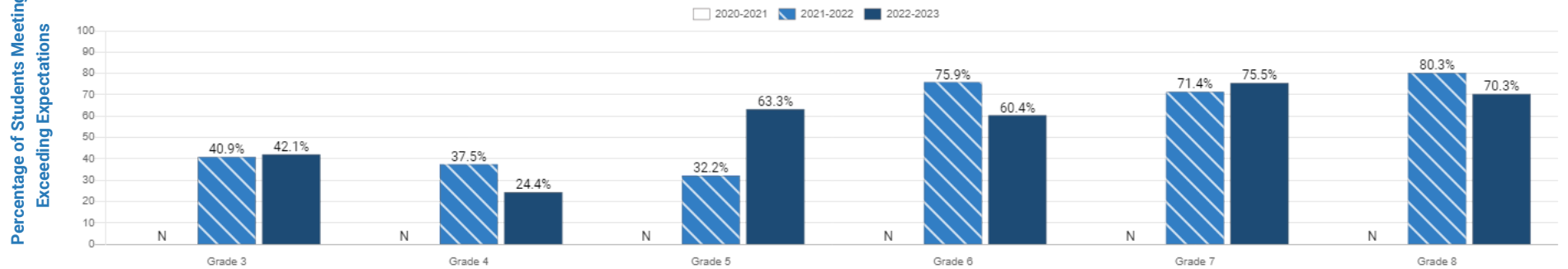

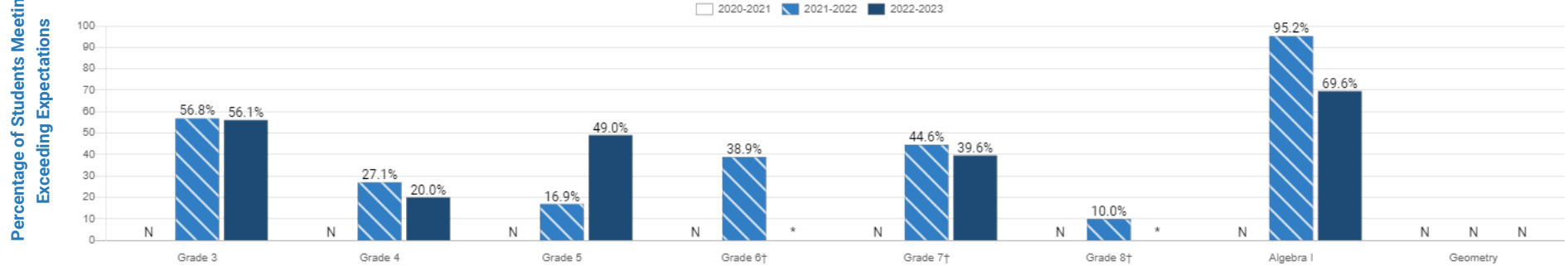

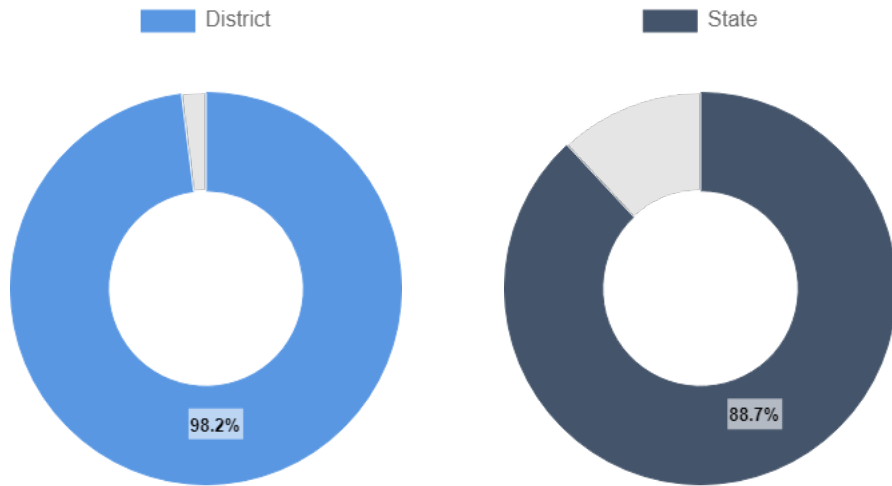

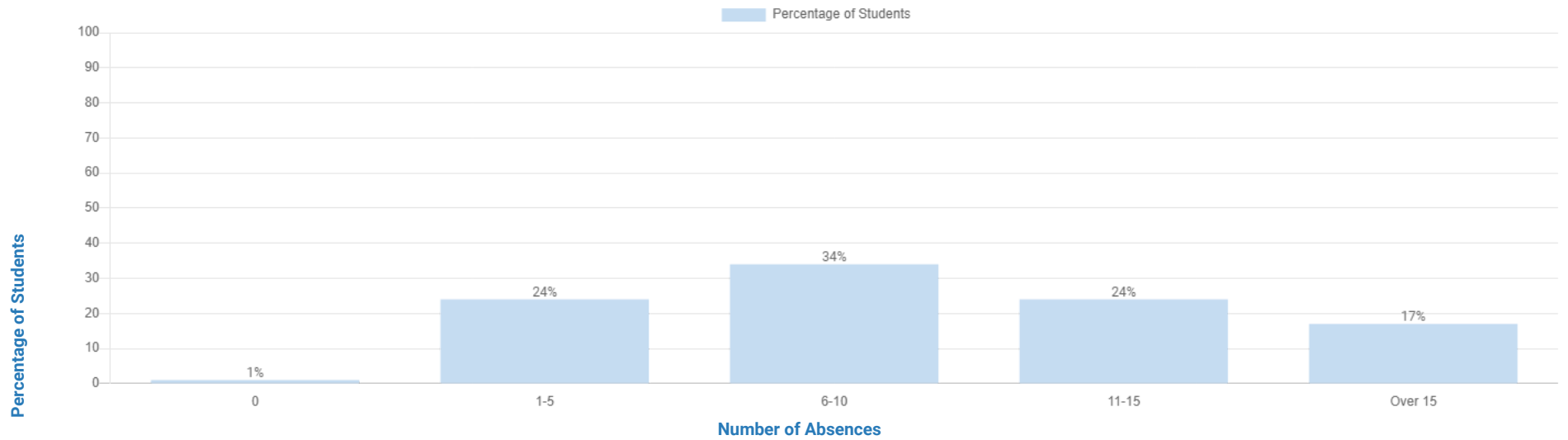

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.



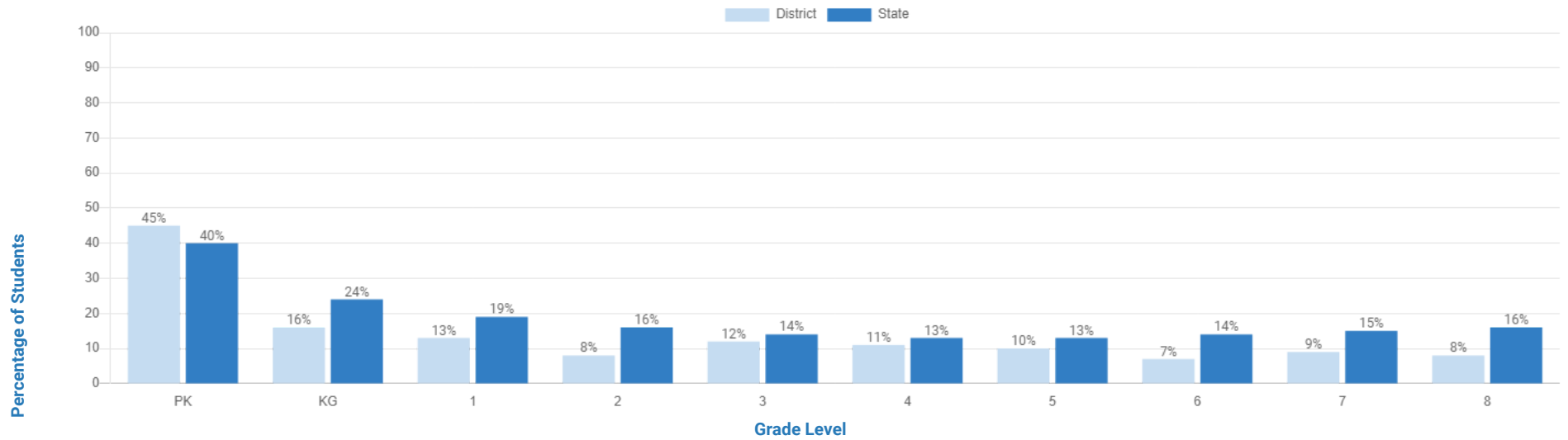

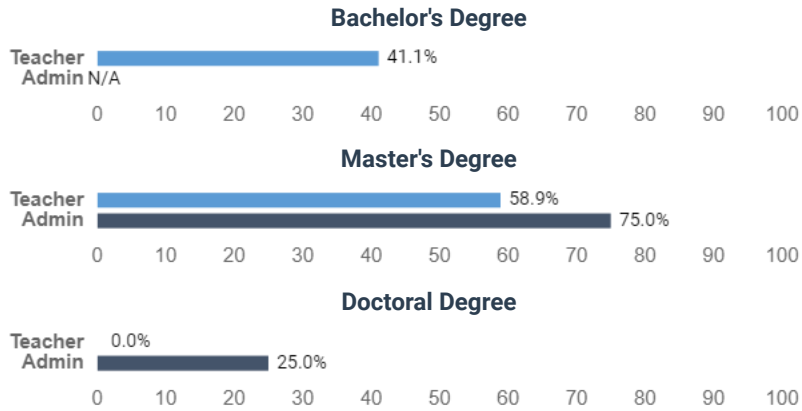

Schools that were identified for CSI or ATSI status in fall 2022 were eligible to exit status at the end of the 2023-2024 school year if all exit criteria were met. ### Facilities:

New, state of the art boilers were installed through the NJ Direct Install program, saving the district over \$700,000. New drainage was installed in the parking lots.



### School Safety:

The safety and security of our schools is our number one priority in order to make sure that we are providing the safest environment possible for our students. We annually update our school security procedures; we annually provide training for our staff; and we work closely with the NJ State Police, Sussex County Sheriff's Department and local fire departments. Security, lock-down, evacuation and/or fire drills are performed on a monthly basis. A full time armed security officer has been hired and started working the first day of the school year.



### Technology and STEM:

All Middle School students are issued their own chromebook at the beginning of the school year. We offer laptops and tablets for students to access, utilize and support their learning. Google has been implemented to serve as a communication and collaboration tool. We are using web-based technologies to guide instruction. IXL, Reflex Math, Gizmos Science, Reading A-Z, Brainpop, etc. We have also implemented robotics for students to gain initial experience with coding and engineering.

### Early Childhood Education:

For a tuition fee, we offer a general education preschool program. This program was created to provide an inclusion opportunity for our Preschool Disabled class. We therefore have a limited number of seats available and often use a lottery system for selection. Children in the district who are age 4 by October 1 of the current school year are eligible to attend this 5 day per week program; 2.5 hour sessions each day.



### Effective and Efficient Use of ESSR Funding:

The ESSR funds have been mostly consumed by hiring a full time mental health clinician with Effective Solutions to assist students with mental health needs as identified by our staff. The rest of the funds were spent on before and after school small group tutoring, which is offered to all students identified with a learning loss as well as six week summer RTI program where they received small group instruction in Math and ELA. Funds were also spent on supplemental and curricular programs such as Benchmark Education, Learning A-Z and Collaborative Classroom, a new K-4 ELA Program. Funds were also used to support professional development in the areas of Modern Classroom Project and Collaborative Classroom.
