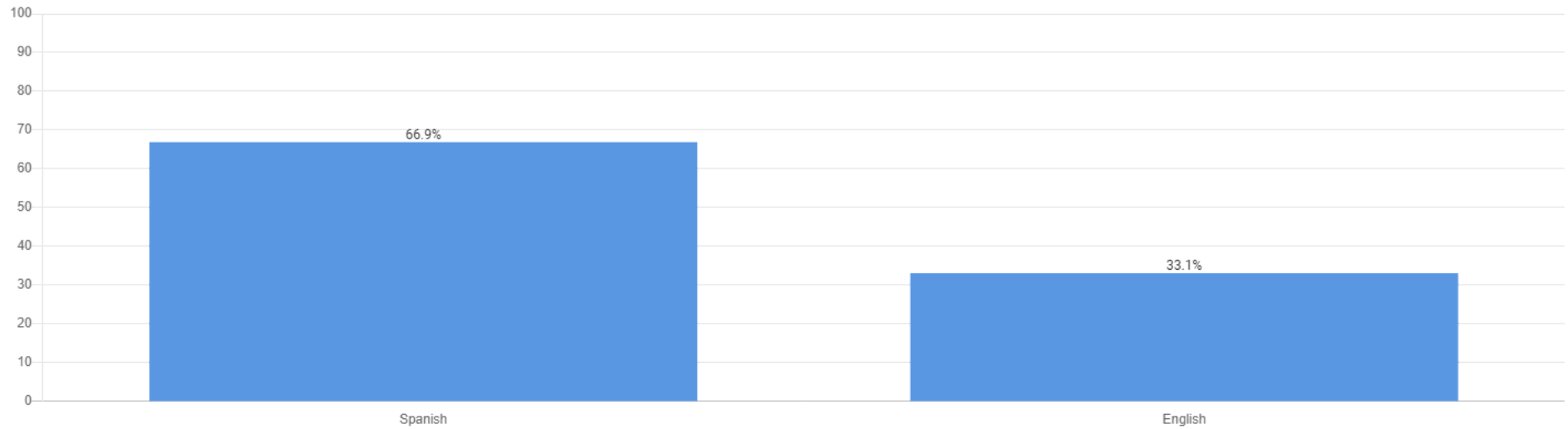

Student Growth

Student growth is a measure of how much students are learning each year. New Jersey's ESSA state plan outlines that academic progress will be measured with school's median student growth percentile (mSGP) on statewide ELA and mathematics assessments. Each individual student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7. The SGP measures their academic progress from one year to the next compared to other students with similar prior test scores (academic peers).

A student's SGP falls between 1 and 99 and can be grouped into three levels. An mSGP below 35 indicates low growth, an mSGP between 35 and 65 indicates typical growth, and an mSGP greater than 65 indicates high growth. If the SGPs for all students are ordered from smallest to largest, the mSGP is the percentile in the middle of the list.

Important Note for 2022-23: Student growth data is not available for the 2019-2020, 2020-2021, and 2021-2022 school years due to federal waivers and assessment cancellations. An alternate measure of academic progress, or growth, called Relative School Improvement Measure (RSIM) was used for the 2021-2022 school year only.

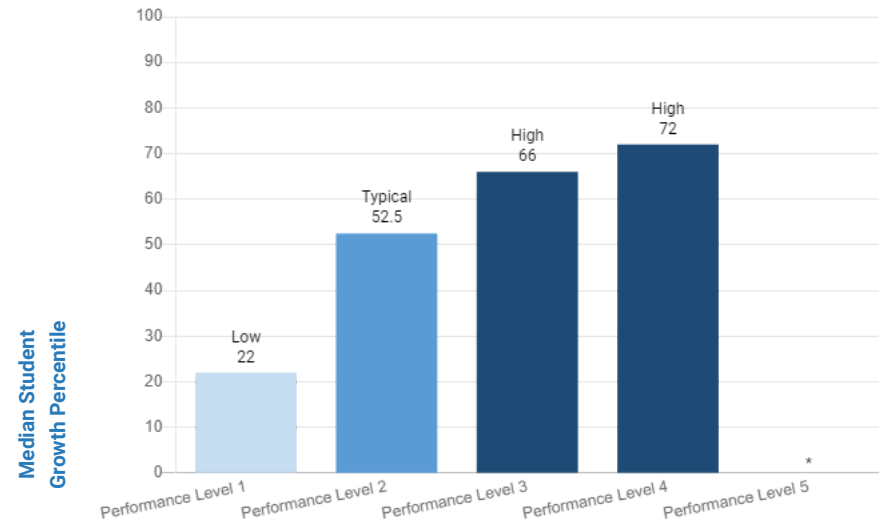
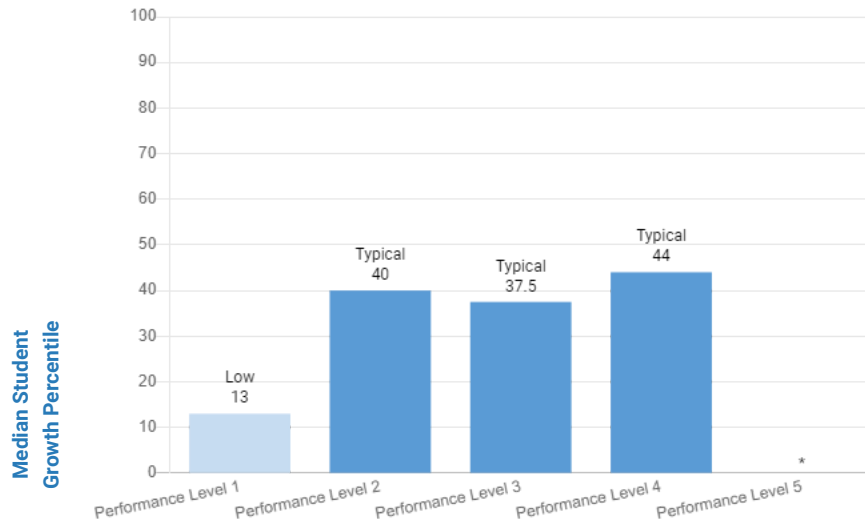

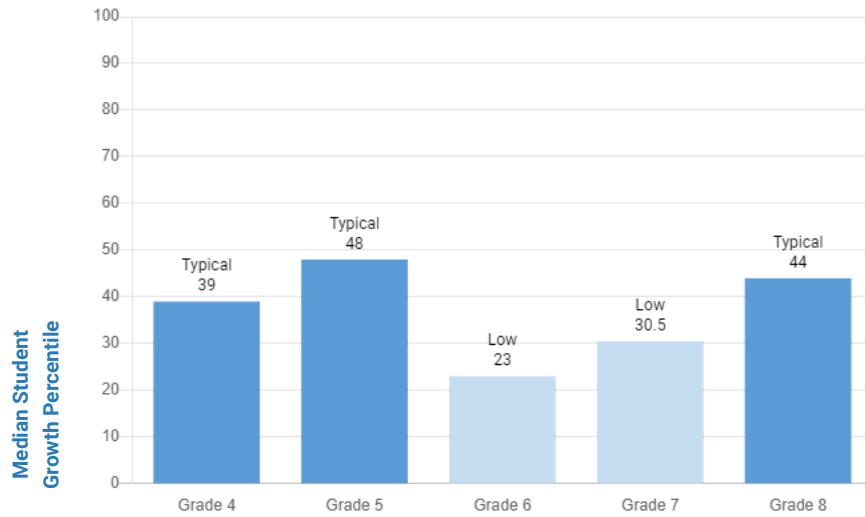

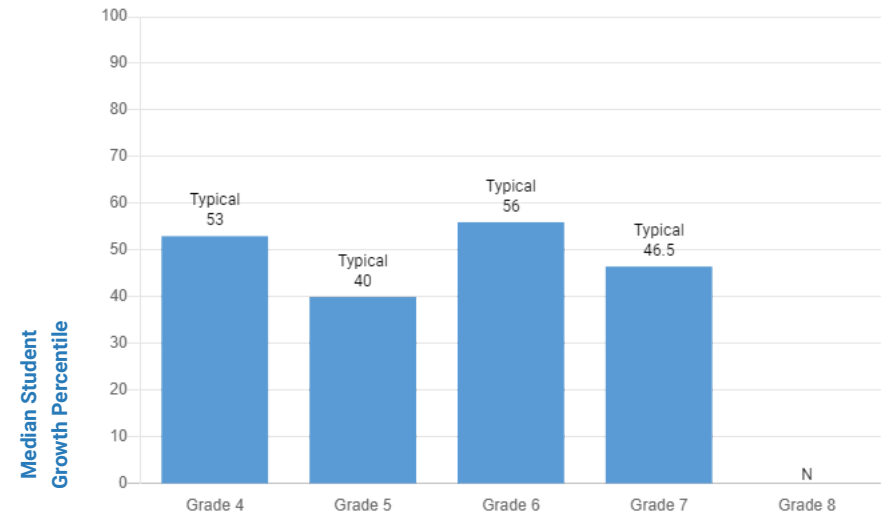

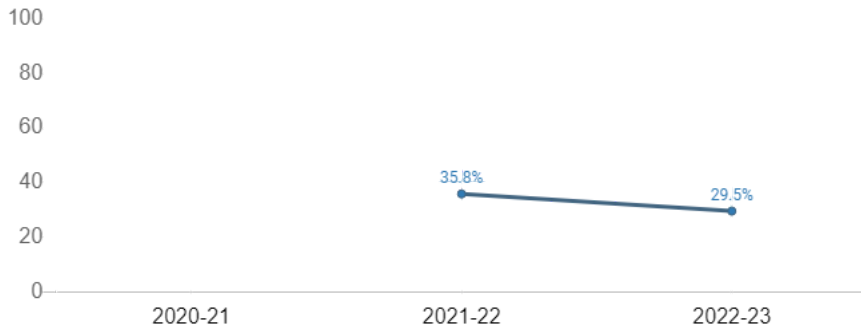

English Language Arts and Mathematics Performance Trends

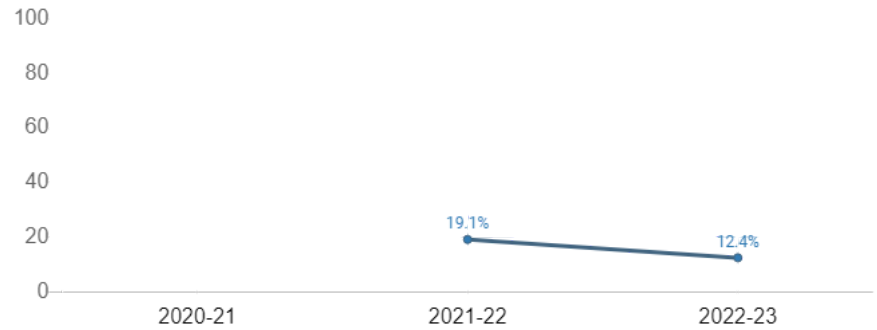
These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

English Language Arts Assessment - Participation and Performance

This table shows performance on statewide assessments for English language arts (ELA) both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include only students in grades 3 through 9. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM.

This table shows both the percentage of students who met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long-term goal of 80% proficiency by 2032. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long-term goal. 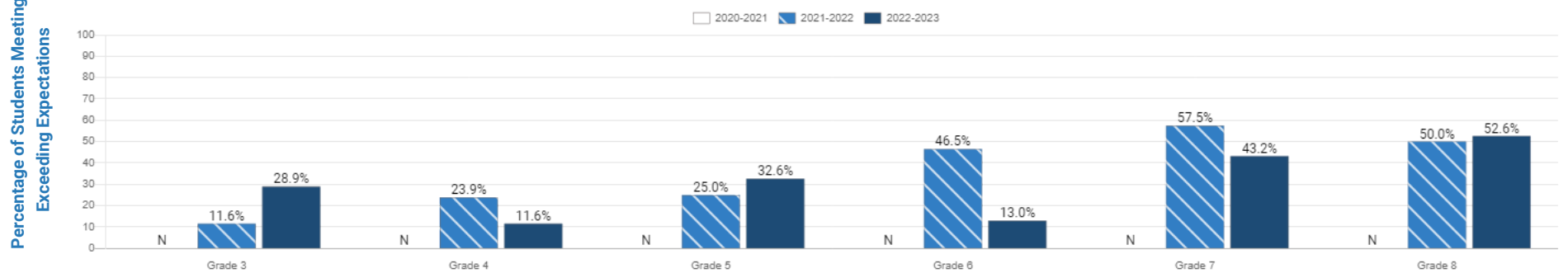

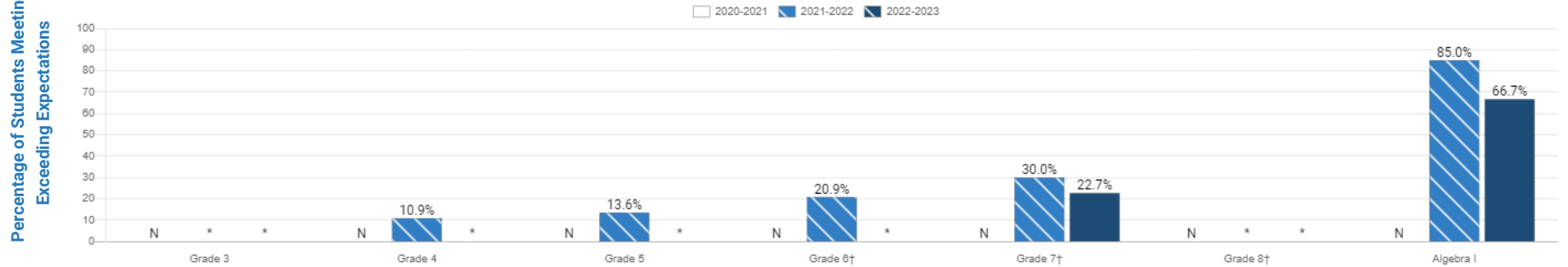

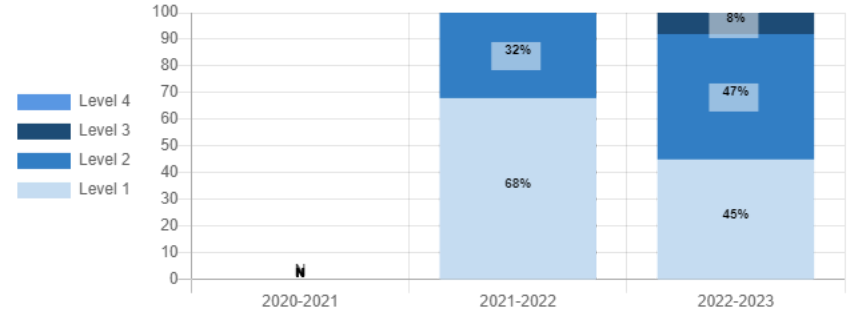

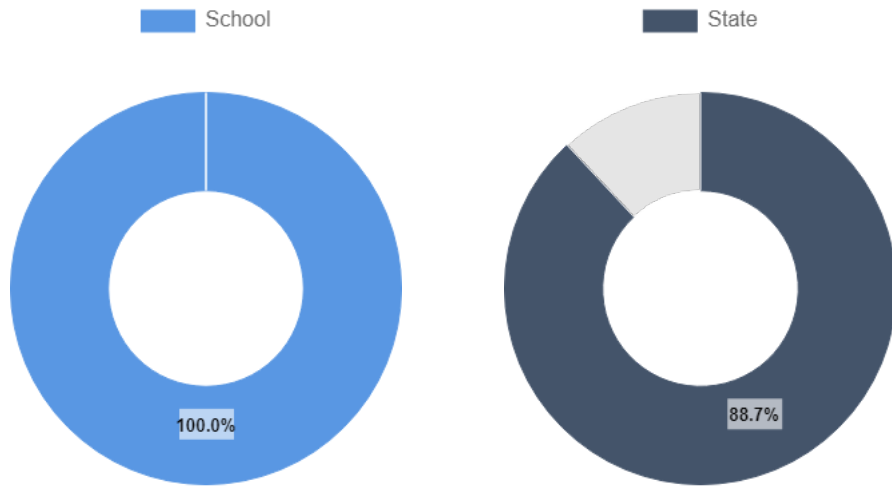

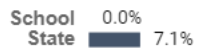

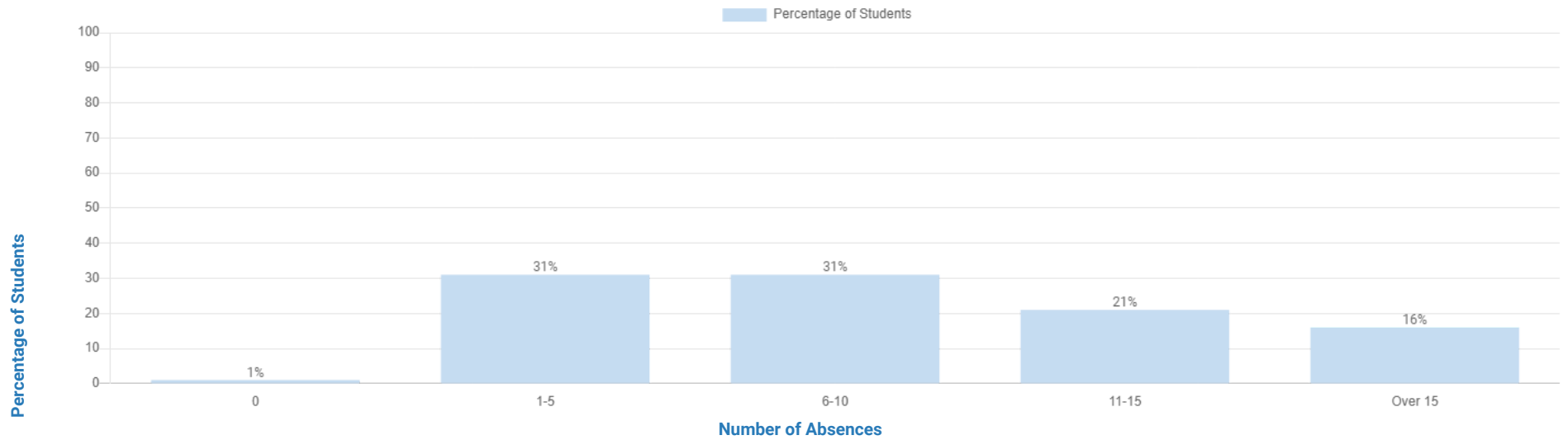

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.



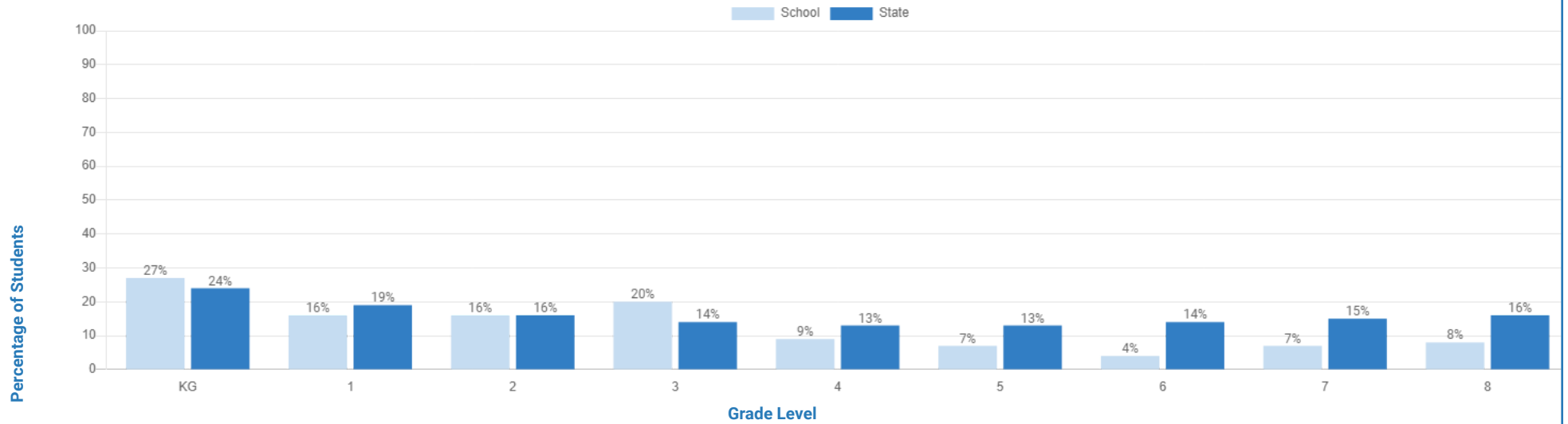

Staff and Professional Learning:

Teachers have daily planning time with their teaching teams. Teachers and administrators have two hours of whole school collaboration on Wednesdays for professional development, teacher-to-teacher workshops, data analysis, co-teaching planning, classroom preparations, curriculum development, book clubs, and more. We also have seven full days spread throughout the school year for professional development. Our teacher evaluation model includes peer observers.



Student Supports and Services:

We offer services for English Language Learners (ELL), students with disabilities, and students who need academic intervention, using an inclusion model. Teachers who provide these services primarily co-teach with general education teachers. Our program for ELL incorporates language acquisition methodology and quality instruction. Our Dual Language Program offers services, support, and rigor for language learners, both English and Spanish, in grades K-5. We have established I&RS and RTI programs.



Student Health and Wellness:

GBCS offers healthy breakfast and lunch during each school day. All students participate in Physical Education and Health at least three times a week. Students in kindergarten - fifth grade have thirty minutes of recess, daily. Middle School Students have ten minute recess breaks three times a day. We offer evening cooking and nutrition classes for students and parents. There are a multitude of ways in which GBCS supports the social and emotional health of students. Our school has positive discipline as the backbone of our philosophy. We build mind health and mindfulness within a Positive Discipline and Restorative Justice model through workshops for all staff and students with strategies to learn specific skills for mindfulness, wellness, and self-regulation. We have a daily mindfulness/meditation period and a Social Emotional Management room to support the relationship between mind-body-emotion behavior.

We have two cisterns that are used to water our gardens. We have an outdoor classroom theater, gazebo, sand box, playground, benches, and tables. Our members come to our schoolyard to take family photos by our flowers and picnic on the weekend. Our building is air-conditioned and includes a science lab, media/computer center, art studio, kiln room, music room, food pantry, spacious classrooms, and small group instruction spaces. Technology and STEM:

GBCS recognizes technology as a literacy expected in higher education and our economy. It is a universal language spoken by the entire world and something we integrate into the GBCS academic program. We use technology in balance with hands on and interactive activities that develop abilities to relate to each other, think critically, and concentrate. We have one-to-one Chromebooks in grades 2-8. We have one-to-one iPads for students in grades K-1 which are used for limited activities. Each classroom is equipped with a Promethean board. Each classroom teacher has a MacBook, an iPad, and a document camera. We have class sets of iPads in Art and Music classes, a Laser Cutter and a 3D Printer, classroom sets of Lego Robotics, and fifty MacBooks for student, staff, and family use in our Media Center. Our middle school math and science program uses Prisms, a spatial learning platform, to learn core math and science that actualizes pedagogies that we know work best.



Effective and Efficient Use of ESSR Funding:

GBCS has effectively and efficiently used the Elementary and Secondary School Emergency Relief (ESSER) funding in a multitude of ways. The school has: Provided Professional Development to address Equity and Access, Trauma Informed Care, Positive Discipline, and Social Emotional Character Development. We offered expanded summer and after school programs to all student groups to provide for continuity of services academically, socially, and emotionally. Additional programs were embedded within the school day. School counselors, Child Study Team members, administrators, and the school nurse meet regularly to support student needs and develop related action plans where applicable. Care Solace services are available to students, parents/guardians, staff members and their families. Care Solace links people to social, emotional, and behavioral health service providers.

Other Information:

Our Dual Language education program integrates native English speaking students with native Spanish speaking students for academic instruction, which is presented in both languages, in Kindergarten-Fifth Grade. Social and academic learning occurs in an environment that values the language and culture of all students and sets high standards to ultimately achieve academic success in Spanish and English. The language used for instruction is broken down by a 50/50 ratio. Fifty percent of classroom instruction is provided in English and fifty percent of classroom instruction is provided in Spanish. The goal is for all students to read, write, listen, and speak two languages equally well by the end of the program. The dual language model creates an additive bilingual environment, which allows students to acquire a second language while maintaining and developing their native language. Reading, language arts, math, science, and social studies, are taught in both Spanish and English. The diversity at GBCS provides an ideal platform for all students to have the opportunity to learn and develop a second language. Through the dual language program, students are exposed to a rigorous curriculum and given the opportunity to learn a second language. Dual Language Program Goals: One of our goals is "To prepare all students to become productive, responsible and contributing members of our changing global society by providing a nurturing environment that rigorously promotes the realization of individual potential." Students in the dual language program are presented with the social and cognitive benefits of bilingualism. They gain a second language, a broader vocabulary, and multiple views of the world (Cazabon, Lambert, & Heise-Baigorria, 2002).
