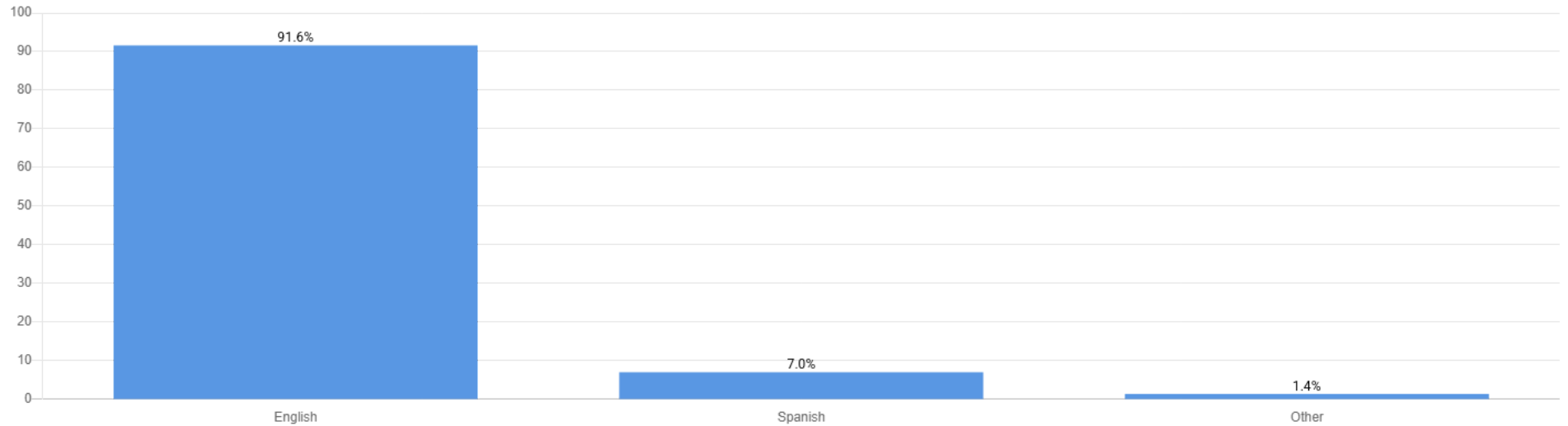

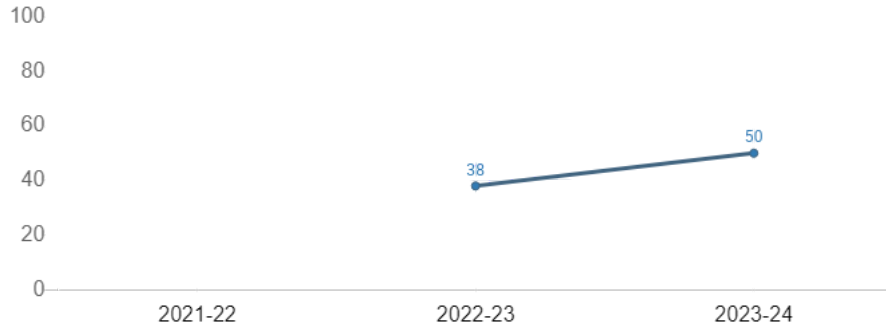

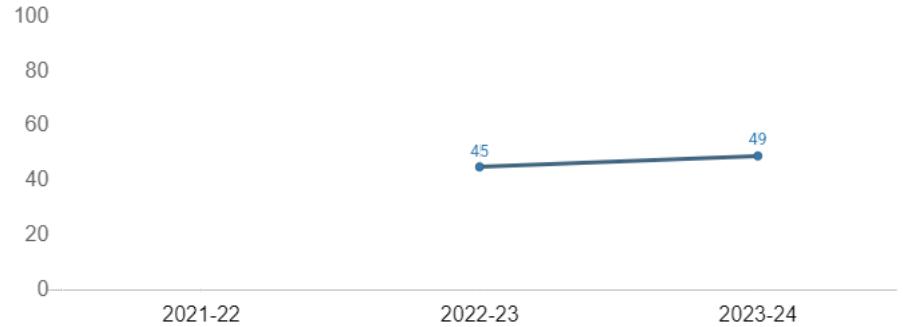

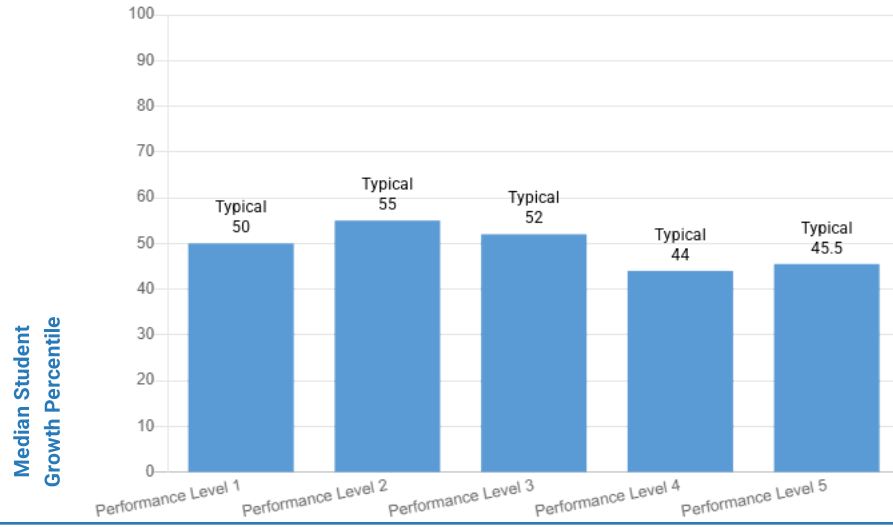

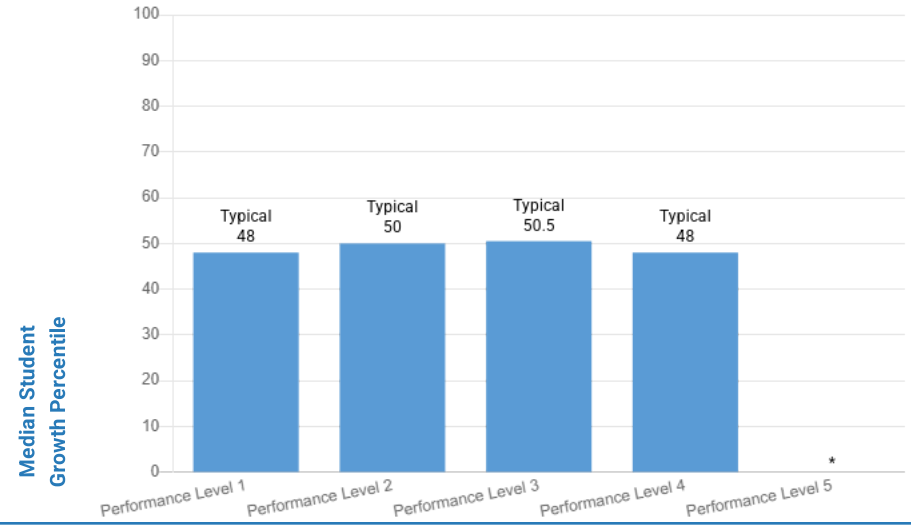

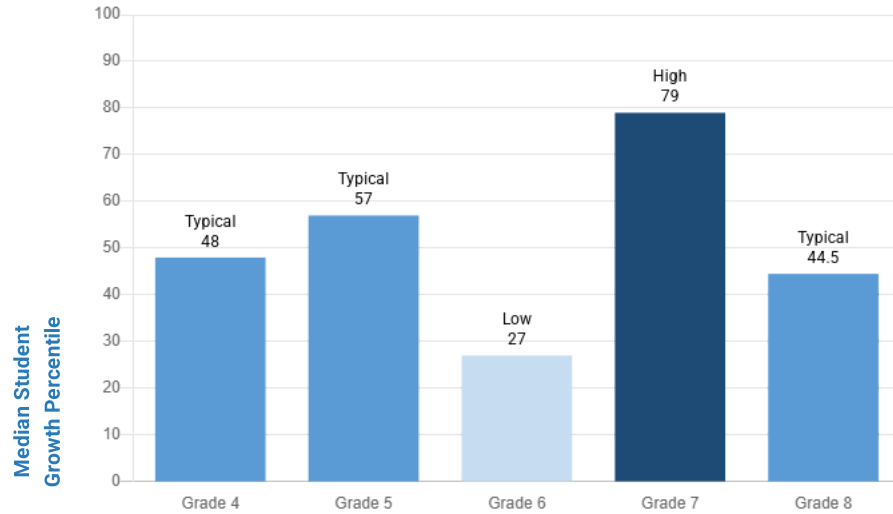

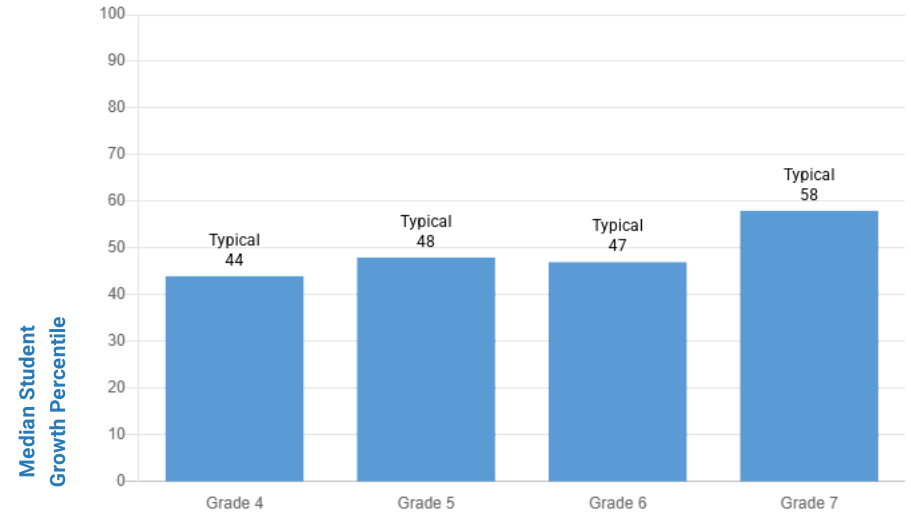

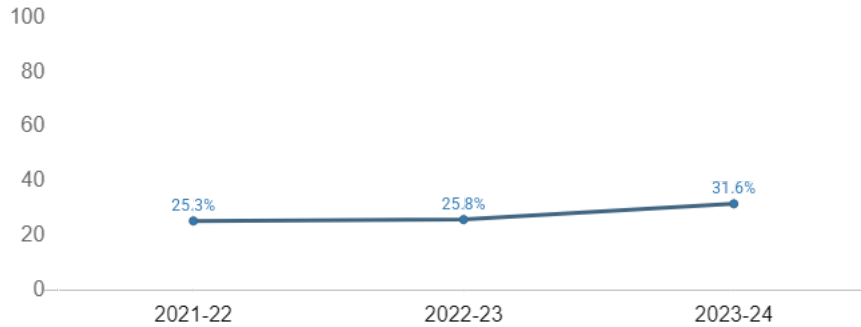

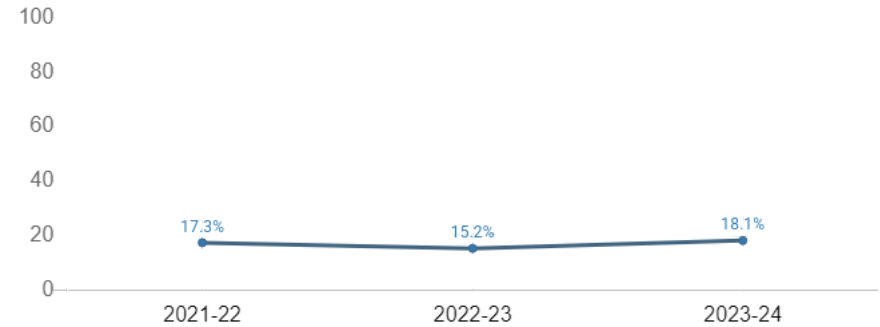
English Language Arts and Mathematics Performance Trends

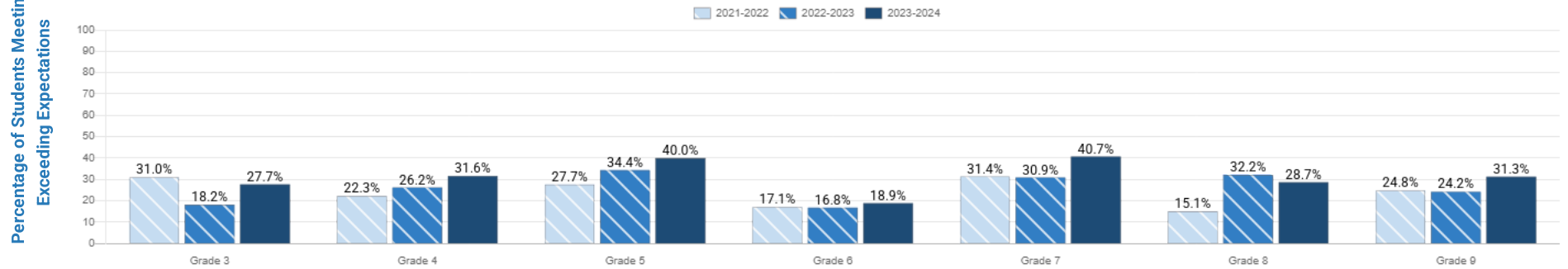

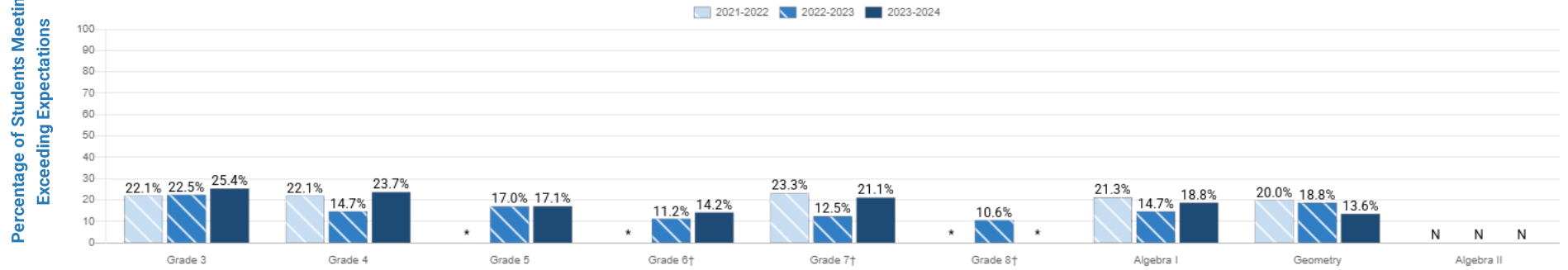

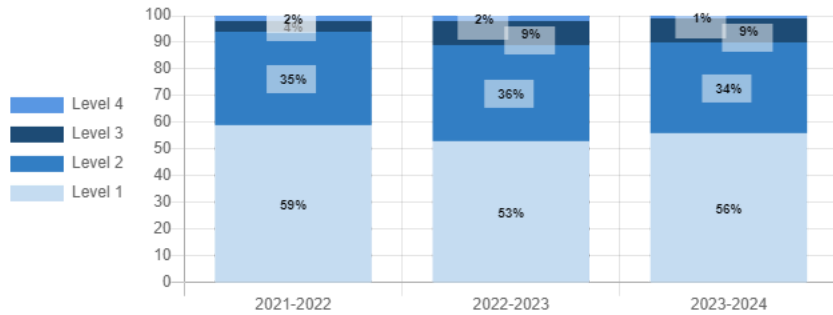

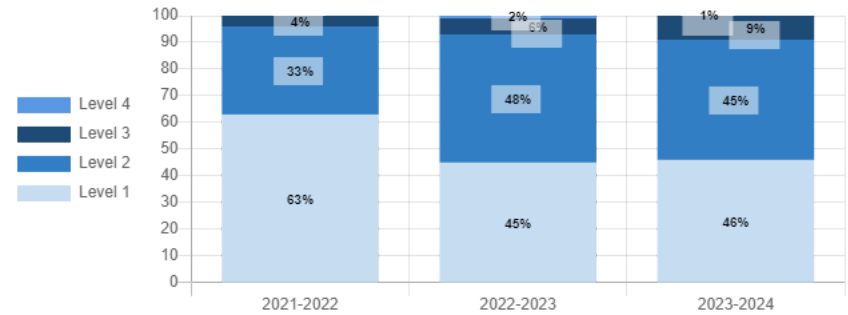
NJSLA Science Assessment: Grade 5 Summary

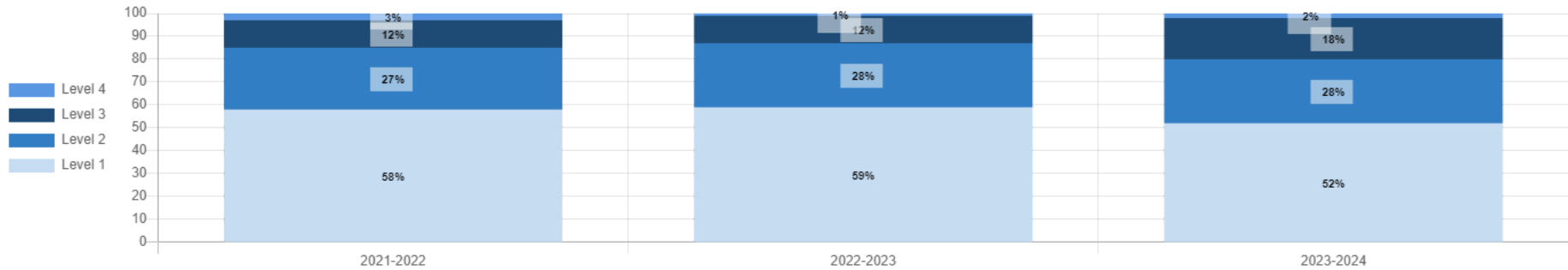

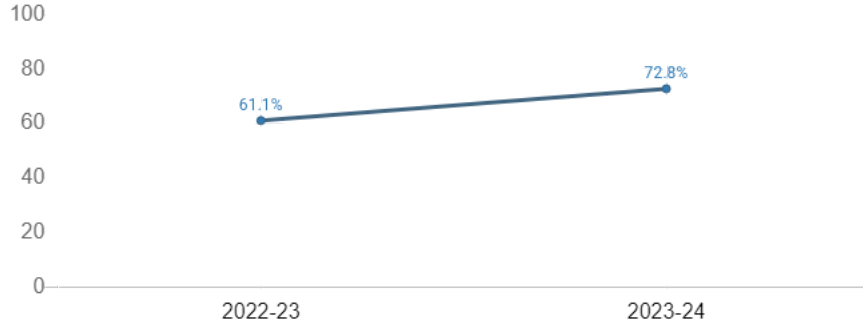

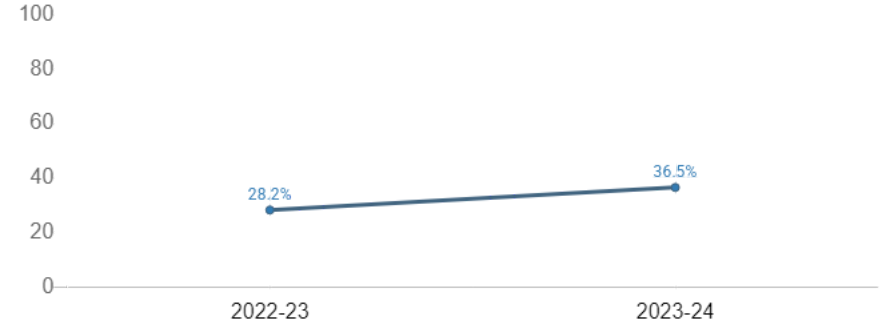

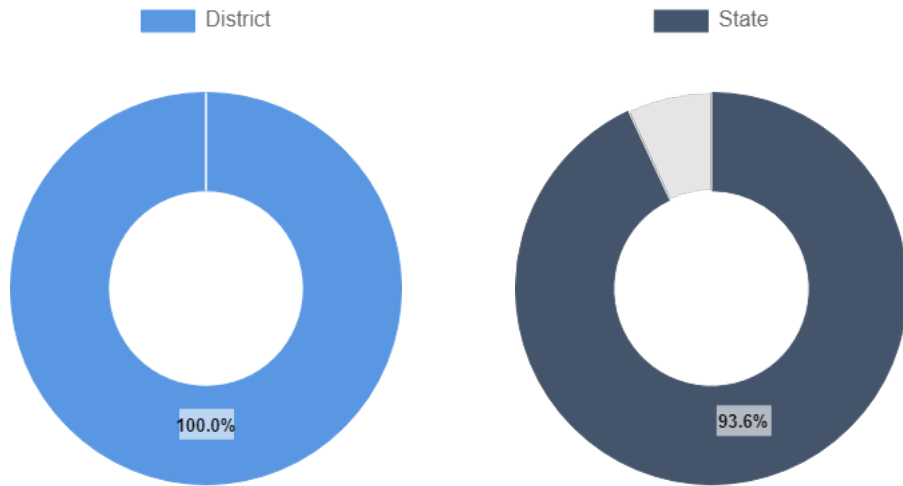

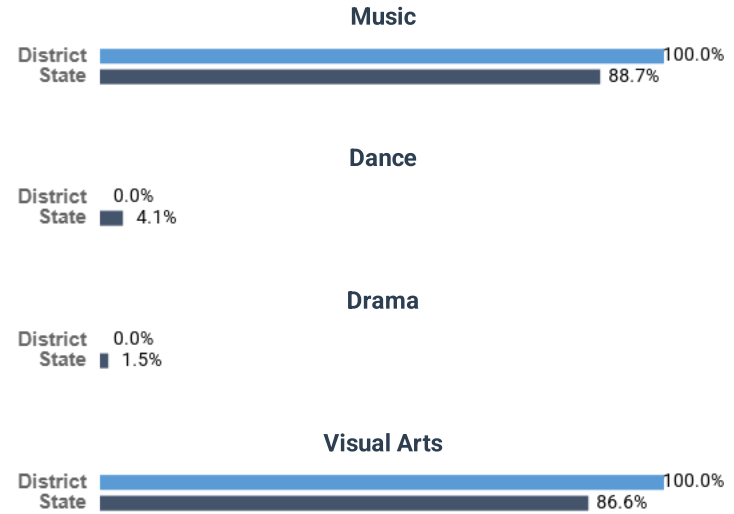

Students enrolled in one or more classes by discipline:



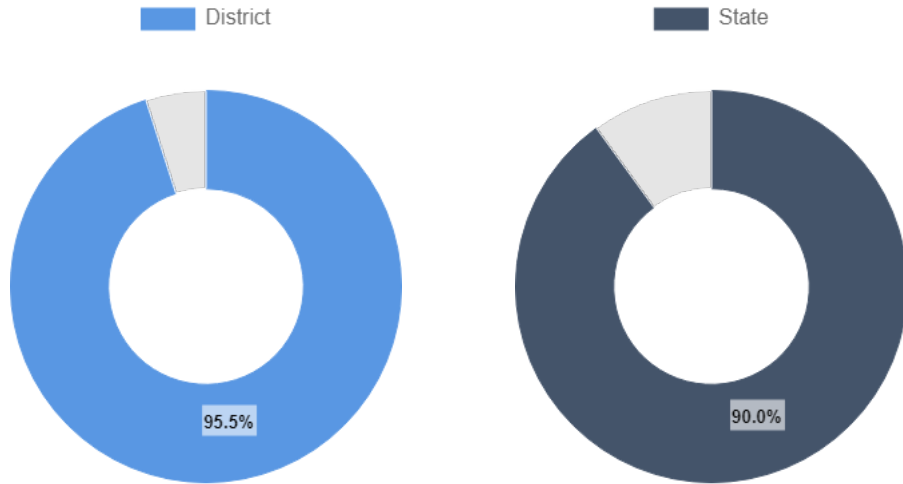

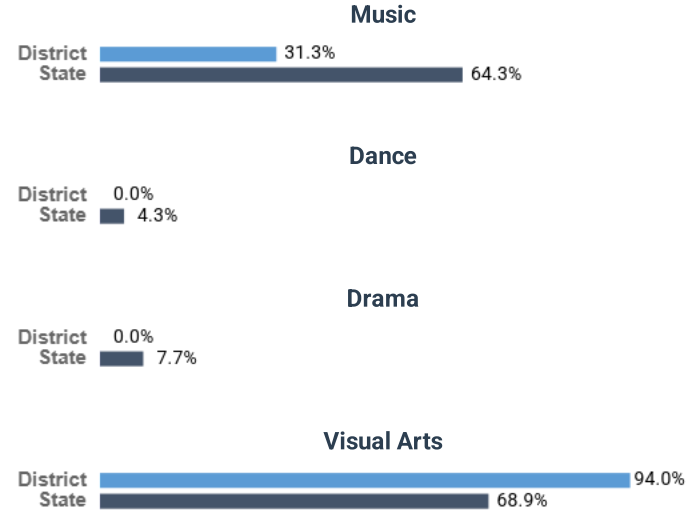

Students enrolled in one or more classes by discipline:



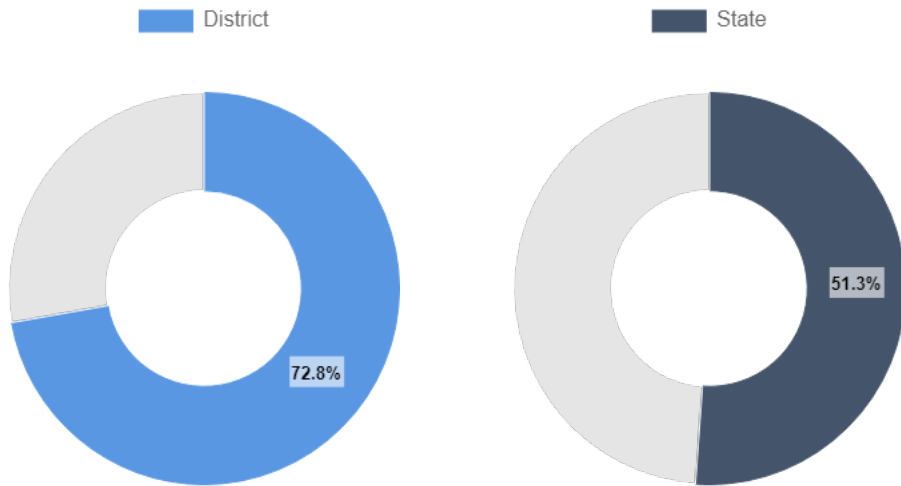

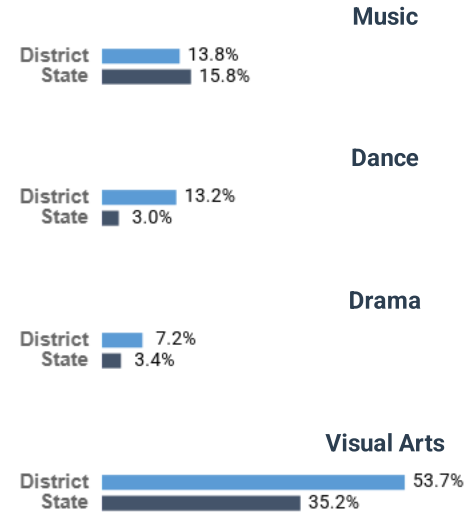

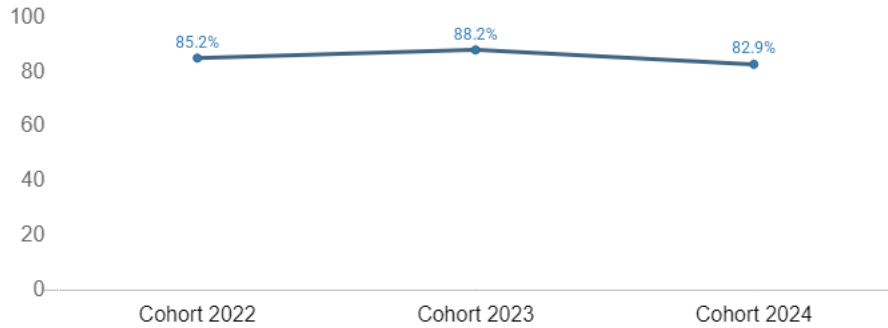

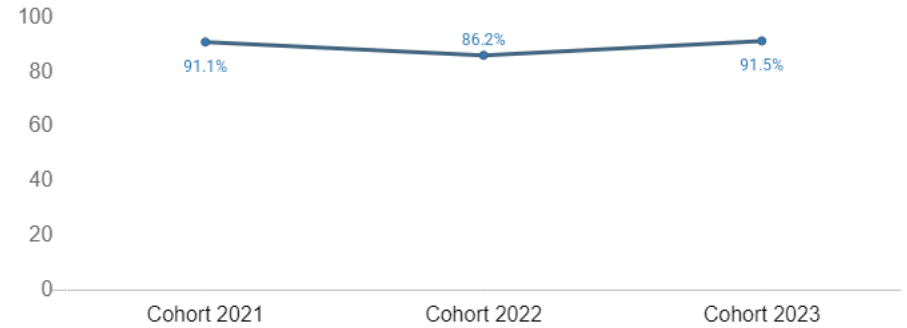

Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

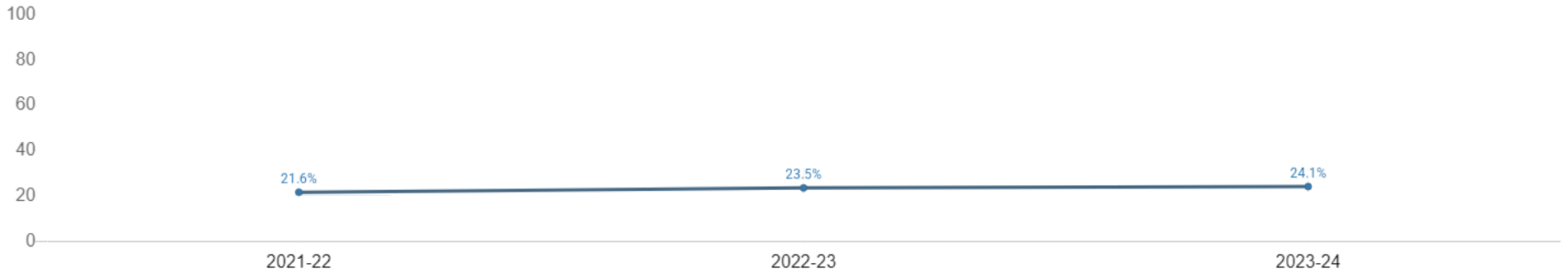

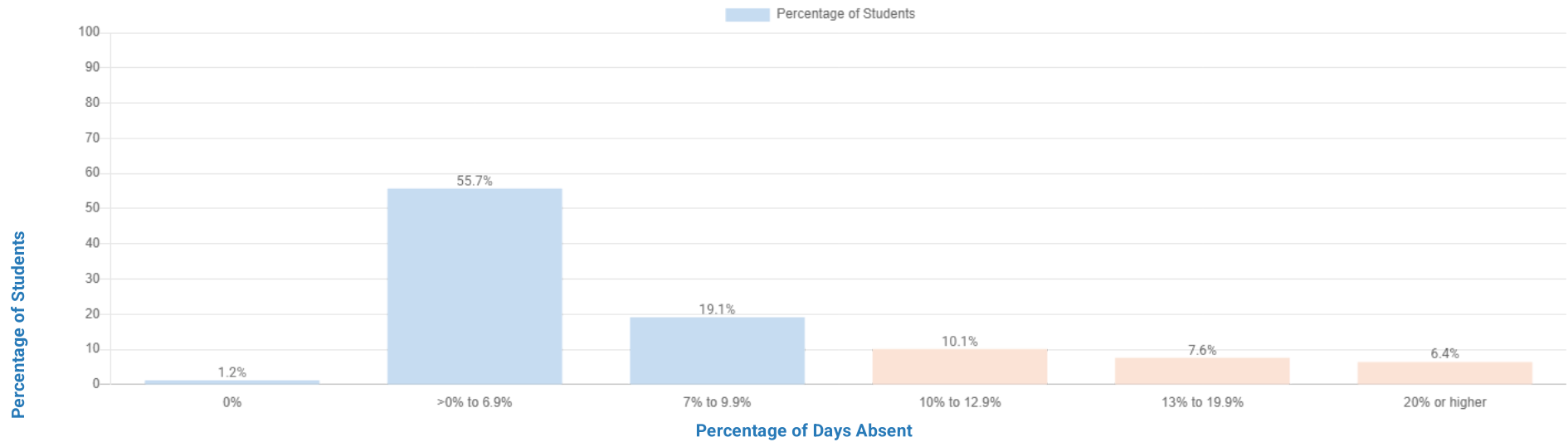

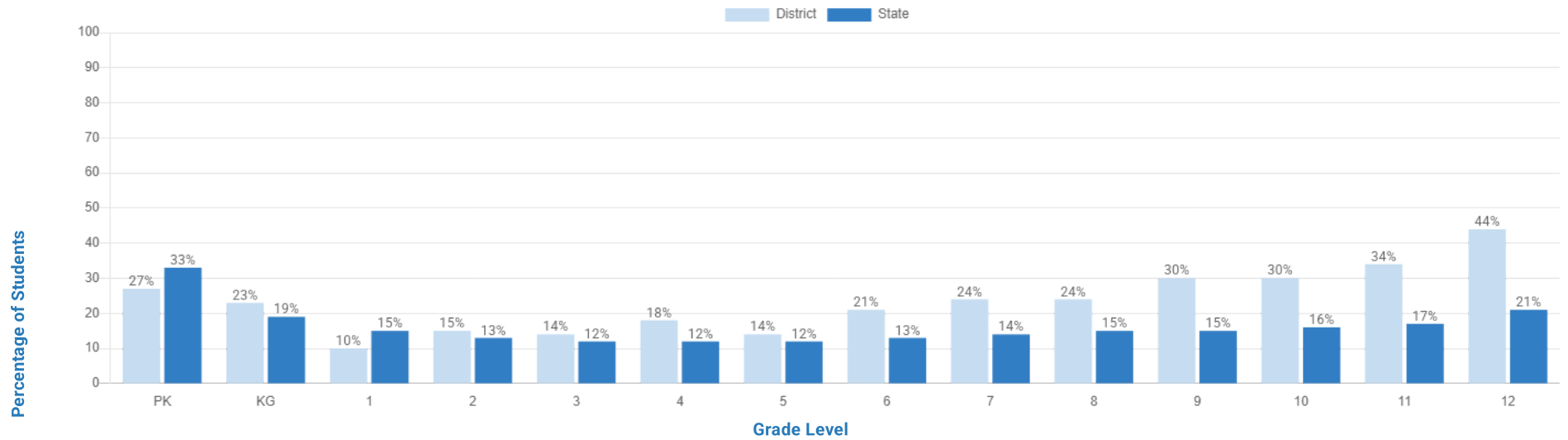

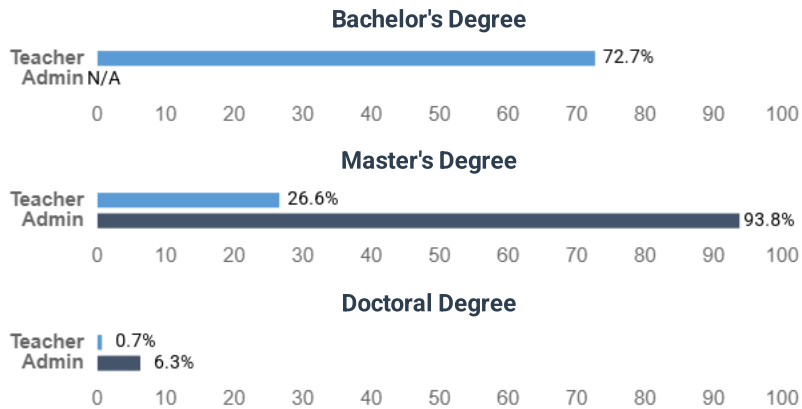

Before and After School Programs:

Our after school B.O.O.S.T (Buena Out of School Time) program serves students in grades 3-8. The program is funded through the 21st Century Community Learning Grant. It provides a learning center for youth that allows them to make responsible choices, be creative and express themselves in a positive, actively engaged atmosphere. Our focus is STEM with an emphasis on careers allowing students to connect academics with career choices. An on-site Before and After School Program for students in Grades Preschool to Grade 5 is operated by the Cumberland County YMCA. Parents have the opportunity to register throughout the year.



Staff and Professional Learning:

BRSD has an extensive Professional Development Plan based on multiple points of data including test scores, benchmarking, grading, staff/ family and student surveys. We have budgeted funds for high quality professional development for all staff members, as well as scheduled common planning time. We also have a contract with Stockton University for ETTC/SRI, which provides a wide variety of professional development courses for staff members to attend. Each year, staff members participate in Global Compliance Network Trainings (GCN).



Postsecondary Information:

Many of our students continue after graduation to complete college and university degrees. We provide opportunities for students to take SATs, PSATs on our campus. Our high school program also provides dual credit courses at a discounted fee so that our students have a "head start" on their college credits at high school graduation. BRSD students have access to a full time onsite nurse at each building. In the elementary schools, students participate in Health and Physical Education classes and receive instruction in the classroom as well as physical activities. The secondary school students participate in Health and Physical Education classes and have access to Youth/Teen centers that offer various programs for students in regards to mental and physical health, including exercise and nutrition. Throughout the district, we adopted the Thrively educational technology program to support social and emotional learning and well-being for our students and staff. This program incorporates strength, interest and habits of mind surveys, student check-ins, personalized feedback, and built-in lessons in a variety of areas to empower schools to improve student social, emotional, and academic well-being.

Facilities:

Beginning in the Summer of 2022, the Buena Regional School District initiated construction projects at several of its schools, including BRHS, Cleary, CLES and Milanesi. As we begin to finalize those projects, we will continue to review and adjust our long range facilities plan.

Early Childhood Education:

The Buena Regional School District offers a free six hour preschool program at two primary elementary schools, JC Milanese and Collings Lakes Elementary School that are funded through the PEA grant. This program is for students ages 3 and 4. The District has a total of 11 general education classrooms that service 15 students each and one self-contained classroom that services 8 students identified as preschool disabled. We are currently in our first year of partnering with Head Start which services 1 general education classroom.
