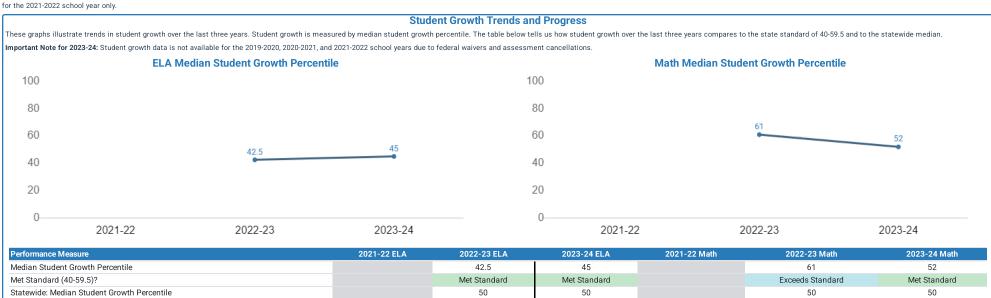

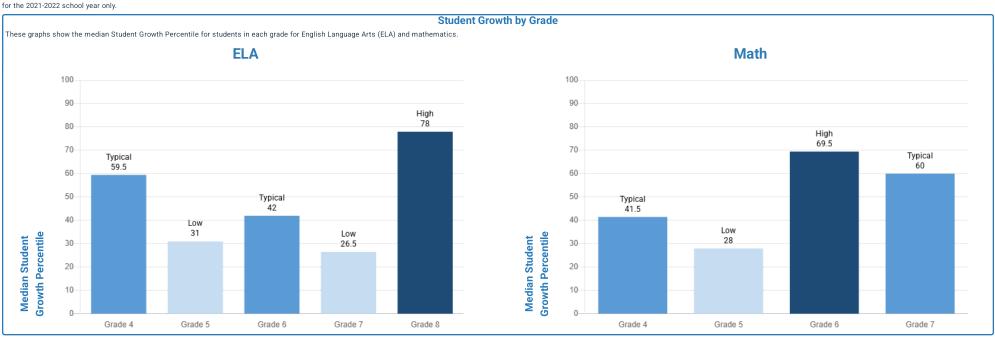

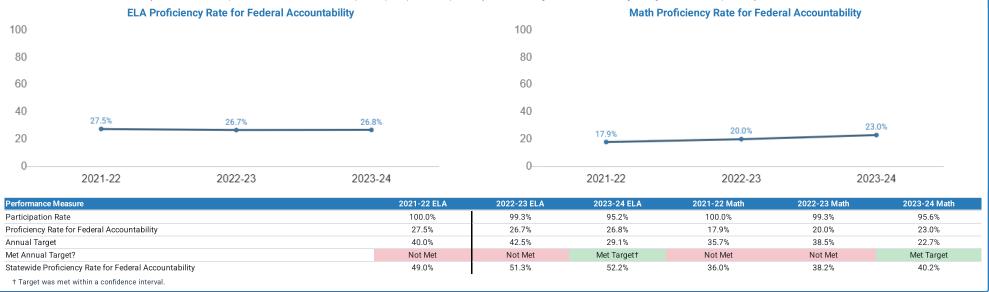

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, of if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers - Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. Additional data on the professional qualifications of teachers and administrators, broken down by schools with high or low economically disadvantaged populations, is available on the School Performance Staff Page.

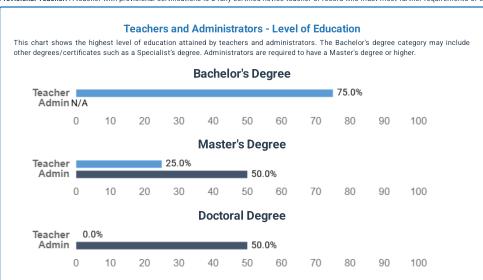

With a school population of approximately 60% of our children qualify for free and reduced lunch the school district is committed to Early Childhood Education. 5-hour/day Pre-K programs are offered at the Dawes Avenue Preschool Center. The school district also offers full-day Kindergarten. The Somers Point School District continually works to provide educational excellence. Our research-based programs, our highly qualified teaching staff our, commitment to staff development, and creative initiatives are many reasons why the school district is viewed as State of the Art. Somers Point is a community that takes great pride in educating its youth. Parental involvement in both schools is encouraged and enhanced by the PTO and the Foundation for Education which has donated over \$500,000 throughout their existence. While this community continues to change demographically, its long-term commitment to its youth is still prevalent. With the cooperation of our Somers Point residents, the district continues to move forward on preserving the past and preparing for the future.
