











### English Language Arts and Mathematics Performance Trends






### NJSLA Science Assessment: Grade 5 Summary











## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.










### Teachers and Administrators - Level of Education

## Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
  - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
  - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

We are committed to developing and sustaining a partnership with all stakeholders that provides a quality education in both formal and informal settings for all students. Our purpose is to ensure that individuals become life-long learners and have the opportunity to maximize their potential to become productive and responsible members of society.



### Awards, Recognition, Accomplishments:

Dumont served as the consulting District for the New Jersey Tiered System of Support for the Early Reading (NJTSS-ER) project grant. The multi-year project is sponsored by the NJDOE Division of Learning Supports and Specialized Services with the purpose of implementing NJTSS-ER via strategic personnel development. Its goals include: increased state, district, and school-level leadership, high-quality professional development in NJTSS-ER, increased fidelity of NJTSS-ER implementation, and improved reading skills for students with disabilities and/or those requiring intervention. The District was also recently awarded the Developing Resiliency with Engaging Approaches to Maximize Success (DREAMS) Grant with the NJDOE / NJDCF. The DREAMS Program provides trauma-informed and healing-centered supports to schools.



### Courses, Curriculum, Instruction:

As a district we continue to seek the best instructional opportunities for our students while revising and updating our curriculum offerings to meet the needs of children. Technology is not only transforming the way our children learn, but also how we, as educators, deliver the curriculum. The district is continuing its implementation of curriculum aligned with the current New Jersey Student Learning Standards.

### Before and After School Programs:

The Dumont Public Schools offer several different before/after school programs for the community's students. Through partnership with the YWCA, each elementary school houses a fee-based childcare program to assist families with drop off and pick up conflicts. Additionally, the district offers free learning acceleration programs to select students in ELA and Math to support learning and to close achievement gaps for students.



### Facilities:

As part of a long-range facilities plan, the district is continuing a district-wide ventilation/HVAC system improvement project that is expected to be completed by the 2025-2026 school year. The district is also engaging in an Energy Savings Program that utilizes a building management system to manage heating and cooling costs and other cost-saving building improvements that include the addition of solar energy.



### School Safety:

Our district provides secure facilities which include: faculty swipe keypads, IDs for all faculty and staff, a Visitor Management Sign-In system, emergency phones in every classroom, and security cameras strategically placed around the district. In addition, we continue to perform monthly fire and other safety drills, have daily police walk throughs in each of our buildings, meet with our school security and crisis teams to review any immediate concerns, hired a School Security Specialist, and have updated our crisis clipboard provided to all faculty and staff members. In addition, we added camera equipment around the district Drop Boxes installed at each of our elementary schools have minimized the number of visitors for routine deliveries and parent communications.

This year we will be implementing a number of initiatives to better serve students and that are designed to enhance opportunities for our students, such as implementing a Computer Science special for Grade 5 students; expanding the Sonday Essentials Reading program to Grade 3; implementing new Middle School Science materials and training for staff; expanding our Structured Learning Experience (SLE) program at the high school, which supports student internships and work-study opportunities; updating and enhancing our STEM courses in the Middle School. In addition, we will be continuing our partnership with West Bergen Mental Health Clinic that will provide additional supportive counseling services for our students and families.
