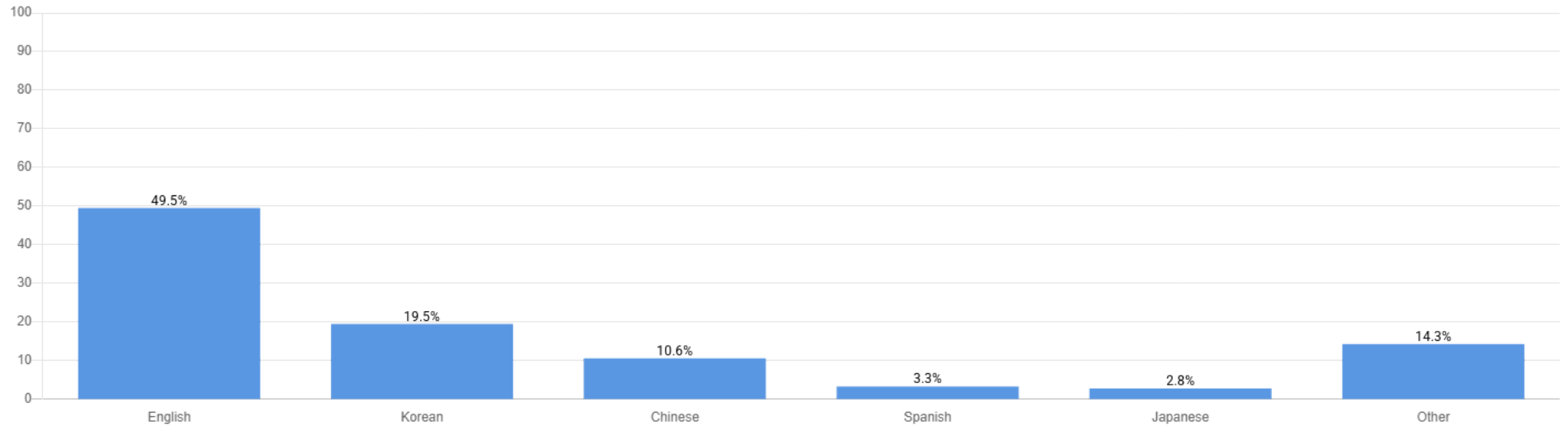

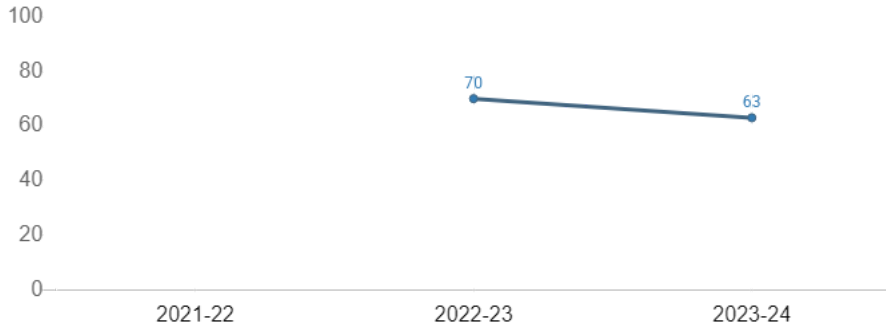

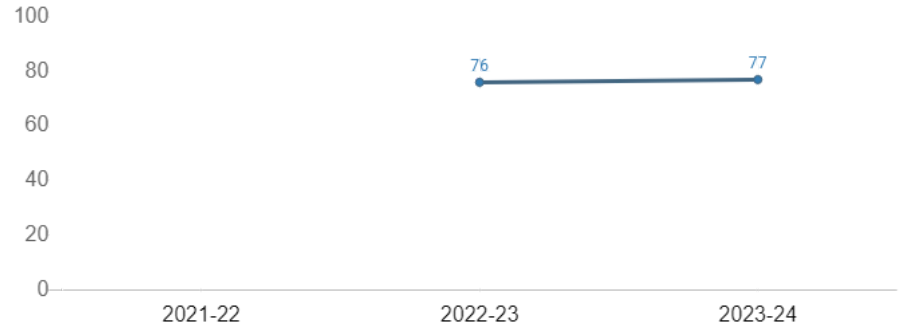

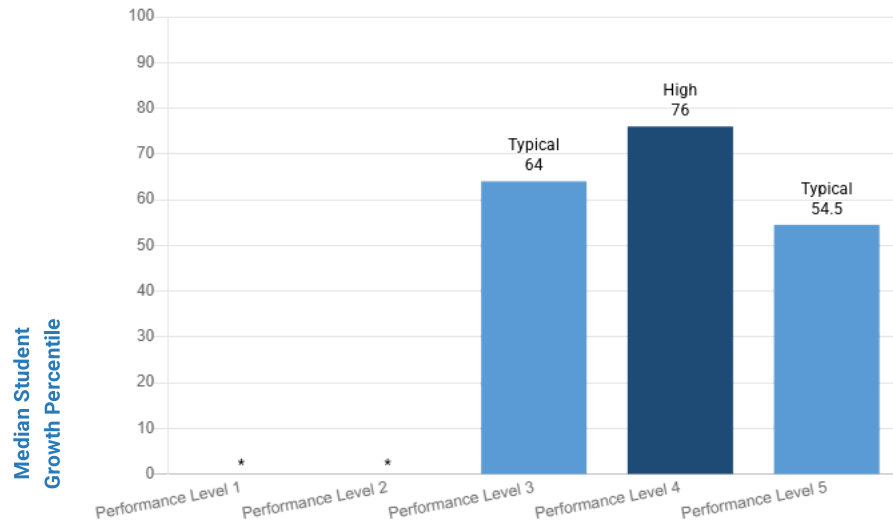

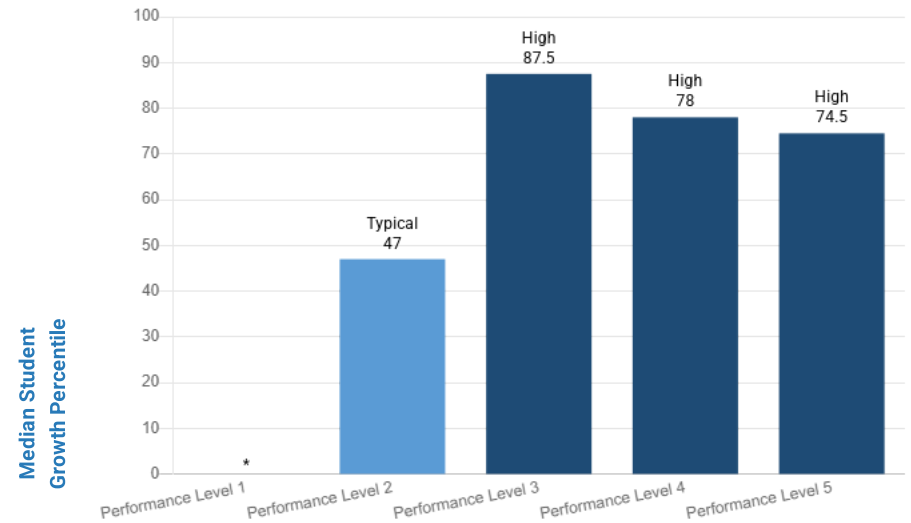

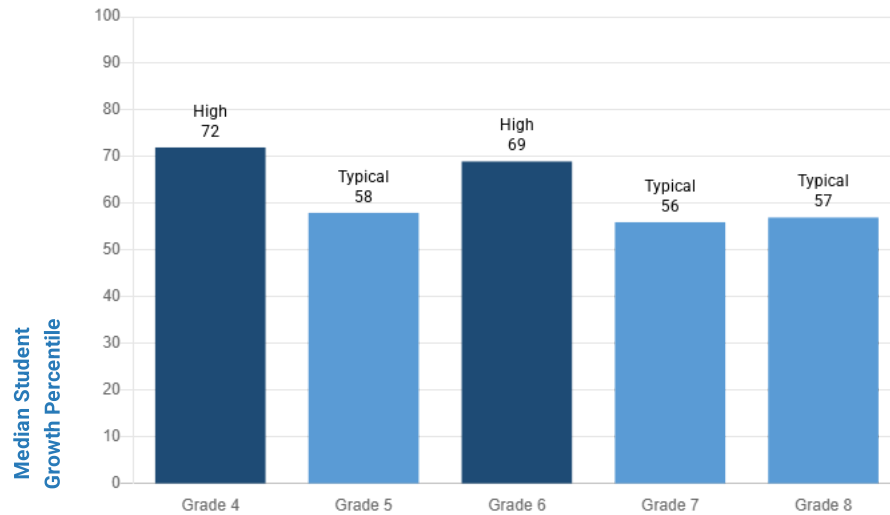

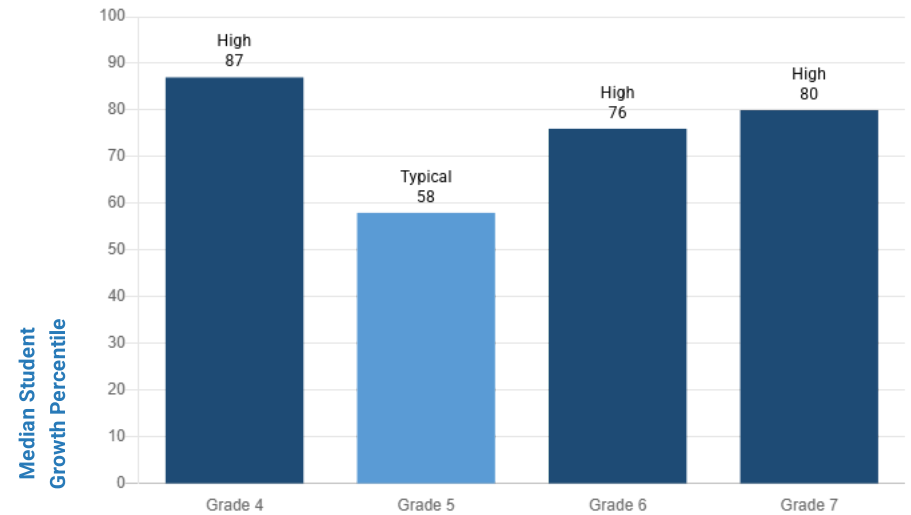

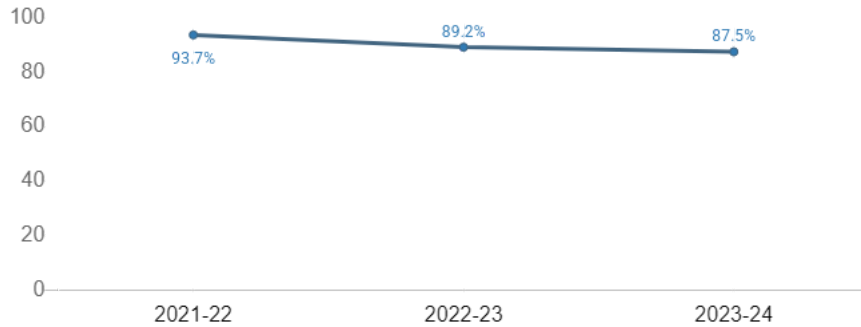

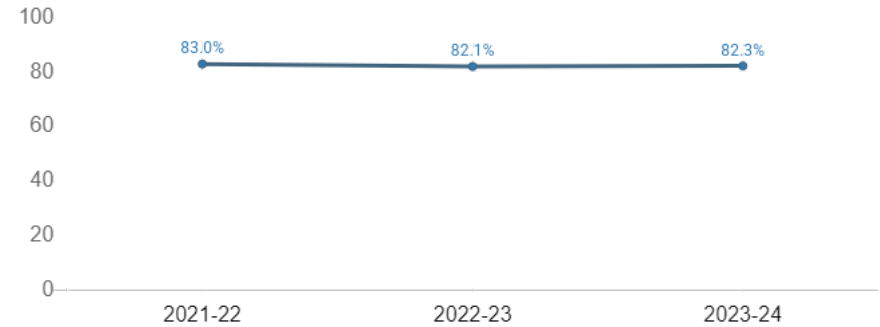
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 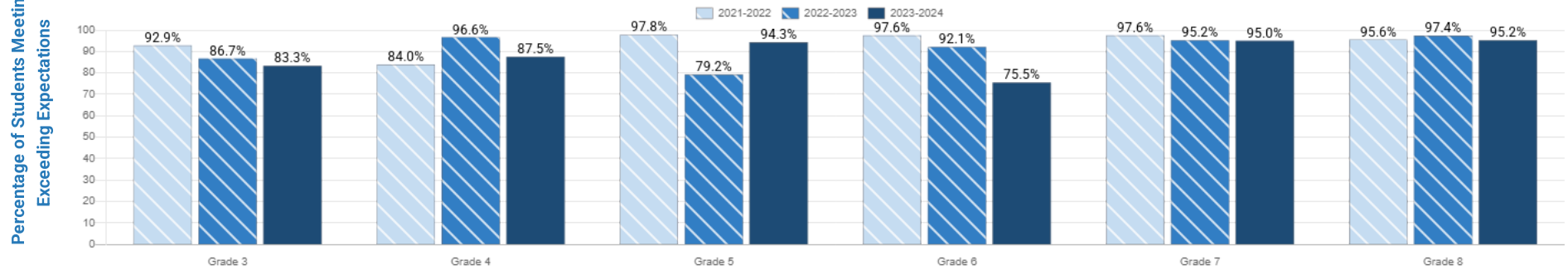

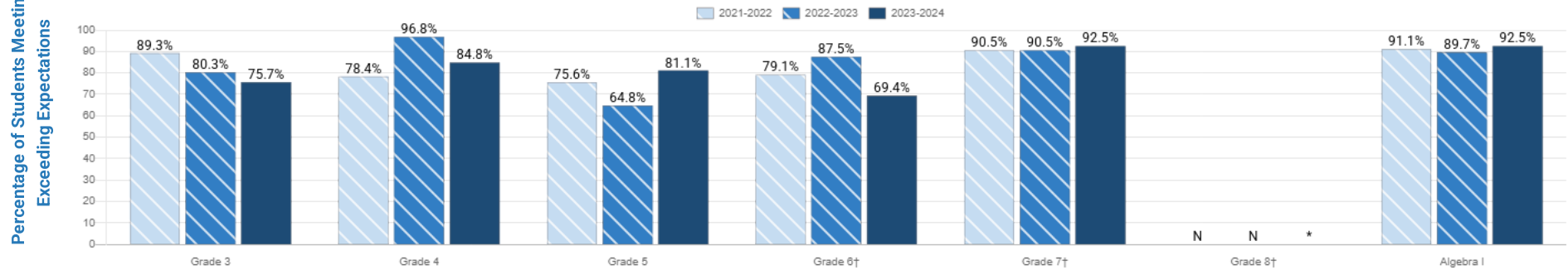

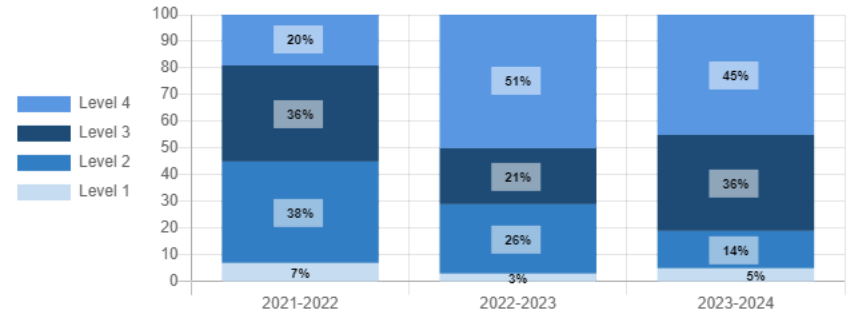

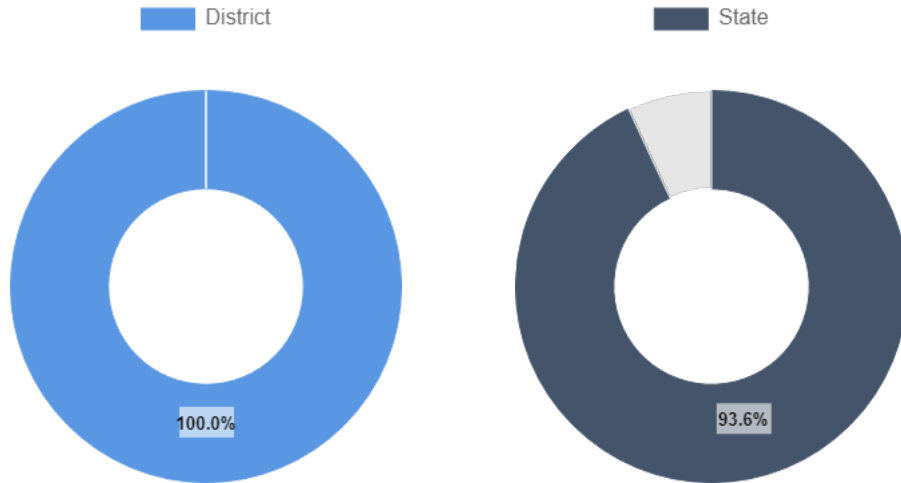

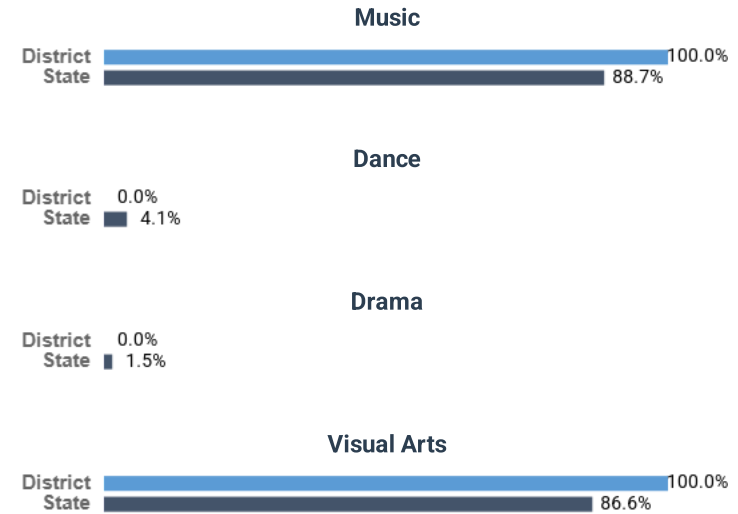

Students enrolled in one or more classes by discipline:



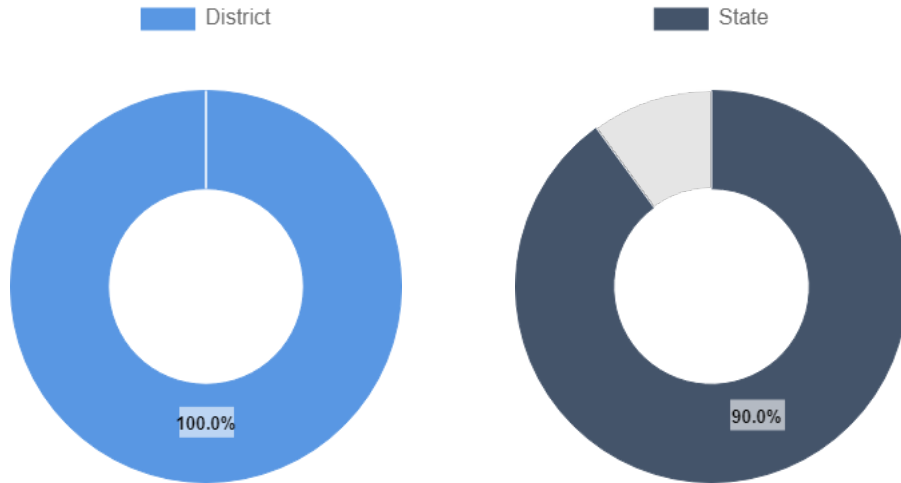

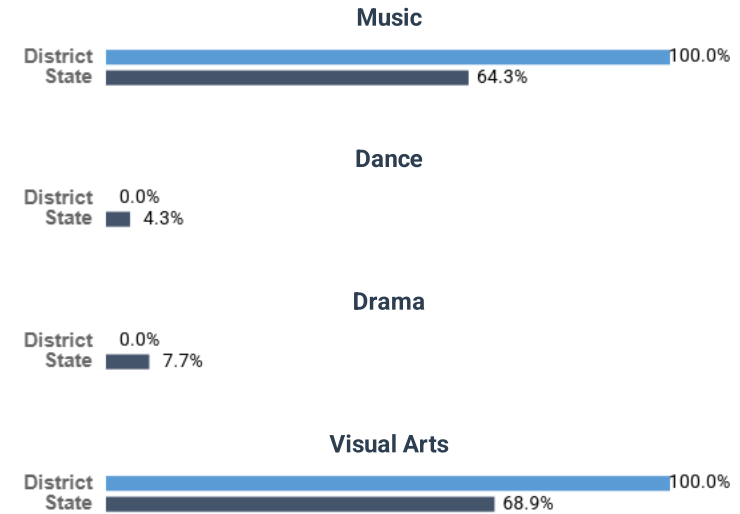

Students enrolled in one or more classes by discipline:

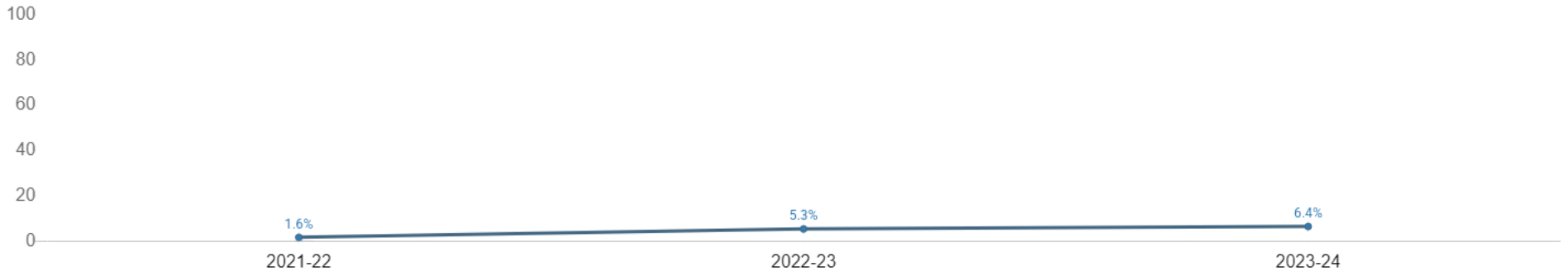

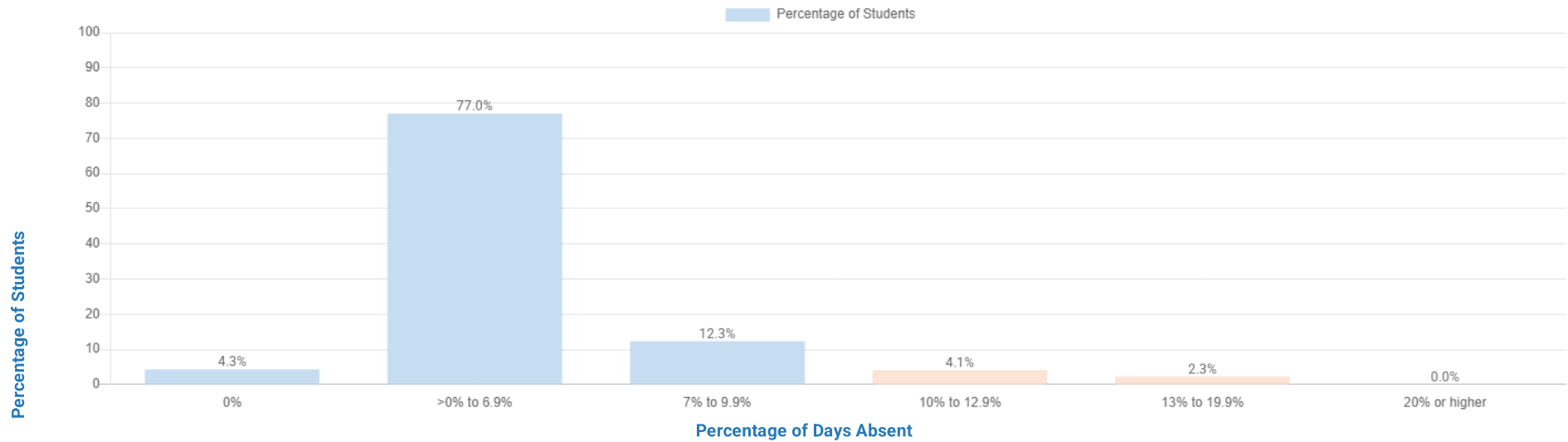

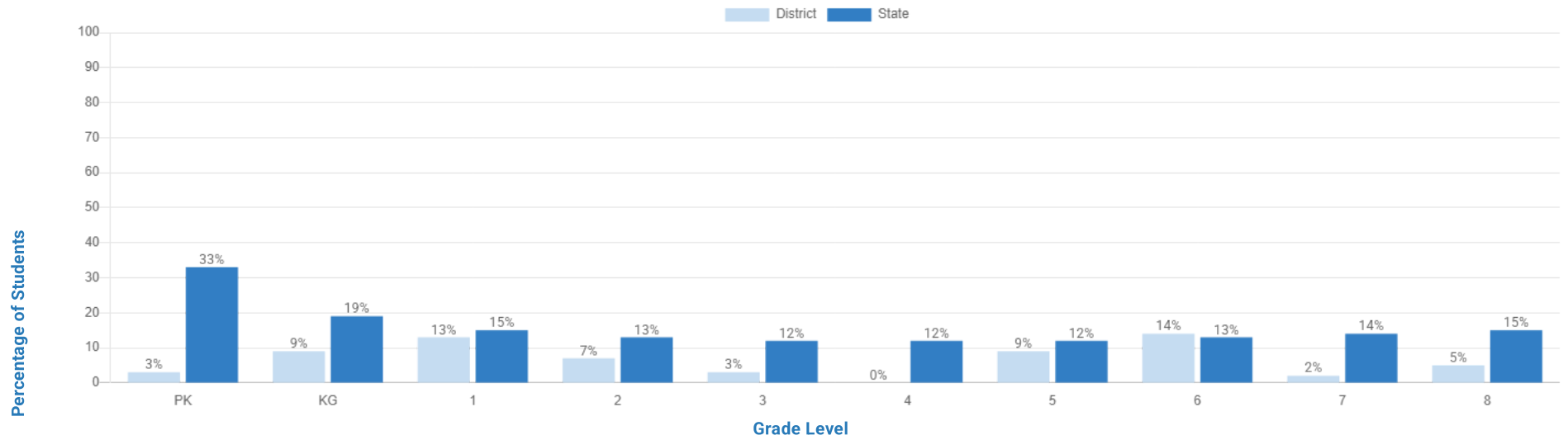

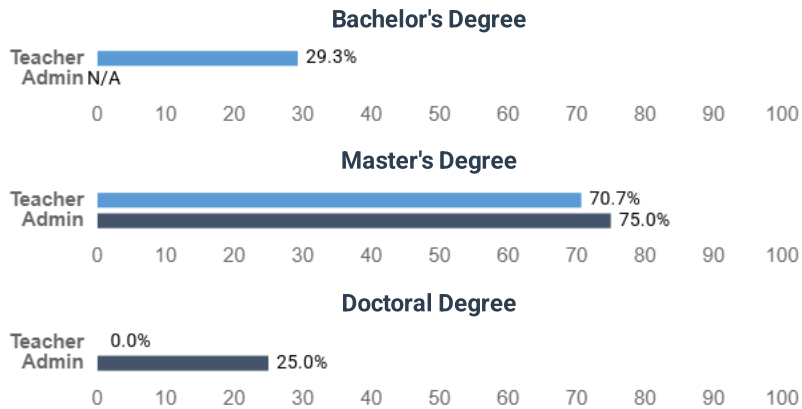

The educational community will create a safe, nurturing environment that honors the cultural diversity of our students and society. Students will develop character and moral values that help them become productive citizens. The educational family will develop responsible citizens that respect and take pride in our national heritage. Vision Statement: Working collaboratively, we will unite all stakeholders in the creation of a safe and nurturing educational environment that will foster academic achievement and stimulate a love of learning. Our district will encourage self and social awareness, promote character development and honor diversity to prepare students to contribute responsibly to the advancement of our democratic society.



Awards, Recognition, Accomplishments:

The graduating students of Englewood Cliffs are recognized for excellence in English, math, social studies, science, and Spanish. Graduating students are also recognized for good character and participation in the musical, band, and chorus. Moreover, students receive the Presidential Award for achieving at a high academic level. Additionally, Upper School was recognized as a 2022 National Blue Ribbon School for Exemplary High Performance, one of only 9 schools in New Jersey to receive this distinction. According to the most recent rankings by US News, Upper School was ranked #12 (middle school) on the list of New Jersey's best schools.

Courses, Curriculum, Instruction:

Englewood Cliffs offers a range of programs, including UFLI and the ELA workshop model, GoMath! with math workshop, and Knowing Science. These resources provide digital access and support differentiated learning. The district integrates design thinking into "Educate to Innovate" (library media) and technology courses, emphasizing career readiness and financial literacy standards. A Standards-Based Report Card in grades K-4 aligns with curriculum and pedagogy, while grading in grades 5-8 focuses on mastery of target skills.



Clubs and Activities:

The district offers many opportunities to participate in various clubs and activities. Students in grades 6-8 participate in "Educate to Innovate," which includes student leadership activities, community service opportunities, and skill building through competitions. Students in grade 5 participated in a Social Skills course that explicitly taught key social-emotional competencies to all learners. A large percentage of the school participates in band, glee, and school musicals. Students are also given opportunities to participate in various competitions including the Math Counts competition (grades 6-8), Scripps Spelling Bee (Grades 3-8), a speech competition (Grade 8), a science fair (grades 5-8), and GATE (Gifted and Talented). GATE students participate in the Future City competition and the Invengineering Expo. Every year, we are proud to have many of our students accepted in to Bergen County Choir and Band.



Before and After School Programs:

The district provides after school programs that support both academics and social emotional learning. Examples include Homework Club, Chess Club, and Arts and Crafts.

Staff and Professional Learning:

We use Google Forms to identify ongoing professional learning goals. Professional development focuses on digital resources, supporting MLs, and enhancing instructional efficiency and transparency. Teachers collaborate with ELA and Math consultants to address content, pedagogy, and student needs.



Parent and Community Involvement:

The district has a very active PTA and Education Foundation. These organizations supplement the curriculum with programs, materials, training, and technology. Additionally, the district has a Special Education Parent Advocacy Group that works with the district to help students with special needs. All parents have access to the Parent Portal through Genesis, and staff often utilize Google Classroom to communicate directly with students and families. The district works closely with the police, fire department, and the mayor's office to implement the safest environment possible. Additionally, three events were held with the specific goal of engaging families in their students' academic experience: EC Open House, Literacy Night, and Reading Under the Stars. The school eagerly looks for opportunities to welcome all educational stakeholders into the schools in order to best support our learners through ongoing collaborative efforts.

Facilities:

Renovations include new student restrooms at Upper School for Grades 3-8. The new restrooms have entry/exit doors, which operate on a touchless system to ensure enhanced safety and cleanliness. We have also renovated the 2 science labs at Upper School, the technology room at North Cliff School, as well as the basement storage area. The district has 2 technology classrooms, 2 science labs, 2 art rooms, 2 libraries, 3 gymnasiums, and 3 all purpose rooms.



Technology and STEM:

Technology is incorporated into all curriculum content areas as an interdisciplinary connection and is also offered as a stand-alone course for the entire district. Targeted professional development continued with the goal of unpacking Design Thinking standards expanding the district's "Educate to Innovate" initiative. The district is also fully one to one with every student being afforded their own iPad or Chromebook, and each classroom has a Smart Board or Promethian Board equipped.



Attendance:

The district closely monitors attendance for all students. Any students who exceed 5 absences receive letters from the district as well as contact from a district employee. This process also occurs when reaching 10 and 15 absences, and specific interventions are put in place for students who show this is a consistent concern.
