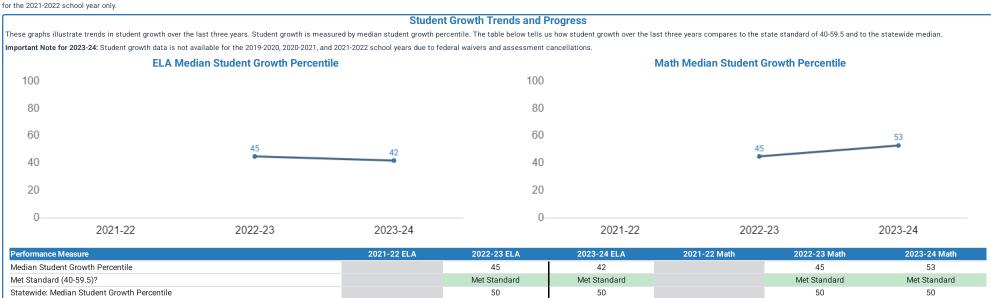

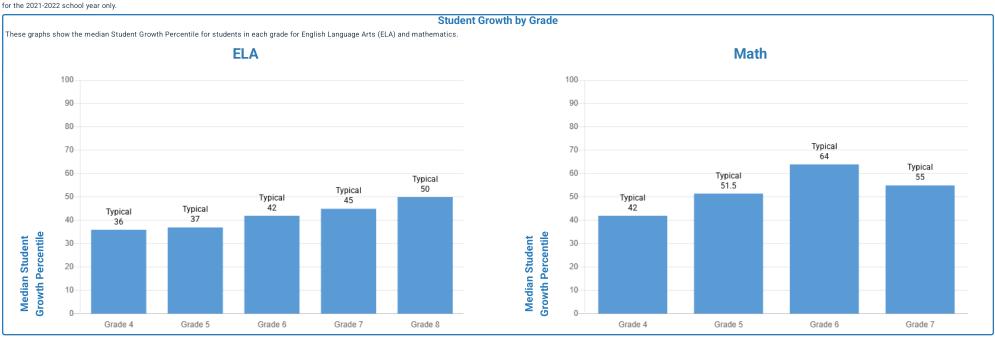

Staff

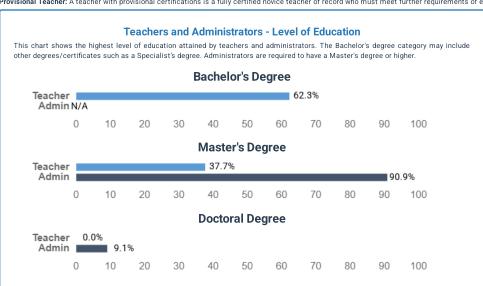
