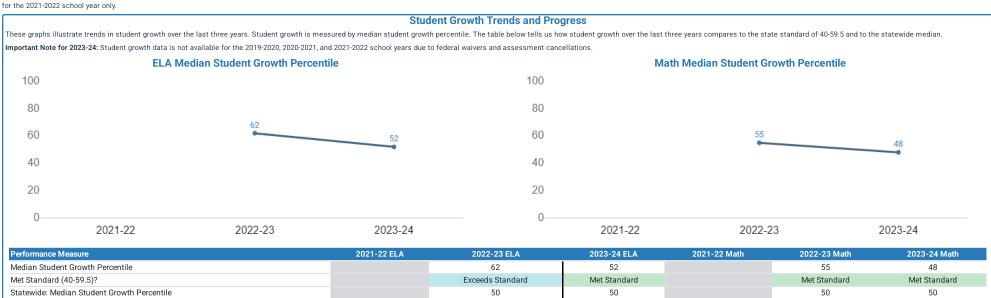

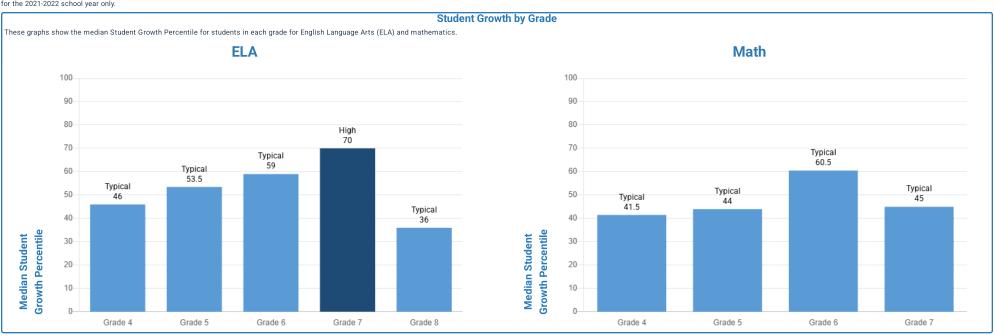

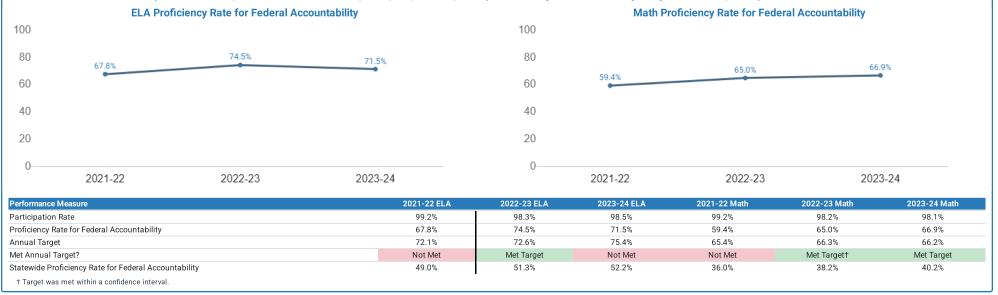

Bright Horizons is an integrated preschool program located at High Mountain Road School providing a unique opportunity for both general and special needs students to receive an education in a half or full day inclusive setting. Each classroom is taught by both a general and special educator in collaboration through a co-teaching model. This team teaching approach provides the opportunity for preschool students who experience early developmental delays to be educated with their non-disabled peers. Additionally, related service providers support students in the classroom setting determined by the IEP Team.



The District utilized ESSER funds to implement a variety of initiatives: 1) School-based instructional coaches to coordinate with principals/ educators and provide job-embedded professional learning in response to emergent student needs (academic, behavioral, social emotional, health, etc.); 2) Provide supplemental student programming including a Summer Learning Academy and Morning Academic Support to support learning acceleration; 3) Provide Mental Health Counselors for students in need of more intensive mental health services. The implementation of each of these initiatives has served to create a comprehensive system to support students and faculty with great success.
