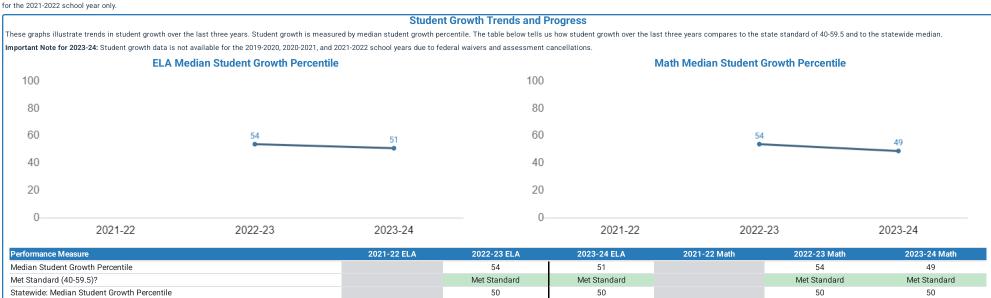

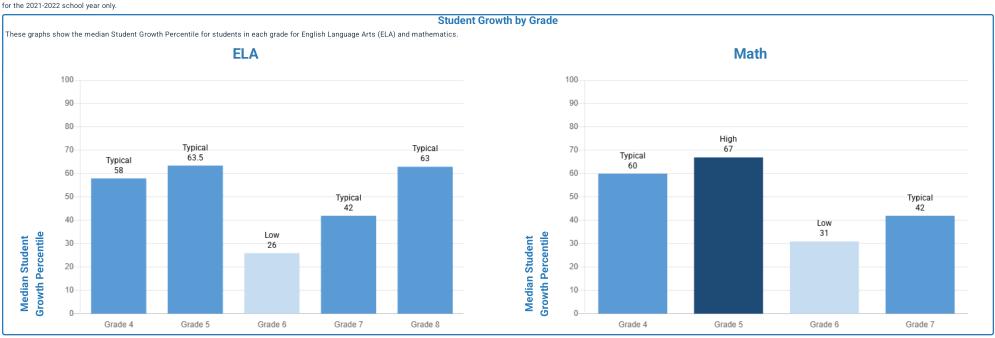

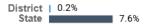

# Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

Initiatives include nationally recognized STEEM (Science, Technology, Engineering, Entrepreneurship & Mathematics) program, & Standards-Based Report Cards.

Sports, clubs and activities are offered to students across grade levels. We offer 51 high school athletic teams and 11 middle school athletic teams. Our high school facility boasts stadium field lights, 2 turf fields for football, lacrosse and soccer, along with a baseball field and five tennis courts. High School sports teams continue to distinguish their efforts with conference, county & state awards and good sportsmanship acknowledgments. This past year the District won several Divisional, Sectional and State Championships.



There is a wide variety of after school clubs which showcase the varied interests of the student body. The District awards varsity letters to students in grades 9-12 who participate in any academic or other extracurricular team activity that competes with other teams from other district schools. **Before and After School Programs:** 

Each of the four (4) Kindergarten through Fifth Grade Elementary Schools offers after school club activities. Student enthusiasm determines the clubs that are established each year, so the clubs reflect the interests of each school's unique personality as referenced in their school report. Additionally the District, through its Community School, provides supervised Before School Care and After School Care programs which are much appreciated by the borough families. The Community School also offers After School Enrichment, which include new classes such as Rubberband STEAM, Makerspace, NANO BOTS, Robotics and Cooking.



**Staff and Professional Learning:** 

Many staff members have earned graduate Degrees and continue to grow, pursuing advanced academic degrees in specialized fields of study. Glen Rock Public Schools are proud that our staff members are desirous of being lifelong learners. Our teachers receive training in the most current research-based practices through in-district professional development programs and are encouraged to participate in workshops offered in their content areas sponsored by leaders in their field. The District supports all new hires in the District through an induction program and we have six subject-area supervisors to support all staff, K-12. The Board of Education recognizes the contributions our staff members make in their professional communities and are eager to work collaboratively with the faculty in order to provide the opportunity to attain the highest level of learning and achievement.



The District encourages every student to be a lifelong learner in whatever pathway they select. The Counseling Department's role is to help to provide a supportive, safe, and trusting environment in our schools which empowers all students to become social, academic, and career-oriented citizens. High School students are encouraged to be active participants in planning for their future by attending workshops with their parents, gathering information about GPA calculation and transcript information. Rising senior workshops, held in the Spring of Junior Year, are facilitated by the Guidance Department providing a review of the college process timeline, a look ahead at what's coming in senior year & things that students can do, including linking Naviance with the Common Application for Colleges. Scholarship information is provided to students along with the appropriate application to students who request it. Historically, 98% of Glen Rock students are accepted to college.

**Student Supports and Services:** 

The District offers educational services in the least restrictive environment to students who have been identified as eligible for special education & related services. Opportunities include placement in general education classes with supplementary aids and supports, in-class resource programs, replacement resource programs and special class programs in district and out-of-district. Members of the Special Services Department, as well as all faculty, work cooperatively with families to determine the most effective combination of programs and services beginning as early as pre-kindergarten to meet the unique needs of all students. Additionally, the district employs a Supervisor of Special Education to assist teachers in all aspects of instruction, including articulation from grade to grade, monitoring the progress of students through analysis of assessment results, and working collaboratively to meet students' Special Education needs in Resource/Adapted and In-Class Support.



The District has initiatives that enhance the safety, health and well-being of our students and staff, enabling every student to achieve their fullest potential as lifelong learners. This year emphasis continues to be on Social and Emotional learning as well. Self care and positive self talk have been shared with students at all levels. Elementary School Counselors implemented a daily mental health check for all learners; and provide lessons on resilience, mindfulness and a sense of belonging. A Wellness Center has been established in the Middle and High School to develop wellness programs and address the increase in adolescent mental health concerns. Students are encouraged to drop in and take advantage of meeting with certified counselors to provide social and emotional support outside of the traditional classroom setting. Requirements for course level advancement have been revised to reduce stress levels and allow for transparency, equity and consistency in enrollment.



**Parent and Community Involvement:** 

All Glen Rock Public Schools are supported by an active parent body through each school's Home and School Association as well as the Federated Home and School Association. The Federated Home and School Association includes members from each of the six schools to work together to create a collaborative environment for every school. The Home and School Association facilitates after school events and fundraisers to support classroom teachers and the district. Each school has a staff member as a liaison to the Association to ensure open and transparent communication. Additional supportive groups include the Glen Rock Booster Club and an active Glen Rock Alumni Association.

The public school system is comprised of six schools serving a population of over 2,600 students in grades K-12. The original Ridgewood-Grove School, which still stands as part of a private residence, has been replaced by four elementary schools - Richard E. Byrd, Central, Clara E. Coleman and Alexander

Hamilton - plus Glen Rock Middle School and Glen Rock High School. The District has a Buildings and Grounds Department, which is committed to maintaining the six schools. All requests for repairs and upgrades are reviewed by the Department and responded to in a timely manner. All instructional



spaces throughout our schools are air conditioned. The Board of Education employs a Security Director position who also serves as the School Safety Specialist. He coordinates and maintains a comprehensive security/school safety program and implements programs and activities to reduce school violence. The district implements lessons on resilience and mindfulness in order to provide a sense of belonging in our schools and our community.

**Technology and STEM:** 



Technology and STEM are supported as enrichment programs in our elementary schools for all students, providing a foundation for future learning and innovation. At the middle school, we expand on the foundation built in the elementary school by offering specialized programs in engineering, TV/Media broadcast, and computers, all designed to engage students in hands-on, problem solving activities. Our robotics club at the middle school provides the students with their first opportunity to participate in competitions while fostering teamwork and collaboration. At the high school level, students can further their exploration of 21 Century/Career Readiness topics with advanced classes in engineering, TV/Media broadcast, computer science, webdesign, and interior design. Students also have the opportunity to join the highly decorated Robotics Team that competes for a state title on a yearly basis.

The District offers full and half day preschool for students who qualify. This program is based on a creative curriculum and enables students to receive related services as needed. We also provide individualized instruction and services as needed within these settings. Our case manager works with Early Intervention to provide a smooth transition to our programs when children turn three years old.
