







## Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.



**Student Supports and Services:** 

The Intervention & Referral Services (I&RS) team consists of an interdisciplinary team of professionals who support learning, behavior, social and health problems for students in all school settings. The I&RS Committee discusses the student's strengths, weaknesses, and determines the specific interventions necessary to assist in meeting the student's needs. The Child Study Team (CST) includes a school social worker, school psychologist, and learning disabilities teacher consultant. The CST is responsible for identifying children with disabilities from ages three to twenty-one. Evaluations are conducted to determine if the child has a disability which affects their educational performance. If eligible, the team coordinates with related service providers to develop an Individual Education Plan (IEP.) Students who require English as a Second Language (ESL) services receive instruction designed to improve English, reading, writing, listening, and speaking skills.



The district supports Social-Emotional Learning (SEL) at all grade levels. At the elementary level, schoolwide initiatives, such as Godwin's Pride and Highland's Do the Right Thing, help students navigate decision-making. At MPHS, a school-instituted Wellness Council is charged with creating programs to address student and staff physical, social, and emotional needs. A "Wellness Month" was created and the school provides homework-free weekends to support student mental health. The district's comprehensive Physical Education program includes instruction on physical and mental health.



**Parent and Community Involvement:** 

The Parent-Teacher Associations, Sports Boosters, Performing Arts Parents Association, Midland Park Public Education Foundation, and other community groups work collaboratively with staff as valued partners in the education process. The philanthropic efforts of this myriad of volunteers demonstrate ongoing support for schools and district and the wide variety of fundraising conducted has benefited district technology, broadcasting, sports, arts, and academic programs.

Ensuring a safe and civil environment for all students is a primary concern in our district and we remain dedicated to working collaboratively to remain in compliance with New Jersey's Anti-Bullying statute (ABS.) We reaffirm our shared commitment to ensuring all incidents, whether identified as HIB or student code of conduct violations, are swiftly and appropriately addressed. Students in grades 2-12 participate in an anonymous electronic School Climate Survey to ensure program initiatives address district-specific needs. Ongoing staff training, survey analyses, and the support of our School Safety Committees make our district schools instructional environments where everyone feels safe, valued, and welcomed.



All buildings are continually maintained to provide safe and comfortable learning environments for all students. Recent improvements include: HVAC upgrades, electrical upgrades, outdoor classrooms, playground upgrades, and classroom renovations.



The district has school security guards working at the elementary schools and high school. The security guards assist administrators in maintaining safe and secure school environments, and also seeks to foster a positive relationship with students and staff by being a visible presence during the school day. The district has a state-of-the-art emergency management system in all its schools an automatic dispatch alarm to local and county law enforcement. New, safer school entrances have been created to enhance security measure, and mandated lockdown, evacuation, and other emergency management drills are routinely conducted to ensure an appropriate response by students and staff during times of emergency.

In 2021, the district was awarded a \$43K grant for computer science education. The district recycled 600 HP Chromebook G1 devices in-house, replacing them with new HP 14" Touchscreen ChromeBooks for MPHS students. Students and faculty use the Google platform and a PC lab is used for computer programming. A MAC computer lab supports graphic design classes. Broadcasting classes produce high definition student work over the local access channel for the community and the robotics class builds robots through engineering design. The Girls Who Code Club was created to bring STEM awareness to the female student population and a \$4800 BOSCH grant was awarded to purchase coding kits. STEM initiatives are woven into second grade curricula and students benefit from Makerspace activities and technology projects. Students are integrating technology into science and social studies and work with STEM initiatives by incorporating problem-solving through mechanical/technological means.



The district offers a morning and afternoon integrated preschool program for residents three to four years of age who are identified for these programs by the Child Study Team. Students are integrated with general education peers and benefit from a creative curriculum utilizing play-based activities to promote early literacy, readiness skills, math, motor skills, language, and social emotional growth. The full day preschool program utilizes the Applied Behavioral Analysis (ABA) approach and is provided to students with greater developmental needs. This program is a highly-structured environment, with low student to adult ratio to ensure individualized monitoring of skill development.



Our community embraces the Midland Park Mindset which calls for all staff and students to show a willingness to be great. This willingness to be great is demonstrated through hard work, acting with integrity, self-reflection, teamwork and innovation.
