



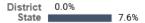

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.



The district has recently employed SLEOs in our elementary schools, and, this year, expanded the SLEO program to our High School. Having an officer in each building at all times helps us to provide a consistent safety presence for our students in the building during the school day.



Our district is a 1:1 district, in grades three through twelve. All students use a Macbook Air laptop, connected to our district's network and filtered using an active, safety-oriented web filter. Upgrades to district technology are planned, including a fiber-optics network to connect our buildings.
