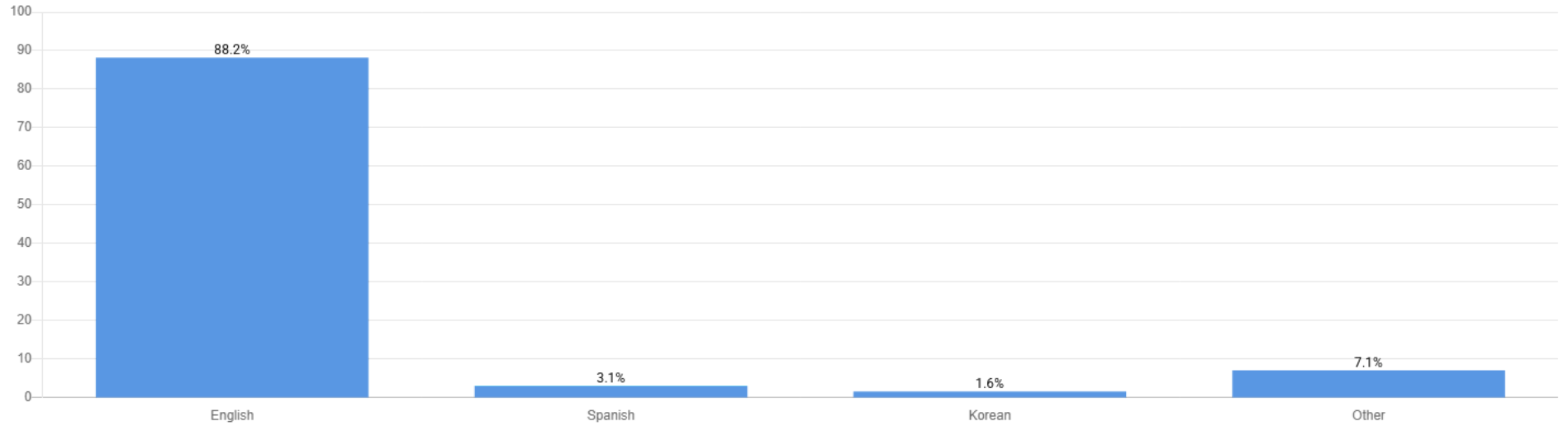

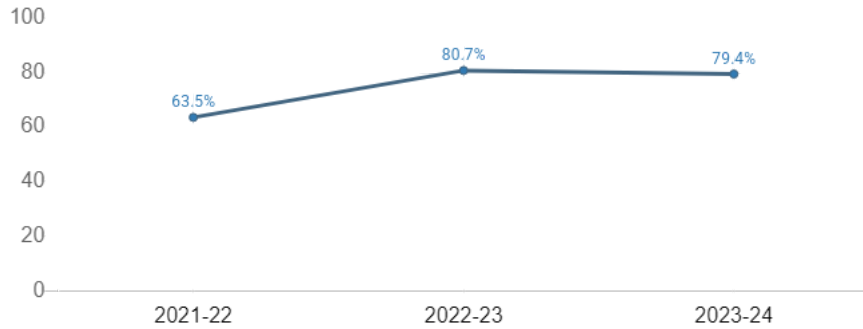

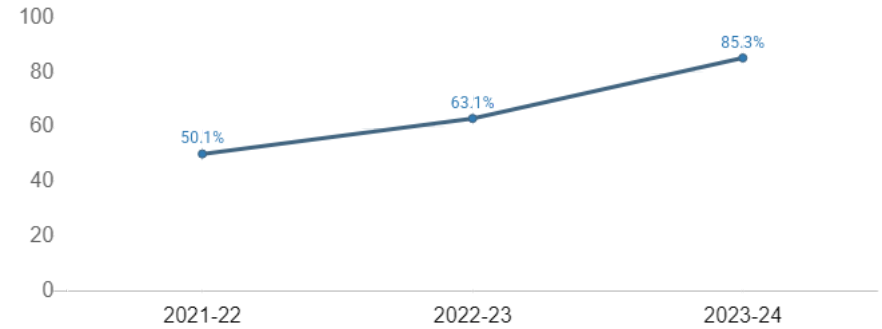
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. 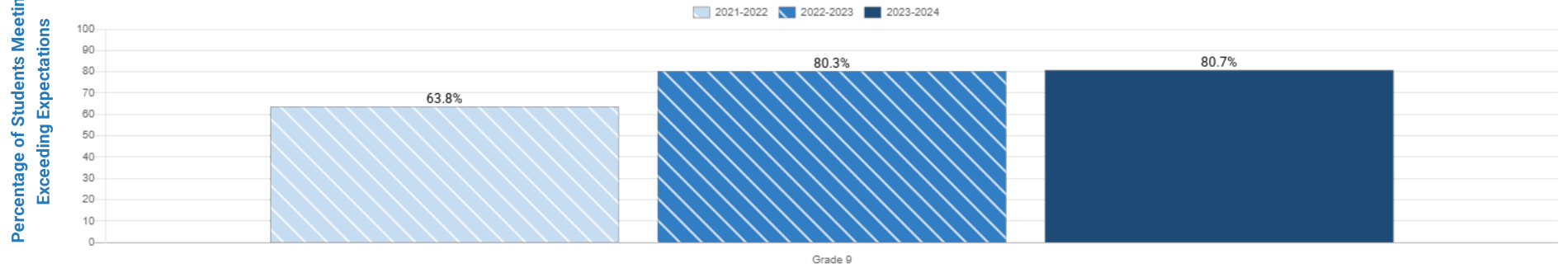

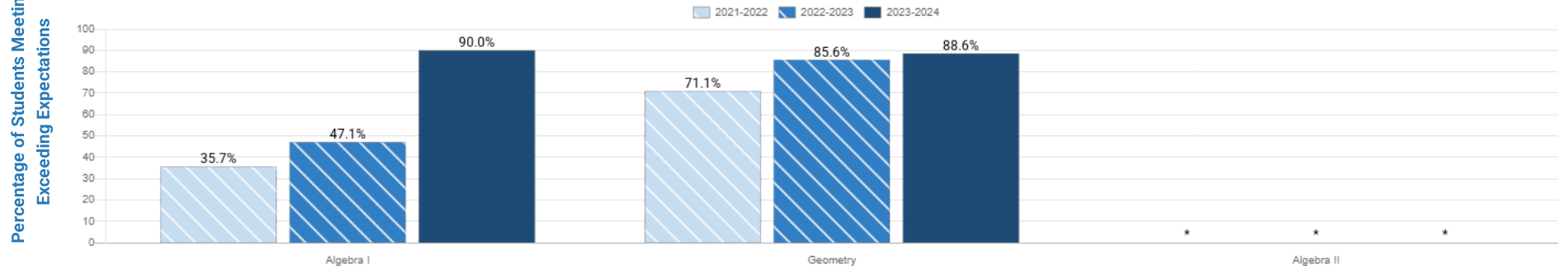

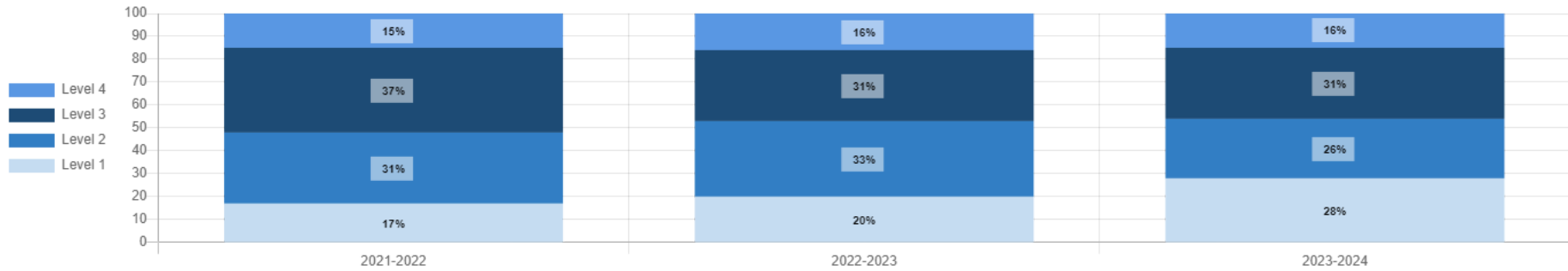

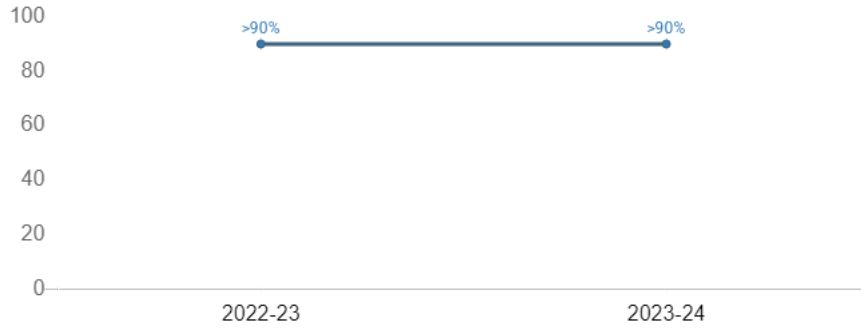

Students taking one or more AP or IB exam

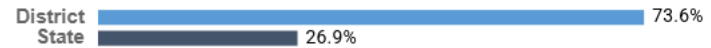

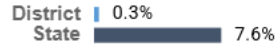

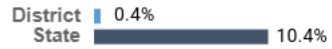
CTE Participants

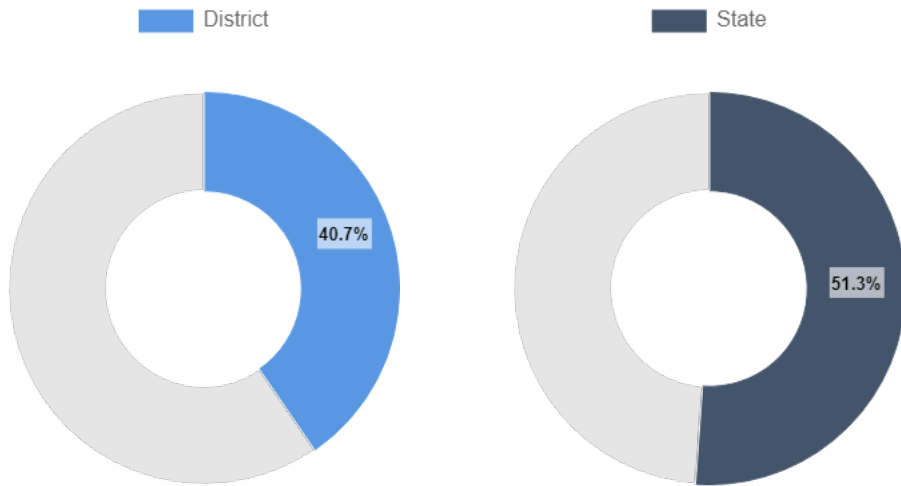

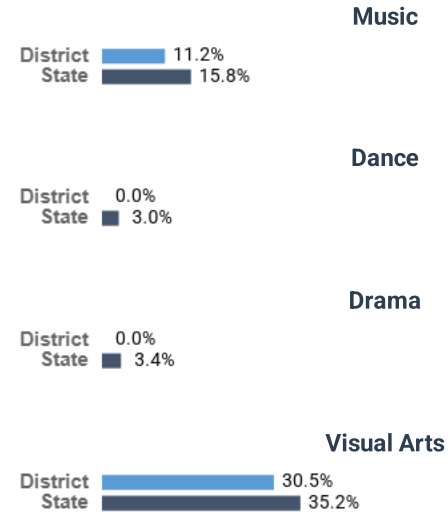

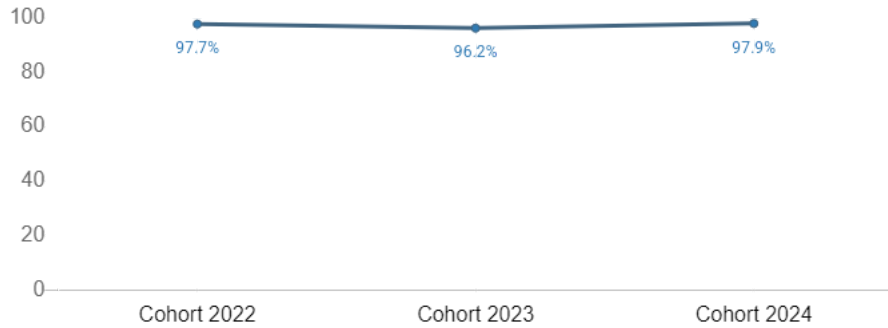

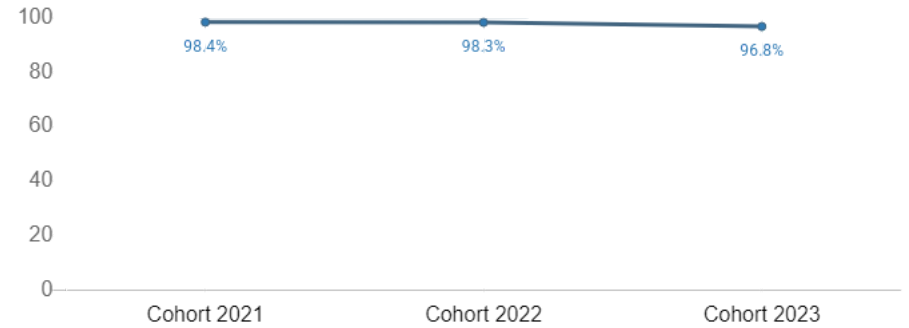

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

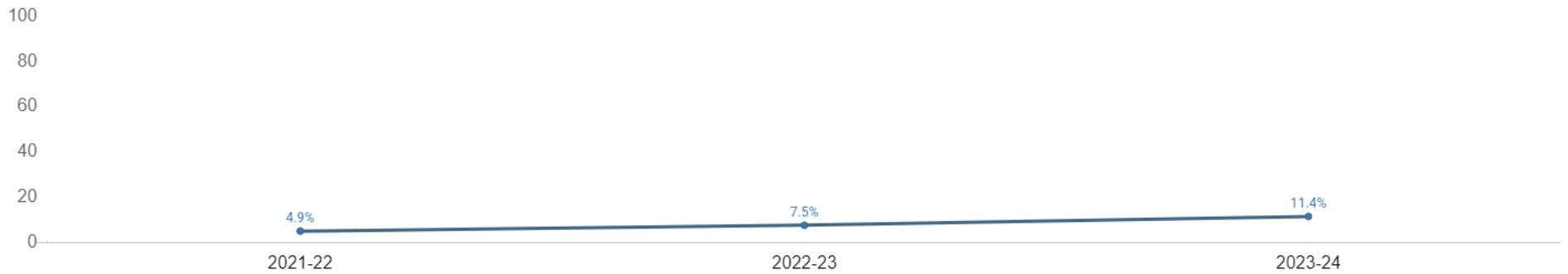

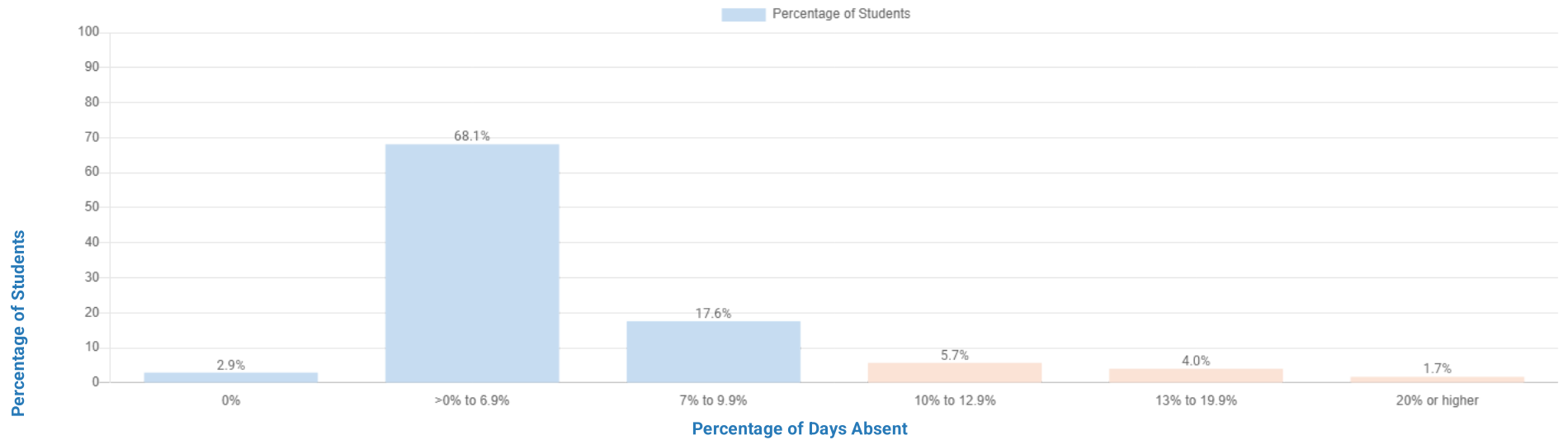

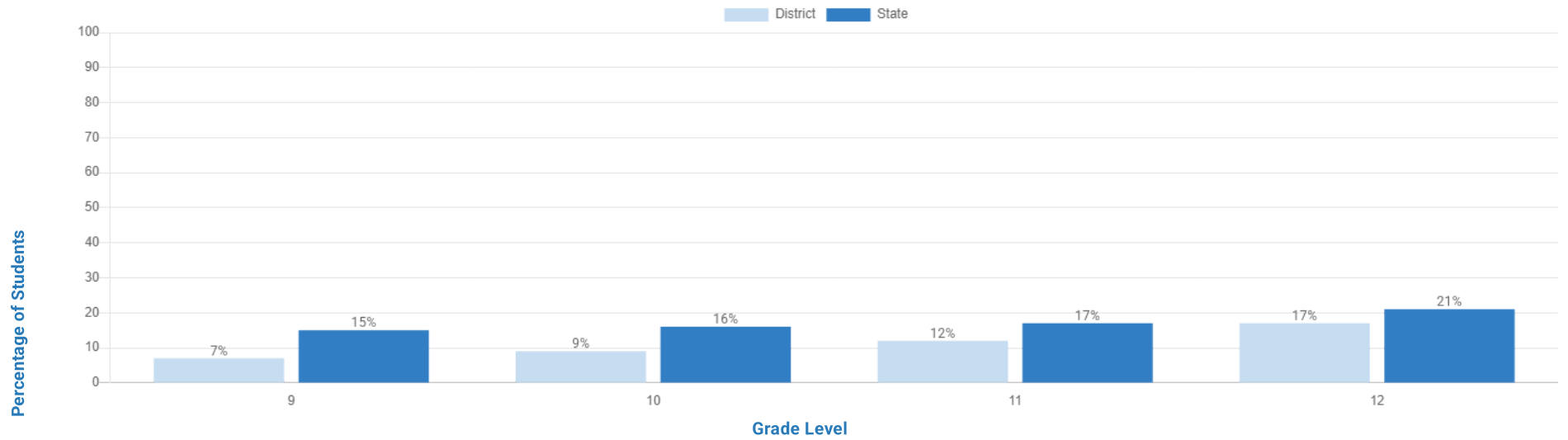

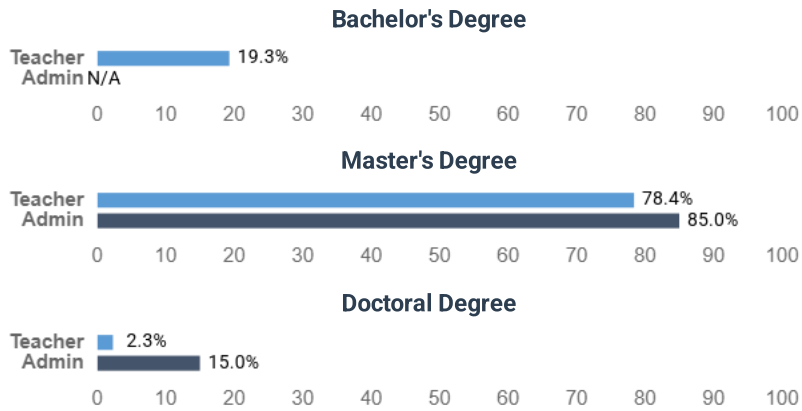

School Safety:

Creating a secure learning environment is a top priority. We have implemented a range of passive and active safety and security measures to ensure the well-being of our students and faculty. Each school is staffed with three SLEO-III police officers who provide security and conduct mobile patrols. Our comprehensive security system includes camera monitoring, electronic access control, and a reinforced physical plant. We collaborate closely with local law enforcement and EMS to support our safety programs. As the first district in the state to certify all students, faculty, and staff in CPR, we are also equipped with multiple defibrillators in every building. Additionally, many staff and students are certified in Bleeding Control, and Bleeding Control kits are readily available throughout our facilities.



Technology and STEM:

Our students have access to a variety of computer science courses that teach coding and its practical applications. Recognizing the growing importance of data literacy, we have expanded and enhanced our statistics offerings, integrating them with science and social studies. Students can engage in multi-year research projects, college-level and dual-enrollment courses, including an Engineering course offered in partnership with the University of Texas. Our Technology Education program provides students with state-of-the-art resources, including 3D printing, laser engravers, and CAD software. Our award-winning Robotics team offers students a platform to design, build, and compete at the state, regional, and national levels. Technology is also integrated into our arts programs, where students explore digital photography, TV and video production, web design, and music technology.
