





Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.



Professional development in Ridgewood is organized around the district's identified annual goals. New teachers participate in a rich orientation program that begins in the summer and extends across the entirety of the school year. New teachers are further developed through our New Teacher Induction Program which includes structured professional development and support for the first four years of employment. Professional development days involve teachers in collaborative curriculum work, and the district additionally supports teachers' participation in learning opportunities outside of Ridgewood.



Students may participate in Senior FOCUS, which is designed to support students through the college application process. Over 95% of graduates from the Class of 2024 attended a two or four-year college.



Student Supports and Services:

The district offers an array of support services to meet the needs of diverse learners. This includes comprehensive programs for Special Education students, Multilingual Learners, students with 504 Plans and students with Health Plans. The district uses Intervention and Referral Services and offers Basic Skills Instruction. Guidance Counselors and Child Study Teams work closely with students and their families, and teachers consistently integrate differentiated instructional strategies. The district has partnered with West Bergen Mental Healthcare, a fully licensed and accredited mental healthcare organization, to provide a school-based counseling program that directly supports students and their families. The therapists are experienced in youth development, therapy and case management, and utilize a variety of effective models to develop skills and strategies for personal growth.

Ridgewood Public Schools continues to add to our already significant school safety and security protocols. The district funds the position of School Security Specialist. Three Class III Officers shared by the schools are funded by the district and local municipality. All of our buildings have lockdown shades installed throughout, building exterior management systems, and communication systems to facilitate management of emergency protocols.



The district offers a comprehensive STEAM education program spanning grades 3-12, combining both required and elective courses to foster students' engagement and skills in science, technology, engineering, arts, and mathematics. Middle and high schools utilize dedicated makerspace classrooms to deliver hands-on, innovative STEAM curricula, supporting creativity and problem-solving through project-based learning. Technology is seamlessly woven throughout the PreK-12 curriculum, enhanced by professional training for teachers in instructional technology to improve the overall learning experience. Recognizing the growing importance of computer science, the district is expanding its course offerings at both the middle and high school levels, preparing students with skills for a technology-driven future. Additionally, high school students have access to robotics courses, equipping them with hands-on, problem-solving experiences that develop computational thinking and engineering skills.



Ridgewood Public Schools provides a range of preschool programs designed to support the needs of our youngest learners. Located at Glen School, Ridgewood offers both self-contained and integrated preschool classes. In self-contained settings, we run preschool disabled and multiply disabled classes, both funded locally and with open enrollment.
