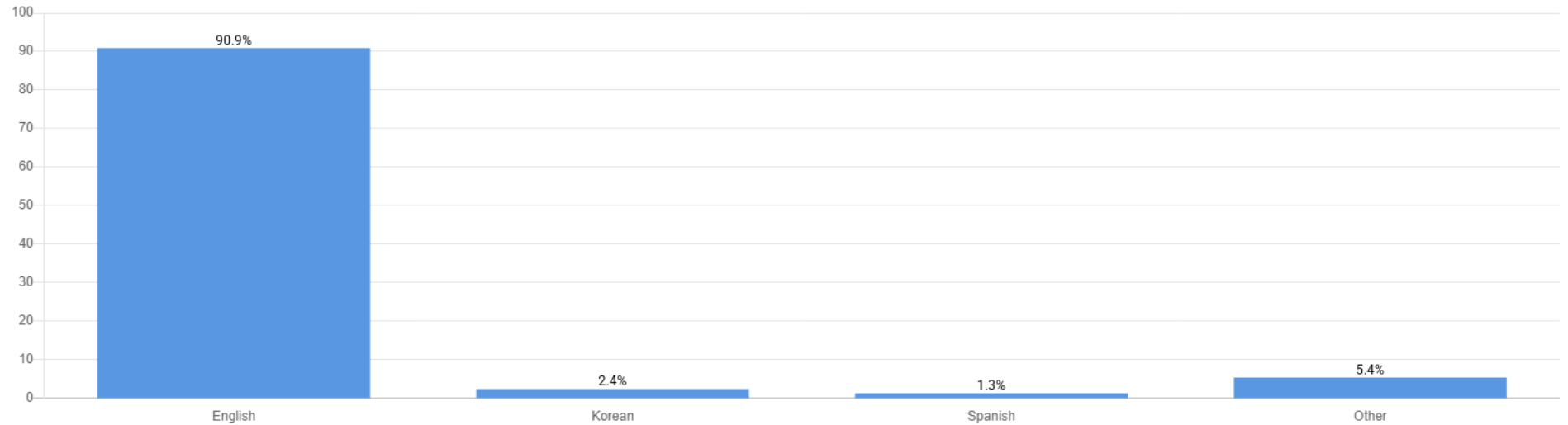

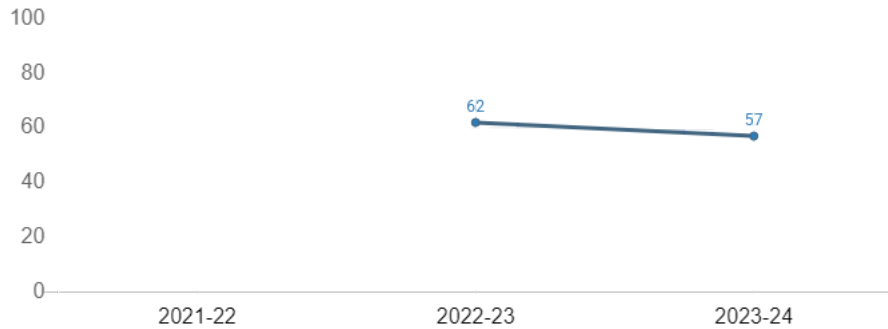

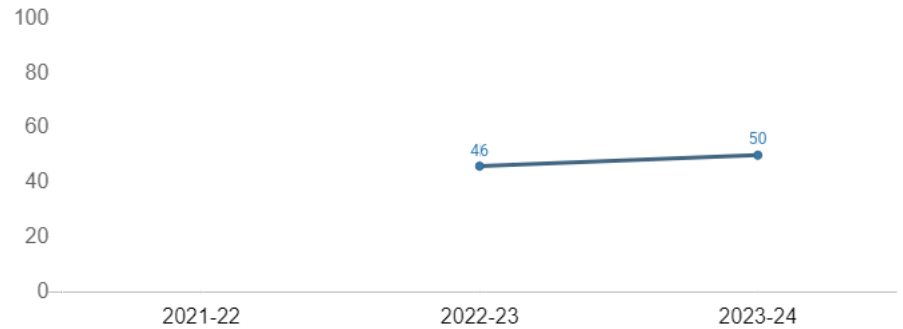

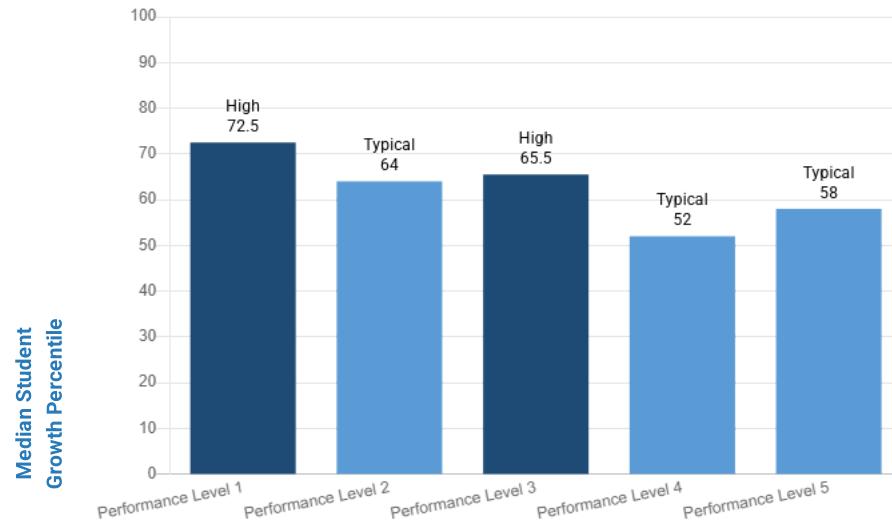

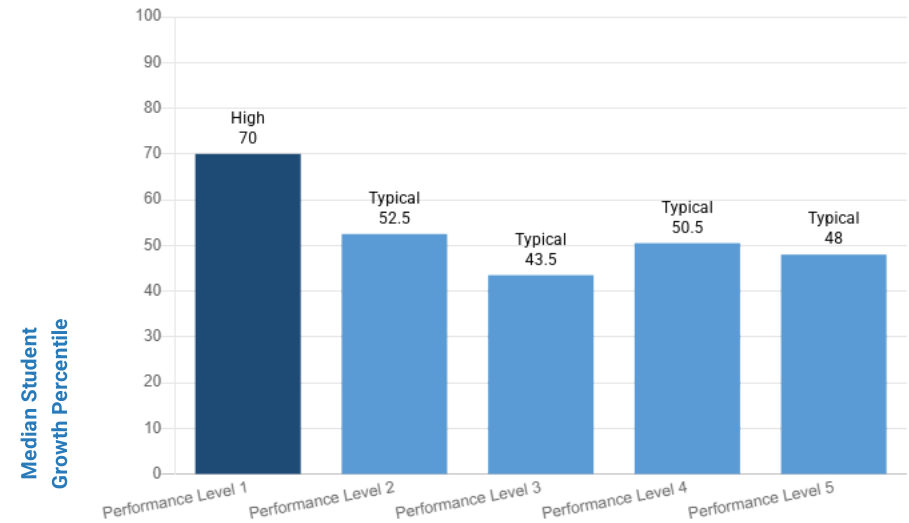

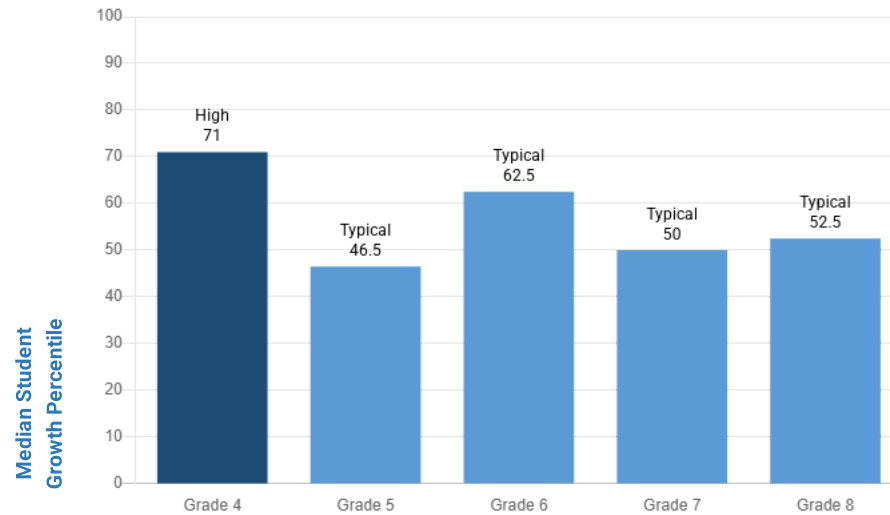

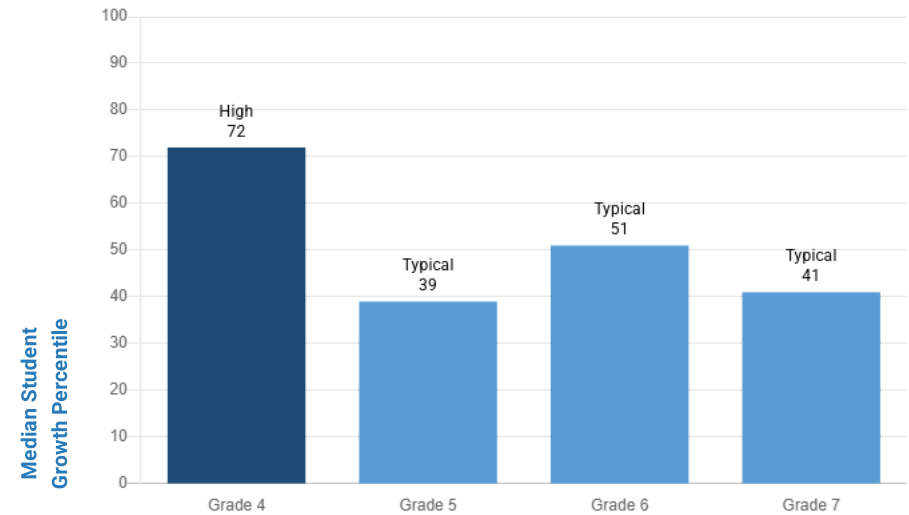

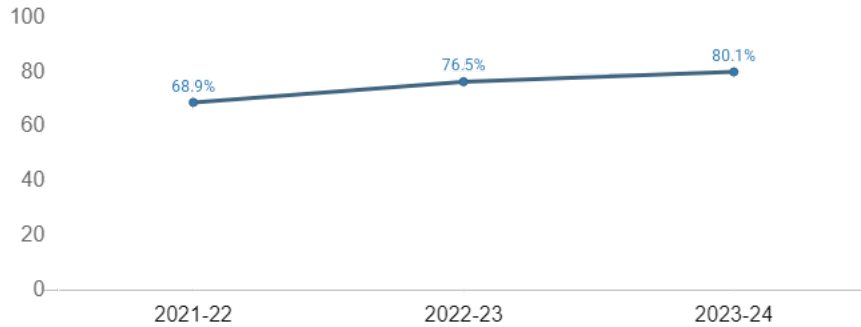

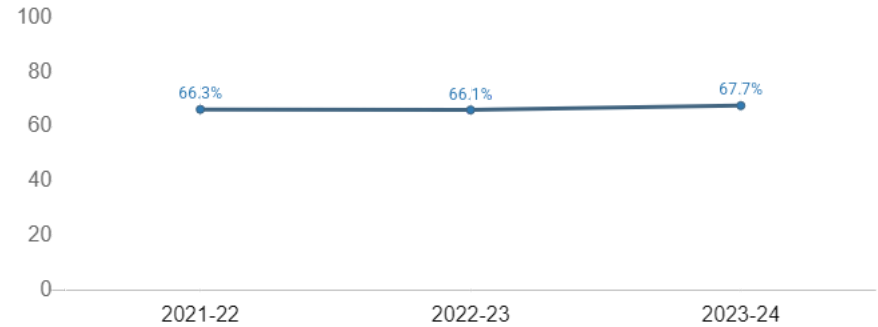
English Language Arts and Mathematics Performance Trends

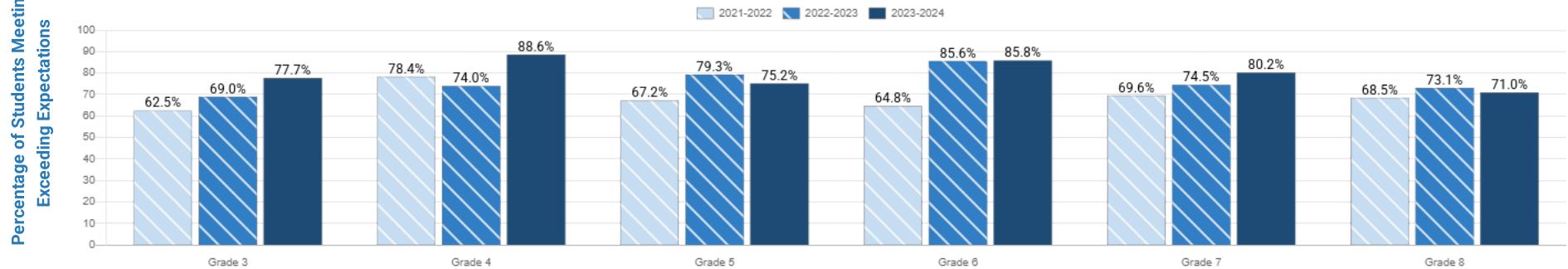

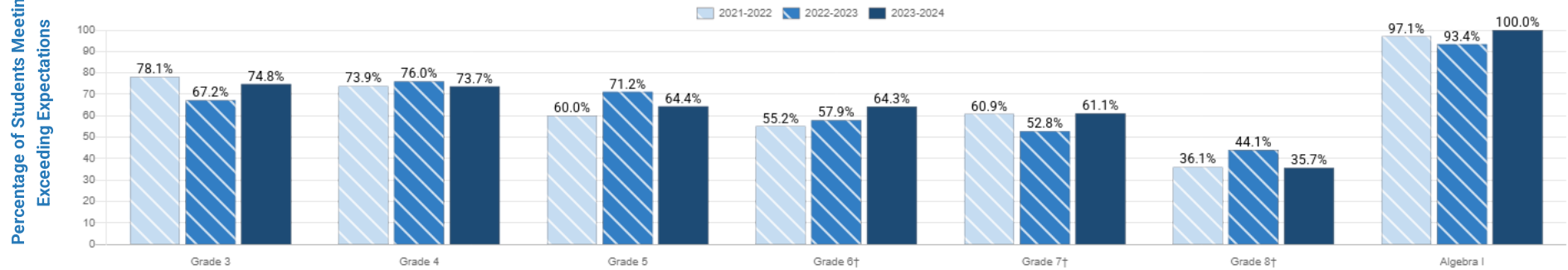

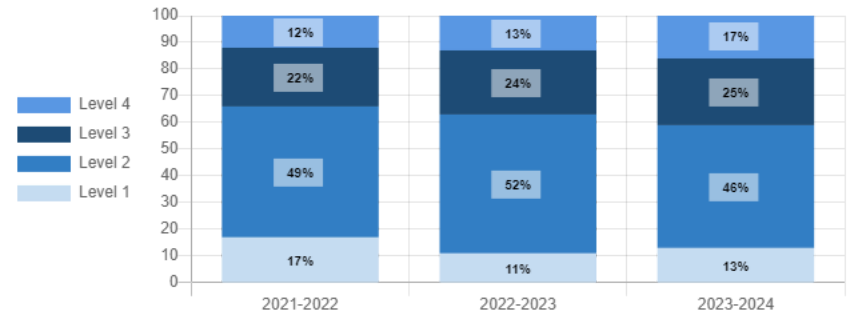

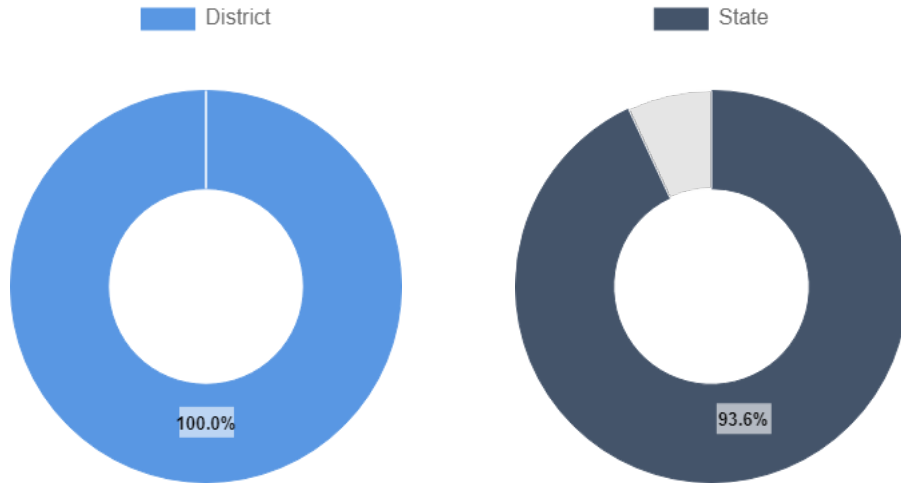

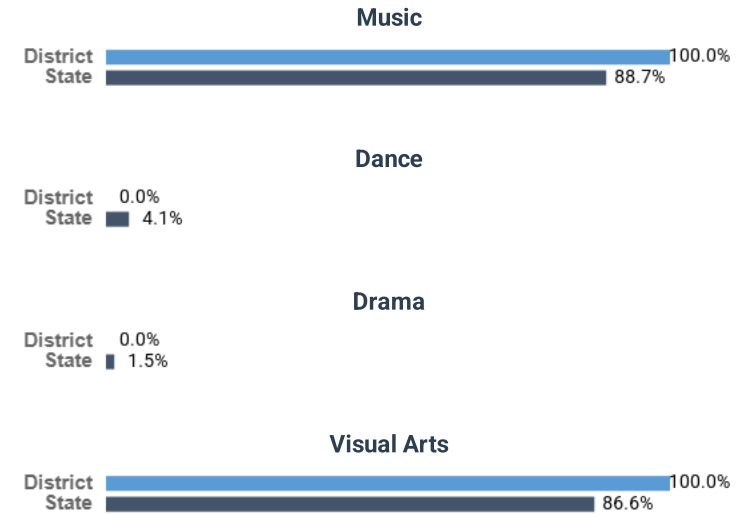

Students enrolled in one or more classes by discipline:



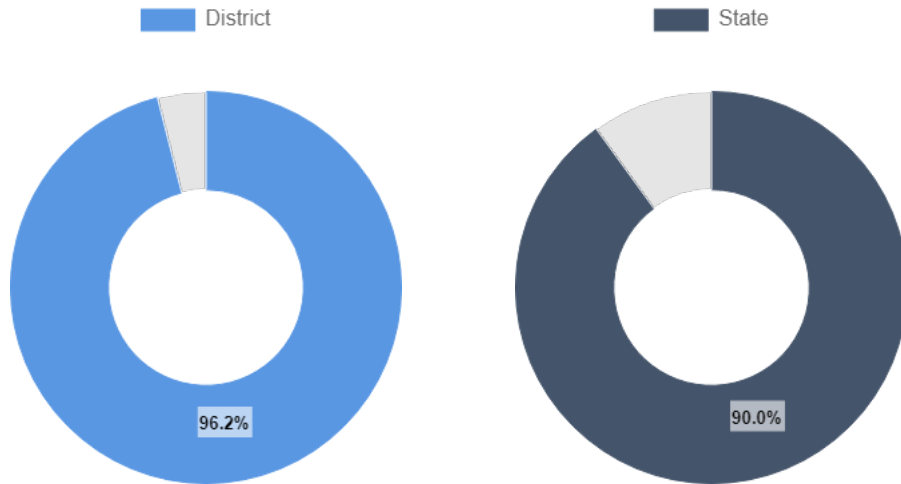

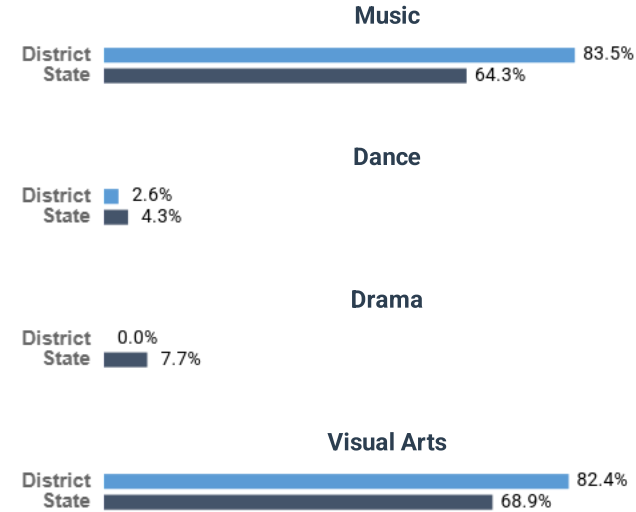

Students enrolled in one or more classes by discipline:

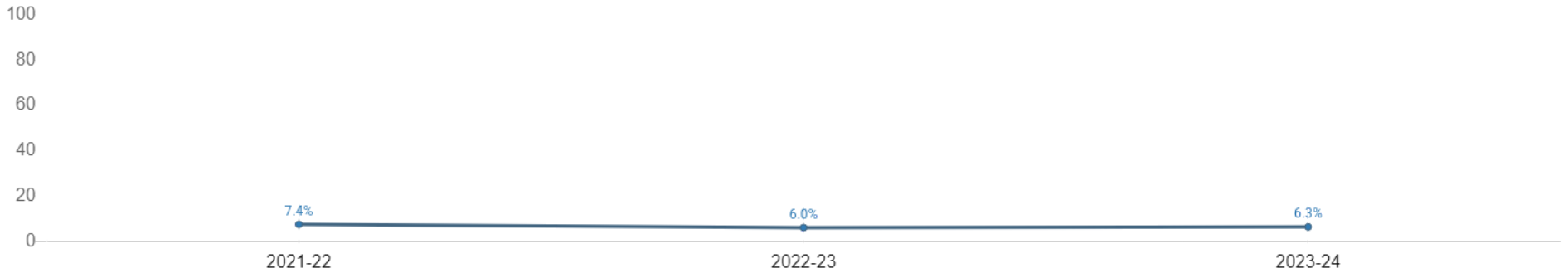

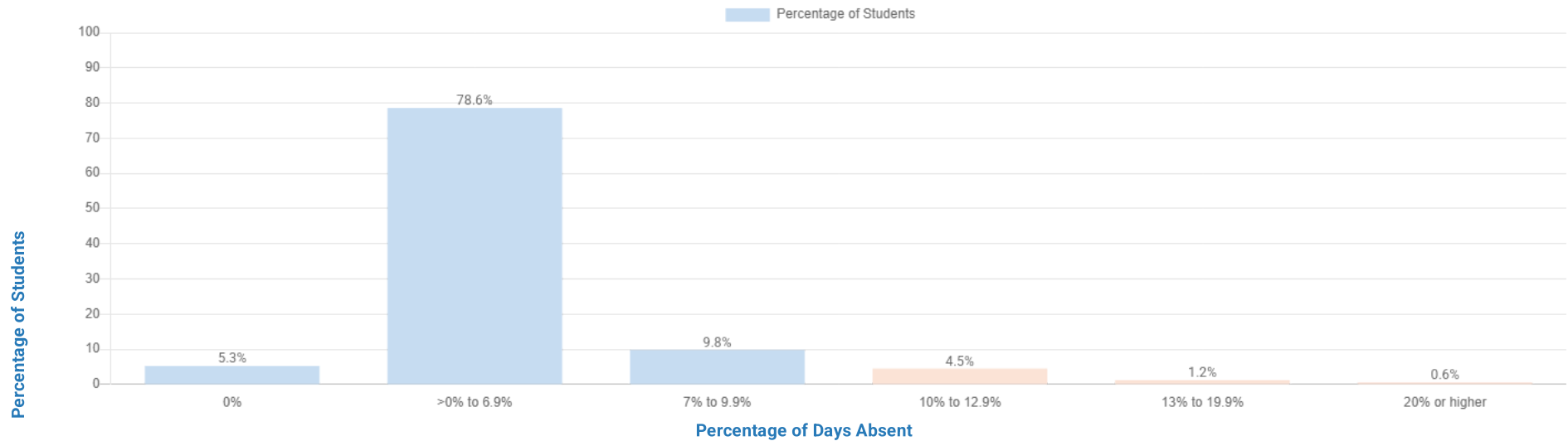

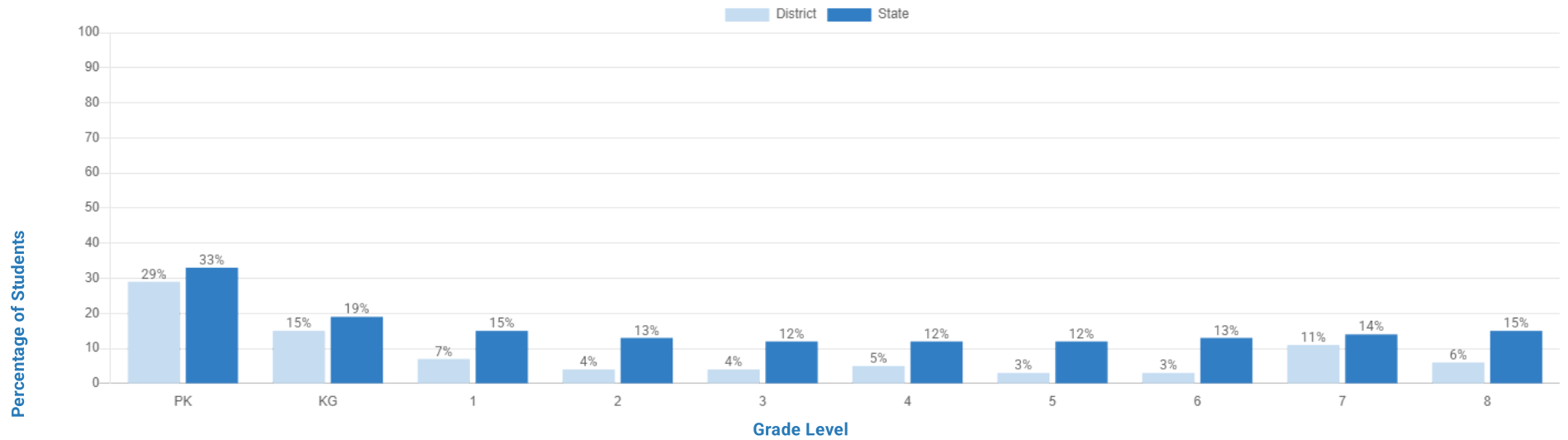

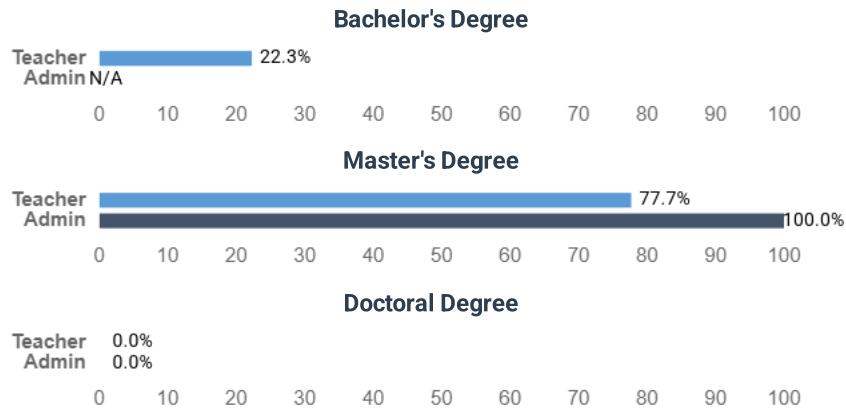

The River Vale School District prioritizes continuous professional development for our staff. Each school hosts professional learning communities focused on curriculum, data, and assessment, fostering collaboration and skill enhancement. Staff can choose from a variety of workshops led by experts, and educational consultants support their classroom efforts. We offer a minimum of three district-wide professional learning days on campus and invite keynote speakers to address relevant educational topics. Staff members create Professional Development Plans aligning with district goals and individual goals. We are dedicated to cultivating an environment that nurtures the growth and development of our dedicated staff.



Student Supports and Services:

The District provides a variety of services to students who need additional support, including Intervention & Referral Services (I&RS), supplemental instruction, special education services for students with disabilities, and specialized instruction for English Language Learners. The District also believes in differentiating instruction for all students so that their learning is personalized to the maximum degree possible.



Student Health and Wellness:

The River Vale School District prioritizes student health and wellness with a range of initiatives. Thanks to the generous support of the River Vale Education Fund, we have a mindfulness yoga program to promote mental and physical well-being. Furthermore, we've instituted Threat Assessment Teams to identify at-risk students and ensure they receive the necessary help. Our district remains committed to the holistic well-being of our students.

Facilities:

These renovations encompass an array of enhancements, including the installation of central air conditioning, new roofs, ceilings, flooring, lighting, and the rejuvenation of classrooms and classroom bathrooms in our elementary schools. Additionally, our middle school has undergone a significant expansion, which not only created extra classrooms but also dedicated counseling spaces and a wellness center. This expansion not only improved the flow of traffic within the school but also eliminated dead-end hallways, enhancing the overall accessibility and functionality of the building. As part of these initiatives, we've also developed two outdoor courtyards at the middle school, providing safe and secure outdoor learning spaces, enriching the overall educational experience.



Attendance:

Consultants and new software were used to address the impact of the Covid-19 Pandemic. A Math Consultant worked with staff and students on using data to bridge the learning gap caused by Covid-19. The consultant worked with staff on using NJSLA data more effectively and making instructional decisions that are differentiated for each learner. A Literacy Consultant worked with staff and students on creating a culture of individualized instruction and on using Patterns of Power to address grammar deficits and Scholastic Short Reads to ensure guided reading in the upper elementary grade levels. Data was used to provide small-group instruction and target specific skills. Purchase of Linkit Benchmark Assessments to progress monitor students on specified standards identified through benchmark data. Purchase of Newsela, Freckle, and IXL platforms to best individualize instruction and target specific prerequisite and grade-level skills.
