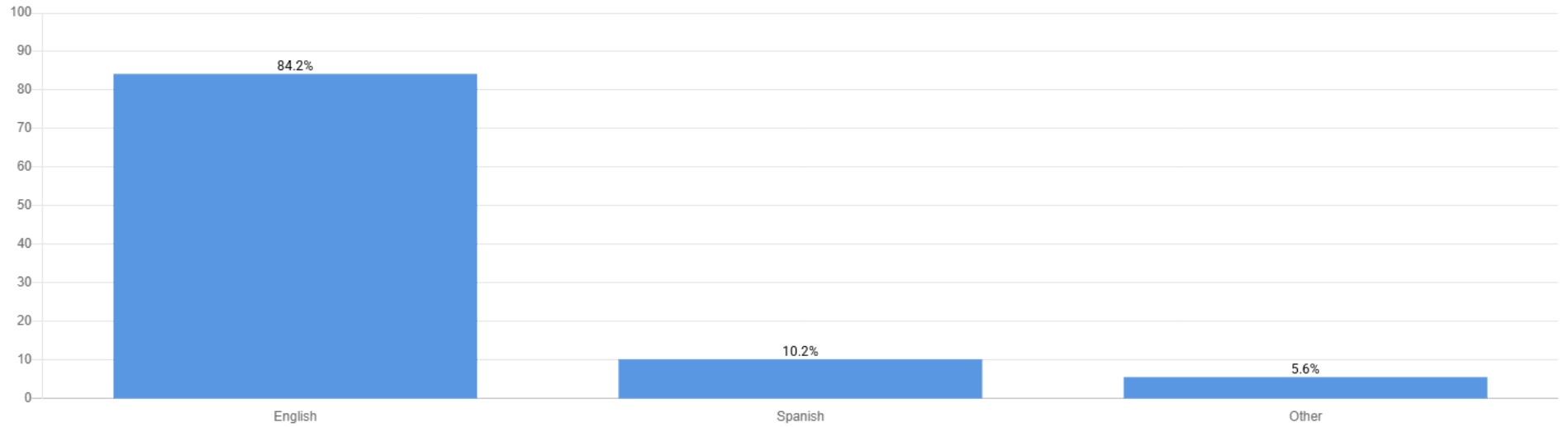

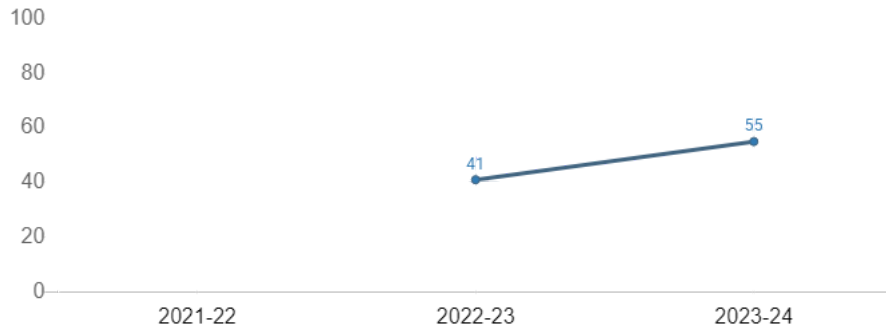

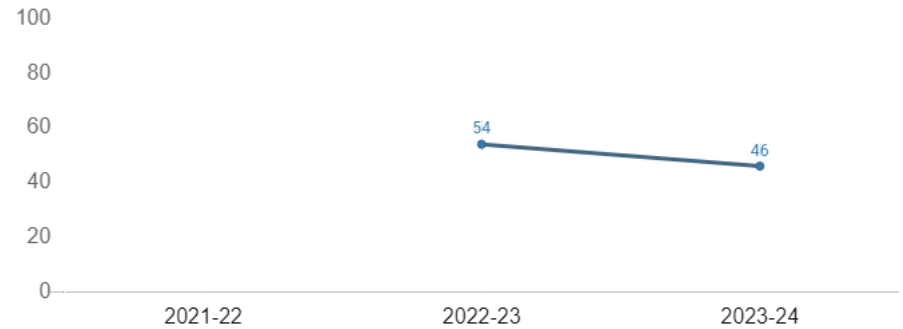

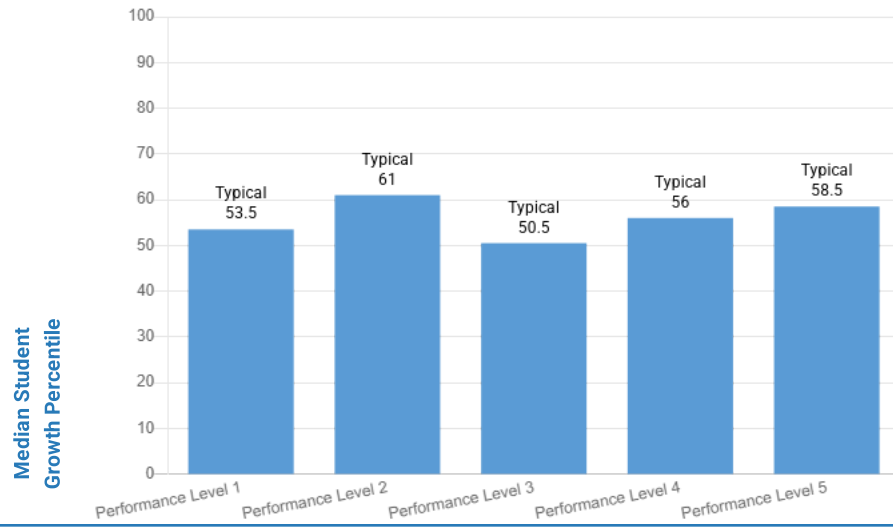

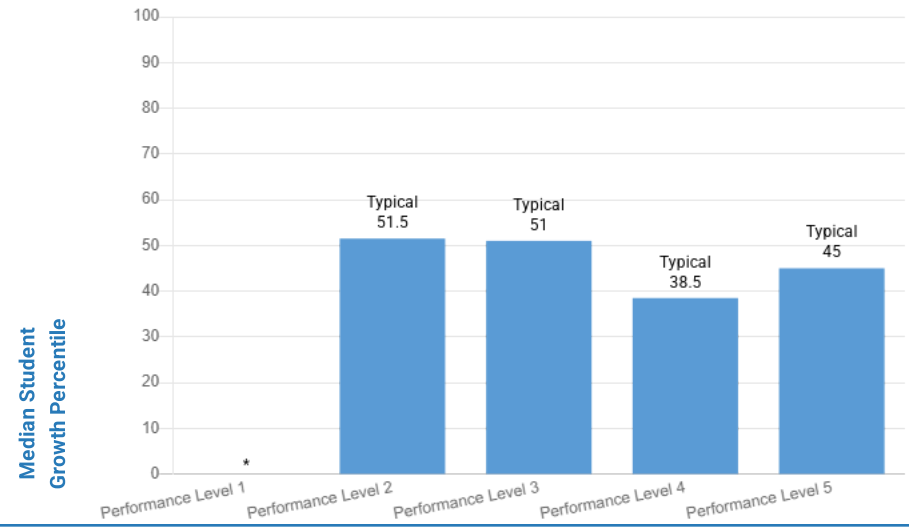

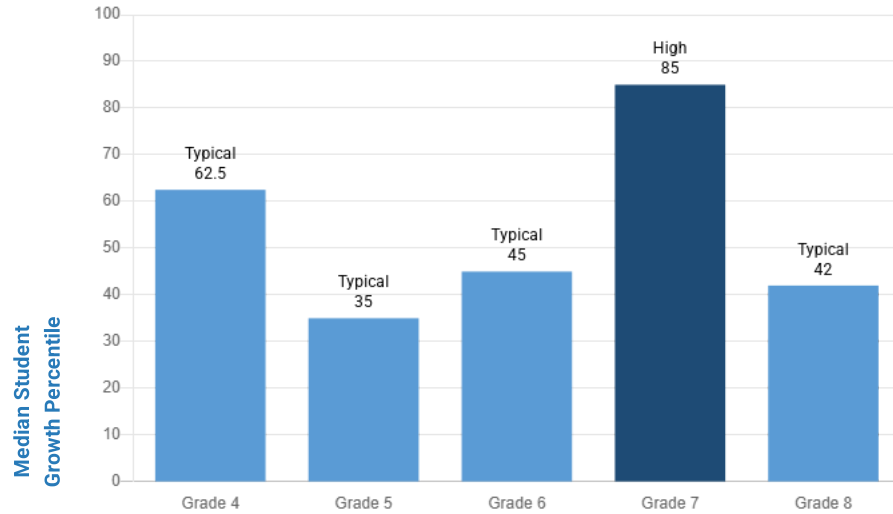

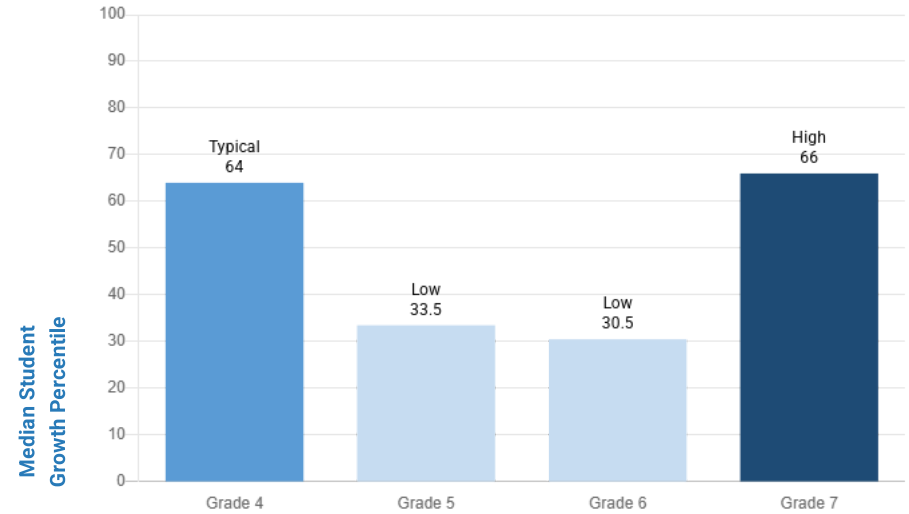

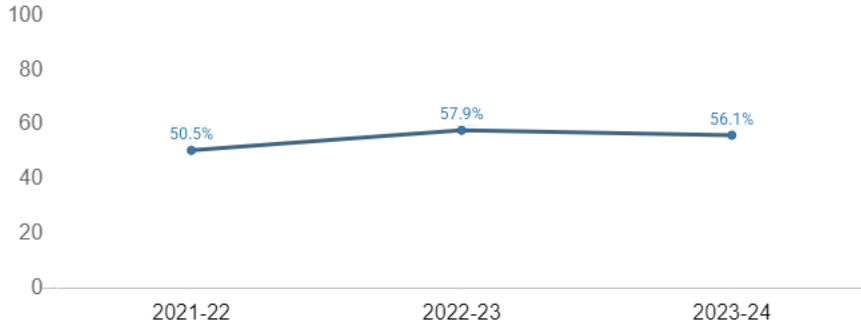

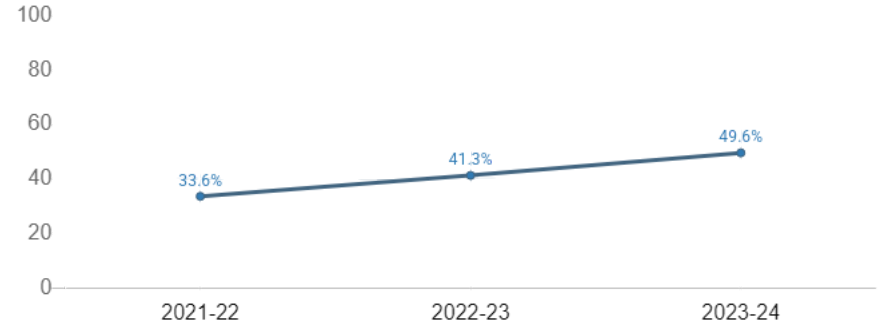
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 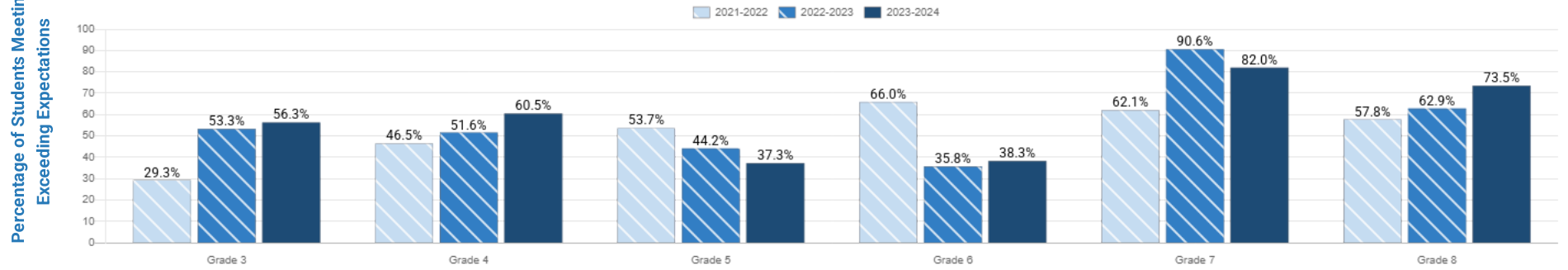

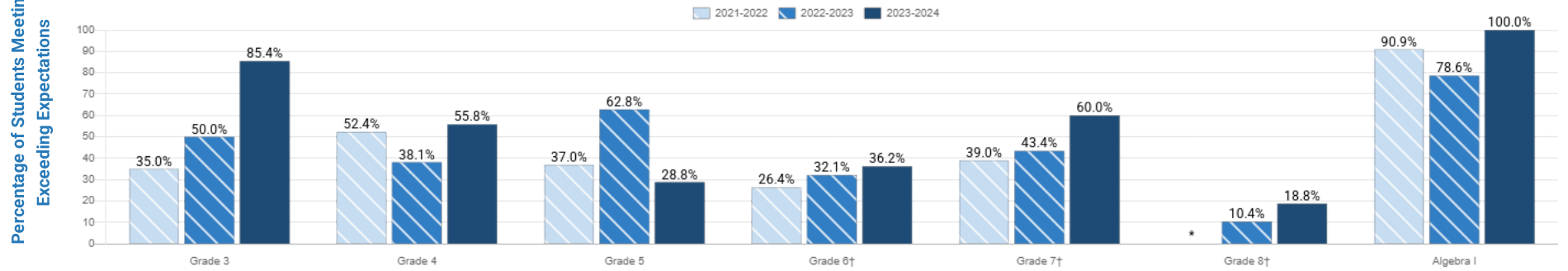

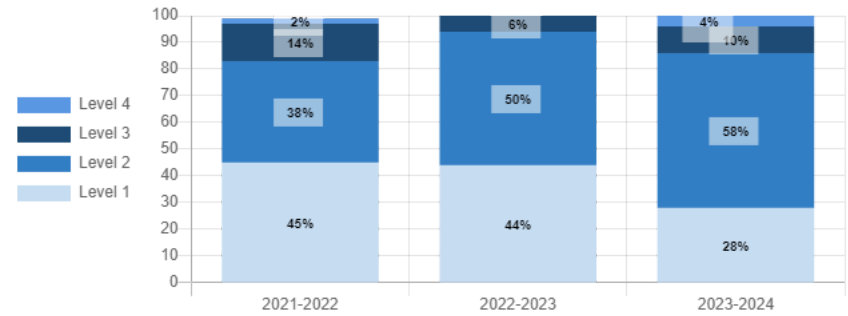

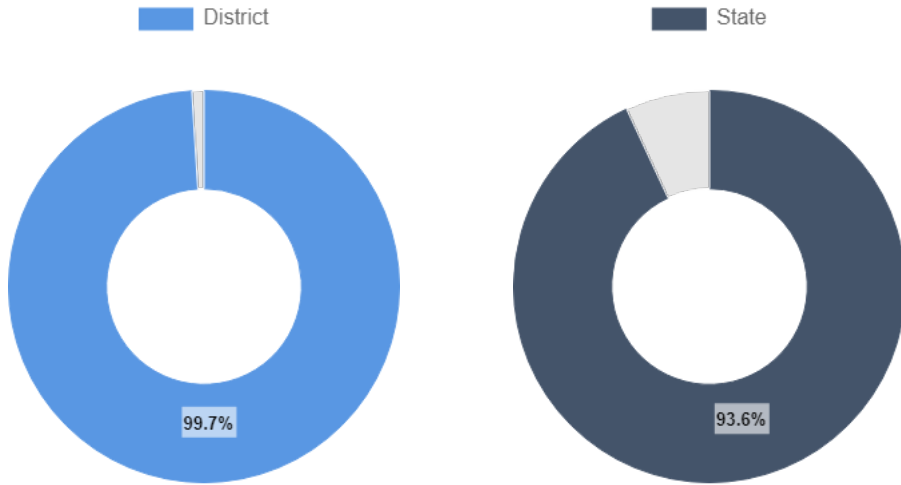

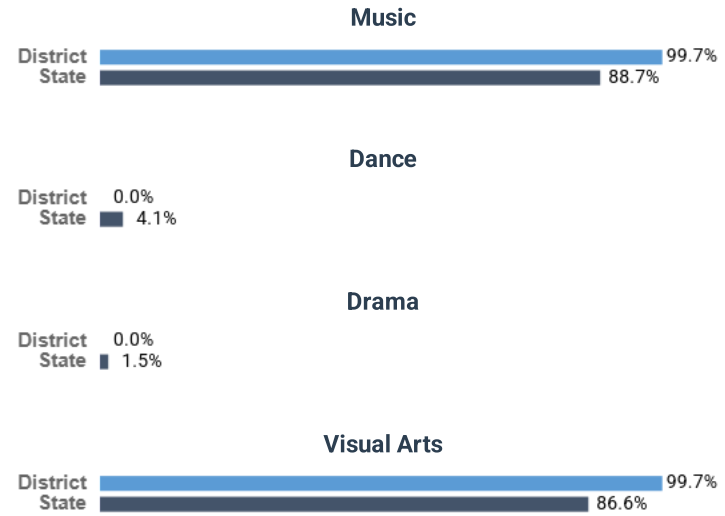

Students enrolled in one or more classes by discipline:



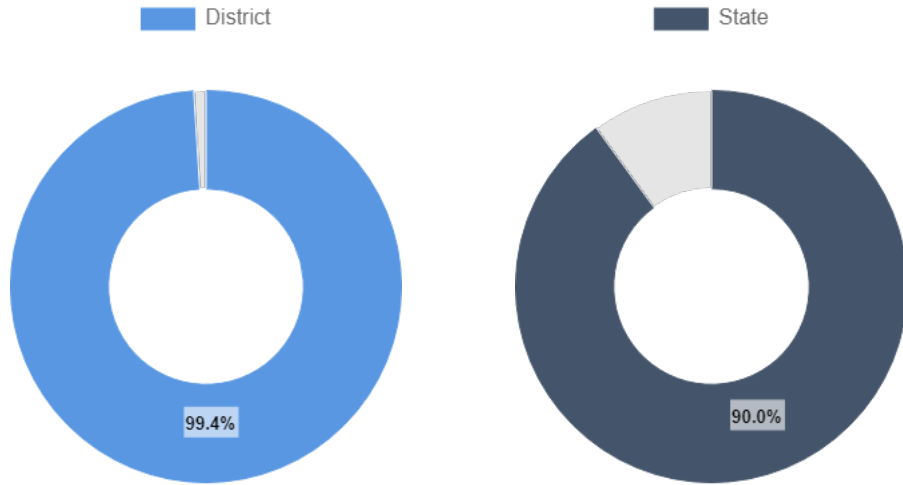

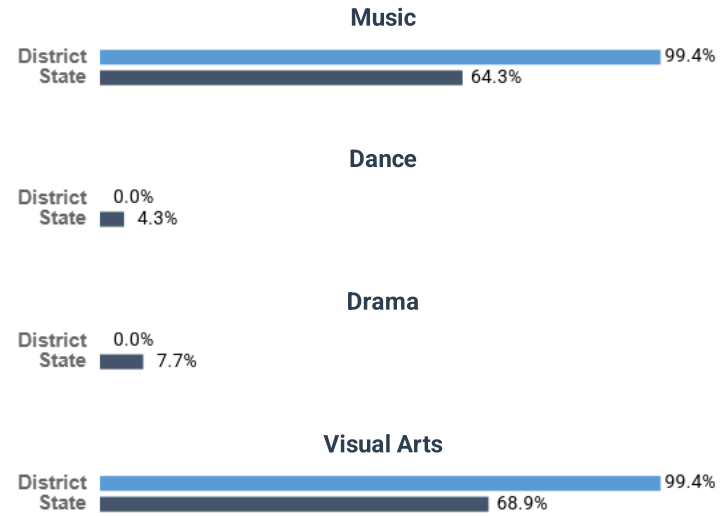

Students enrolled in one or more classes by discipline:

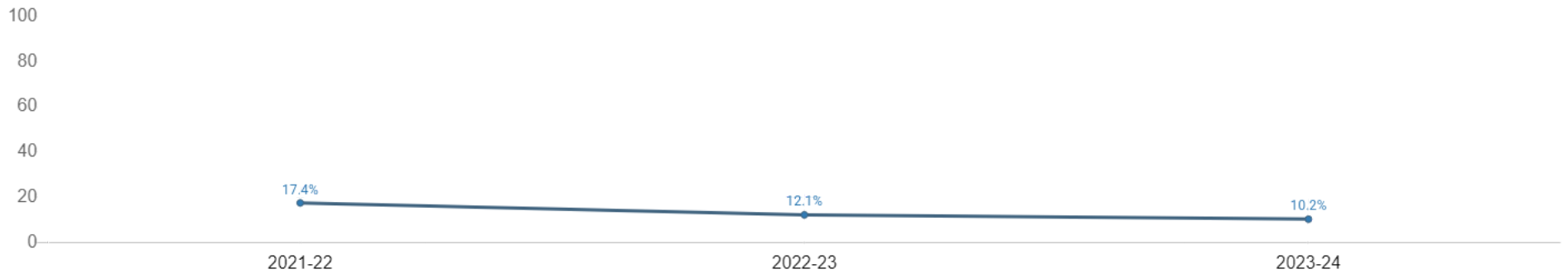

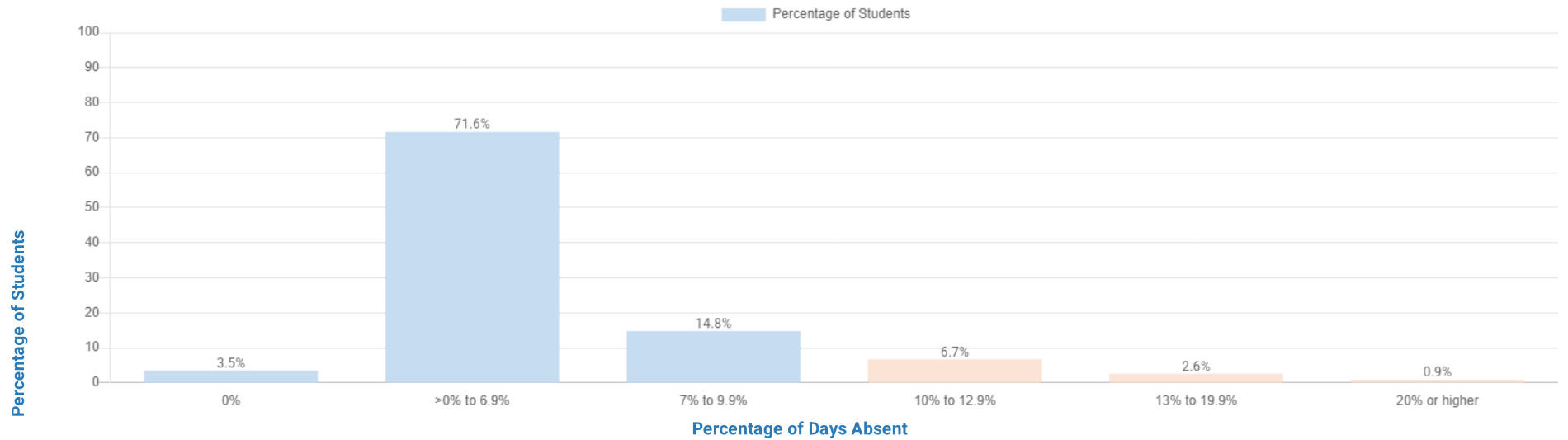

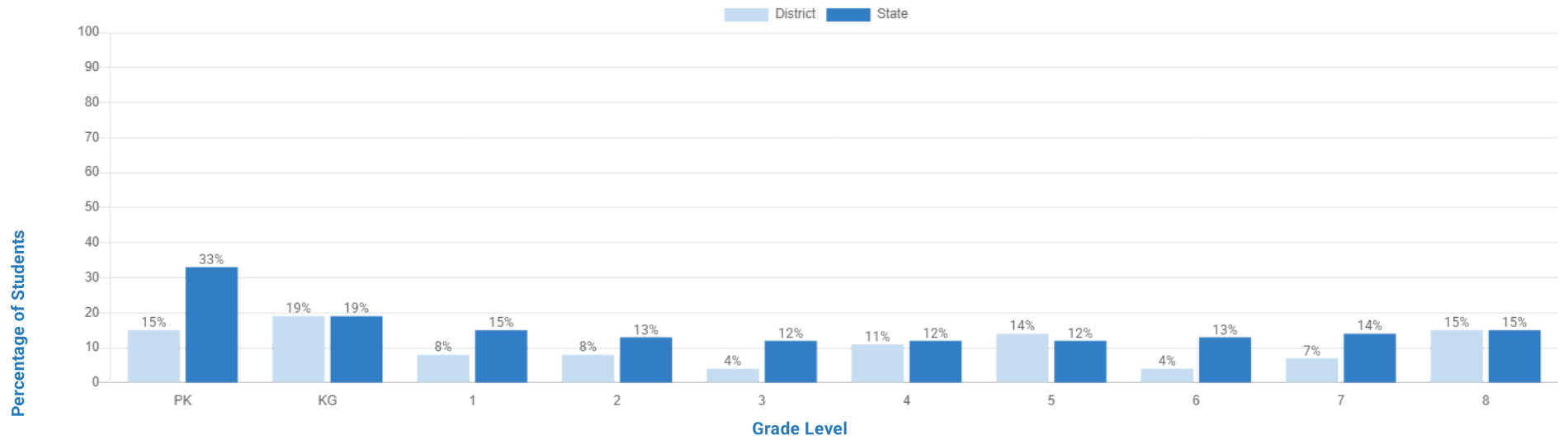

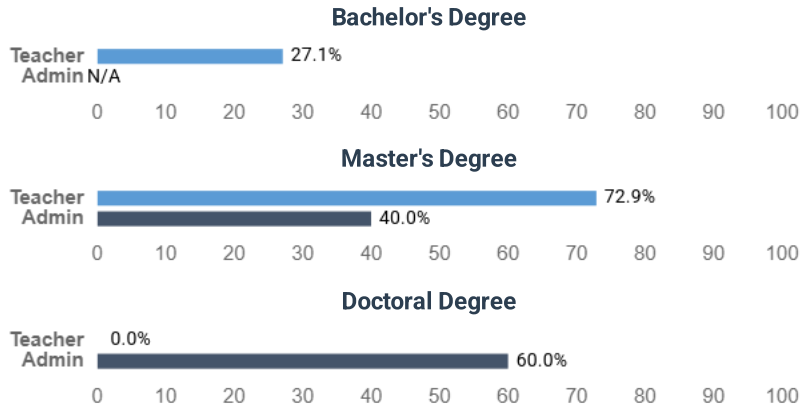

The Care Program provides fun and enriching opportunities for Midland School Students in Grades Pre-K (age4) through 8th grade. The Care Program provides a warm and welcoming atmosphere, and clean environment created by our professional staff. Arts and crafts and partnerships with local community serves, such as the township library, serve to supplement the Care Program's Services. Also, The Extended School Day Program provides for part of the school year, offers academic support the ELA and Math to students with identified needs.



Staff and Professional Learning:

This district's professional learning opportunities range from district-wide scheduled programs to small group and individual professional development workshops and conferences. The district also provides professional learning community opportunities to support and enhance articulations, trainings, and other enriching collaborative efforts that will support and enhance instruction and educational services. These opportunities go beyond compliance requirements, extending to include areas identified as in need of support or deemed desirable through faculty and staff survey.
