



Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.



ML teachers support our English Language Learners with language acquisition. Federal Title funds are used to provide additional support to this subset of students during the summer. Special Education Teachers, Child Study Team Members, and Related Service Providers support students with specialized needs. Academic Support teachers provide additional direct support for struggling students. Intervention and referral services designed to assist students who are experiencing learning, behavior, or health difficulties.



The middle school Counseling Department collaborates with staff about the benefits of SEL and its positive impact to student performance. The middle school Advisory program creates an environment that focuses on social and emotional learning and building meaningful relationships to enhance the school climate and, as a result, student learning. The middle school counseling department partners with the physical education/health department to deliver mental health and wellness education throughout the school year to grades 6-8. Health and Wellness continues to be a focal point within the high school community. Guidance offers several programs annually that focus on a wide range of mental health issues, several new clubs related to health and wellness have been added, and the physical education and health department continues to shift to a lifetime fitness model for our older students, highlighted by our mountain biking unit.

In January 2021, the district administered a survey to the stakeholders at each school in the community for first time in recent memory to gather feedback on climate and culture. The district serves approximately 2,800 students and includes four K-5 neighborhood elementary schools, a 6-8 middle school, and a 9-12 Jr./Sr. High School. In December 2017, the community approved a referendum to create a 6-8 middle school. Construction began in 2019 and we officially transitioned our 8th grade to the Middle School in October 2020.

The high school Applied Technology department is continuing to integrate new opportunities for students.
