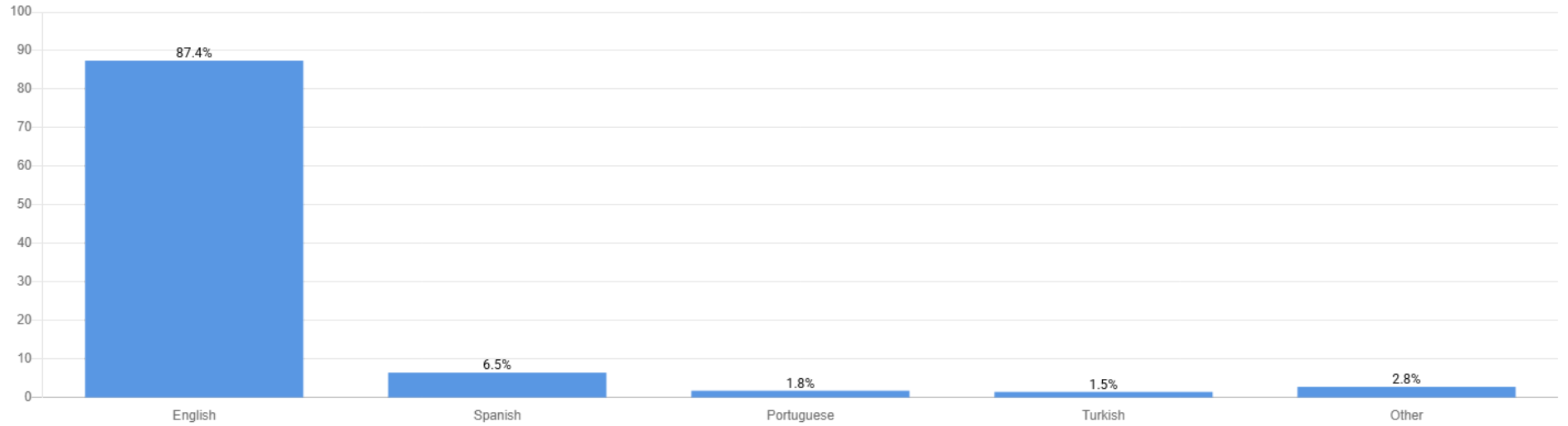

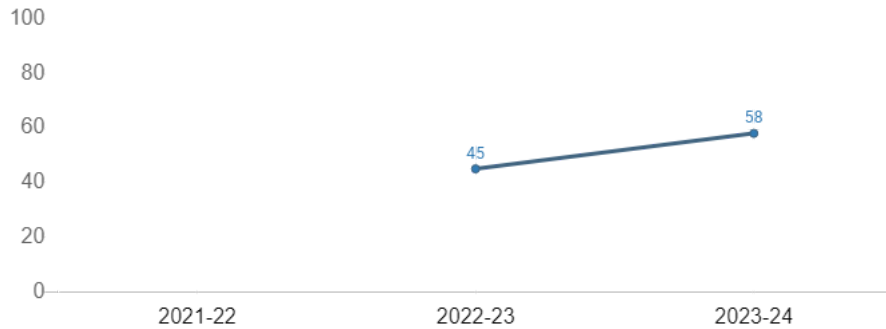

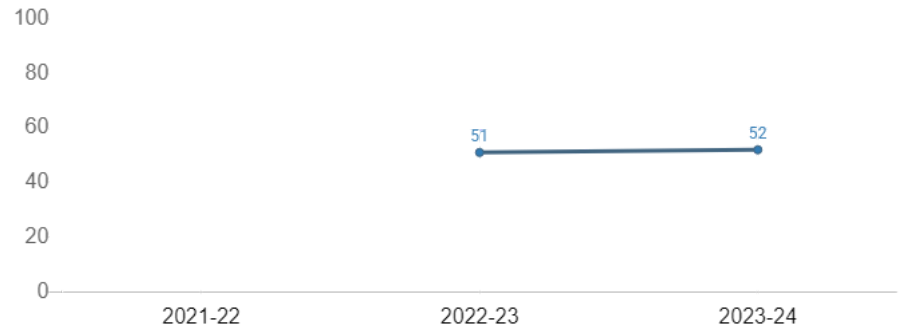

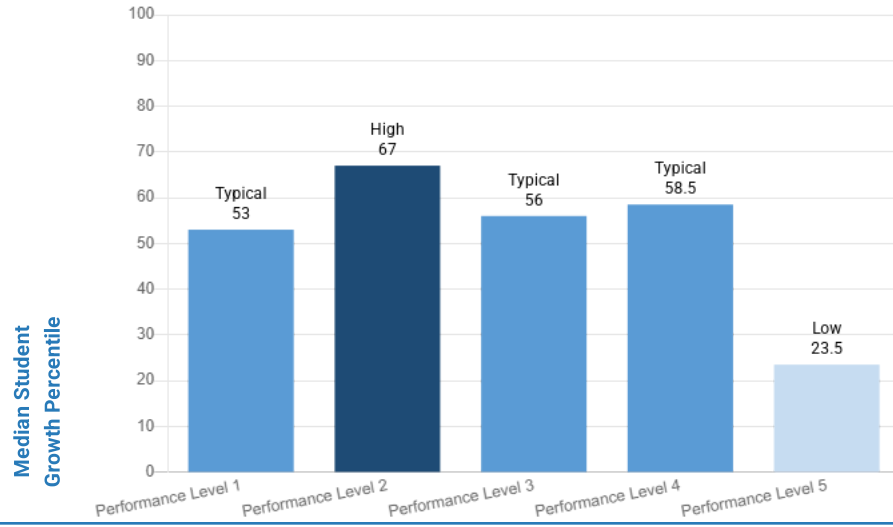

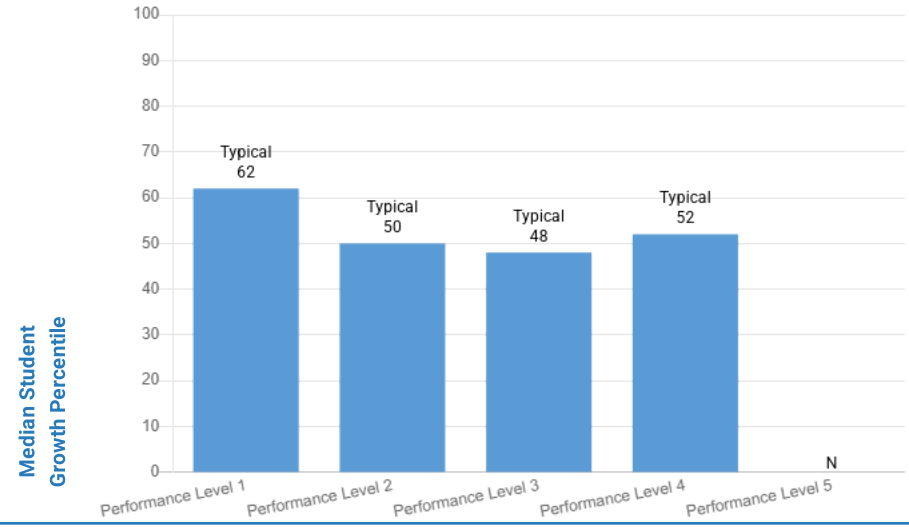

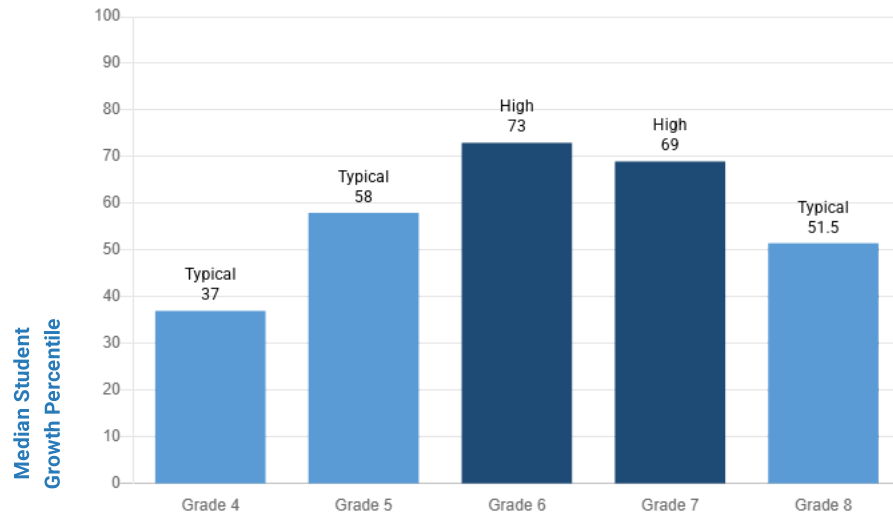

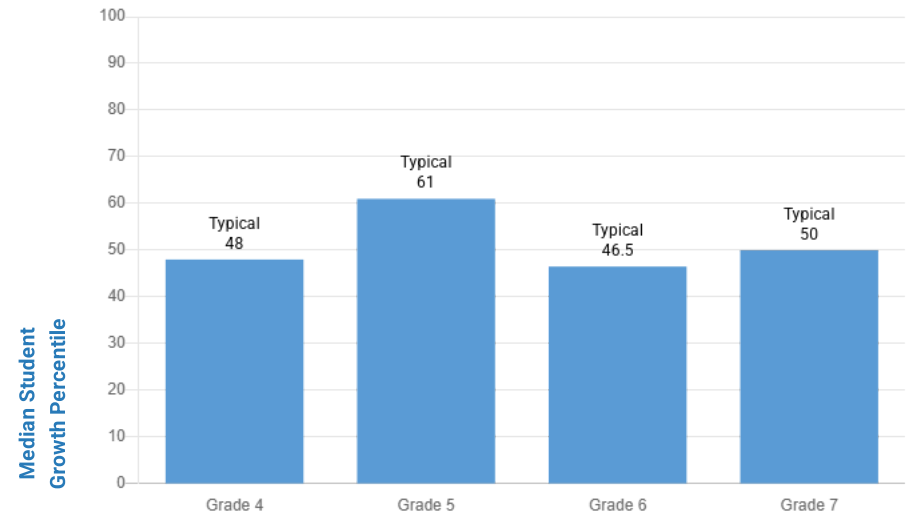

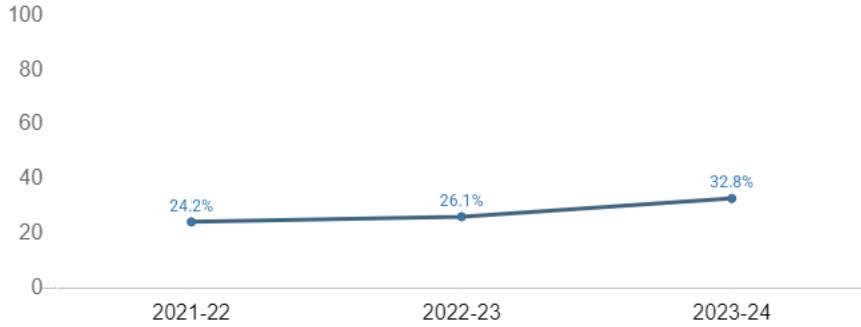

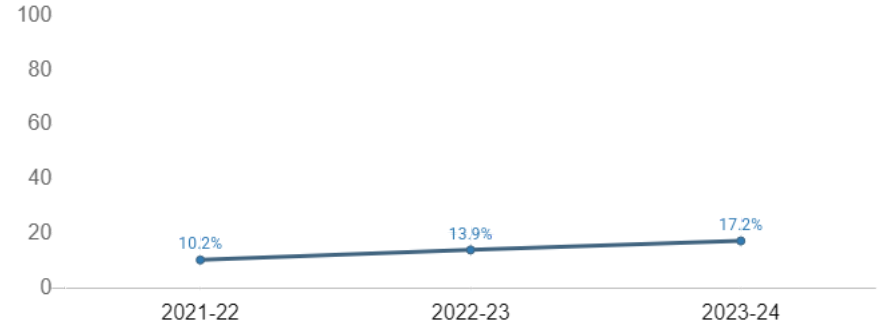
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 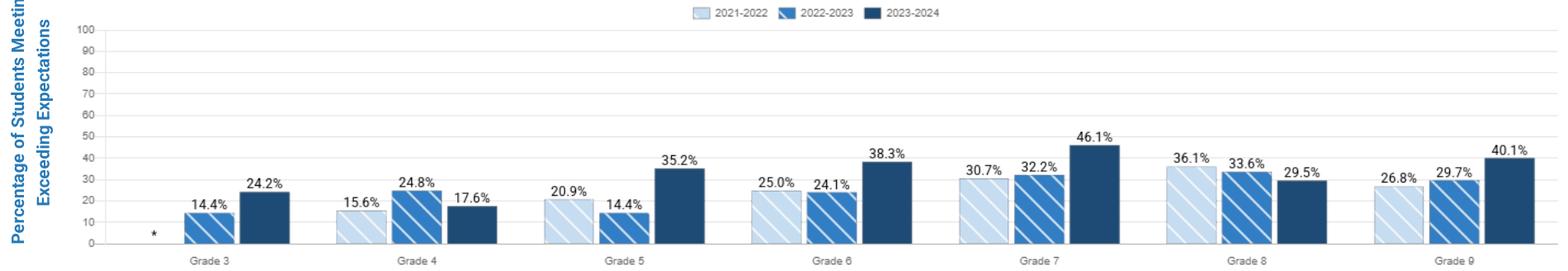

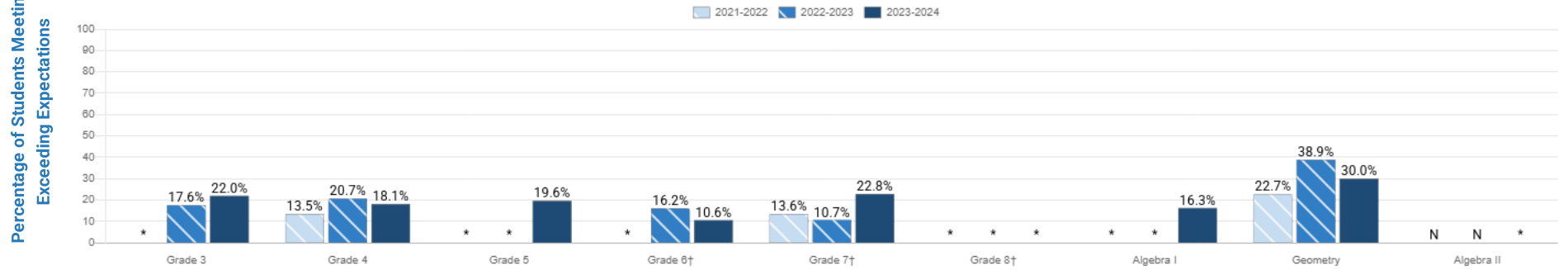

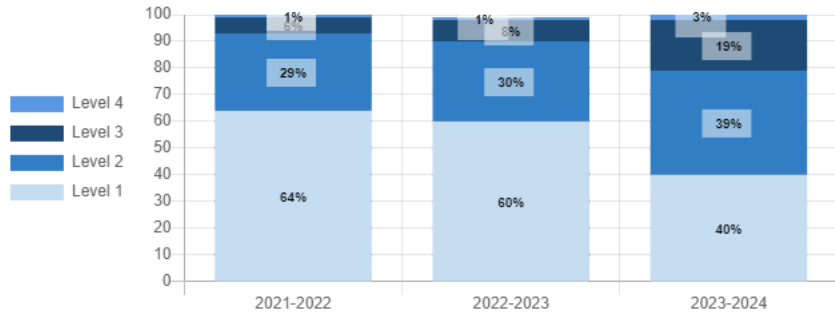

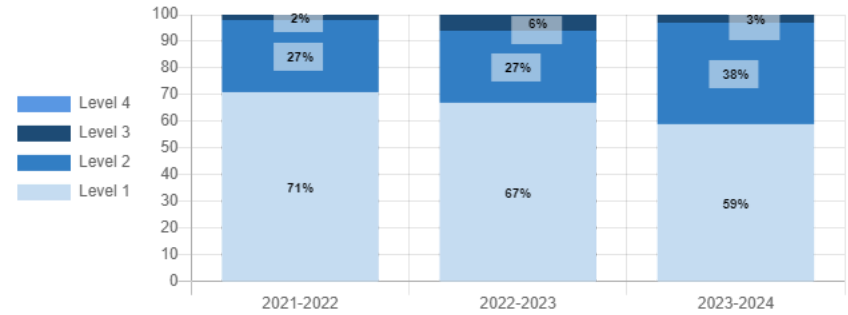
NJSLA Science Assessment: Grade 5 Summary

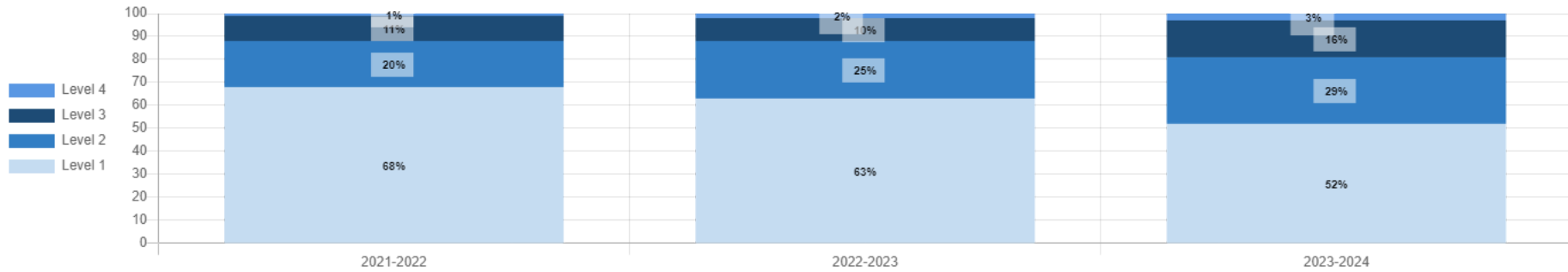

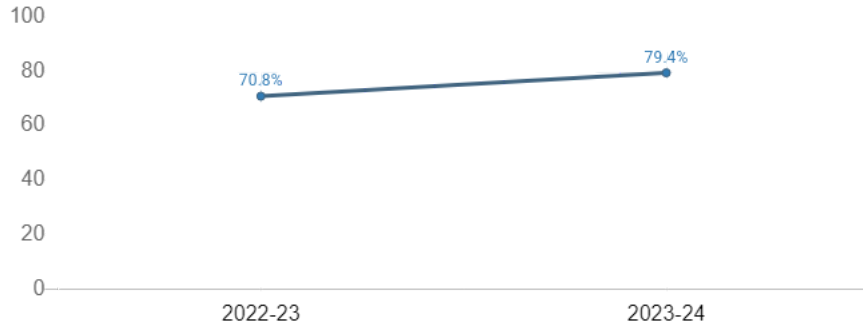

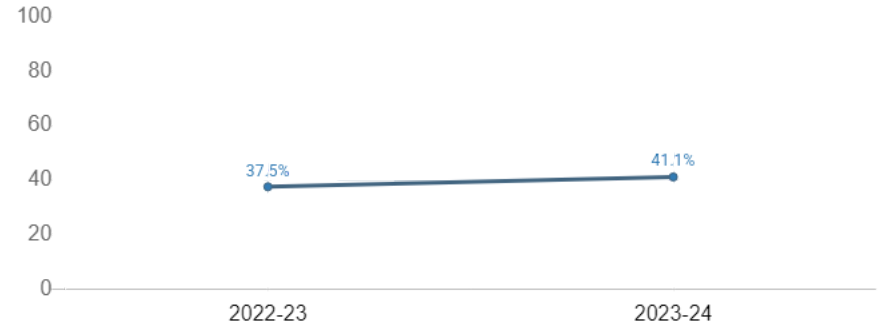

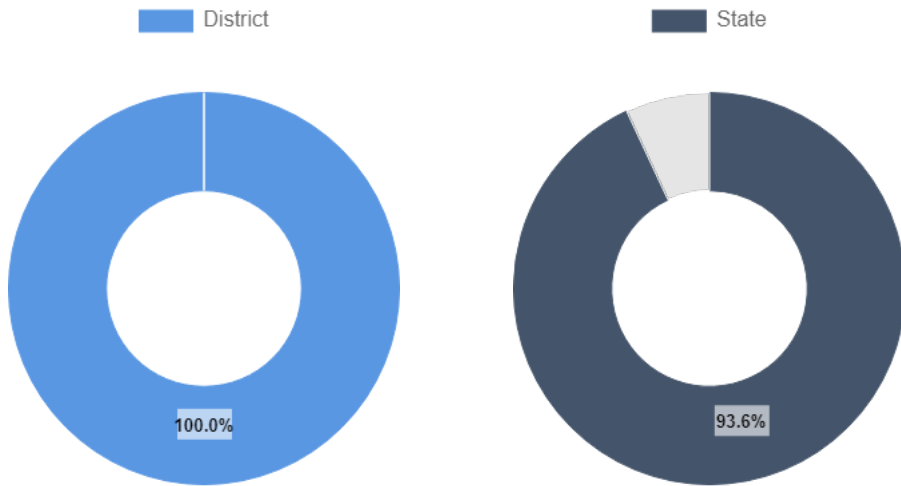

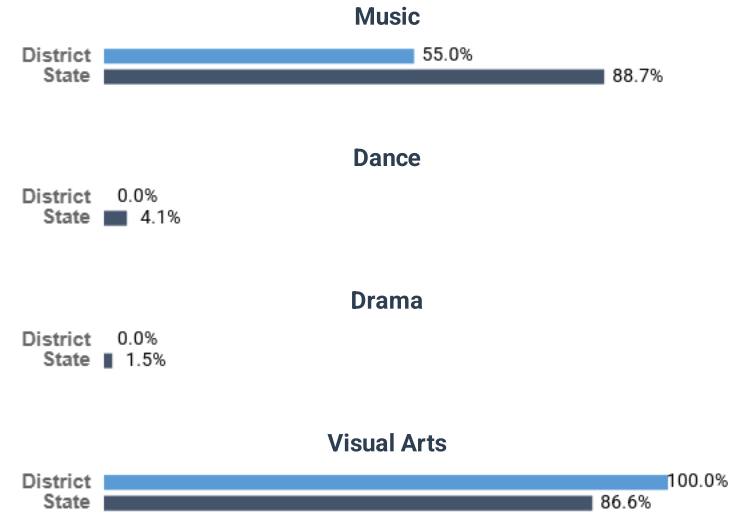

Students enrolled in one or more classes by discipline:



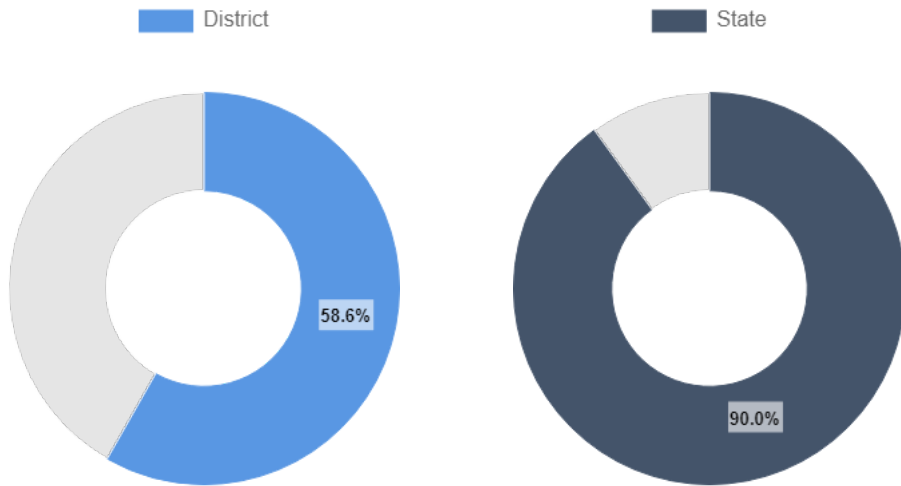

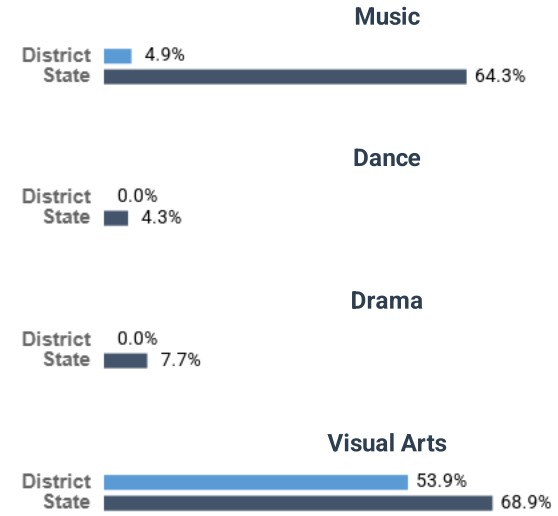

Students enrolled in one or more classes by discipline:



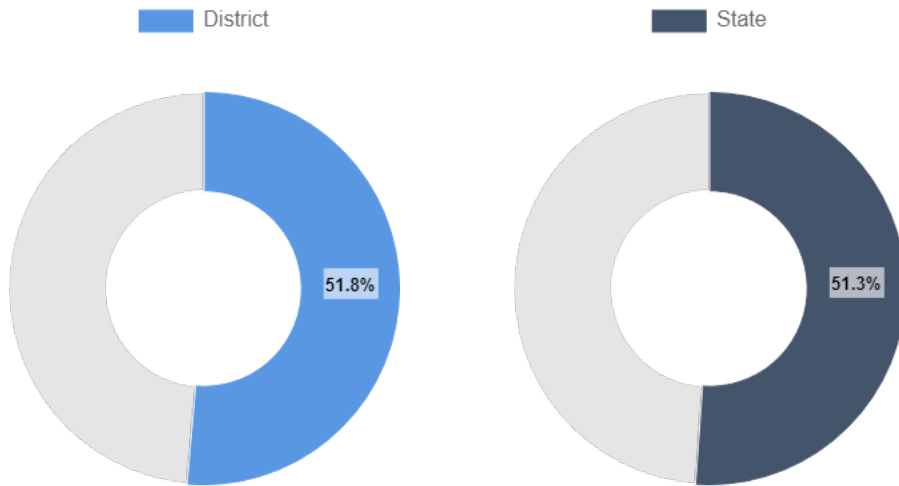

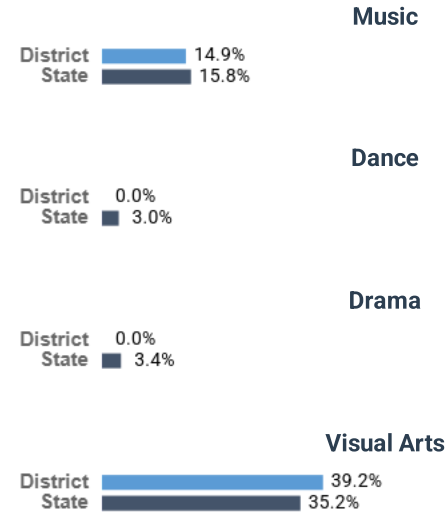

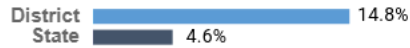

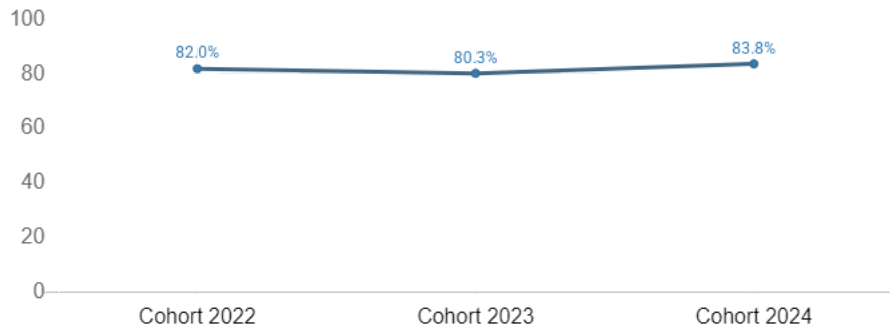

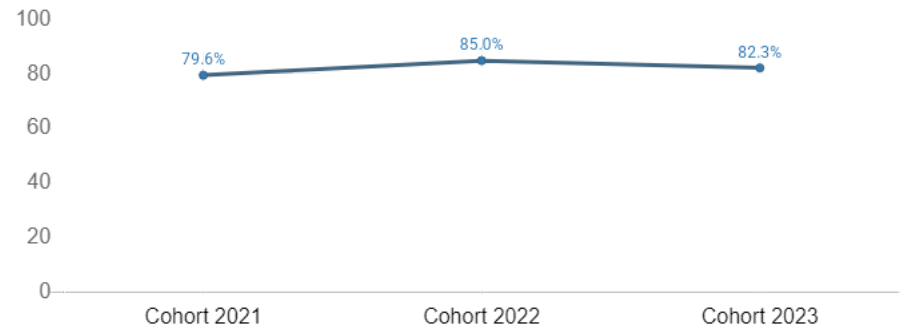

Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have meet state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

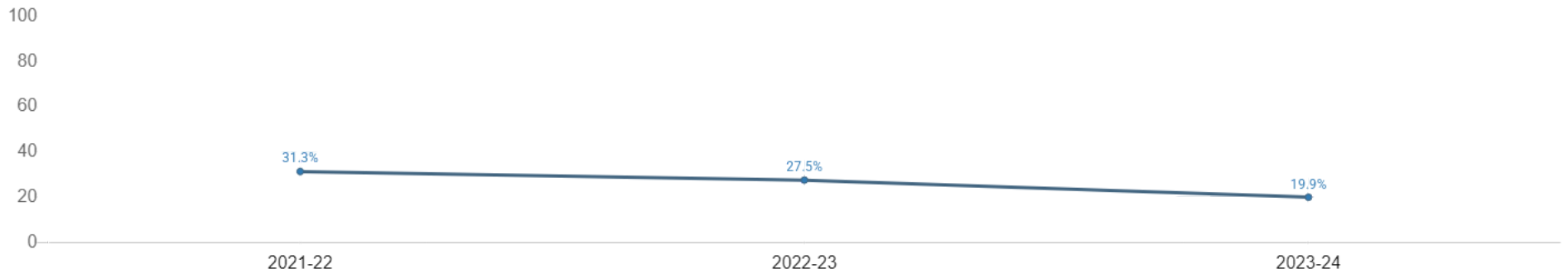

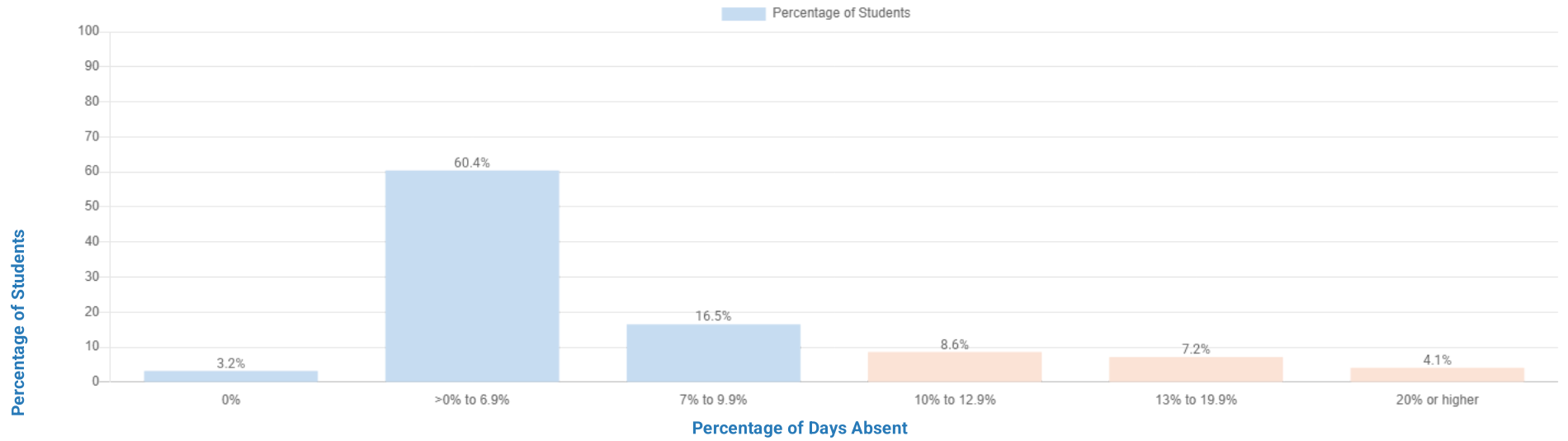

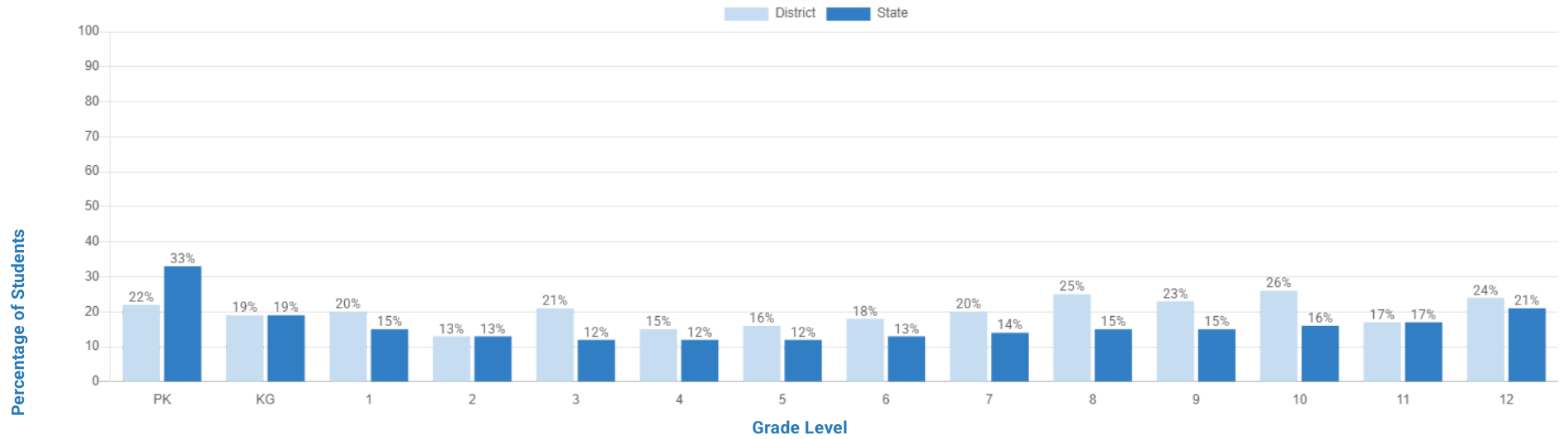

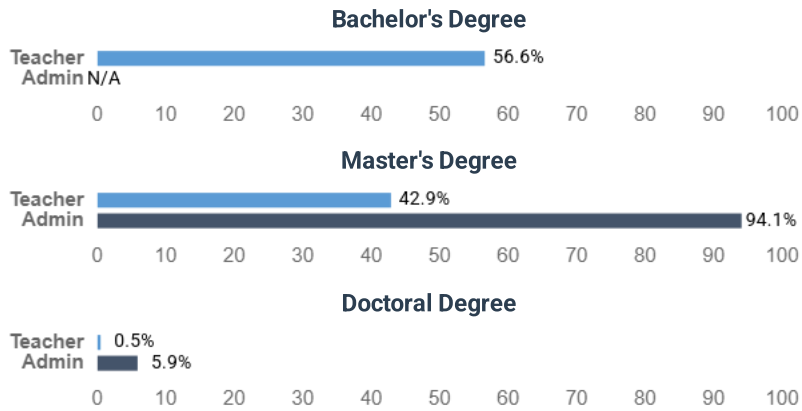

Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

 - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

Awards, Recognition, Accomplishments:

Burlington City School District was selected as a NJDOE as a Lighthouse Award recipient for making significant progress in working with diverse groups of learners, specifically for increasing equity in postsecondary enrollment. Athletic programs continue to grow with increased participation rates and sports available (especially in middle grades) Our Preschool Program is a 5-Star rated Early Childhood Center. The City of Burlington was also proud to have one of our teachers chosen as Burlington County Teacher of the Year for 2022-2023.



Courses, Curriculum, Instruction:

The District boasts a robust and comprehensive curriculum aligned to the NJSLs that has been developed and continually updated to include differentiation through modifications and enrichment opportunities. Learning success begins in our incredible early childhood program, which provides a strong foundation for long term academic growth and success, through our rigorous high school curriculum, which includes varied elective and AP opportunities as dual-credit enrollment courses, and the continuation of the P-TECH Academy.

Staff and Professional Learning:

Staff members are encouraged to continue their professional growth and model a goal of life-long learning for our students. These efforts are cultivated through a myriad of internal and external professional development opportunities including District-wide in-service sessions, building-wide training activities, external professional workshops, and online training opportunities. In addition to these opportunities, there are also several district-wide professional learning communities (PLCs) such as a Math PLC, Literacy PLC, Science PLC, Equity PLC, Technology PLC, and Special Education PLC, to name a few. Finally, staff members are encouraged to collaborate with peers and supervisors to enhance teaching and learning through common planning and grade level/department opportunities.



Student Supports and Services:

The City of Burlington Public Schools promotes that students learn at different rates and vary in their abilities to think abstractly or understand complex ideas. Multiple student support services are available, including but not limited to lunchtime/after-school tutoring, Intervention and Referral Services, as well as Child Study Team Services. The City of Burlington Public Schools strives to develop programs and improve instructional strategies that can address the variety of learning styles and interests for all students in the least restrictive environment. Comprehensive Special Education programs are provided to all identified students ages 3-21. In-class resource, pull-out resource, self-contained, and a combination of educational settings are available for students. A full-day alternative high school setting is available for students in grades 7-12 who have difficulty in the traditional high school setting. Gifted and talented assessment and programming are also available.



Student Health and Wellness:

Our district offers "Breakfast in the Classroom" in our elementary schools. Each of our schools follow the guidelines of the Healthy Hunger-Free Kids Act which is implemented by our food management provider. Students are offered various options for physical activity during recess from playing basketball to having fun on the playground.

Parent and Community Involvement:

Pre-pandemic, our District hosted two Family Fun Nights per year which engaged staff and families in theme based activities with food, games and prizes. We were able to host a Back-to-School Boardwalk bash which brought over 500 attendees to the District for family and community engagement. Attendees played games, won prizes, and received free back-to-school supplies. Our entire school community looks forward to these events. We have also hosted City Pride Partnership Breakfasts with local businesses and staff where career readiness is discussed and team building activities take place.



Facilities:

The District boasts state-of-the-art resources in the area of STEM. Every classroom has access to SMART Panels, iPads, laptops, or computer labs to interact actively with technology which enhances teaching and learning. Our District offers a 1:1 initiative for all students in preschool through grade 12, as well as a fully functional STEM Lab that supports flexible, technology-intense learning activities for all secondary grades and subject areas.



Attendance:

The Burlington City School District has emphasized reducing Chronic Absenteeism over the past two school years. Our District suffered from a drastic increase in Chronic Absenteeism coinciding with the COVID-19 Pandemic. The percentage between Burlington City and the state average grew from 2020 through 2023 to a 29% Chronic Absenteeism rate (versus a 16.6% statewide average). We implemented a detailed Chronic Absenteeism District Action Plan during the 2023 - 2024 school year. The District Attendance Team meets monthly to review school and District attendance data, identify trends, and brainstorm positive student incentives and proactive communication strategies for parents. The focus on attendance has led to excellent results, as the Chronic Absenteeism percentage decreased from 29% in June 2023 to 20.3% in June 2024. The start of the 2024 - 2025 school year shows promising results as we currently stand at a 13.36% Chronically Absent rate.

Other Information:

The City of Burlington Public School District includes Samuel Smith School (Preschool to Grade 2); Captain James Lawrence School (kindergarten to Grade 2); Wilbur Watts Intermediate School (Grades 3 to 6); and Burlington City High School (Grades 7 to 12). Our total student enrollment of over 1,800 students includes students age three through Grade 12. The District has an exceptional early childhood education program and is proud to offer residents of the community access to a high quality full day program for three and four year old residents in the Early Childhood Center at Samuel Smith School. Likewise, the full day kindergarten program provides a strong foundation for student academic growth. The City of Burlington Public School District continuously analyzes available data, both quantitative and qualitative, with regard to student academic, affective, and staff wants, needs, and achievements. The regular meeting of PLCs in the areas of Math, ELA, Science, Social Studies, and Instructional Best Practices allow targeted group examination of relevant data, discussion of pertinent topics, and brainstorming for continued improvement. This collaborative reflection extends into Administrative PLCs focusing on community engagement, curriculum, Achieve NJ implementation, and Title One support. This committee level analysis of data allows for informed decision-making at district, building, and team levels. Data, specifically state and national assessment results, are shared with students, staff, and the community. Programs are revised to meet the changing needs of the students, the advancement of the standards, and the changing world of technology.
