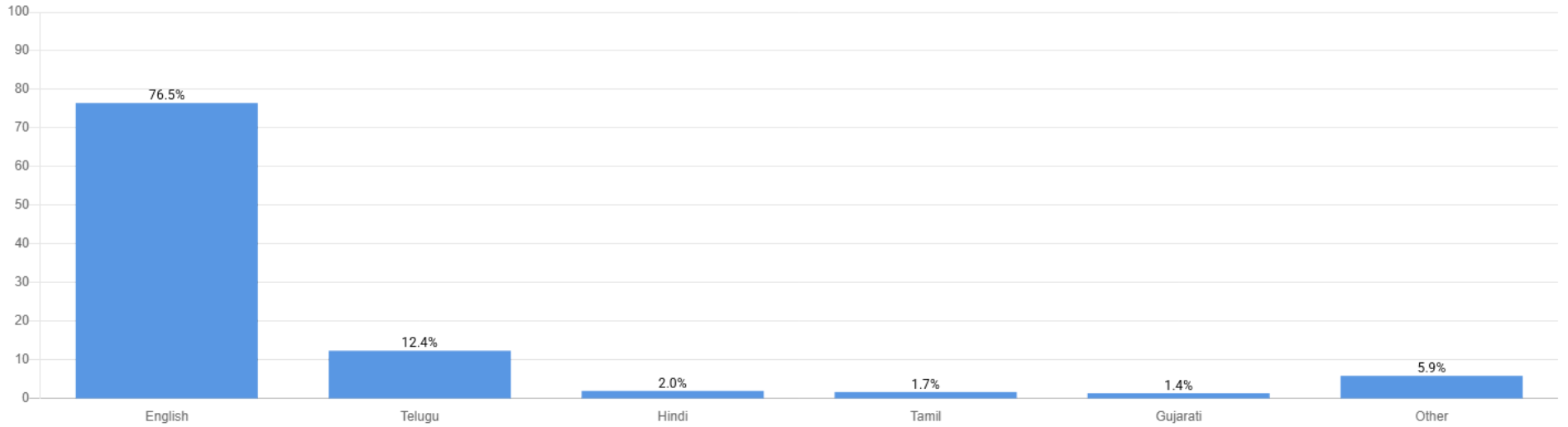

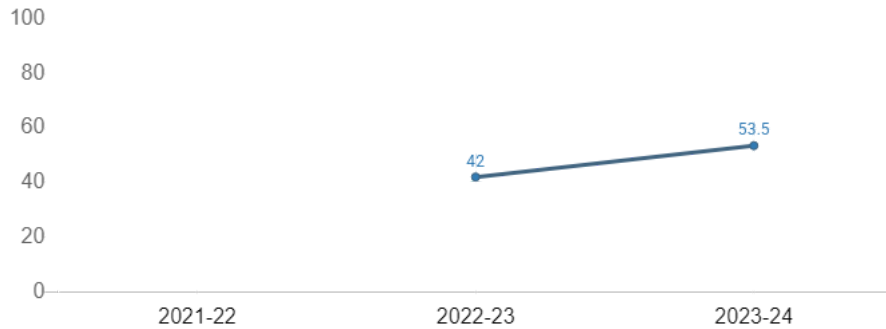

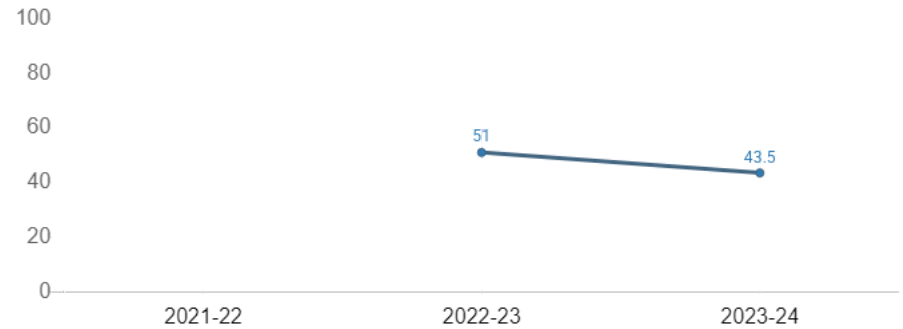

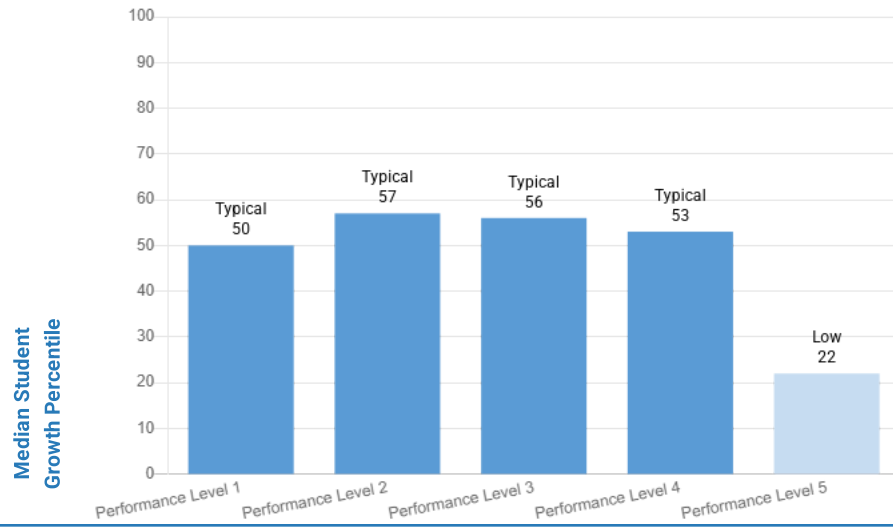

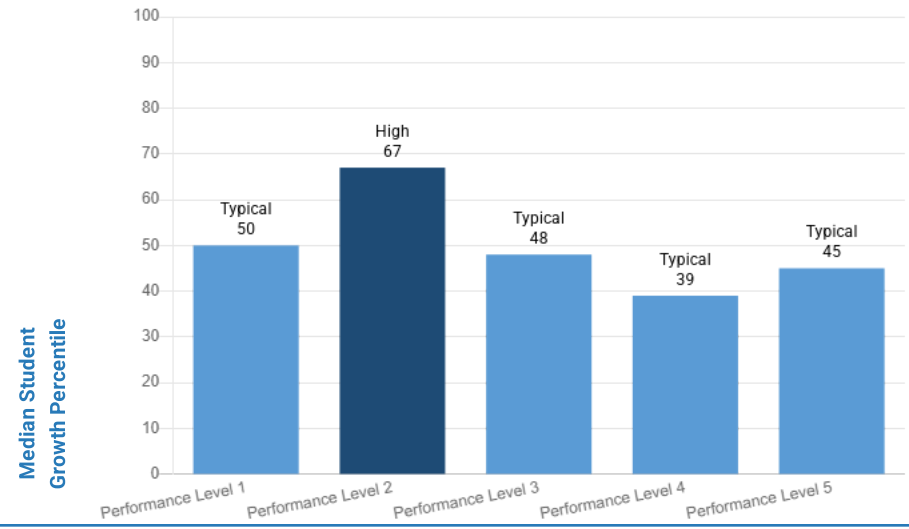

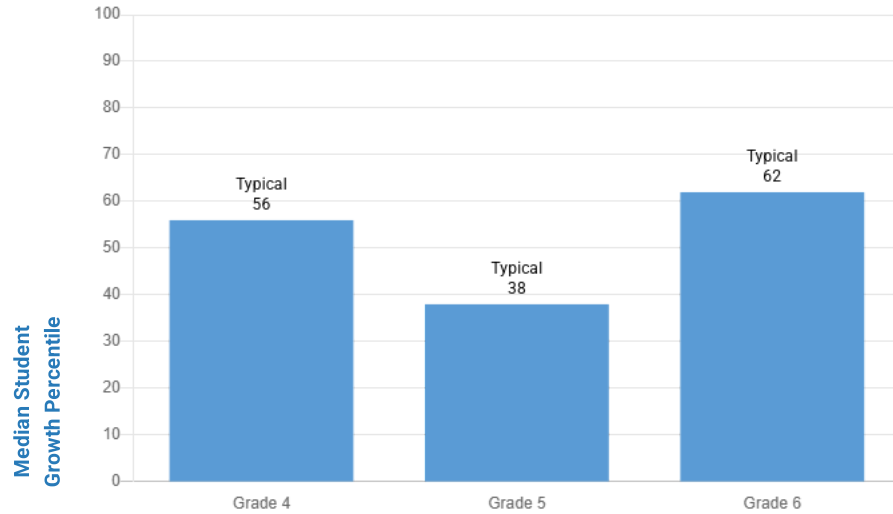

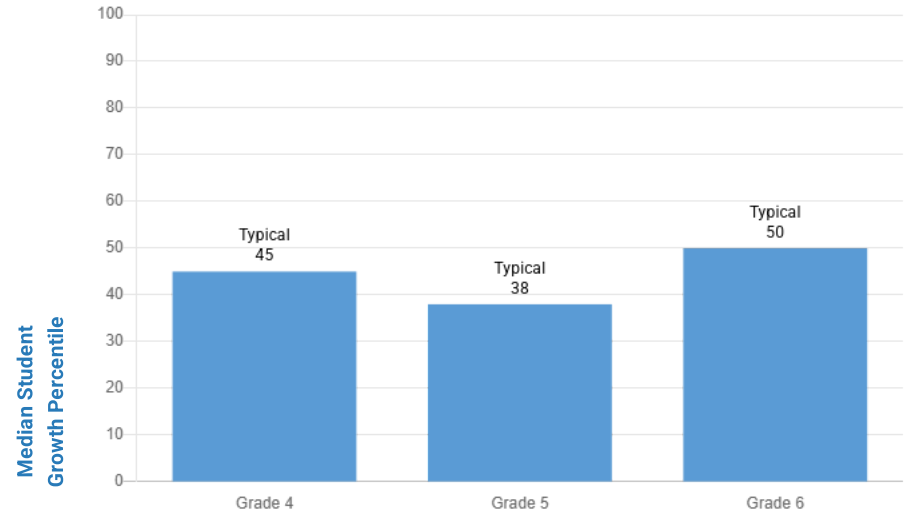

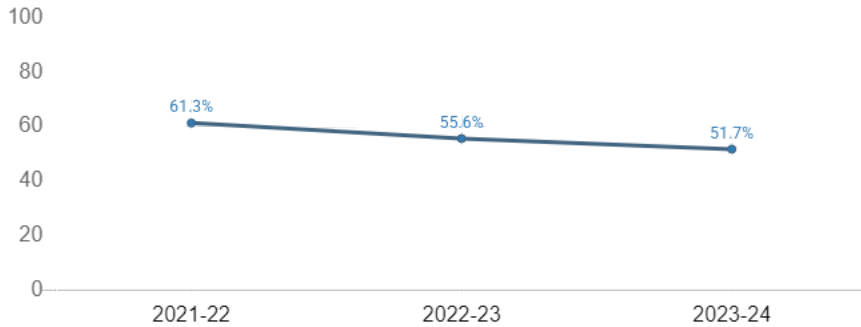

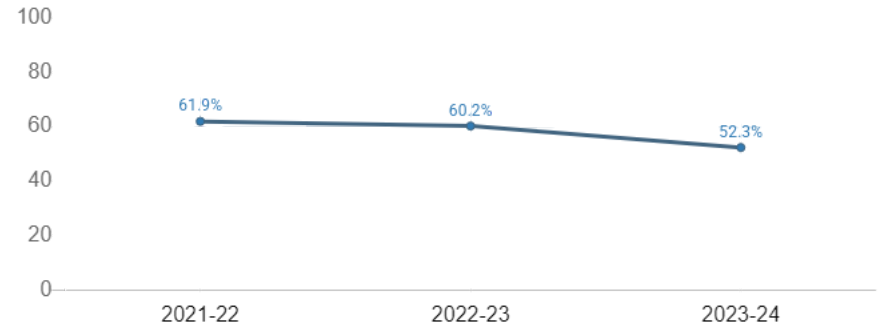
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 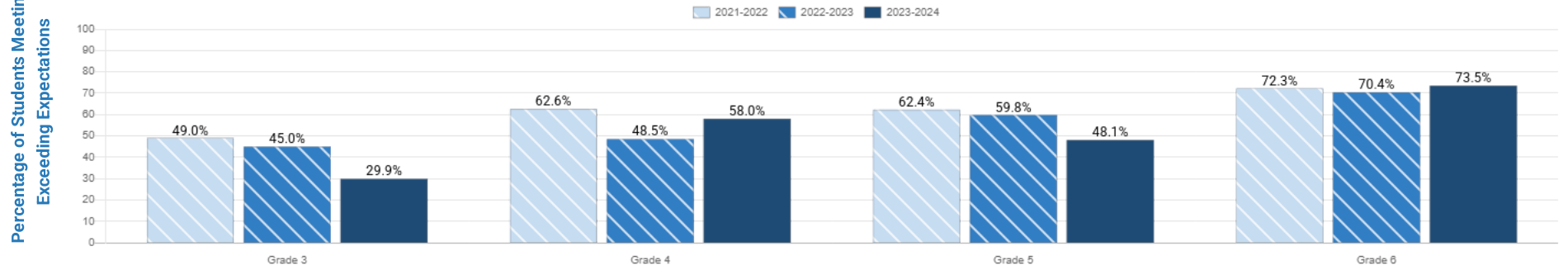

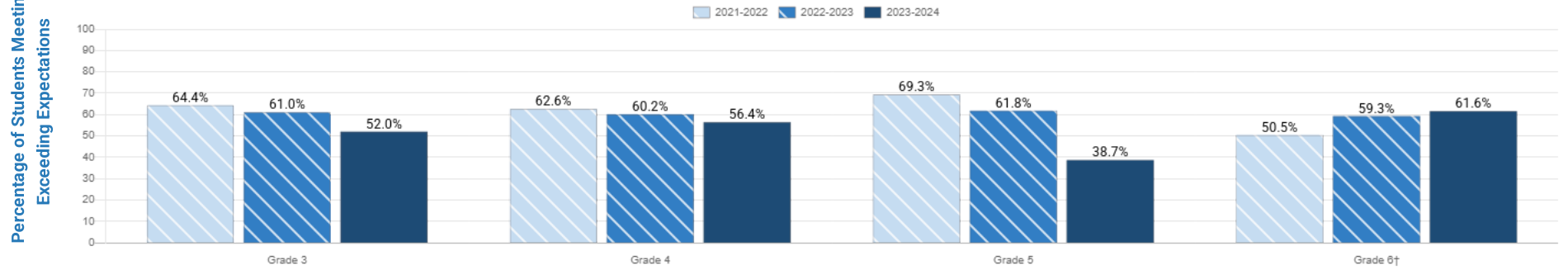

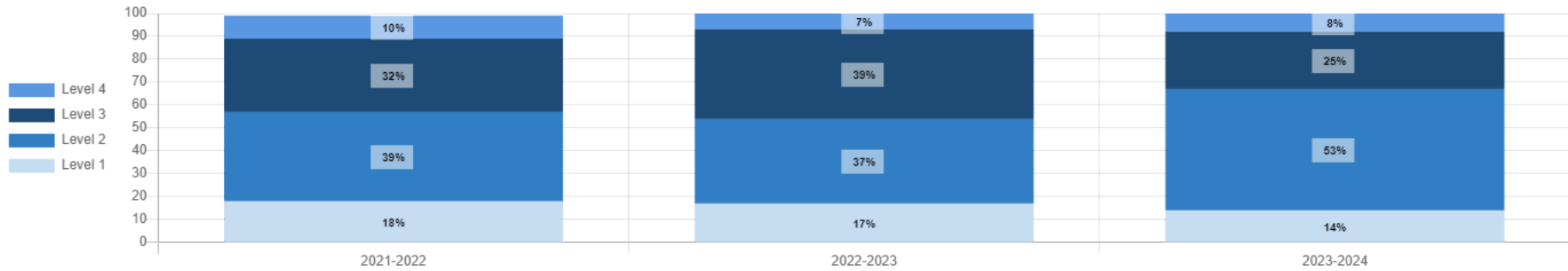

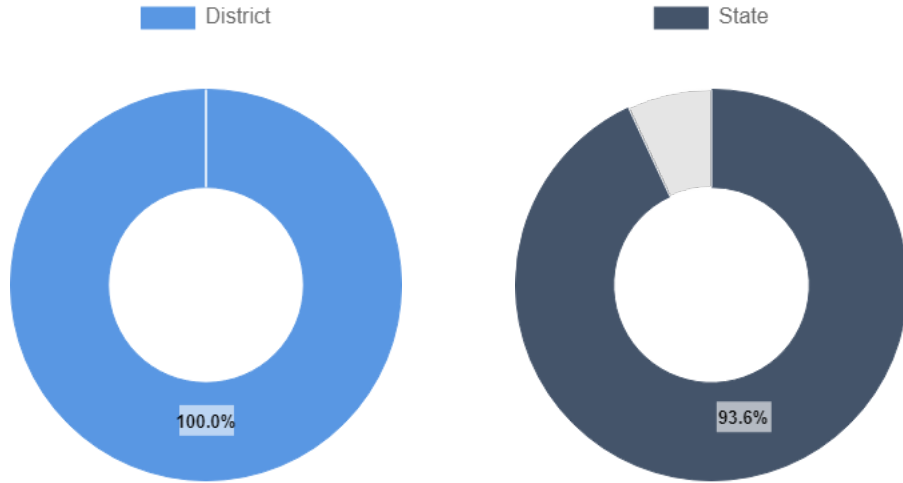

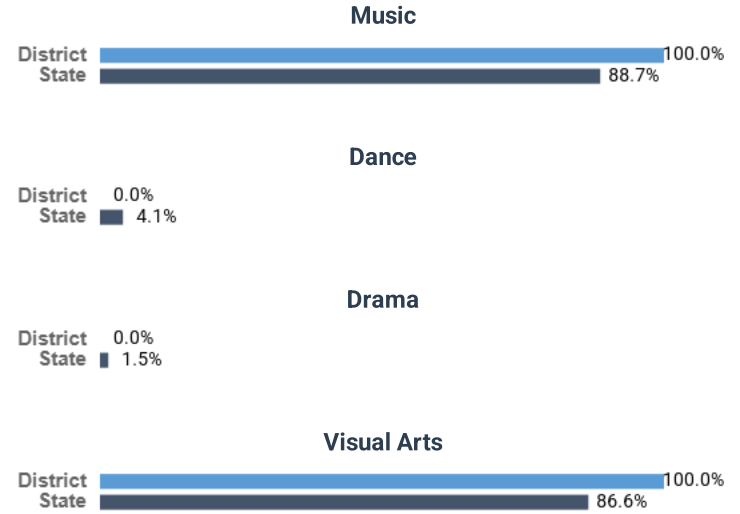

Students enrolled in one or more classes by discipline:



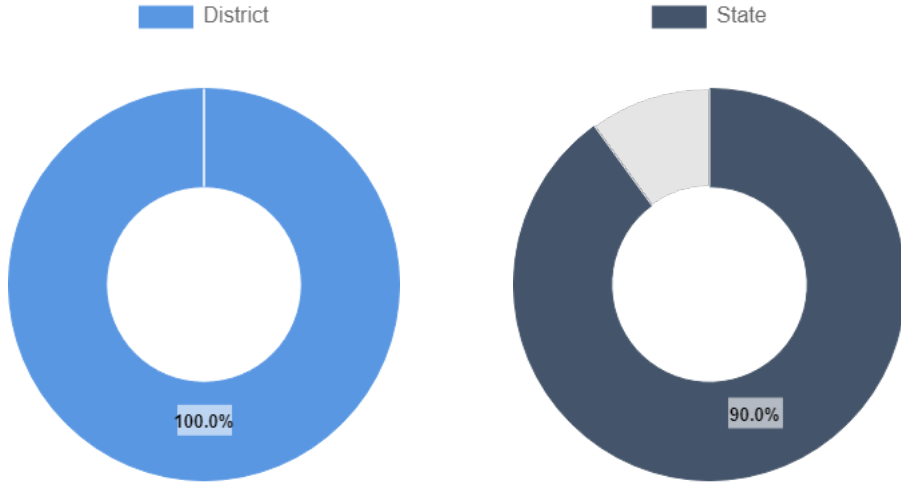

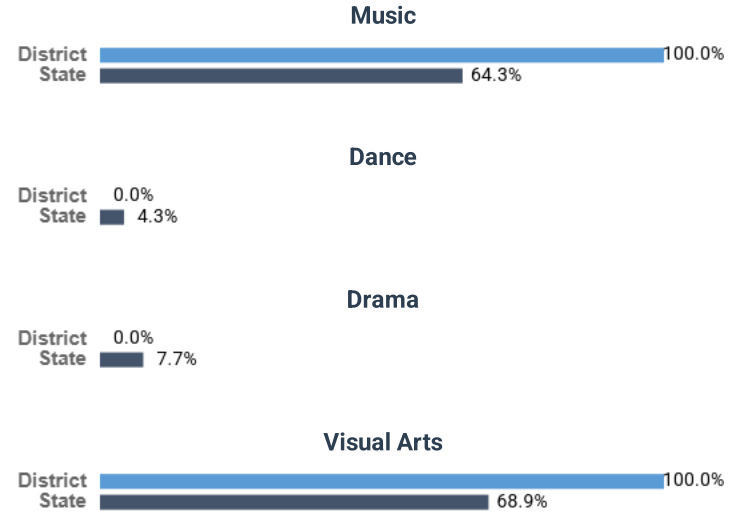

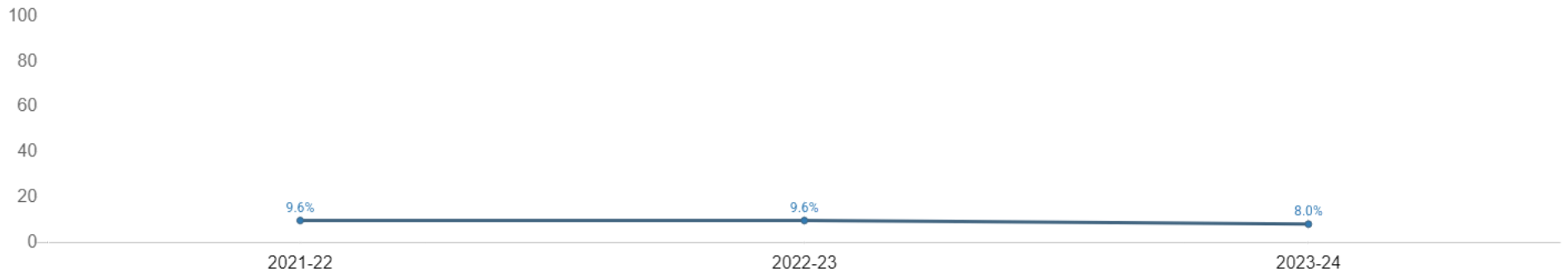

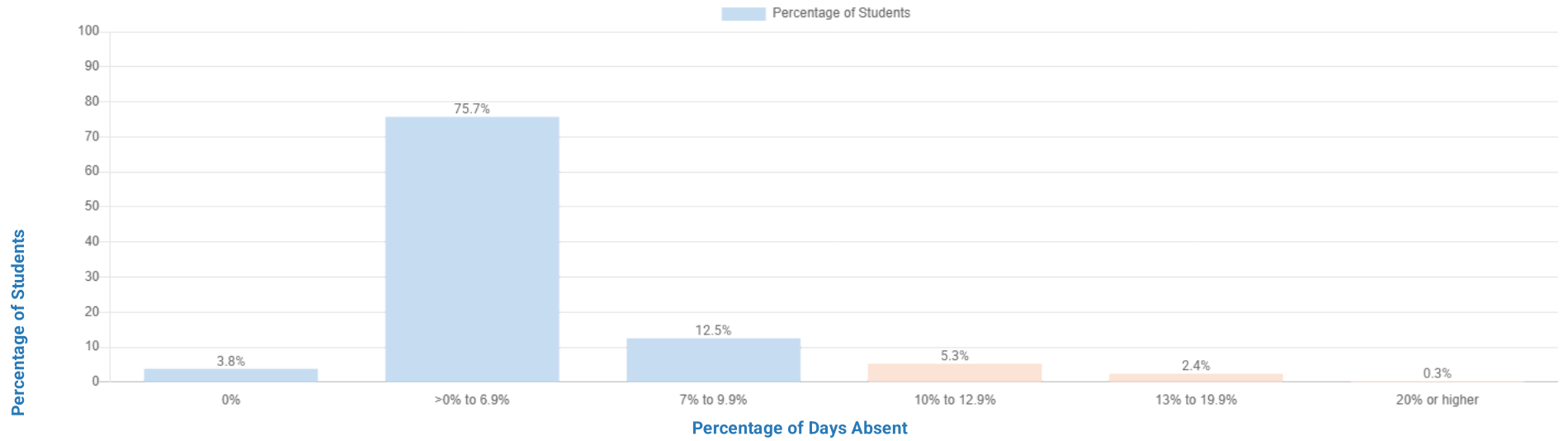

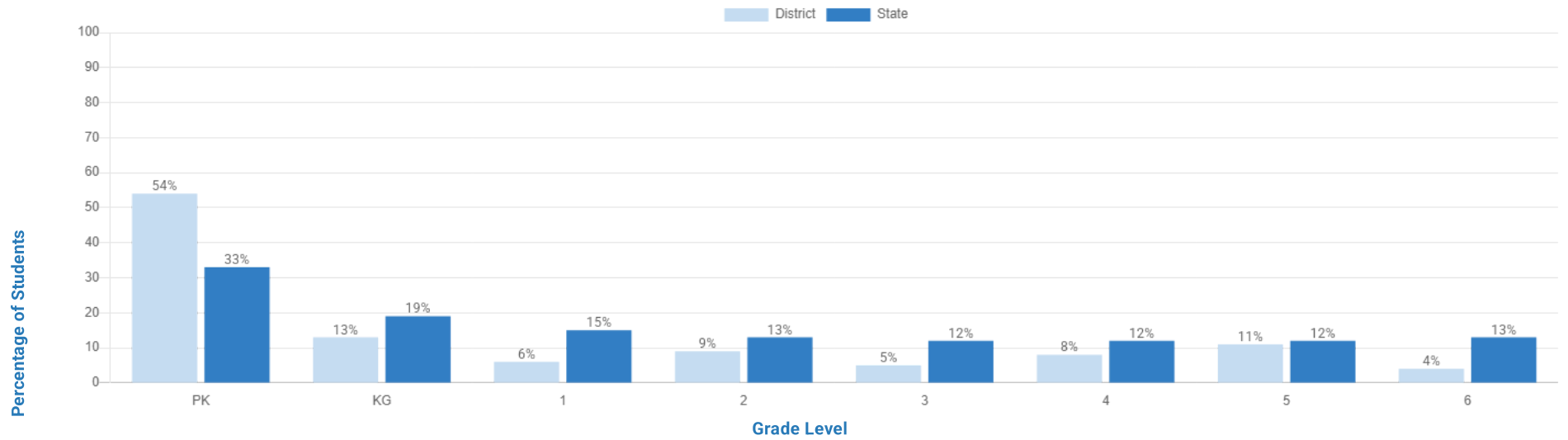

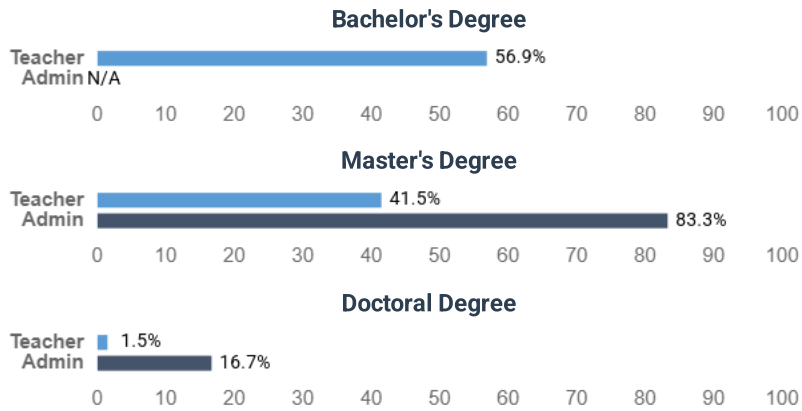

Courses, Curriculum, Instruction:

The Chesterfield Township School District has established an aggressive 5-Year Curriculum Plan that guides all curriculum work in the district. The district provides students with research-based curricula to meet the various needs of all learners in all content areas. This year we implemented our new math curriculum and resources and continued a focus on the ELA curriculum based on the Science of Reading. All curriculum work is supported through continued professional development on best practices in instruction.



Clubs and Activities:

Students attending Chesterfield Township Elementary School have a plethora of activities to choose from that take place during and after the school day. Activities include: After School Clubs Program, Peer Mediation, Chorus, Instrumental Music, Sixth Grade Safeties Program, School Play, Variety Show, Student Government and Students Advancing Kindness in Education (S.A.K.E.).



Before and After School Programs:

For parents who require child care before and after school hours, Chesterfield Elementary School contracts with the Champions Program for before and after school childcare. The Champions Program has served the district for over 9 years, and the program continues to grow each year.

Staff and Professional Learning:

The faculty and staff at Chesterfield Elementary School continue to grow as educators year after year. Professional development is offered to school faculty and staff in areas related to district initiatives. As a district we've found success working with facilitators and experts to provide training with each initiative. With the implementation of our new math curriculum, faculty continued to participate in professional development focused on best practices in math instruction. All staff continue to participate in professional development based on our equity initiative with a focus on instructional materials and ensuring our students see themselves in our instructional resources. This year we also maintained a focus on teacher evaluation and how to improve the process to best support each faculty member's professional growth.



Student Supports and Services:

Chesterfield Elementary School continues to work to refine our approach to provide the most effective academic, social, and emotional support services to our students with needs. This year we began the process of developing a multi-tiered system of supports and began the transition to using the MTSS structure. We also continue to expand our co-teaching model at each grade level. The co-teaching model allows the staff to provide students with services in the least restrictive environment. The district hosts two multi-disabled programs to meet the needs of our students with special needs, and faculty and staff participate in training on special programs to meet the diverse needs of our students.



Student Health and Wellness:

Students participate in health and physical education classes twice every 6-day cycle. In addition, students are given 25 minutes for recess each day. To support the physical, social, and emotional health of our students, teachers schedule "brain breaks" throughout the school day in addition to special programs such as the Chesterfield Public Education Fund sponsored Fun Run. The District also employs a second school social worker who works collaboratively with our two school counselors to support the mental health of our students.

Chesterfield Elementary School benefits from the support of a highly involved PTA and educational fund. Both groups use proceeds to support programs and provide support that directly impacts students in the classroom. The PTA Blingo and the CPEF Fun Run are two of our largest events each year. Chesterfield Elementary School uses the Genesis Student Database and allows parents to access the system through the parent portal which can be found on the district website. Parents have opportunities to learn about our school through parent nights and open forums. Parents also serve on several district-wide and school-wide committees.

Facilities:

Chesterfield Elementary School is a beautiful building in the heart of a residential development. Across from the school is the Village Square where both school and local events are held. As part of our technology plan, the district continues to expand the technology resources and our infrastructure. Currently, all students have access to a chromebook during the school day as part of our 1:1 device initiative. The school has dedicated rooms for all specialists including a technology lab. Our special services department has also developed two sensory rooms in the school for our special needs population. The school has a gymnasium, cafeteria, and specialized rooms such as a science lab. As part of a multi-year initiative, the District continues to upgrade our playground for the benefit of all students.

School Safety:

The Chesterfield School District has implemented several protocols to ensure the health and safety of all students, staff, and visitors. The District contracted with a private security company to audit security in the district which served as a springboard for additional improvements. The District also has a very involved local police department that supports the district in several areas, and officers are present in and around the school on a daily basis. The school also employs a full-time security officer who is present during the day as well as during school activities that take place outside the regular school day.



Technology and STEM:

Chesterfield Elementary School continues to invest in technology for our building as we work to provide our students with opportunities to grow in the area of technology. Part of that initiative includes the expansion of our Gifted and Talented Program. Students in grades K-6 have the opportunity to qualify for our pull-out G&T Program, but the program also offers an in-class model to reach all students. STEM carts provide teachers with resources for STEM lessons in the classroom.



Early Childhood Education:

The Chesterfield School District offers an integrated preschool program for students ages 3-4. The program includes a morning session from 8:35-11:15 AM and an afternoon session from 12:30-3:00 PM. The program is sponsored and run by district staff. As part of the Preschool Expansion Initiative sponsored by the State, the district plans to expand preschool opportunities in the 2024-2025 School Year.
