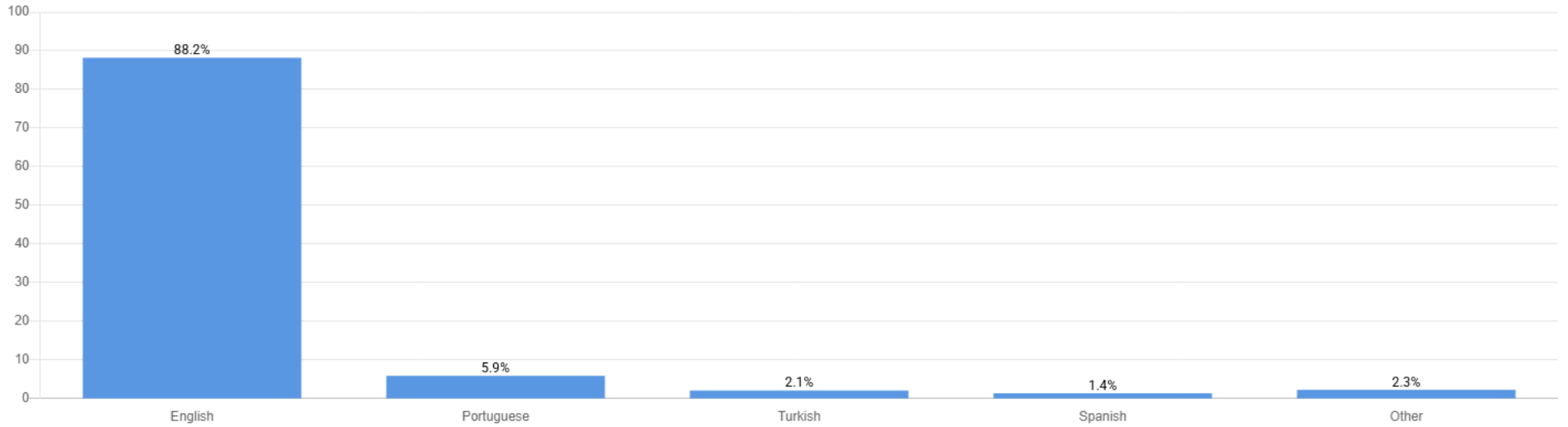

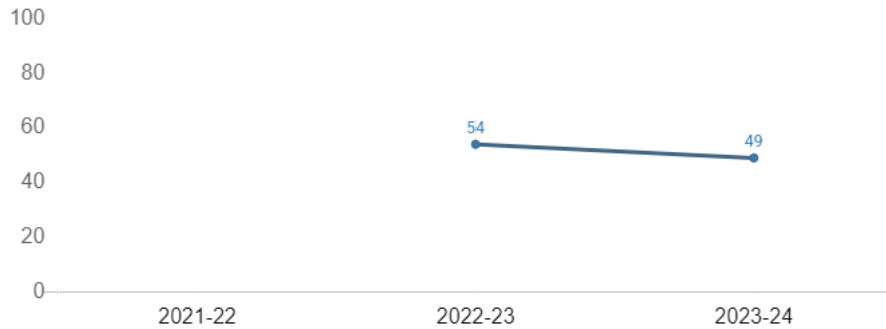

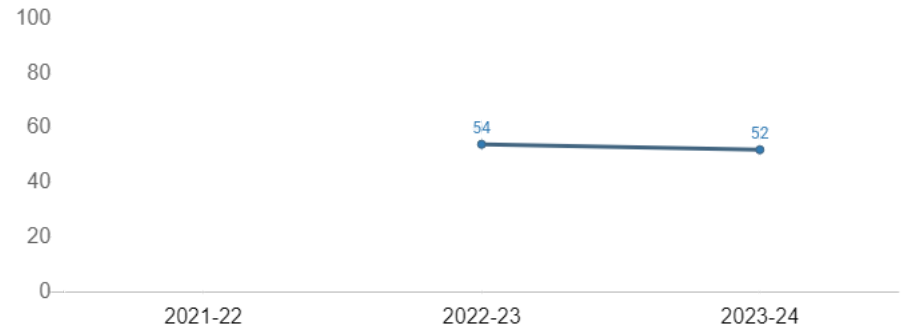

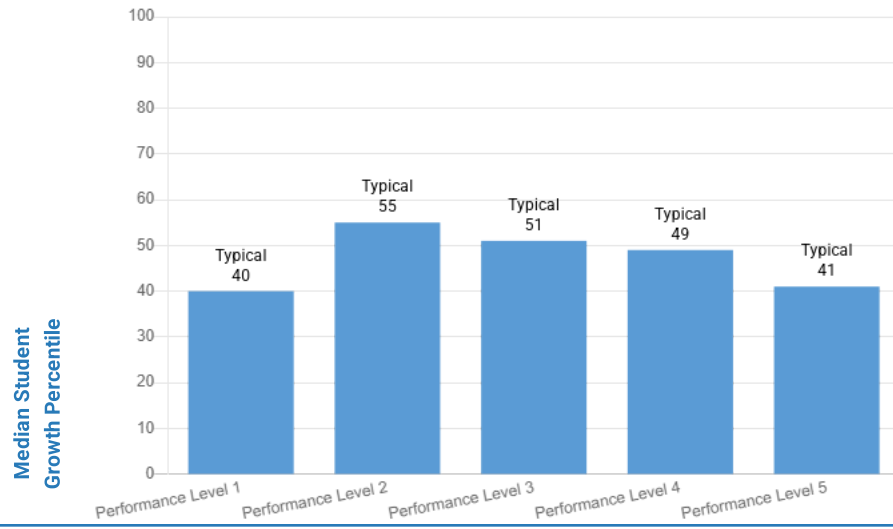

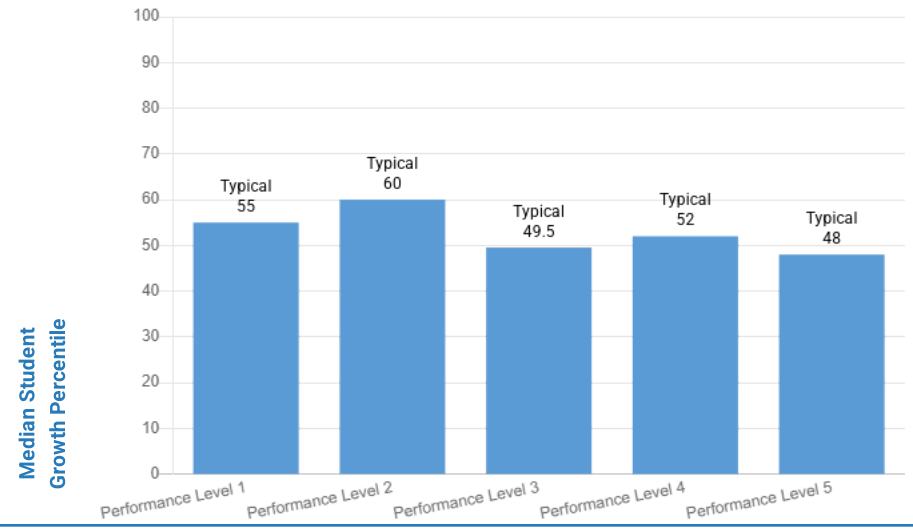

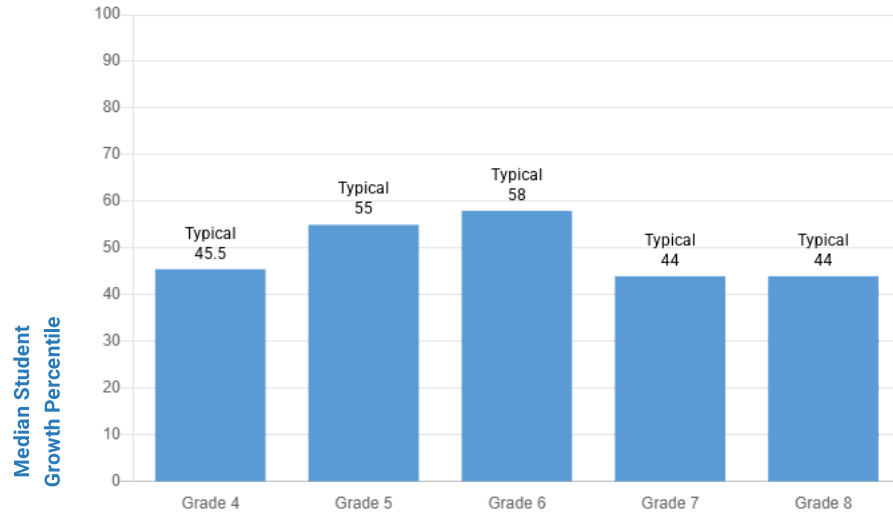

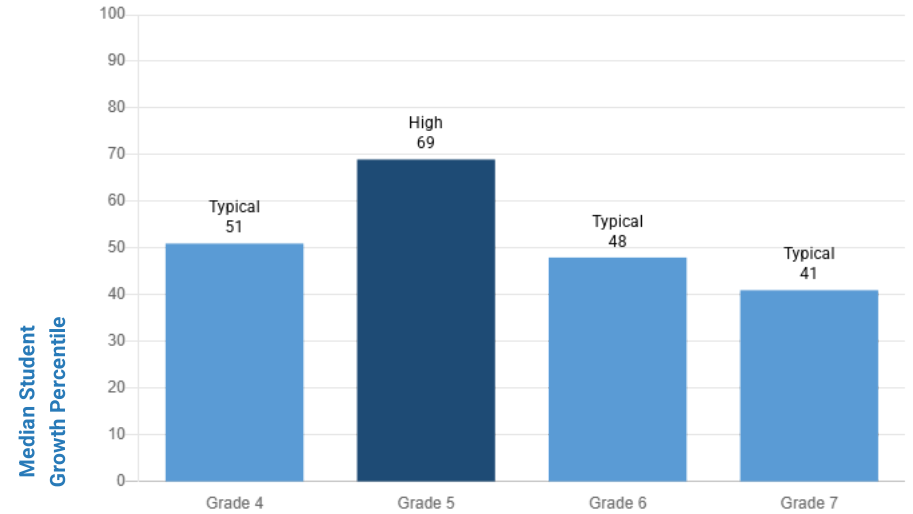

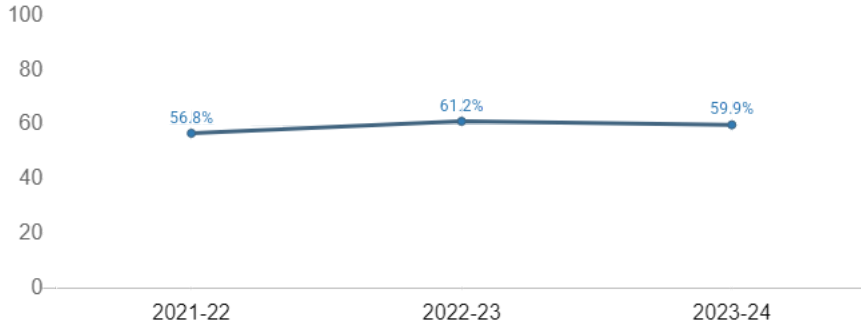

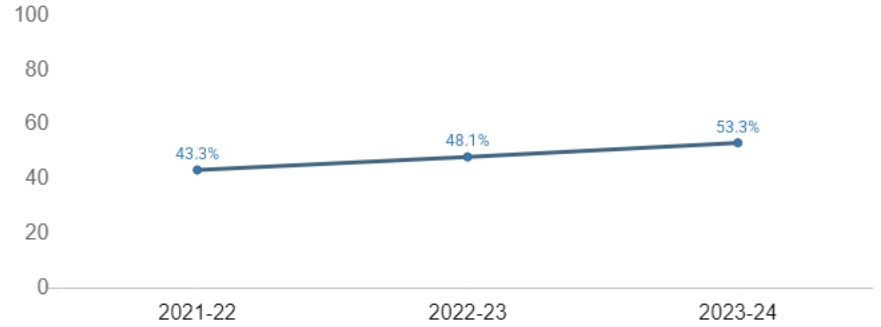
English Language Arts and Mathematics Performance Trends

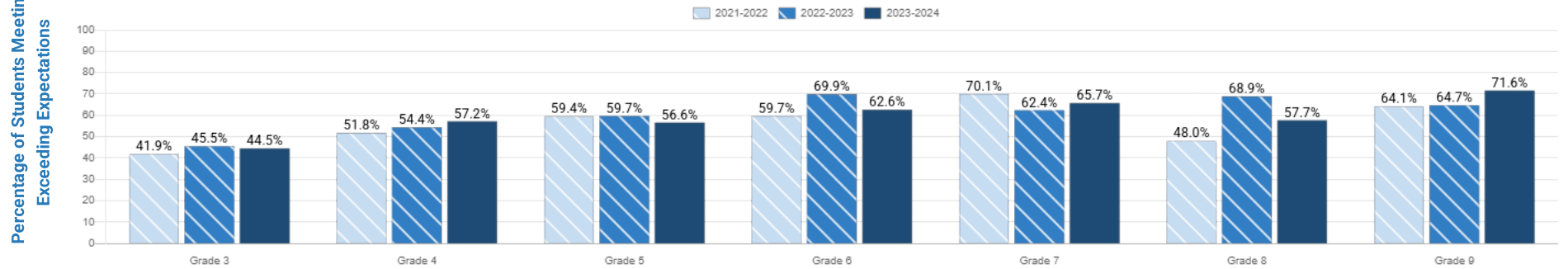

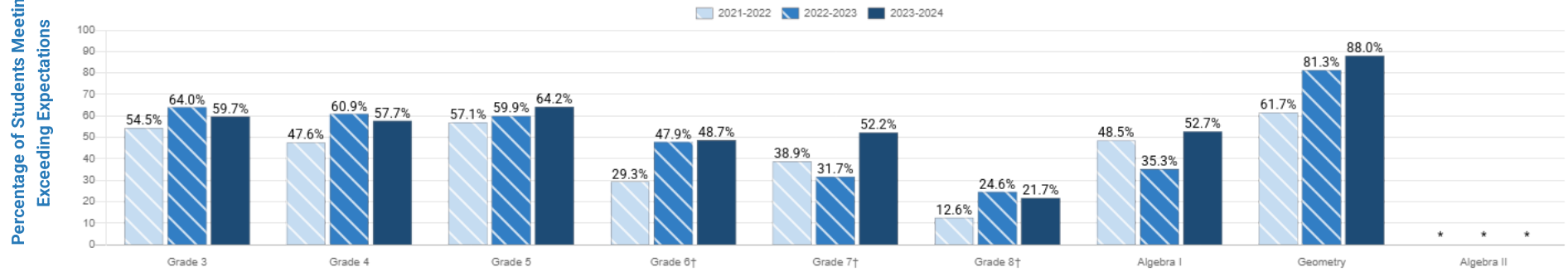

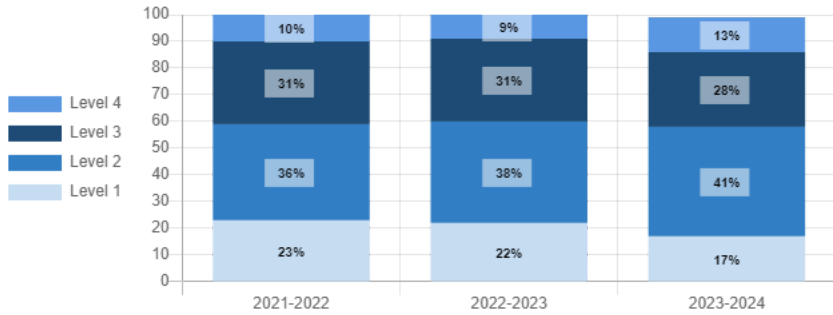

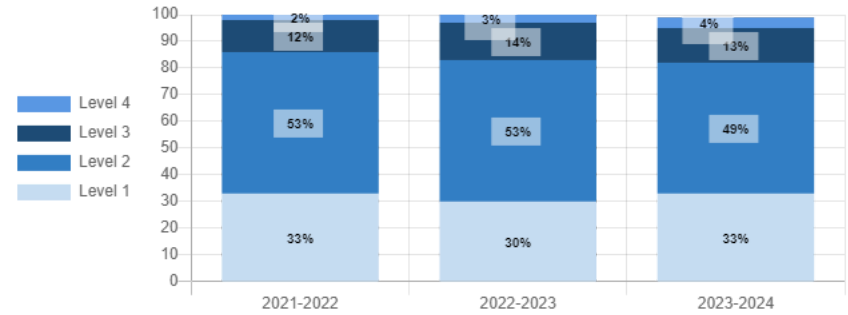
NJSLA Science Assessment: Grade 5 Summary

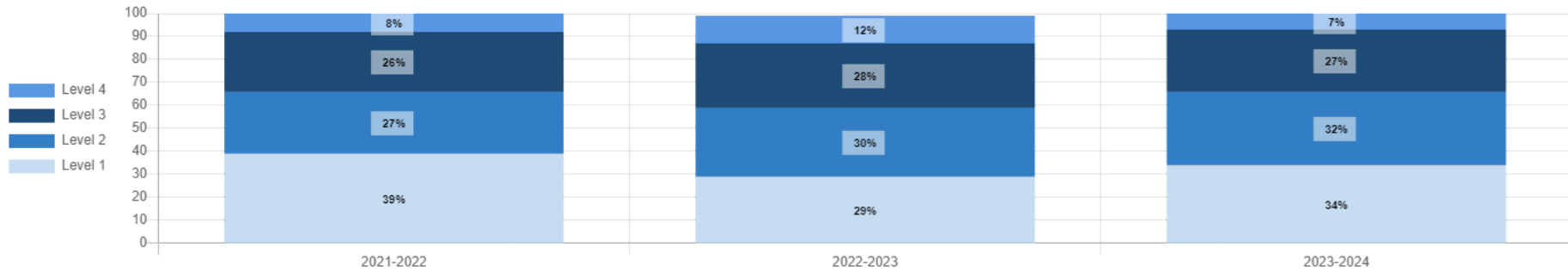

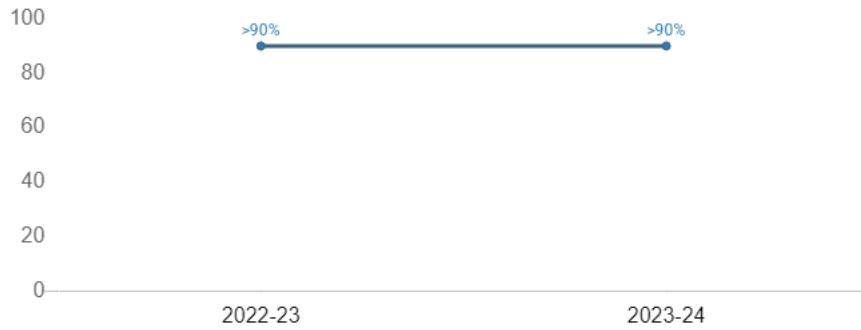

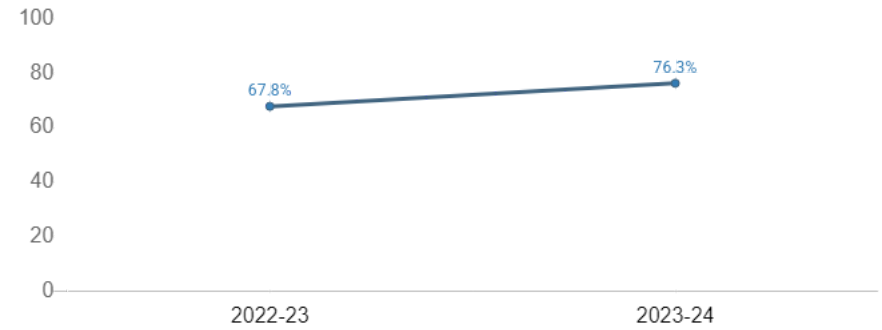

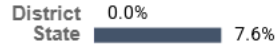

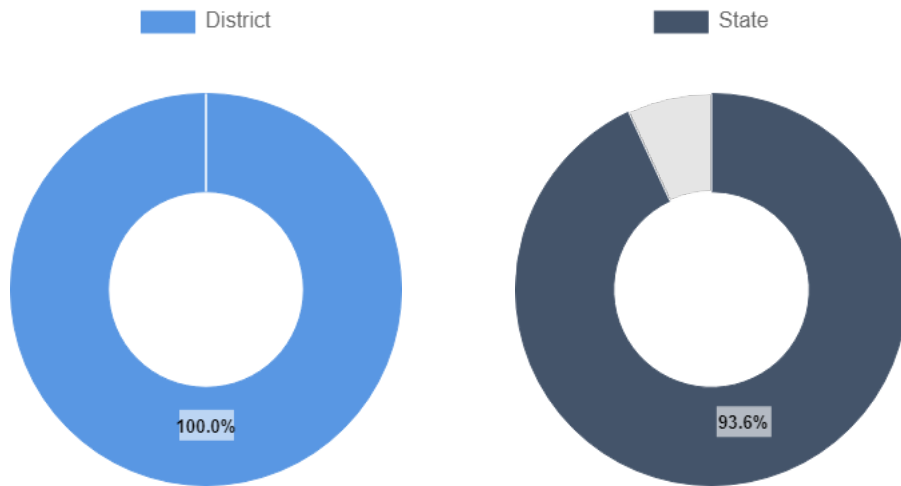

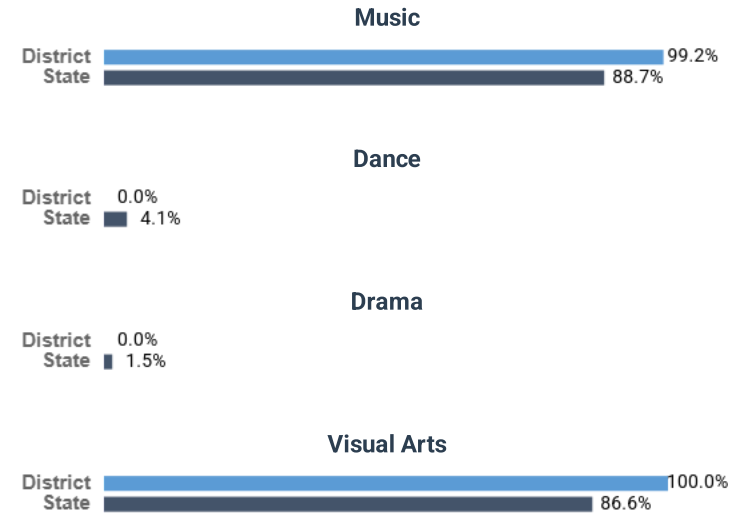

Students enrolled in one or more classes by discipline:



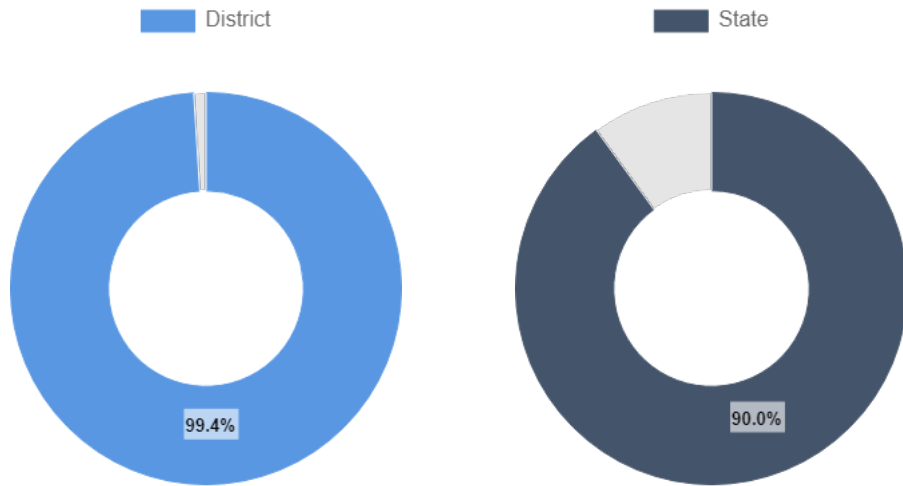

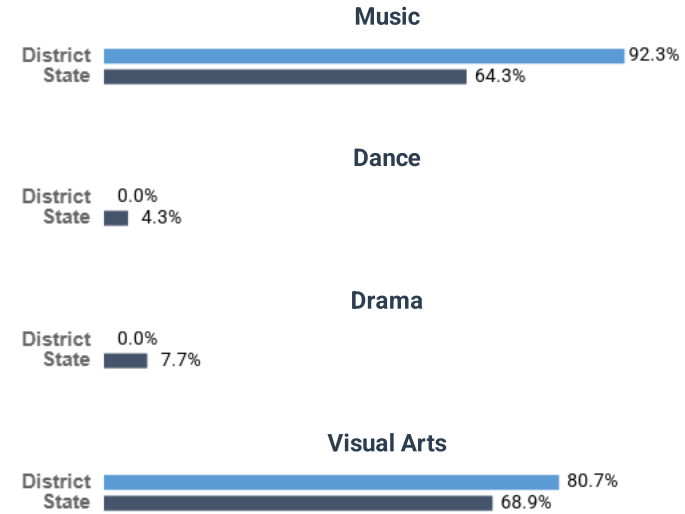

Students enrolled in one or more classes by discipline:



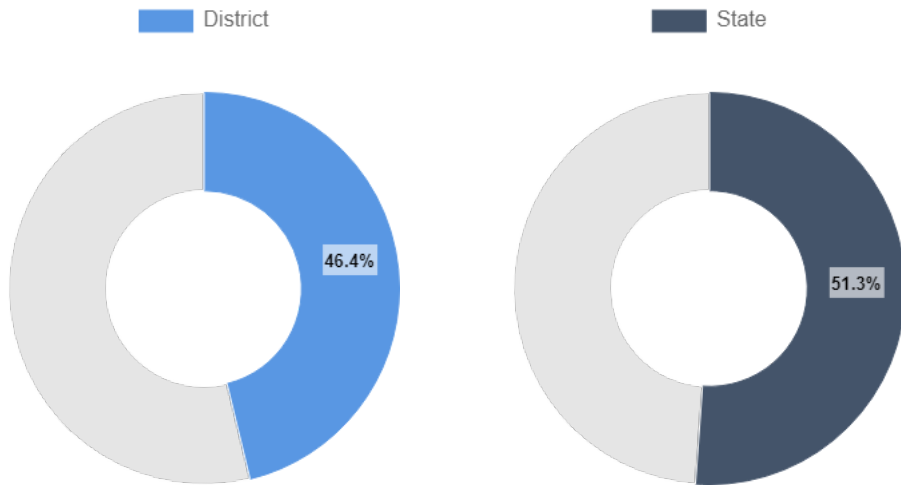

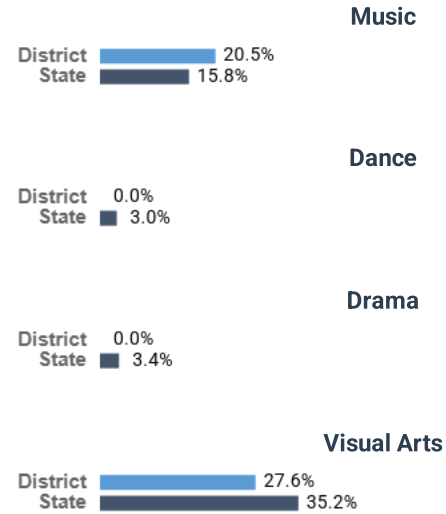

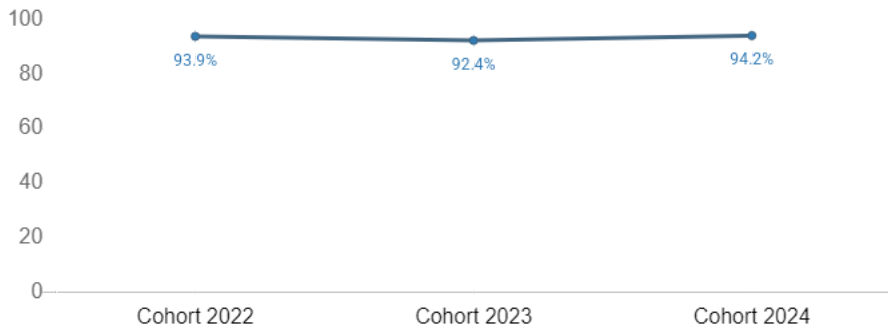

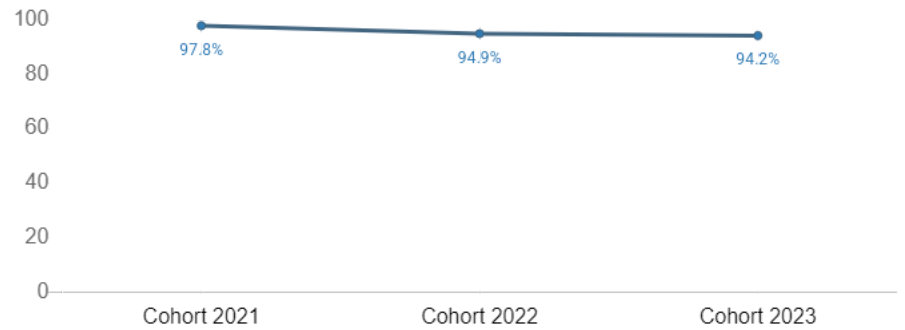

Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have meet state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

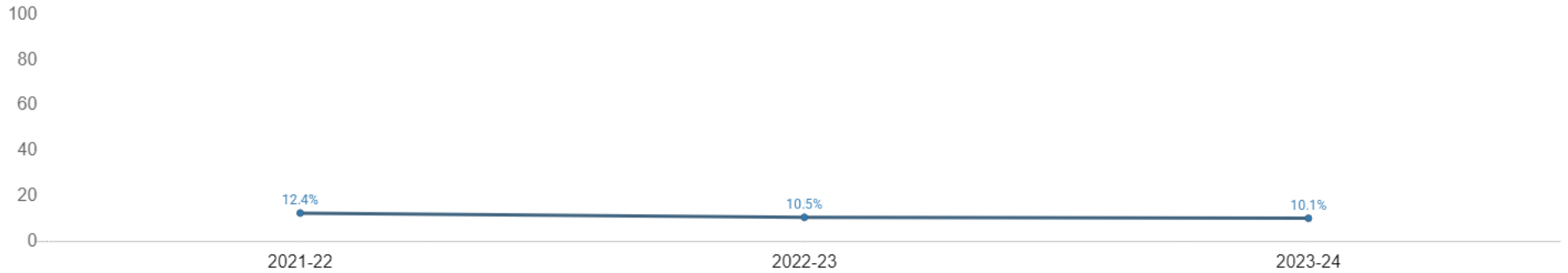

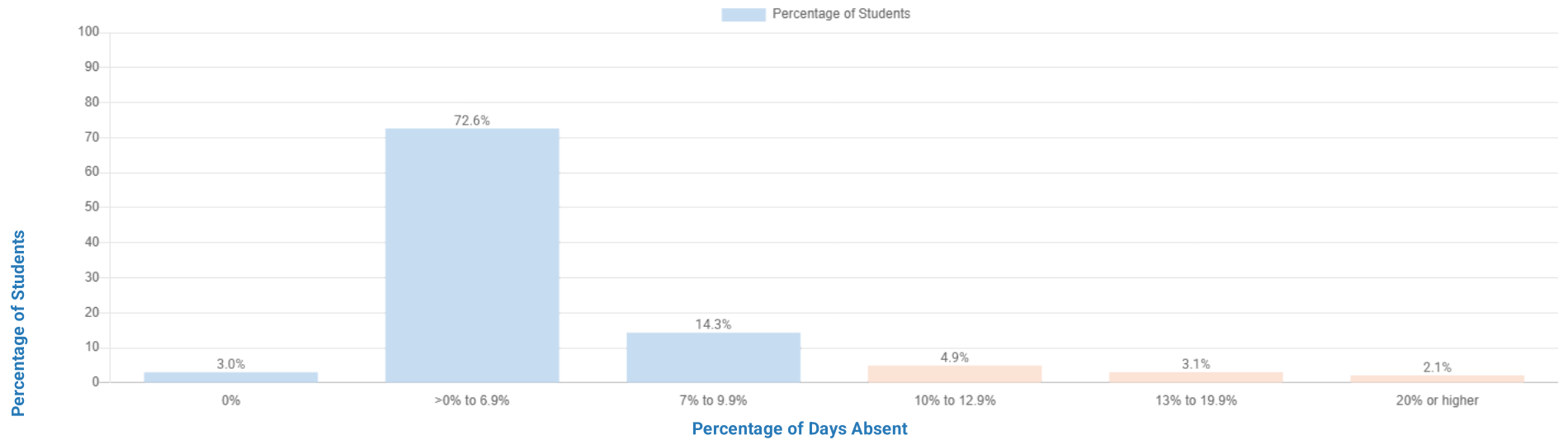

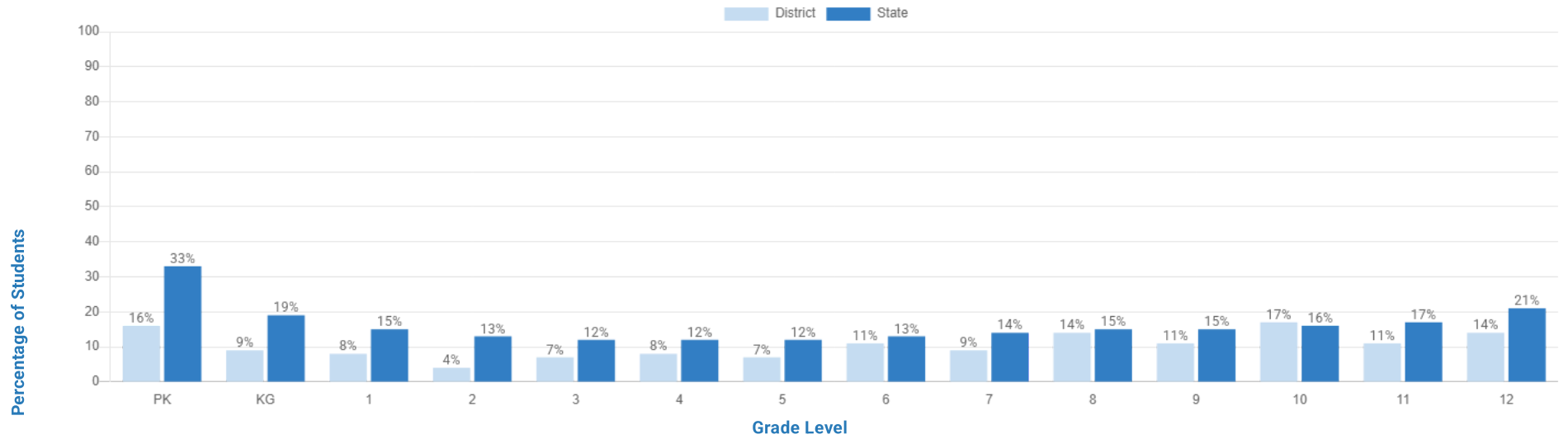

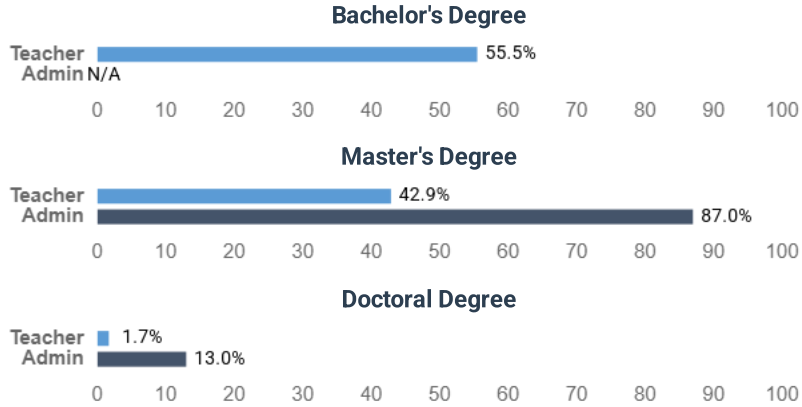

Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
 - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
 - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
 - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

 - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

Sports and Athletics:

Student-athletes at Cinnaminson High School and Cinnaminson Middle School have numerous opportunities for interscholastic competition. There are a combined 38 athletic teams across the two schools.



Clubs and Activities:

Students seeking activities outside of the athletic realm have plenty of options in Cinnaminson schools. The district recently added clubs at New Albany School last year for the first time. Over 80 clubs are offered district-wide in addition to athletic opportunities that already exist.



Before and After School Programs:

The Student Activity Center (SAC) is a tuition-based before & after school program for the district's K-5 students. SAC offers Art, Computers, Physical Education & games as well as assistance with homework. The SAC program boasts special events and dynamic programs that include an immersive STEM offering. Programs are designed to focus on the emotional, physical, social & academic skills of our students.

Staff and Professional Learning:

Six professional development (PD) days are scheduled throughout the year to provide training to staff members in areas pertinent to the curriculum and current best practices. Professional trainers are brought to the district to provide PD to staff on contemporary educational topics. Likewise, staff is also encouraged to participate in out of district in-service opportunities. District memberships in the Burlington County Curriculum Consortium (BCCC) and the Burlington County Professional Development Institute (BCPDI) give teachers the opportunity to attend learning events in a shared-services capacity.



Postsecondary Information:

From the graduating class of 2024, 61.38% went to a four-year school, 23.78% went to a two-year school, 5.44% post-grad, 0.99% pursued an apprenticeship, 1.98% joined the military, and 5.44% joined the workforce. Naviance, Financial Aid Night, College Application Night and Assembly, College Rep visits, and info sessions for local colleges all support students in applying for college or financial aid. CHS supports college entrance exam students by providing the PSAT to all 10th and 11th-grade students during school and at no cost to the student, fee waivers, and free practice sessions through various testing programs.



Student Supports and Services:

Cinnaminson offers a fully-staffed Child Study Team for children in need of special education services. Appropriate programming and related services to access education (such as speech/language therapy, occupational and physical therapy, behavioral consultation and social skills training) are offered from Pre-K through Grade 12+ to children who have been found eligible for special education and related services and have an Individual Education Plan (IEP). Accommodations and/or services are also provided in our schools through a tiered system of support (i.e. 504 Committees and I&RS Teams) which meet regularly to monitor the progress of the students. After-school tutoring is available in each of our four schools.

Student Health and Wellness:

School nurses work in collaboration with the district physician, community, students, staff and parents to ensure a healthy environment and achieve the best educational outcome for our students. School nurses are responsible for the daily well-being of the student population and reporting all pertinent findings to the parent or guardian such as first aid care, managing illness and administering medications. Nurses also manage student health care plans with chronic medical conditions such as asthma, diabetes, etc. and training staff on these conditions. Additionally, the nursing staff promotes a healthy environment through annual health screenings and assessments.



Parent and Community Involvement:

There is a combined Home & School Association for the two elementary school (CEHASA) with the MS & HS having their own Home and School Associations. These organizations provide ongoing support to enrich the academic program. The High School HSA runs Project Graduation for our Grade 12 graduating seniors to provide a safe, alcohol-free event on graduation night. All parents are provided a log-in to the Parent Portal through our student information system, Genesis, to monitor their students' academic progress. Likewise, parents are encouraged to engage with the district via social media platforms and the district website www.cinnaminson.com.



Facilities:

The Cinnaminson High School renovation project was completed in 2016. In addition to refreshing the high school learning space, the district added a new gymnasium and secured vestibules at each school. In the summer of 2021, the district added 8 "Learning Cottages" to the elementary campuses to expand the learning space in the district and allow for the conversion to full day kindergarten.

School Safety:

Student safety and security continues to be the number one priority of the Cinnaminson School District. The district added Special Law Enforcement Officers - Class 3 for each building. Additionally, the VisitorAware system requires all visitors to scan their identification which provides another layer of security before they are permitted to enter the buildings. Monthly fire and crisis drills are conducted throughout the school year. Video surveillance systems are present in each school building.



Technology and STEM:

The district continues to make improvements to its technology infrastructure to support emerging technologies. We have completed a district-wide wireless network refresh and upgrade to the district's internet service. Students have their own Chromebook in grades 3-12 and classroom Chromebook carts in grades 1-2.



Early Childhood Education:

Cinnaminson offers a Preschool Program for Children with Disabilities for children ages 3 to 5 years old. The program gives students the much-needed early help to get ready for kindergarten and the years beyond. Children who qualify would also have access to services such as speech, occupational, and physical therapies. Additionally, Cinnaminson offers a full-day, inclusive preschool program for four year olds residing in the district. The program utilizes the HighScope Curriculum, which emphasizes learning through play and hands-on experiences. The curriculum addresses all areas of development: social/emotional, physical, cognitive, and language along with literacy, math, science, social studies, the arts, and process skills. A continuum of special education services in the least restrictive environment is provided for our preschoolers with special needs.
