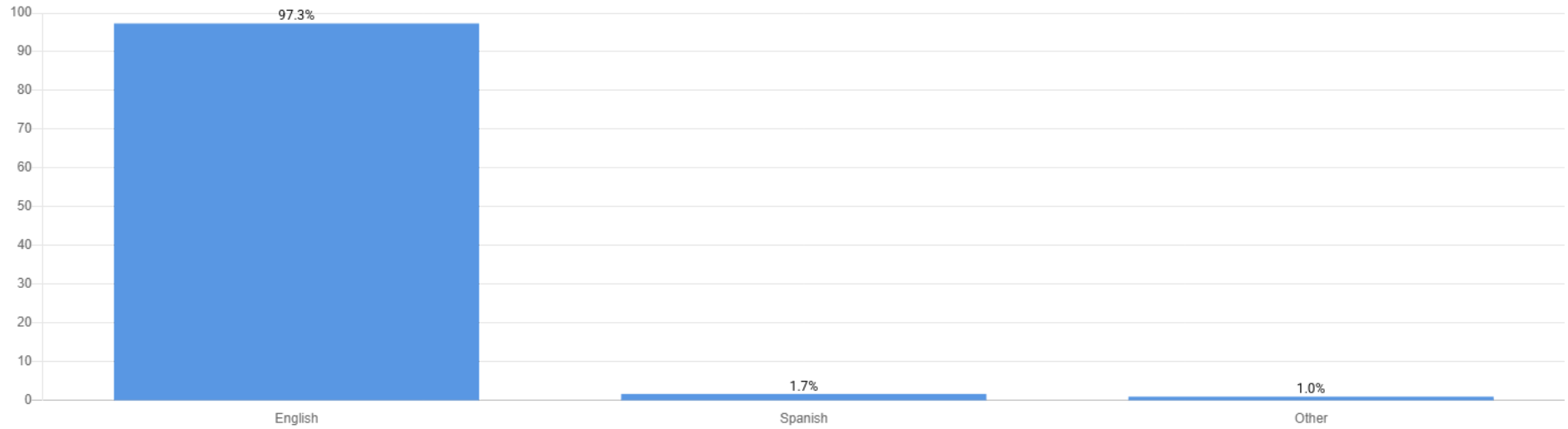

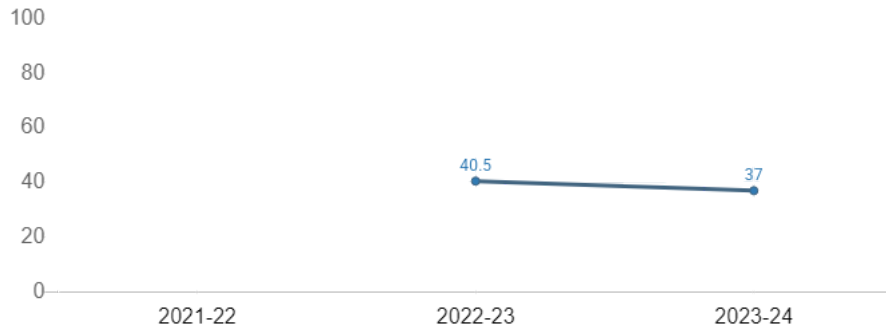

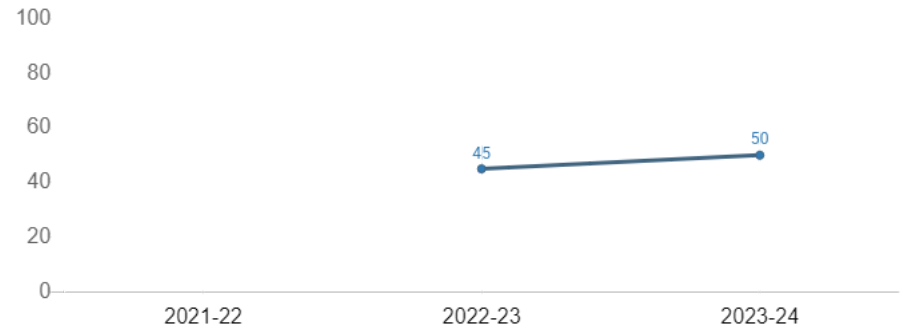

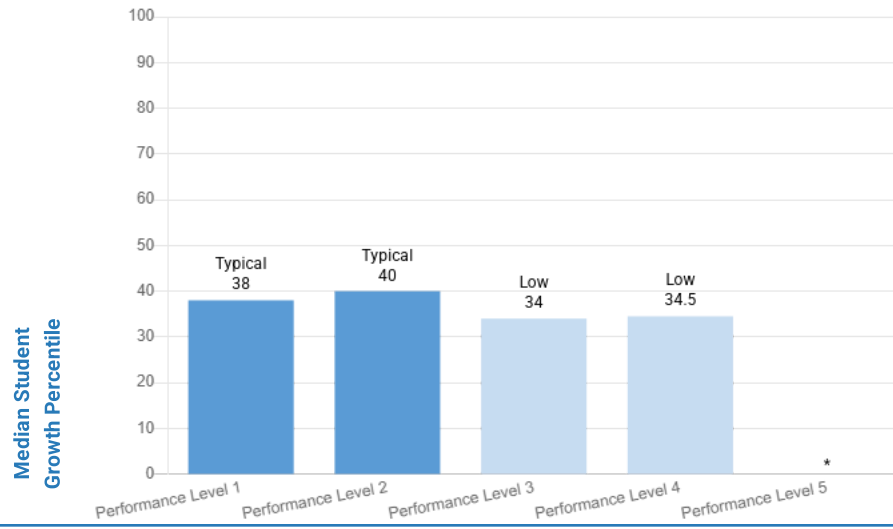

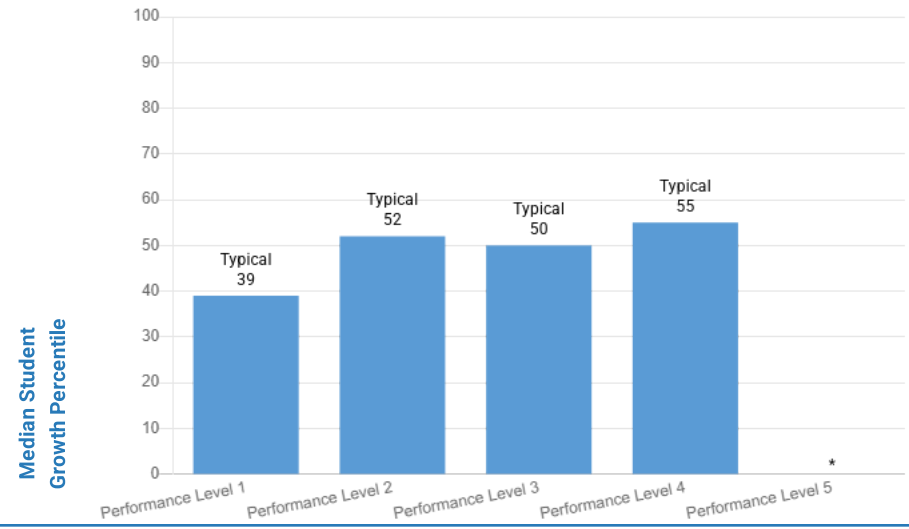

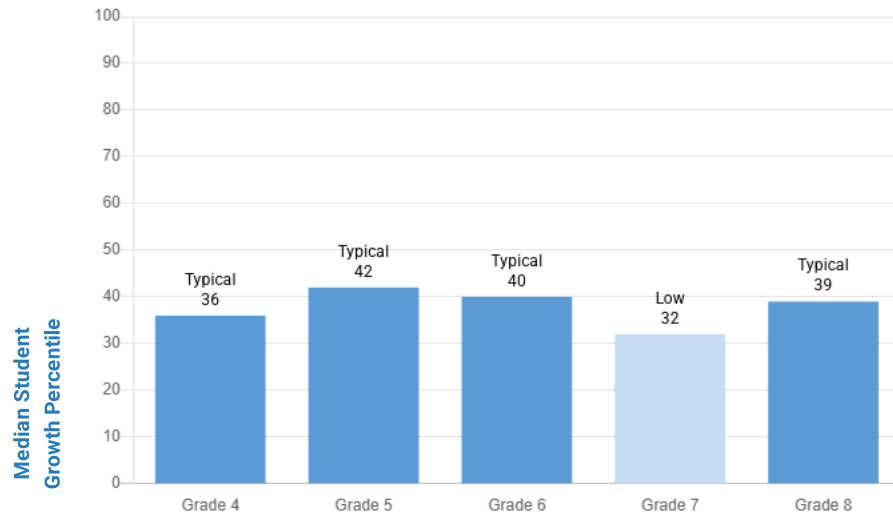

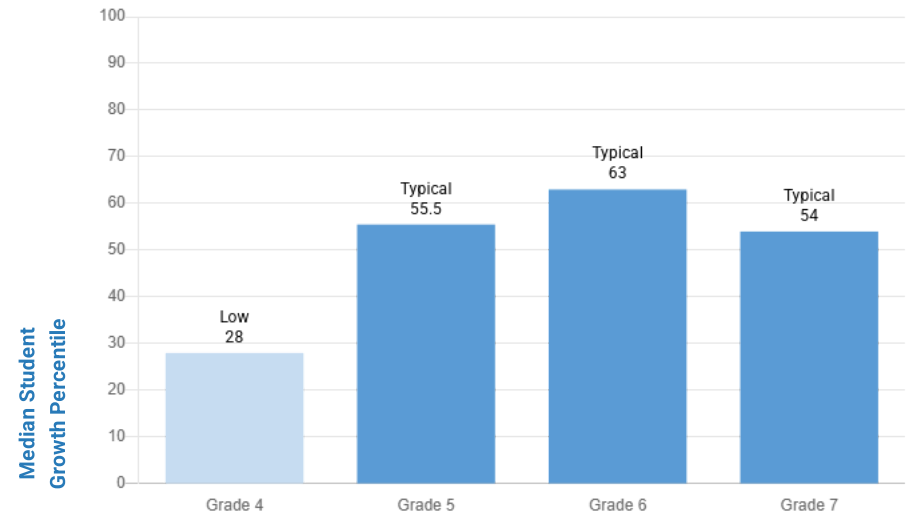

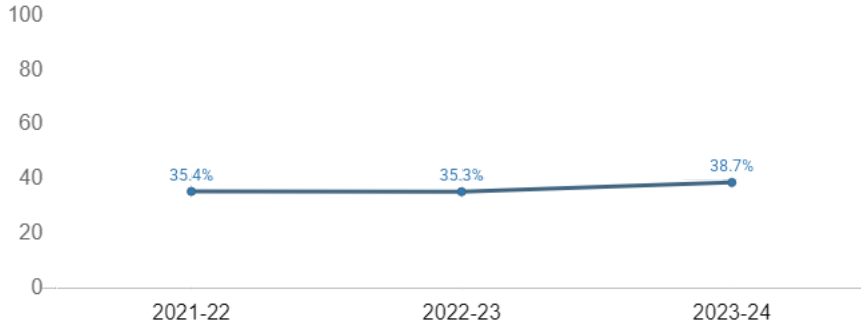

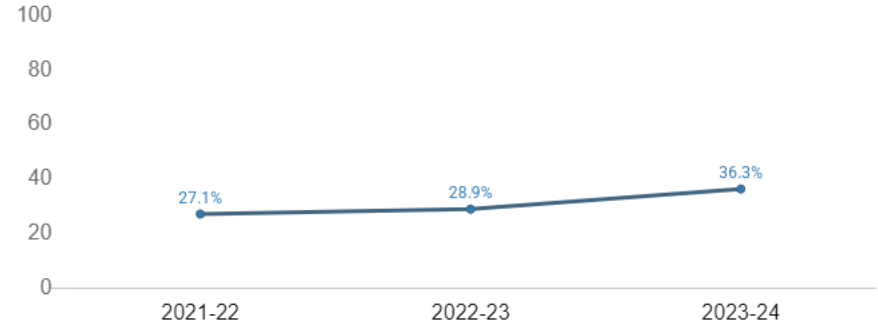
### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. ### English Language Arts Assessment - Participation and Performance

Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM.

This table shows both the percentage of students who met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows status in meeting annual targets. 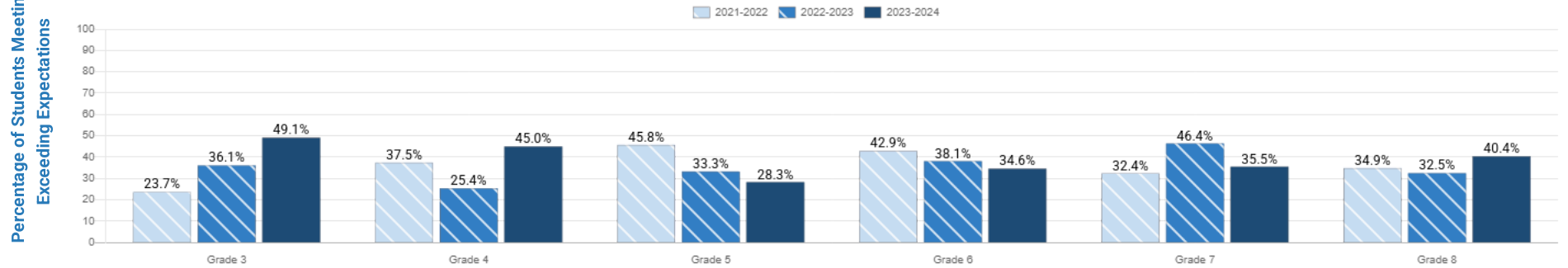

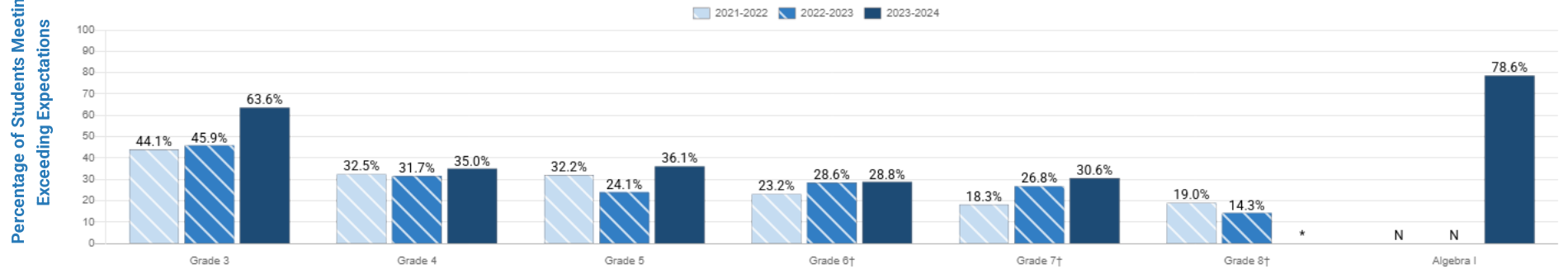

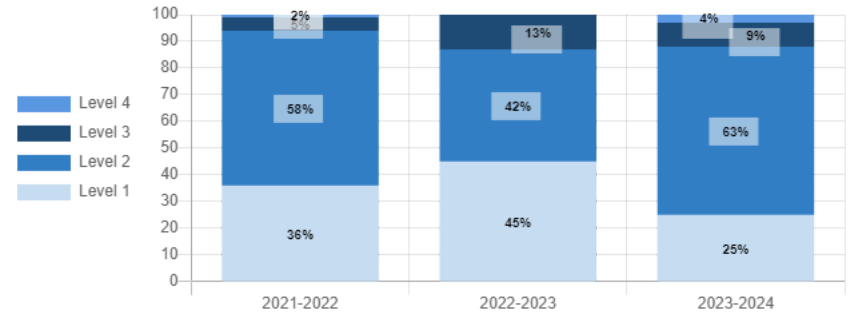

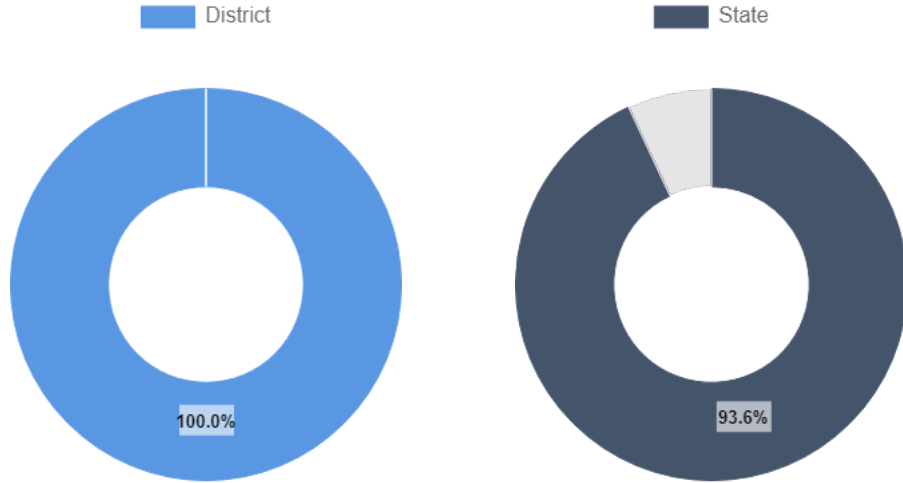

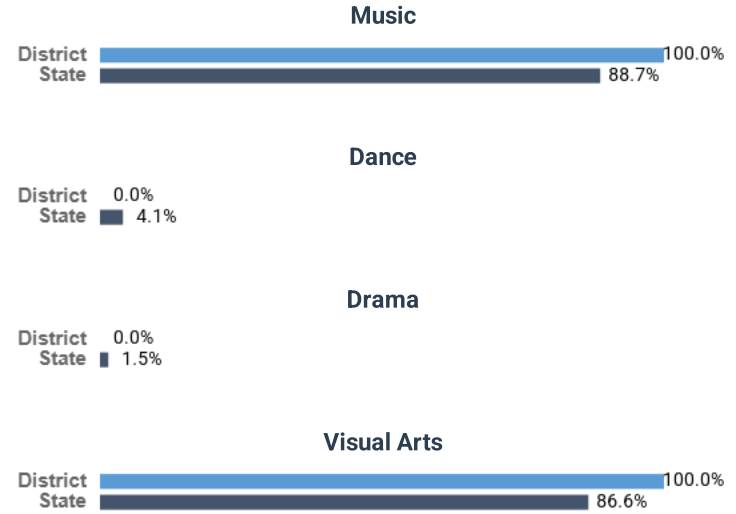

**Students enrolled in one or more classes by discipline:**



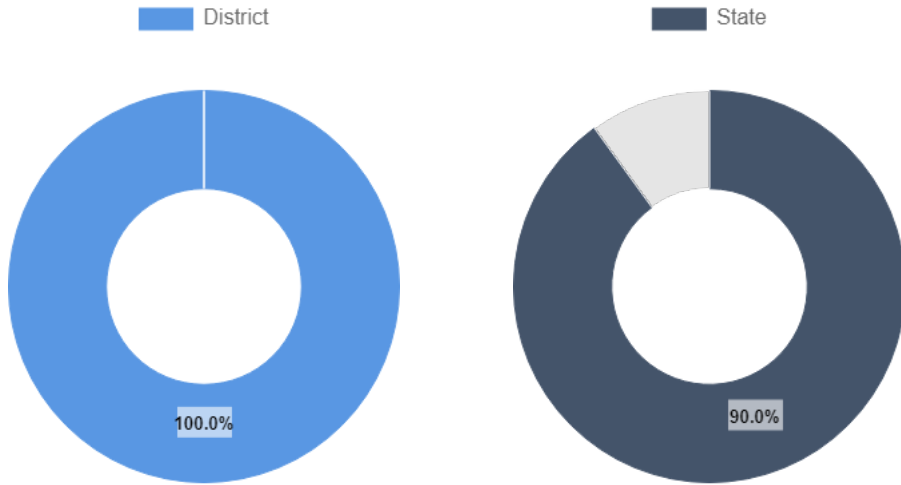

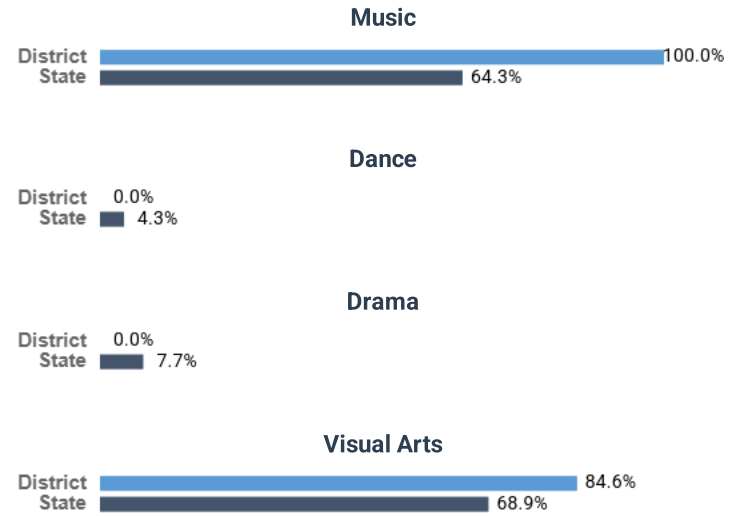

**Students enrolled in one or more classes by discipline:**

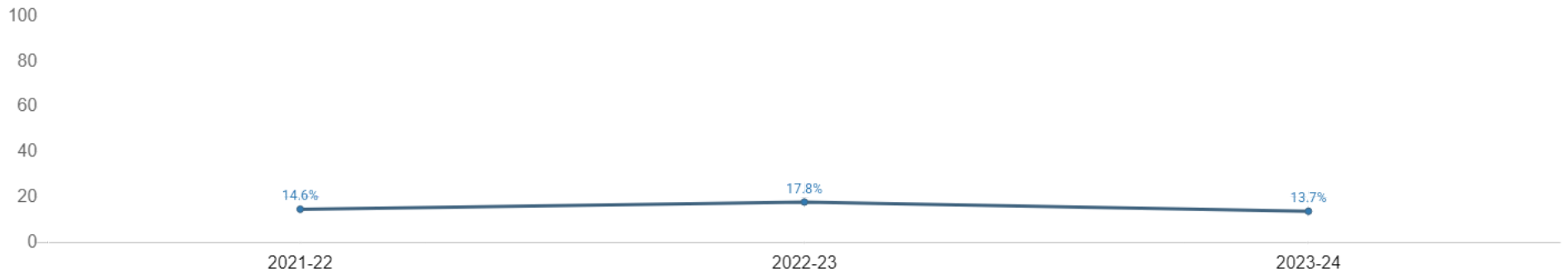


## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the district. 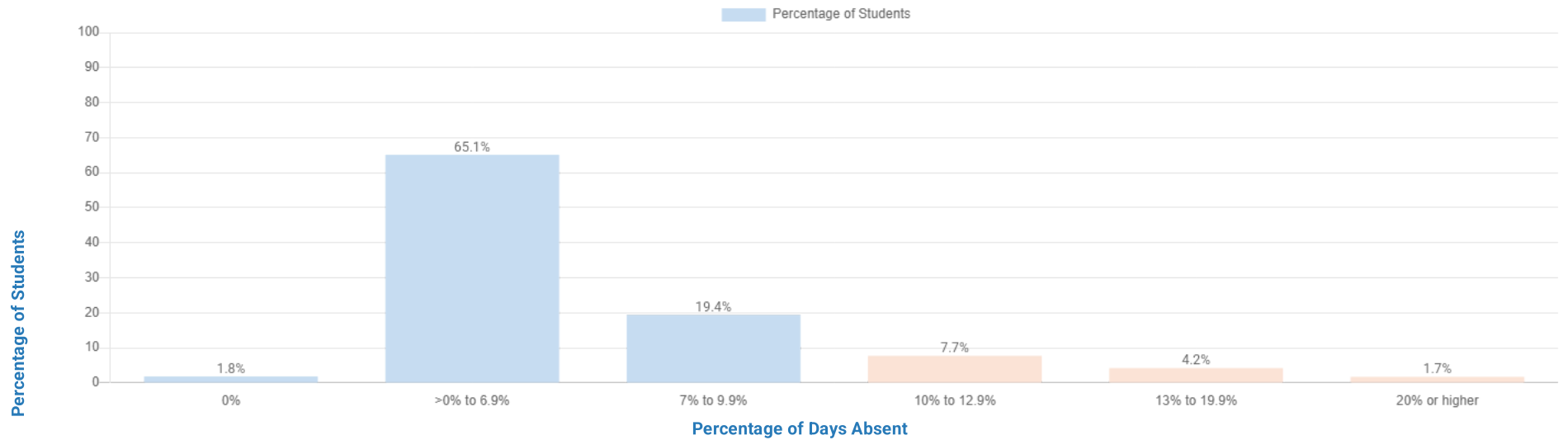

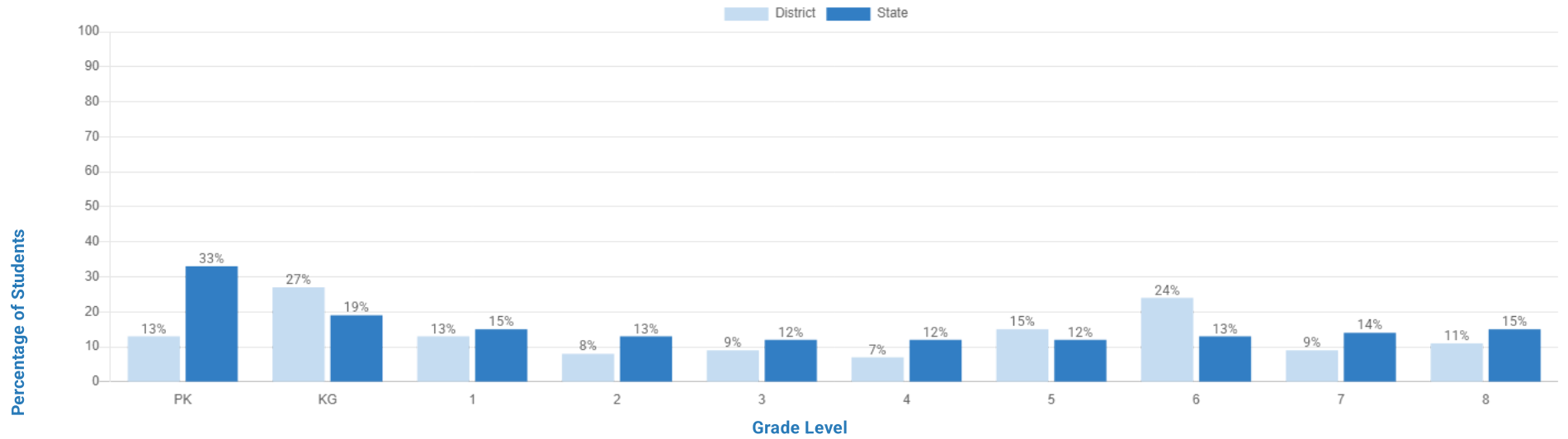

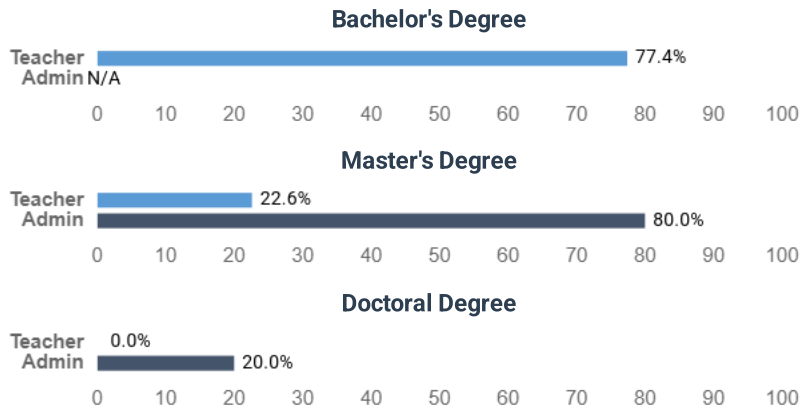

### Awards, Recognition, Accomplishments:

All Eastampton students receive pre-engineering instruction under the STEM initiative Project Lead the Way. PLTW is a rigorous, innovative science, technology, engineering and math program. These hands-on, project-based courses expose Eastampton students to unique areas of study that they do not usually pursue and provide them with a foundation and proven path to college and career success. The K-5 PLTW component is called Launch and grades 6-8 students receive Gateway to Technology. Our PLTW program is partially funded by grants. The Launch program is listed on the New Jersey School Boards Association directory as an A+ Program, Idea, Practice. For students who start in Kindergarten and stay through eighth grade, they will have 9 years of pre-engineering instruction by the time they enter high school. This past year, Eastampton was recognized by Project Lead the Way as a "Distinguished School of S.T.E.M. education" - one of only thirty K-8 schools in the US to boast this claim.

Through our Project Lead The Way STEM programs, students develop in-demand, transportable skills - such as problem solving, critical and creative thinking, collaboration, and communication - that they will use both in school and for the rest of their lives, on any career path they take. As PLTW students progress through grades K-12, they are empowered to explore career paths, engage in problem solving and process thinking, develop technical knowledge and skills, and build communication skills. At Eastampton Community School we are proud to offer both the Launch program to our K-5 students and the Gateway to Technology program to our 6-8th grade students. All of our students have the opportunity to take part in PLTW's hands-on engaging curriculum which allows students to ignite imagination and innovation through learning.



### Early Childhood Education:

Eastampton Community School currently offers a full day 3 and 4 year old integrated preschool program. For the 2024-2025 school year, we are in year 3 of PEA implementation, offering early childhood educational opportunities to 60 students.
