







Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.



Staff and Professional Learning:

Teachers are engaged in a multi-tiered professional development program that encourages continued professional growth through in-district training opportunities by school specialists or outside presenters, outside workshop opportunities paid for by the district, a district-wide book club, monthly professional resources and communications and job embedded collective learning opportunities through PLC team meetings. The goal is to build the capacity of all PK-12 instructional staff by supporting and fostering sustained professional growth in equitable practices in education to include culturally responsive teaching practices, LGBTQ curriculum, social-emotional learning (SEL)/ trauma Informed practices, Sheltered English Instruction (SEI) and response to intervention (RTI) to ensure engagement of the students and the community.



RHS offers college placement programs for students in grades 9-12: An in-house College Fair was held in the Fall. A Financial Aid information night, as well as a Financial Aid Workshop for parents are held annually. Parents have the opportunity to complete the FAFSA. The postsecondary plans for our students last year included 26% to a 4 year college, 40% to a 2 year college, 11% in trade, 2% to the military and 12% into the workforce. Along with traditional state required courses, RHS also provides honors courses, electives which include Psychology, Constitutional Law, Sports Marketing, CAD, Intro to Woodworking, Guitar, Piano, Sociology/Genocidal Studies, and Anatomy & Physiology. RHS also offers College Accelerated Programs (CAP) that include: AP English Literature, AP Calculus, Spanish III/IV, AP Statistics, US History II Honors, AP Spanish, Anatomy & Physiology, and AP Biology.



Student Supports and Services:

Special Education programs meet the needs of identified students through a variety of programs and placements, including inclusion, in and out of class skills support services, self-contained classrooms and an MD program in the elementary school, middle school and high school. Intervention services are available at all schools for students needing academic support. There is an Intervention and Referral Service (I&RS) designed to assist students who are experiencing learning, health, or behavioral difficulties.

The school district has implemented a School Breakfast Plan in the elementary school, called Breakfast After the Bell, in an effort to increase the number of free or reduced meals our eligible students are consuming. In the current school year all students are eligible for free meals through the extended Seamless Summer Meal Option. Studies have proven that breakfast helps kids concentrate in school, boosts test scores and improves behavior and attendance. Additionally the district provides third party mental health support for students, student family members, staff and staff family members through Care Solace which quickly and confidently finds available providers matched to identified needs. This Care Companion team is available 24 hours per day, 7 days per week, and 365 days per year to quickly connect those in need to carefully verified providers in the community.



School and Family Associations are active in our elementary and middle schools. The high school principal facilitates a parent advisory group that meets monthly with high school parents. The CST Director and her team also host a monthly parent advisory group.

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. Based on surveys that were distributed to administrators, staff and families, the majority of responses indicated that the schools are safe and secure, provide good communication, and the staff genuinely care about students. Our facilities are operated and maintained with children and staff at the heart of our focus. Our three buildings and the surrounding grounds provide a safe and inviting environment that supports children in their learning and development. Through a shared effort our staff take responsibility for reporting maintenance needs and identifying potential safety issues.



The Riverside Township School District plans for drills and recognizes the importance of school safety and security. The Board of Education, administrative team, and all staff in our school district prioritize student and staff safety. A full time School Resource Officer provides onsite support and services to our three schools on a daily basis. We have partnered with the Riverside Police Department to stay current and knowledgeable with our practices, drills and security measures. The Riverside Township School District has recent updates that were provided through a School Safety Grant. The funds were applied to numerous safety and security upgrades including additional cameras, more secured entry ways, lighting upgrades, Zero Eyes firearm camera-integrated detection service, and 3M ballistic window film on ground level floors.



The Riverside Township School District has secured enough chromebooks to provide a one- to-one device program for all students throughout the school day. We are supporting teachers in best practices that utilize tech integration and through transitioning to a Google Ready school community. These apps and platforms provide enhanced instruction through the use of interactive tools, home-to-school connections through content-rich teacher learning sites, and curriculum integration of computer science, design thinking, career readiness, life literacies, and key skills standards. Teachers were also provided the opportunity to participate in Google Certification courses through district-wide professional development. STEM learning is available K-12, integrated into classes wherever possible, with special courses in the middle and high school specializing in these areas and afterschool clubs focusing on it as well.
