







Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.



CHPS prides itself on providing long-term, intensive, and personalized professional development which meets the needs of its entire staff. Professional Development offerings reflect the continuation of many curricular initiatives. Professional learning for staff includes job-embedded, collaborative learning that supports the development of enhanced instructional techniques, the use of assessment for learning and the fostering of learning environments/relationships that are conducive to learning. Over the past few years, the district has refined its work in certain areas and expanded in others through continuously assessing responsiveness of staff to the professional development offered. Professional development decisions are made in conjunction with the DEAC Committee and the building ScIP teams. Opportunities for professional learning are offered both in and out of district, through Flex Options, in-service days, during PLC time, and at the building and district level.



Student Supports and Services:

The Cherry Hill Public School (CHPS) District employs full time ELL teachers at all grade levels in designated magnet schools. Students with disabilities receive services in both general and special education classrooms in various types of programs throughout the school district. Every school in the district has an Intervention and Referral Services team responsible for identifying and supporting struggling students. Every school in the district has a school counselor and in addition, each secondary school offers the services of a SAC. Additionally, every school in the district has a school nurse to oversee the student health needs.



The District currently offers breakfast in each school building for purchase or for free to eligible students. Policy 8505, Wellness Policy and Nutrient Standards for Meals and Other Foods provide details of programs, procedures and curriculum as well as the District and School Level Wellness Committees.

The Cherry Hill School District had a successful bond referendum in October 2022. The referendum was the largest to date in State history. The funding provided by the referendum will allow the District to do much needed renovations and upgrades at all 19 school facilities. Work began in the summer of 2023. Roofing projects and playground upgrades were completed in the summer of 2023. The installation of new elementary all purpose rooms, sitework and ADA upgrades and HVAC replacements began in the summer of 2024.



The Director of Security is also the School Safety Specilaist for the District. The District also has its own campus police force which includes nine armed police officers. The District had a successful bond referendum in October of 2022, which will provide funding for main entrance enhancements at the remaining schools that don't have them, as well as enhance the District's security camera and swipe card access systems.



Access to robust STEM education, technology platforms and devices empowers our students to meet and exceed academic standards and prepare CHPS students for life and careers in the 21st Century. Students and staff have access to a variety of technology including chromebooks, laptops, and makerspaces. As outlined on the NJ DOE website, "Readiness in this century demands that students actively engage in critical thinking, communication, collaboration, and creativity. Technology empowers students with real-world data, tools, experts and global outreach to actively engage in solving meaningful problems in all areas of their lives." CHPS recognizes the need to continuously enhance its technology capacity to bolster its academic program K-12. We continue to maintain technology access both within our schools and in the community by providing access to devices, home Internet connectivity, and technology support.

CHPS supports our youngest learners through Preschool Expansion Aid. As we grow the preschool program over the next 5 years, approximately 1700 3 and 4 year olds will be served. Students are educated in the Malberg Early Childhood Center (MECC) as well as private provider locations. The program is 6 hours per day from 9:30-3:30. The program is based on Creative Curriculum with integration of specialized programs for students with IEP's. The program meets the needs of students in a variety of ways, through general education, push in resource, and self-contained classrooms. MECC receives IDEA funds for students with special needs. Non-classified students apply for admission each year. If there are more applications than spaces, a selection process is held. Special needs students do not go through the application process; rather, eligibility through the IEP process determines their acceptance into the program.



CHPS is using NJTSS/MTSS/I&RS/RTI is providing district wide training that focuses on NJDOE best practices when addressing Chronic Absenteeism. This training provides an awareness of demographic group differentiation, student and family supports, partnerships with outside organizations, and incentivising programs to encourage and maintain regular school attendance.

Our middle school students are also leading the way in environmental initiatives throughout the district. In efforts to provide more students with experiential learning opportunities, Cherry Hill Public Schools is expanding internship opportunities for all high school seniors. Students have had work experiences in hospitals, engineering firms, marketing firms, costume construction and design, bakeries, the Police Department and many others.
