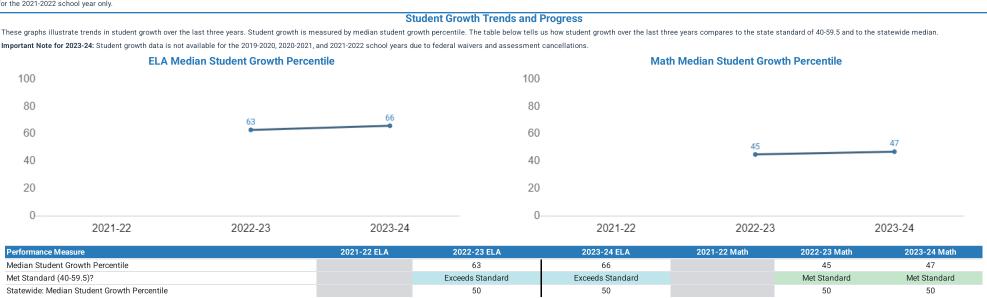

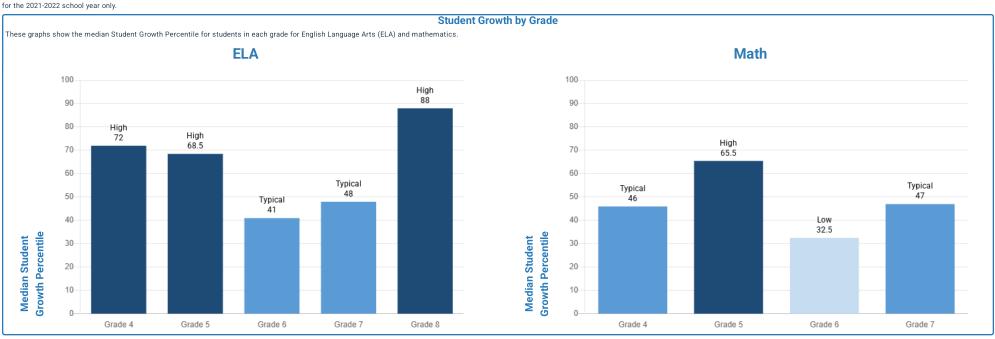

#### **English Language Arts and Mathematics Performance Trends**

## Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

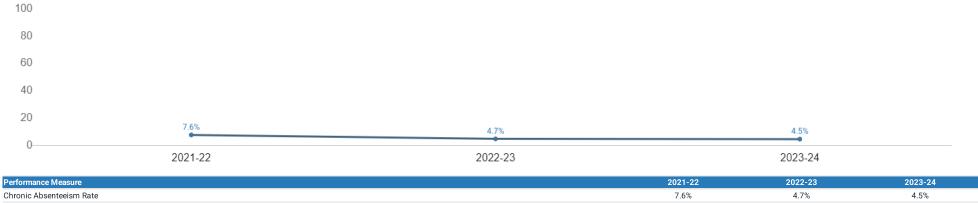

**Staff and Professional Learning:** 

The goal of our professional development program is to nurture knowledge creation and sharing through a sophisticated system of distributed leadership. Teacher leaders at each grade level and in each department meet regularly to plan professional development with the administration. There are 5 full professional development days for staff to take advantage of new learning led by outside presenters, District staff, and teacher self-designed learning opportunities.



**Student Supports and Services:** 

Support and services for student with disabilities are in the form of In-class Resource for math and reading at the elementary level, In-class Resource for math, reading, science, and social studies at the middle school and high school levels, Pull-out Resource Supplemental in math and reading at the elementary and middle school levels, Pull-out Resource Replacement in reading, math, science, and social studies at the middle school level, and a Multiple-Disabilities program at the elementary, middle school, and high school levels. Currently the district implements MTSS to students who are experiencing learning, behavior, or health difficulties through consultative services from the school nurse, guidance counselor, and Child Study Team members. Additionally, academic support is provided through a Learning Specialist utilizing evidence and research based interventions. The Intervention and Referral Services Team meet regularly to monitor the progress of the students.

# **Parent and Community Involvement:**

The Haddonfield School District fosters strong community involvement through various avenues. Parent-Teacher Associations (PTAs) play a vital role in each school, organizing events, fundraising, and providing volunteer support. The district encourages parental participation in decision-making processes through committees and open forums. The Haddonfield Education Trust, a non-profit organization, provides additional funding for innovative programs and educational initiatives. Additionally, the district collaborates with local businesses and organizations to offer internships, mentorship programs, and community service opportunities for students. These partnerships enrich the educational experience and create a sense of shared responsibility for student success.



Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. The Haddonfield School District administers an annual climate survey to all parents, staff, and students (grades 3-12). Climate surveys are completed yearly by all faculty, and students in grades 3-5. These surveys are used to assess these stakeholder satisfaction with our program. We use these results to determine areas of strength as well as areas where we can improve. The student survey is reviewed by the School Climate Team as it asks students about their thoughts about school and issues related to bullying. The administration closely examines the faculty and parent surveys to determine areas we can grow. School goals may be developed based on survey results.



The Most Recent Construction Project was completed in 2019. This project included an HVAC upgrade/installation throughout the entire district. Demolition and reconstruction of the high school B-wing housing a new Kitchen/Cafeteria/and dance/performance center. HMHS: Along with an Athletic stadium, the property includes three interconnected wings including all levels of academic structure. Tatem: This fully Air-conditioned school has an All-purpose room that serves as a Cafeteria/Gym/performing center. A new ADA-compliant playground installation was completed in 2019. Haddon: This fully Air-conditioned school has an All-purpose room that serves as a Cafeteria/Gym/performing center. HMS/Central elementary school: air conditioning covering 99% of these two interconnected schools. The administration building does not have adjoining hallways to the shared site and was constructed in 1890.

The district has secured vestibules in 4 of its 5 school buildings, except for the High School, where we employ a School Resource Officer. We currently use the Raptor Visitor Management System at each of our buildings. The district has a School Climate/School Safety Team in each of the 5 schools. Each ABS has been trained in The Role of the School Climate Team and has received NJPSA/FEA Anti-Bullying Certification. The district established a community-wide District Safety Committee to assess the safety needs of the school district. HSD was awarded a \$500,00 grant to provide an emergency notification system complete with wall mounted lockdown buttons, personal lockdown pendants, integrated lockdown announcement through our PA system, remote access controls, and visual strobes in all indoor and outdoor areas of the buildings; video cameras to provide first responders with live feed; 3M ballistic resistant film on all first floor windows; and gun detection software.



Haddonfield schools seamlessly blend technology and STEM into everyday learning. Students design 3D models in engineering classes, analyze data with coding in math, and conduct virtual experiments in science. Chromebooks and online resources empower research and collaboration. Teachers use interactive whiteboards and educational apps to create engaging lessons. From robotics clubs to coding competitions, students explore their passions and develop critical 21st-century skills. This tech-infused approach cultivates innovation, problem-solving, and a love for learning.



Haddonfield provides an inclusive preschool program that is tuition-based. The cost is 2970 per year. The preschool is a half-day, 5 days per week program utilizing The Creative Curriculum. For young children, meaningful and long-lasting learning requires active thinking and experimenting to find out how things work. This is best accomplished through purposeful play facilitated by highly intentional teaching practices. The Creative Curriculum addresses all areas of development: social/emotional, physical, cognitive, and language. It also addresses literacy, math, science, social studies, the arts, technology and process skills. Every preschool class is staffed with an experienced preschool teacher who is special education certified, two experienced Educational Assistants, and therapists who spend considerable time in the classroom providing integrated OT, PT, and Speech services. There is typically a waiting list for this program.
