














### English Language Arts and Mathematics Performance Trends







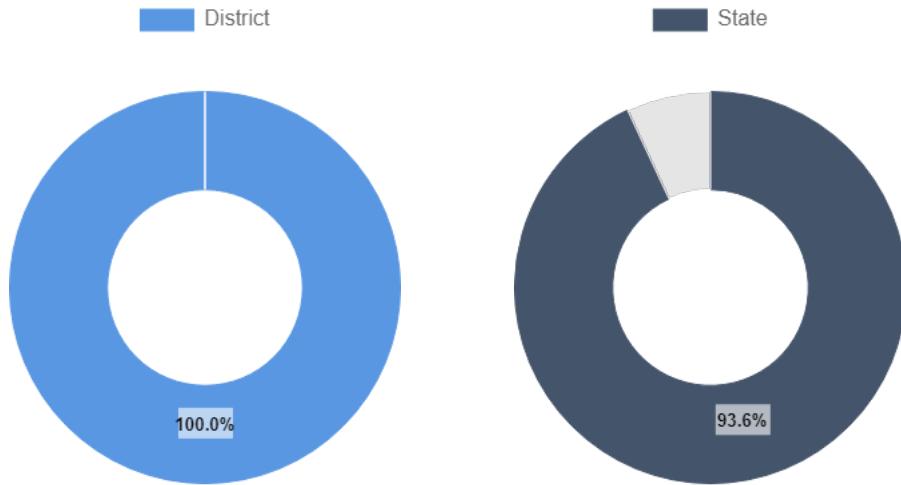



Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:




## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the district. 





New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
  - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
  - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

The NJDOE identified schools for CSI and ATSI status in fall 2023 based on data from the 2022-2023 school year, so the NJDOE did not identify schools for CSI or ATSI status based on 2023-2024 school year data. The NJDOE only identified schools for TSI status based on data from the 2023-2024 school year.

### Courses, Curriculum, Instruction:

Somerdale Park School offers half-day PK (including a PK Disabled Program) and a Full-Day Kindergarten Program. The district/school's curriculum in Grades PK-8 is aligned with the New Jersey Student Learning Standards. Technology is used to supplement instruction through the use of google Workspace and beyond. Students are equipped with chromebooks resulting in a 1:1 student/tablet ratio in Grades PK-8. Students take the NWEA MAP Standardized Assessment 3x/yr. Data from this assessment enables teachers to make informed instructional decisions such as unit/lesson design, activity development, resource selection and customized, small group instruction. Supplemental programs/services include a Gifted and Talented Program (STEPS), Multilingual Learners (ML formerly ESL) Program , Early Literacy Program/Practices rooted in the Science of Reading, Advanced Math Track - Pre-Algebra (7th Grade), Algebra 1 (8th Grade), Advanced English Language Arts Track (Grades 6-8).



### Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Soccer (Coed), Softball (Girls), Volleyball (Coed)

All students are encouraged to participate in extra-curricular sports, activities, and clubs. Extra-curricular participation promotes well-being and provides and opportunity for student growth.

After school care is offered to students in Grades PK-8. Before school care is not offered. A Breakfast Program is offered as well as a "Second Chance Breakfast" for late arriving students.



### Staff and Professional Learning:

Common planning time and bi-monthly professional development opportunities are used to satisfy the State mandated professional developments. Additionally, ESEA Title II Funds are used to contract with outside presenters to offer staff professional development in the areas of data analysis and interpretation, differentiated instruction, effective use of technology, small group instruction, and innovative pedagogical strategies. Staff are also encouraged to seek out individualized professional development opportunities for which they believe will lead to professional growth and increased effectiveness.



### Student Supports and Services:

Somerdale Park School has a full Child Study Team (CST) including a director of special education who also serves as a licensed clinical social worker. A school psychologist, school social worker, and learning disabilities teaching consultant. Additional services provided include speech therapy; occupational therapy; and physical therapy. Somerdale Park School has a full time school counselor whom handles student 504 Plans and chairs the Intervention and Referral Services Committee (I&RS). Academic intervention programs include a Wilson Reading Program and a team of interventionists assigned to provide support in the area of mathematics. Staff collaboration and data analysis combine to identify student support needs and corresponding early intervention strategies.

### Student Health and Wellness:

Somerdale Park School offers a School Breakfast Program and a "Second Chance Breakfast Program" for late arriving students. These programs are intended to promote healthy eating choices and are reinforced in health and physical education classes.



### Parent and Community Involvement:

Somerdale Park School recognizes the value of parental involvement in the educational process. OnCourse Systems is used as the School's Student Information System which provides a parent portal called OnCourse Connect to allow parents access to student performance and ongoing academic/behavioral progress. Many district/school committees include parent representation for the purpose of providing parental insight and input in decision making processes. Somerdale Park School works collaboratively with the Somerdale Parent Teacher Association (PTA). Somerdale Park School Staff make presentations at PTA Meetings to provide information based on communicated need. To disseminate information, Somerdale Park School relies on its up to date website, facebook page, twitter account, and district messaging system - Finalsite.

**Facilities:**

Somerdale Park School has recently replaced the roof, added a parking lot, and built two new playgrounds which include a basketball court. The school is in the process of replacing interior tile, adding an outdoor learning space and eating areas, improving existing drainage and erosion obstacles, and enhancing its outdoor athletic fields with aesthetically improved fencing, back stops, and dugouts. Somerdale Park School has a fully functional gym, a multi-purpose room (cafeteria, stage and gym), library, studio, art room, science lab, and band room.


**School Safety:**

School safety is a priority at Somerdale Park School. Monthly fire and emergency drills are conducted in accordance with New Jersey Law. The school's emergency alert system (BluePoint) initiates an automatic 911 call to both local law enforcement and county dispatch. The system is linked to the school's public address system, exterior horns/strobe lights, and both interior and exterior keyless locking system providing Somerdale Park School superior infrastructure in terms of security and ensuring compliance with Alyssa's Law. Somerdale Park School employs a full time school resource officer (SRO).


**Technology and STEM:**

Somerdale Park School offers STEAM as a quarterly course for students in Grades 6-8 and as a co-teaching science enrichment experience for students in Grades 3-5. Flexible scheduling provides give teachers in Grades K-5 an opportunity to incorporate or extend on STEAM related activities. Each classroom is equipped with a Promethean Board, all staff are provided tablets with wireless connection capabilities. Student/tablet (chromebook) ratio is 1:1 in Grades PK-8
