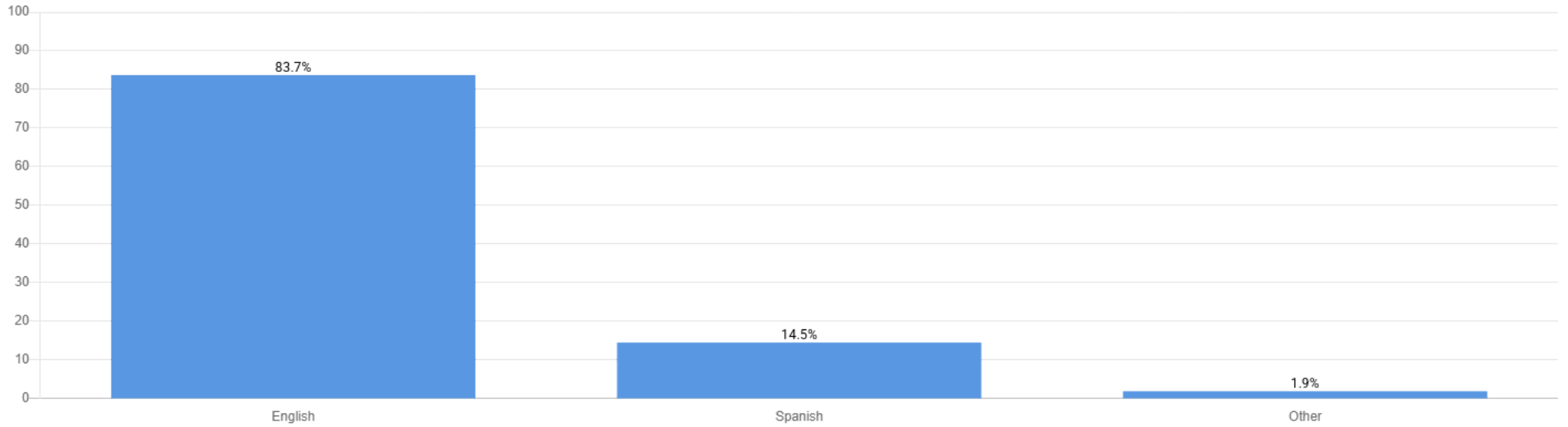

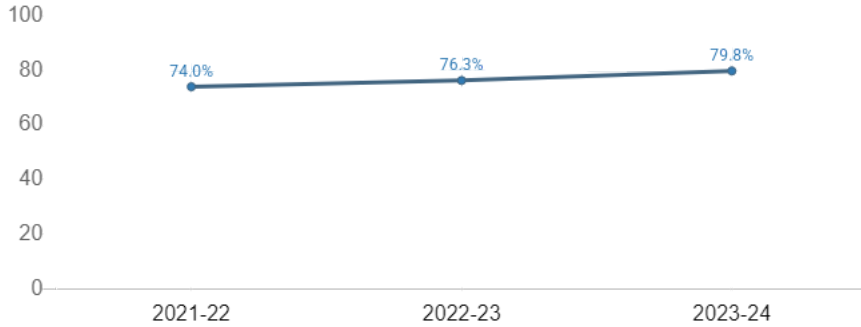

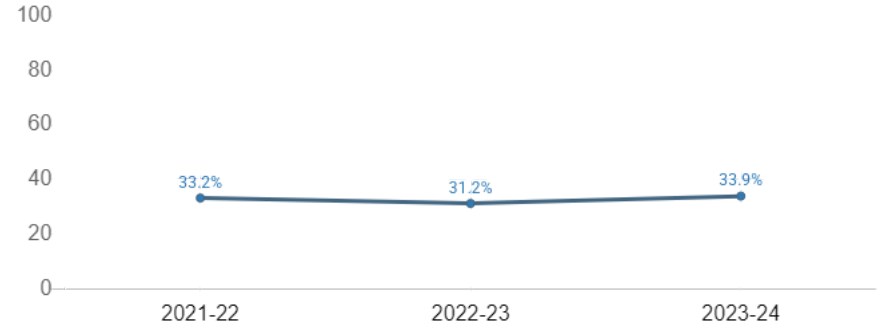
### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 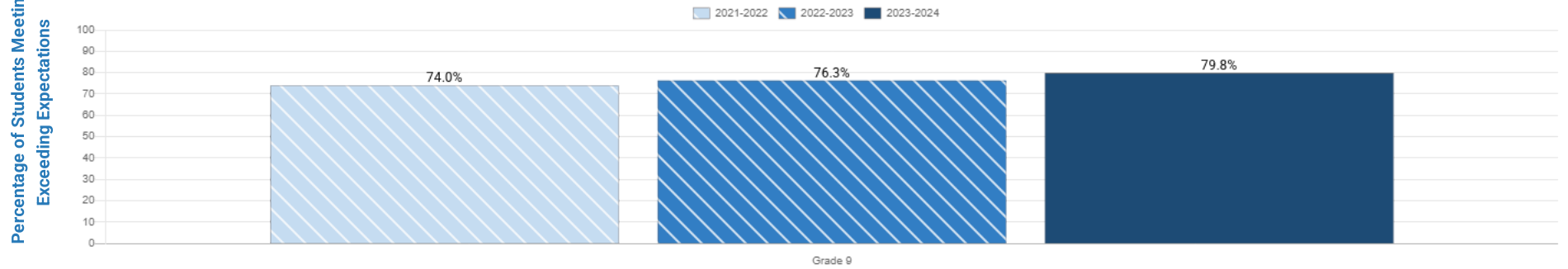

High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 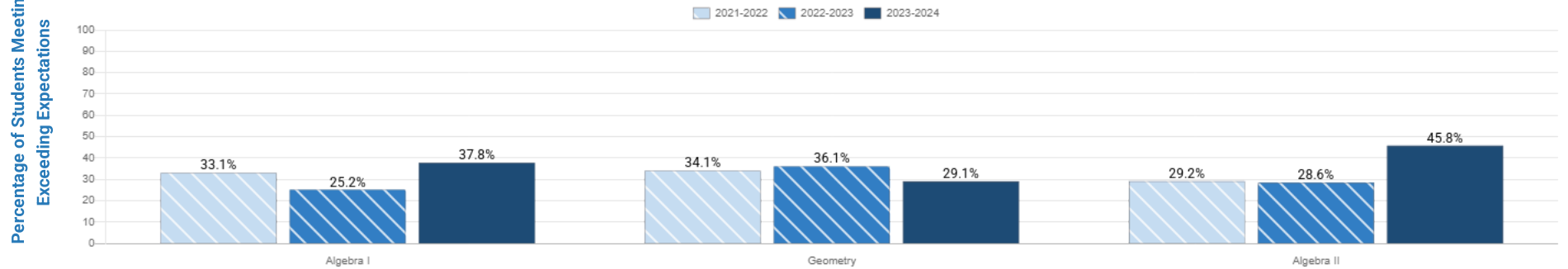

Students in sixth grade who were enrolled in Algebra I course were required to take both the Algebra I and Grade 6 mathematics assessment. The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

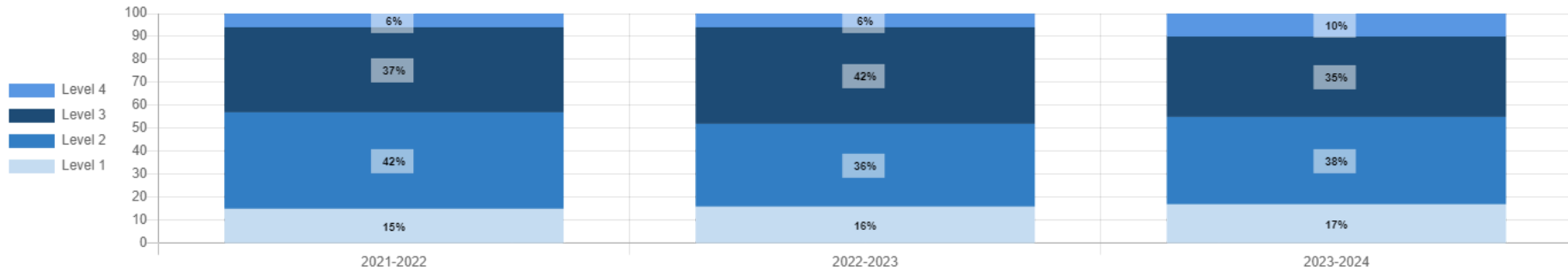

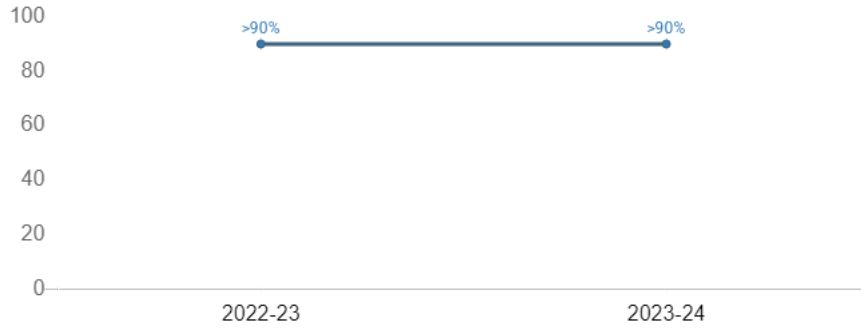

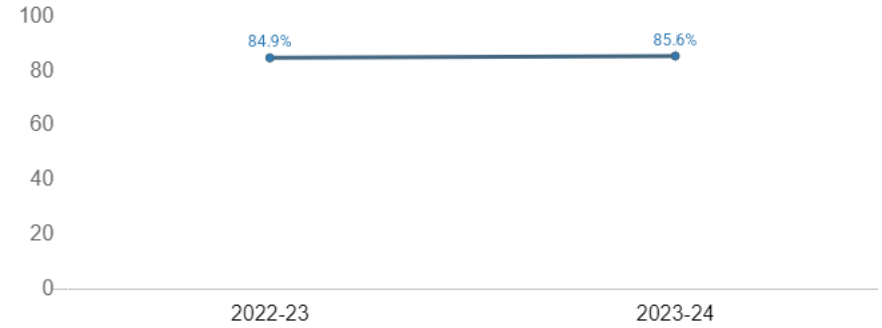

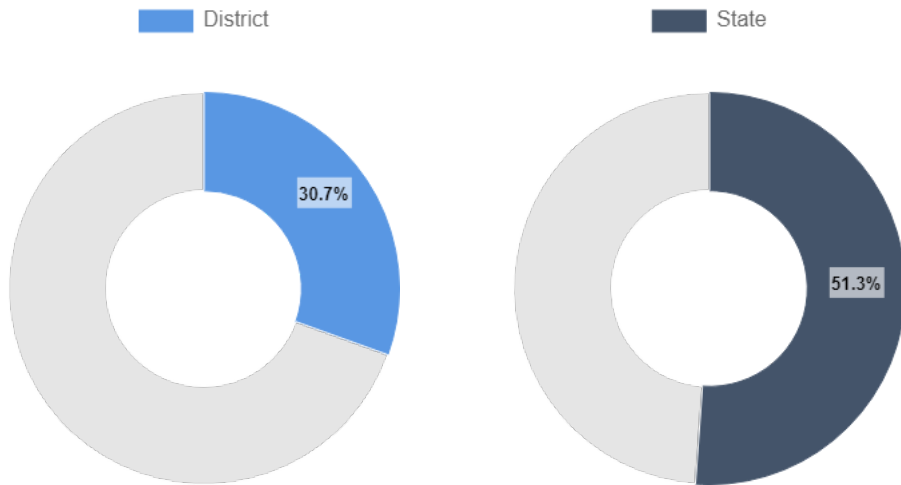

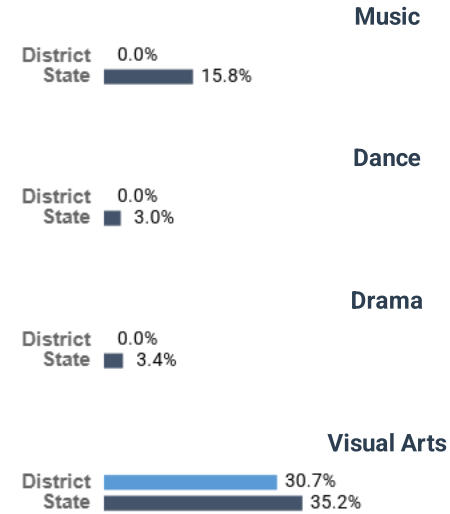

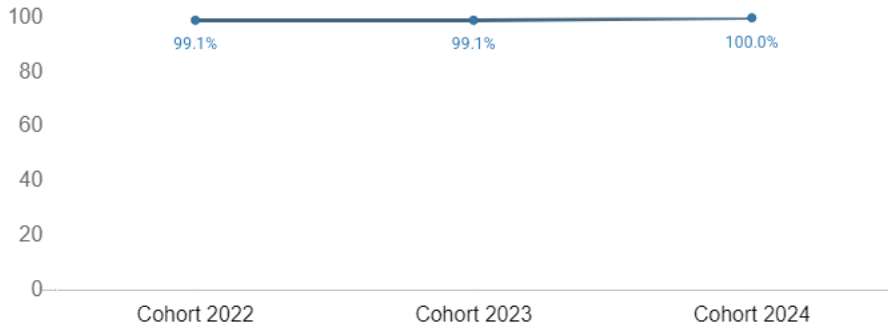

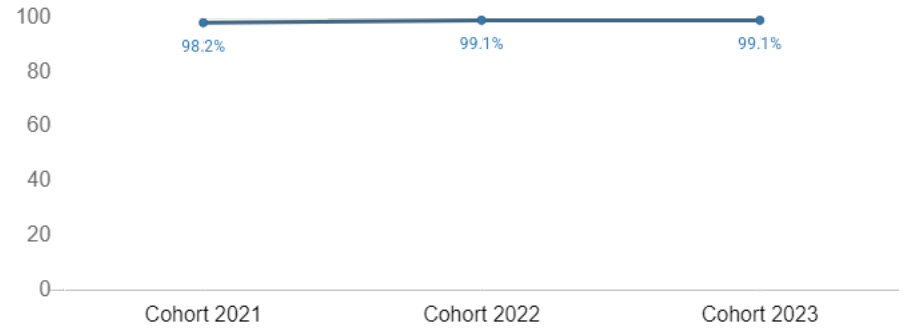

## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

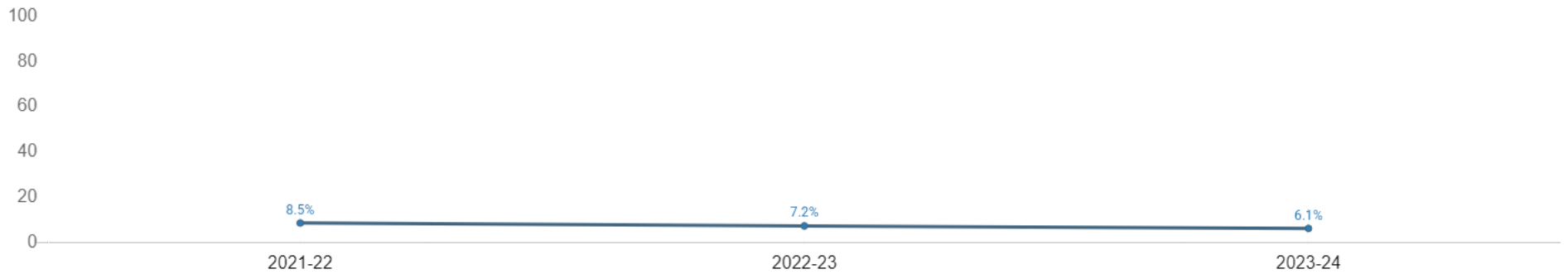

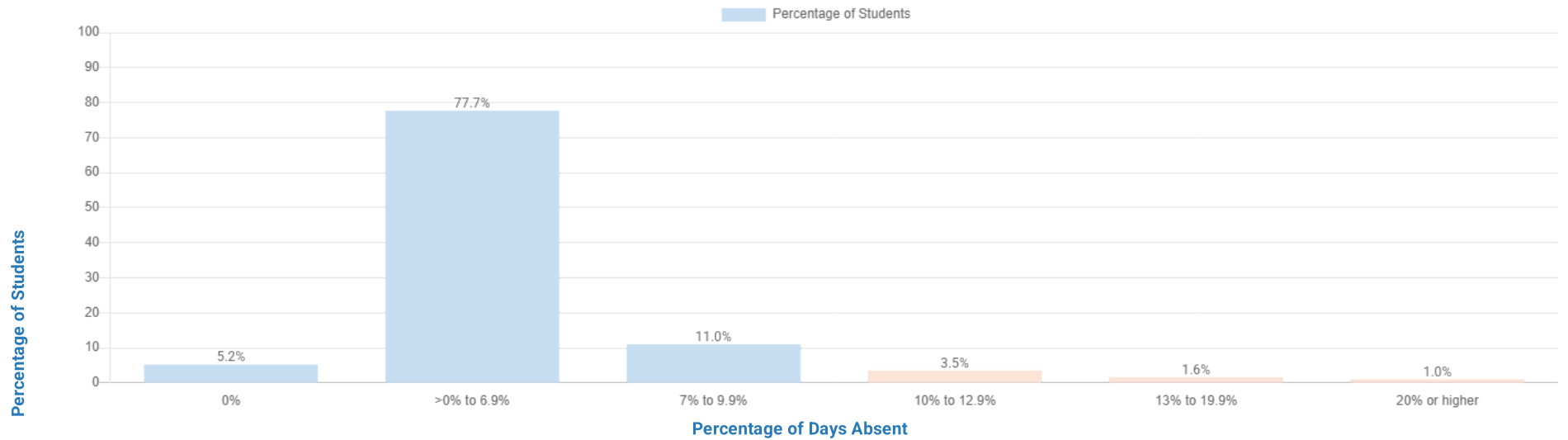

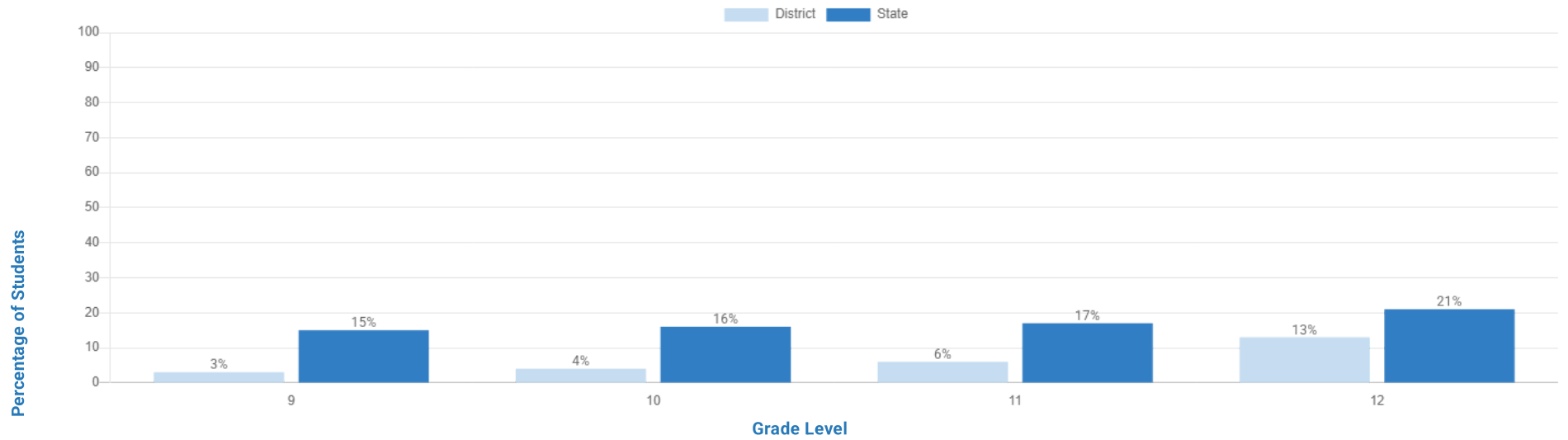

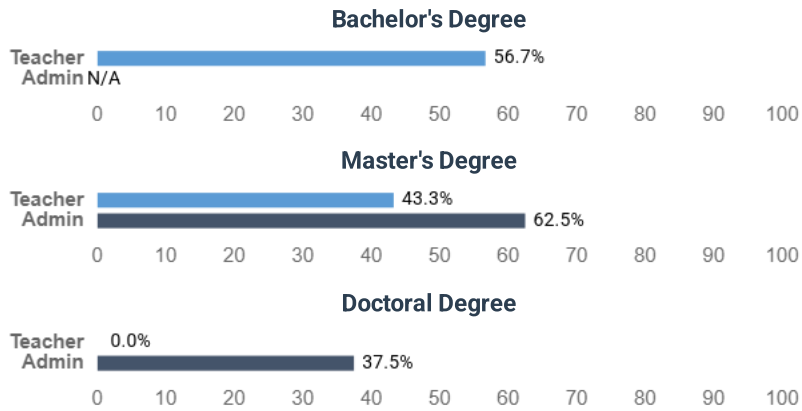

### Mission, Vision, Theme:

The vision of the Cumberland County Board of Vocational Education is for students to thrive in a dynamic and diverse global workforce. With future-aligned career pathways and advanced educational options, our goal is to ensure that all graduates become contributing members of society, empowered to navigate change, pursue learning, and lead our community. The Mission of the Cumberland County Technical Education Center is to foster student leadership, growth, and innovation within career and technical education, promoting a culture of academic rigor and curiosity through experiential, learner-focused education in a safe and inclusive environment.



### Courses, Curriculum, Instruction:

CCTEC is a CTE high school, providing students with a clear pathway into the global workforce through advanced educational opportunities. CCTEC has 11 state approved CTE programs: Automotive Technology, Construction Trades, Cosmetology, Culinary Arts & Hospitality, Engineering, Health Science & Medicine, Information Technology, Law Enforcement, Studio Production & Broadcasting, Innovation & Entrepreneurship, & Welding. To adapt to the demands of a rapidly evolving society, we continuously refine our courses & educational goals. The curriculum is thoughtfully crafted by a dedicated team of teachers & administrators, ensuring it meets the needs of all students. We offer a variety of programs, including challenging AP courses, dual enrollment options for earning college credits in partnership with RCSJ, school-to-work experiences, and co-curricular activities. All courses are delivered through Google Classroom, creating a central hub for students to connect and engage with their learning.



### Clubs and Activities:

CCTEC offers students a diverse array of clubs & activities designed to help them explore their interests, broaden their networks, & hone their professional skills. Students can engage in various clubs, including: Art, Channel ONE, Club Active, Drama, Gaming, GSA, Interact, Mock Trial, Model Congress, NHS, NTHS, Robotics, Newspaper, Spanish, Special Olympics, TEC Ambassadors, Inkwell, Sign Language, Youth-2-Youth, Speak-Up, Black Student Union, Chess, Jewelry, Marvel, Skateboarding, Yoga, D&D, LEGO & Yearbook. CCTEC encourages participation in one of our CTE Student Organizations. The active chapters of HOSA & SkillsUSA offer students the chance to compete in their technical fields at the state, regional, & national levels. CCTEC allows students to run for class officer positions within student-elected bodies representing each class. These leadership groups play a role in organizing spirit weeks, school dances, fundraising events, & various activities that enhance the student experience.

### Staff and Professional Learning:

New teachers participate in a 3 day orientation. This program covers classroom management strategies, cooperative learning, data-driven instruction, questioning & discussion techniques, assessment strategies, technology integration, & student-centered learning. It begins with a tour of the County, allowing new staff members to explore local businesses & neighborhoods, fostering a sense of community & connection. CCTEC offers weekly PD workshops held after school & during prep periods. These voluntary workshops are communicated through a weekly staff newsletter & are facilitated by both administration & faculty. CCTEC has integrated PLCs into the master schedule, granting faculty time during their duty periods to collaborate with PLC members. During these meetings, staff members utilize data-driven protocols to identify gaps in instructional practices, co-plan lessons, & discuss strategies to enhance student outcomes, ultimately fostering continuous improvement in teaching & learning.



### Postsecondary Information:

CCTEC is a CTE high school with 11 programs. All 11 programs culminate in either the obtainment of college credit, an industry-valued credential, or enrollment in a registered apprenticeship. Beginning in their freshman year, students can automatically dual enroll at RCSJ & have the potential to earn college credits through a combination of courses taught at CCTEC & at RCSJ. Those who decide to take additional college courses taught by RCSJ have the opportunity to earn an associate degree by the time they graduate from high school. We cover all tuition fees & course materials, reducing the financial burden of post-secondary education. Students interested in transitioning directly to the workforce after graduation, CCTEC employs a full-time School-to-Work coordinator, who matches potential employers with CTE students looking to enter their trade post-graduation. Through the STW program, students can earn high school credit while working a paid job that aligns with their CTE program.



### Student Supports and Services:

The Student Services department is dedicated to providing support to all students, equipping them for success in college and their future careers. All students has access to a guidance counselor, an ECHS counselor, & a STW coordinator, ensuring personalized assistance. For students with IEPs, support is facilitated through the Child Study Team. This includes a range of resources, from in-class support to self-contained classrooms within the STRIVE program. The I&RS team consists of an administrator, social worker, counselor, teacher, & nurse, all working collaboratively to address student needs. We have established partnerships with several community organizations, such as ACENDA, which operates an office on campus, as well as BBBS of Cumberland County and SpeakUp! Students benefit from a 30-minute remediation period, allowing them to meet with their classroom teachers or engage in various clubs. CCTEC offers an after-school homework club for students seeking further academic support.

### Student Health and Wellness:

CCTEC provides an extensive Health and PE Program with a primary emphasis on lifetime fitness & wellness. Students learn to set fitness goals & develop personalized training regimens tailored to their needs. Students benefit from a daily 30-minute remediation period known as the SMART period, which allows them to engage in physical activities at the gym or fitness center. After school, students can participate in Club Active, a program that fosters teamwork through various activities. For those interested in sports, CCTEC facilitates transportation to their resident districts. Recognizing that nutrition plays a crucial role in overall wellness, our food service vendor offers a comprehensive breakfast and lunch program for all students. Throughout the cafeteria, informative signage highlights the significance of incorporating whole grains, dairy, fruits, & vegetables into students' daily diets, promoting healthy eating habits that support their fitness journey.



### Parent and Community Involvement:

At CCTEC, we value communication with parents. Each week, the Principal sends out an email that highlights upcoming student activities & events, available in both English and Spanish. Throughout the year, we also invite parents to participate in evening informational events, including Back-to-School Night, Junior College Planning Night, Senior College Planning Night, ECHS Night, Technology Night, & STEAM Night. In the classroom, we encourage parents to take an active role in their child's education. Each class utilizes Google Classroom, which features a parent portal that provides access to specific classroom assignments & grades. Parents have access to our Genesis student information system. By logging into Genesis, they can view & monitor their child's grades, attendance, & discipline referrals. To further enhance our partnership, the Principal meets with the PTO on a monthly basis. This collaboration helps ensure that we are all working together to support our students' success.



### Climate Surveys:

Each year CCTEC administers an annual School Climate Survey to students, parents, administrators, and staff members. This Survey is anonymous, and is designed to provide the administration and the Board of Education with data to determine the perception of our school to students, parents, administrators, and staff members. Questions relate to a variety of areas, including school safety and climate, teaching and learning, technology integration, and facility maintenance. Data from the survey is analyzed and shared with CCTEC's faculty, BOE, and the PTO. The data is triangulated and action steps are developed to address areas of concern.

### Facilities:

In 2016, CCTEC proudly unveiled a cutting-edge facility spanning 205,000 square feet. Since then, we have expanded our campus with an additional 50,000 square feet dedicated to our health sciences and medical programs. Most recently, we introduced a new manufacturing program (Innovation, Design, and Entrepreneurship) and equipped a state-of-the-art fabrication laboratory, ensuring that students have access to industry-standard equipment. These exceptional facilities enable CCTEC to deliver a high-quality Career and Technical Education (CTE) curriculum while fostering valuable partnerships with post-secondary institutions and the community.



### School Safety:

The School Safety Unit is comprised of an armed unit of retired law enforcement officers. All school safety officers attend a certification course sponsored and approved by the NJ Police Training Commission. A massive camera surveillance system encompasses the internal and external campus perimeters. Entry into the school is controlled; visitors are screened and must produce an official identification. CCTEC strives to take a proactive role in student safety. The "Students Anonymously Forwarding Evidence" program allows students to anonymously report possible threats of school violence being planned. The School Safety Unit is also engaged in a drug awareness program, "Not Even Once," approved by the NJDOE. In September 2018 a K-9 member, "Meadow," was added to the School Safety Unit as an extra deterrent to any individual who may be planning a violent and/or disruptive event.



### Technology and STEM:

Our district implemented a 1:1 Chromebook program, ensuring that each student is equipped with a school-owned device. Our technology committee drives the development of our 1:1 policies & the selection of digital learning tools, ensuring we meet the educational needs of our students effectively. Technology plays a vital role in our daily curriculum, enhancing learning experiences across all subjects. Teachers are expected to stay updated on our online digital gradebook, which is accessible to both parents and students, fostering transparency and communication. CCTEC offers a diverse array of programs focused on STEM. Our offerings include Auto Technology, Construction Trades, Engineering, Innovation & Entrepreneurship, Health Science & Medicine, Information Technology, Studio Production & Broadcasting, and Welding. We house some of the latest technological equipment available in the industry, providing our students with hands-on experience in cutting-edge fields.
