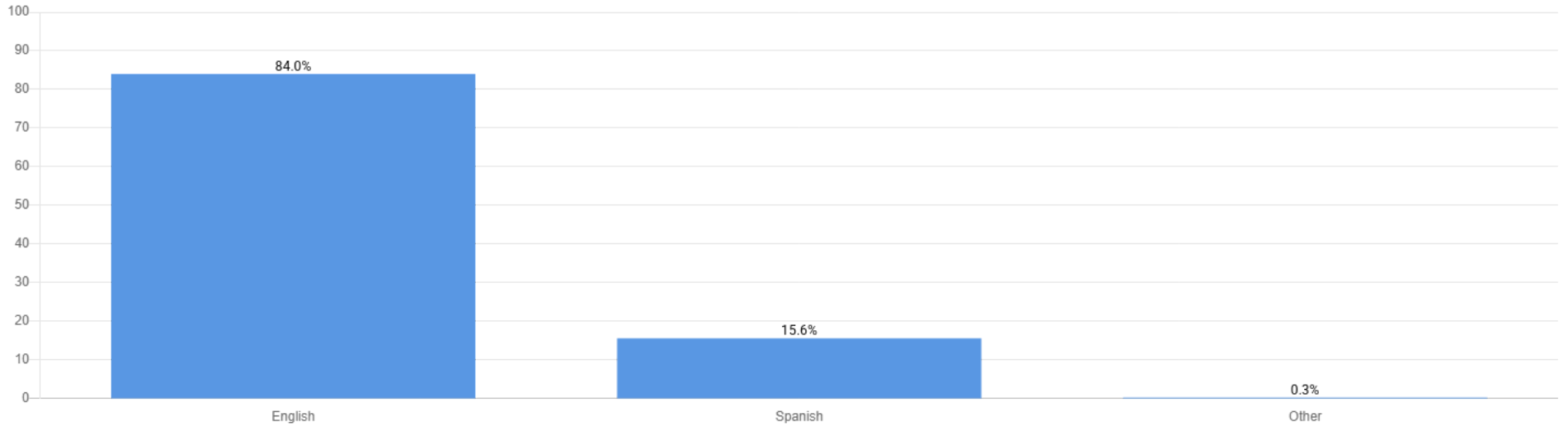

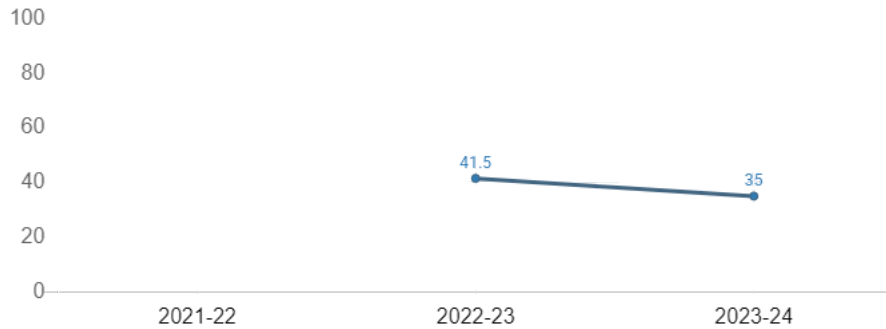

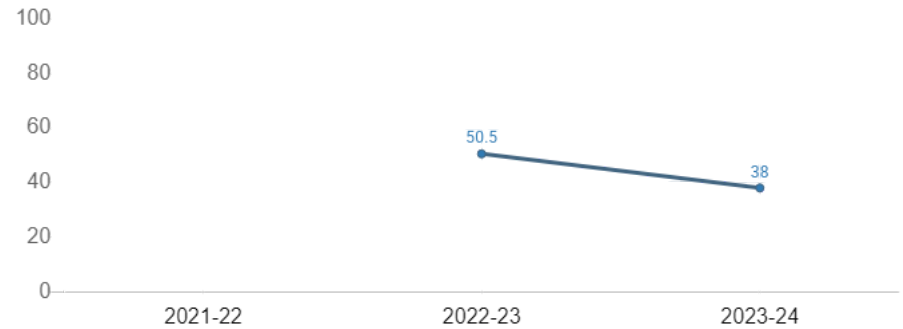

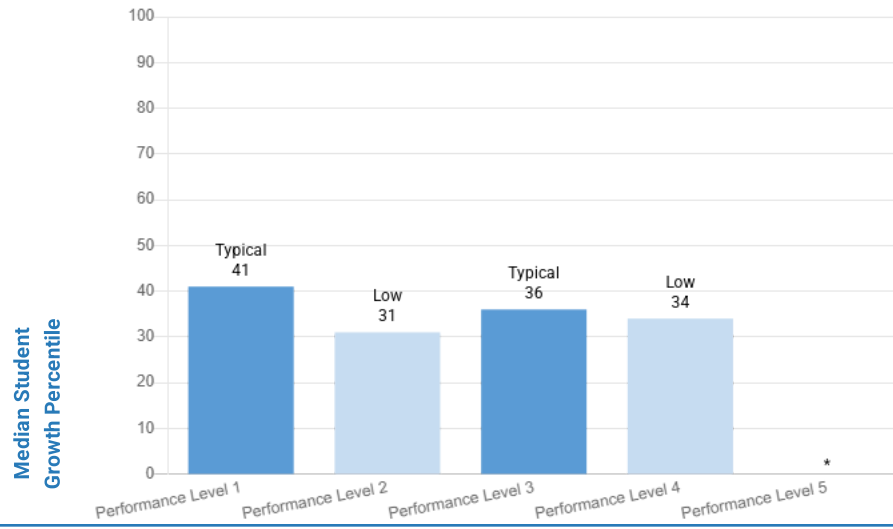

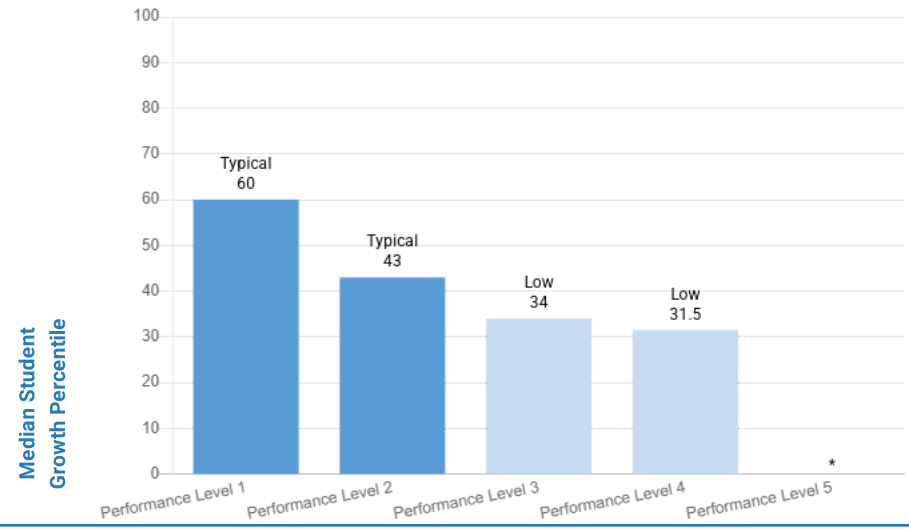

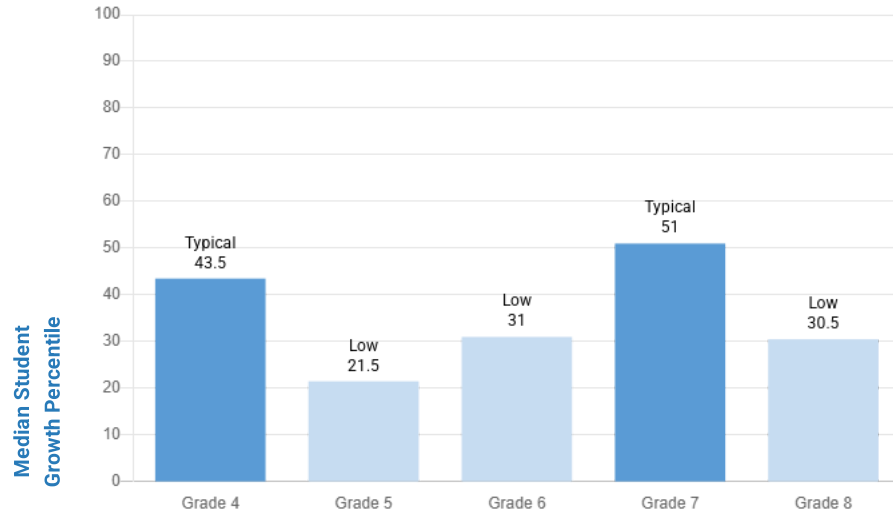

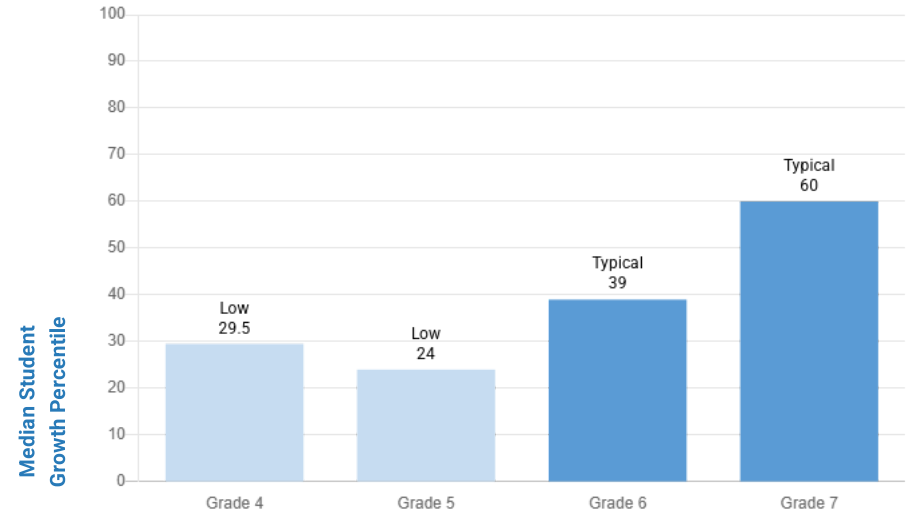

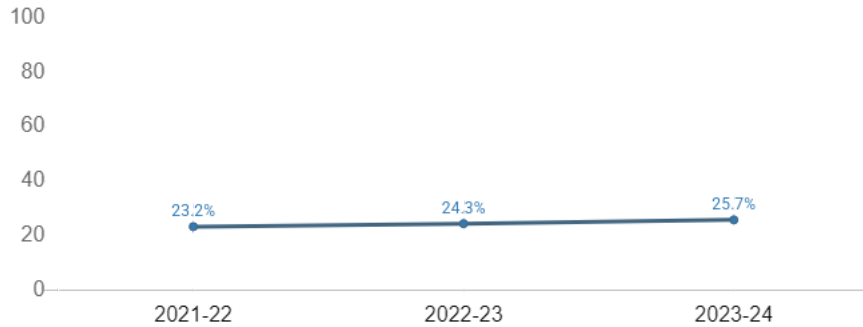

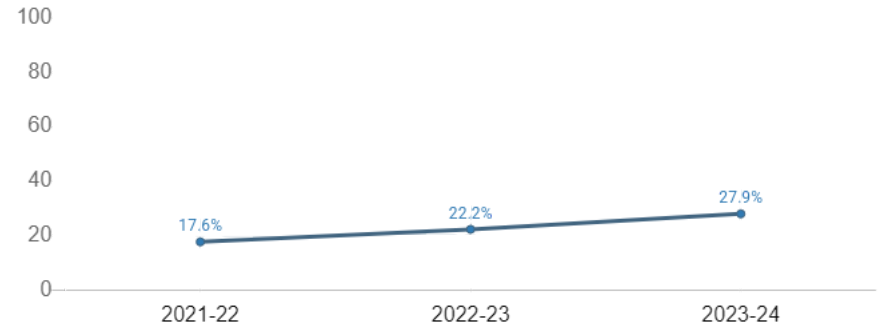
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 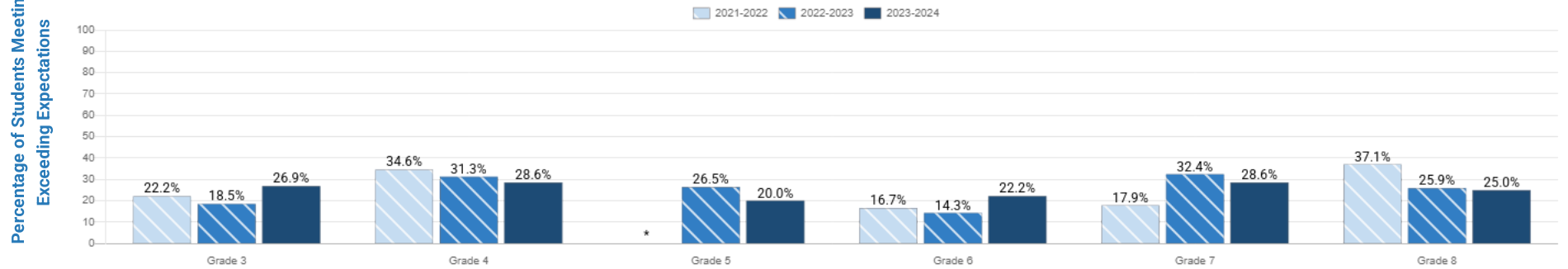

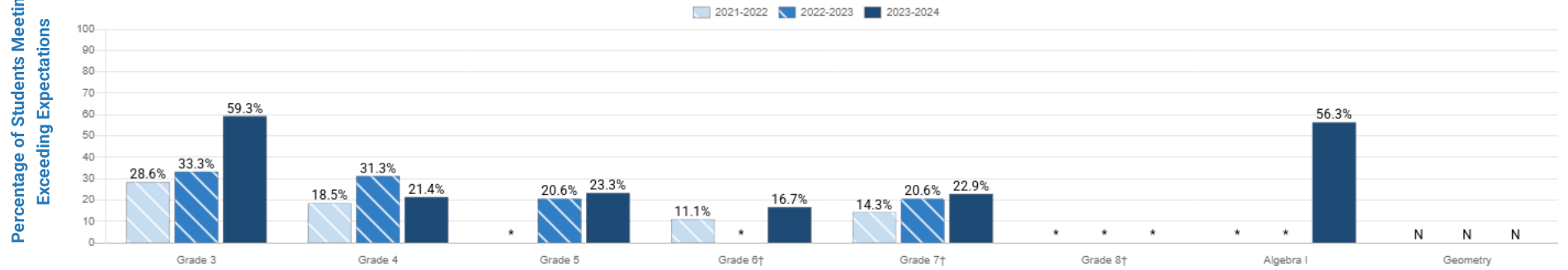

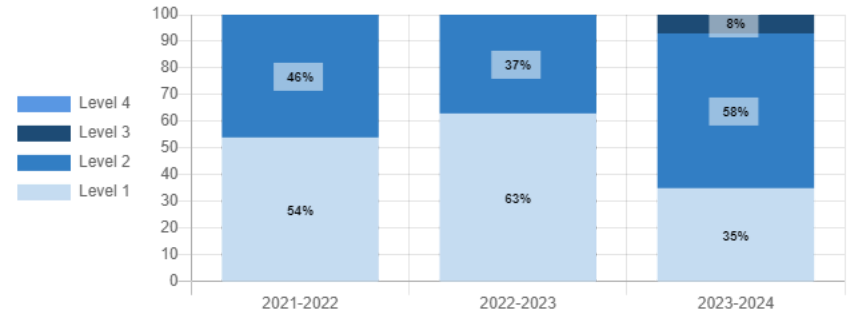

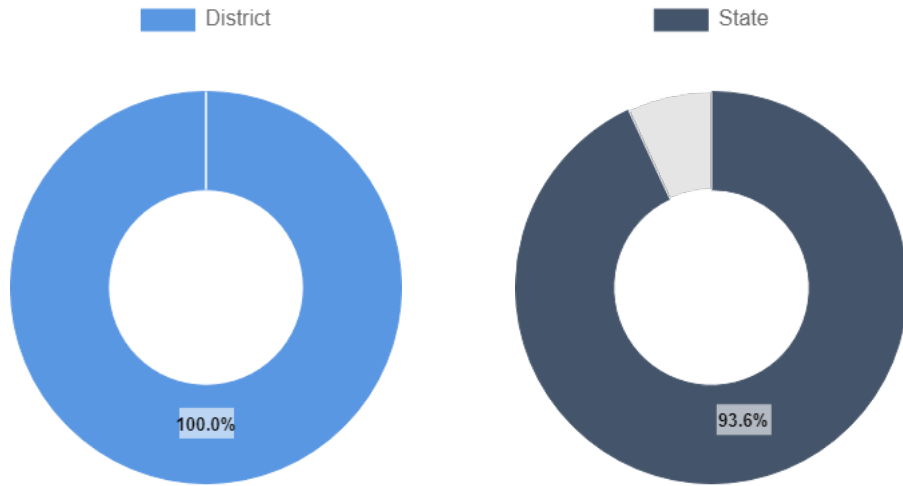

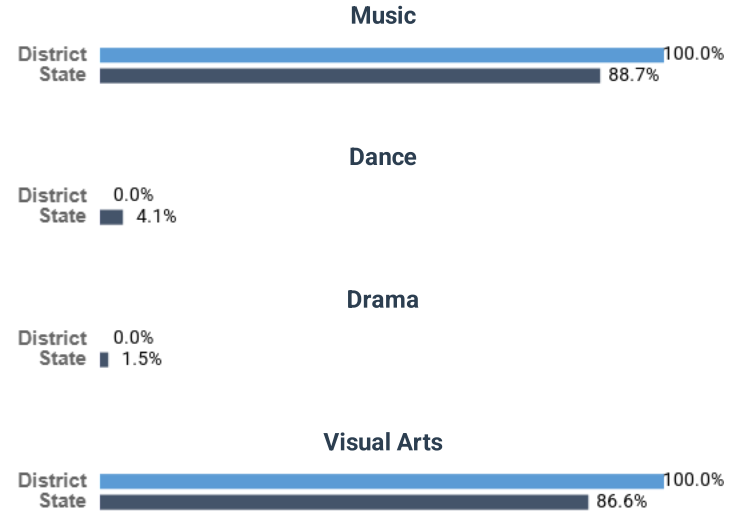

Students enrolled in one or more classes by discipline:



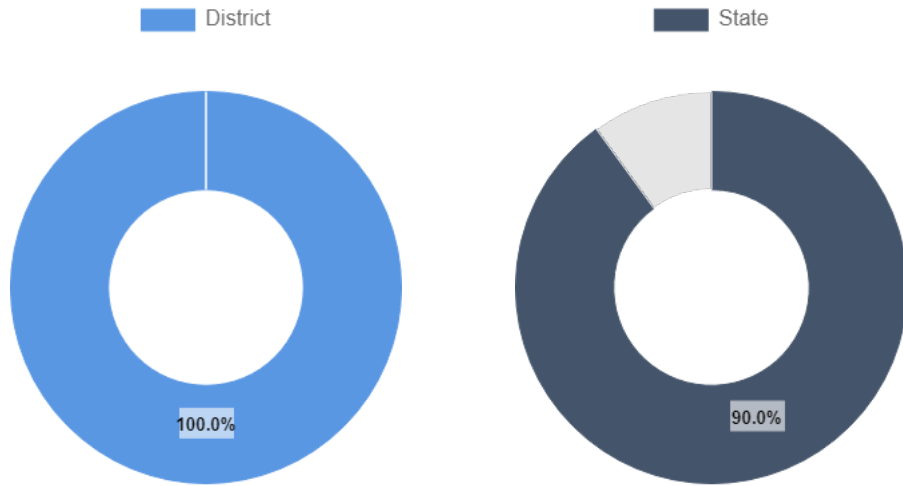

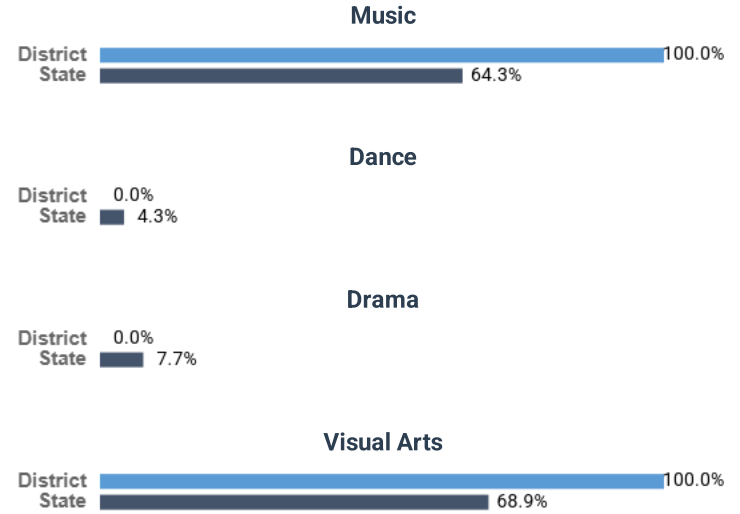

Students enrolled in one or more classes by discipline:

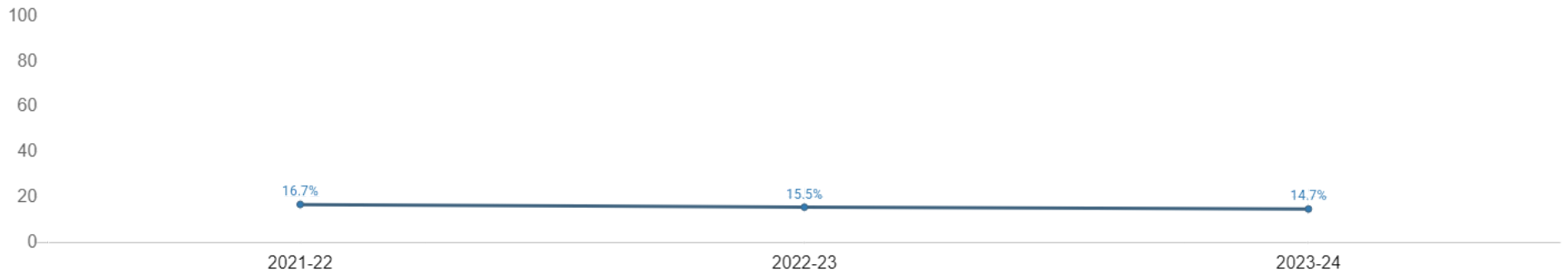

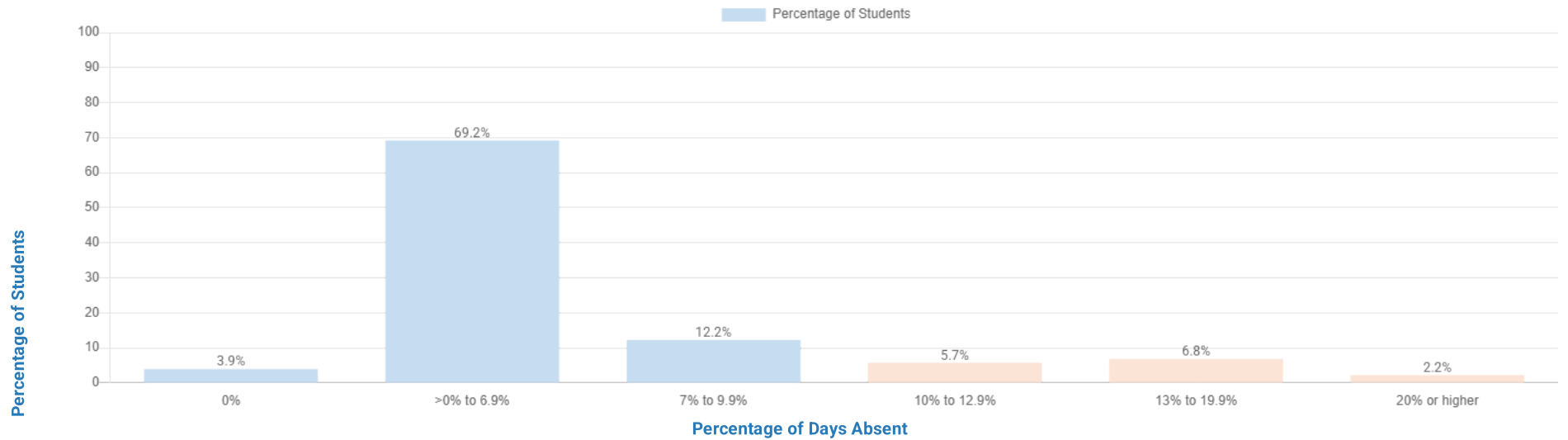

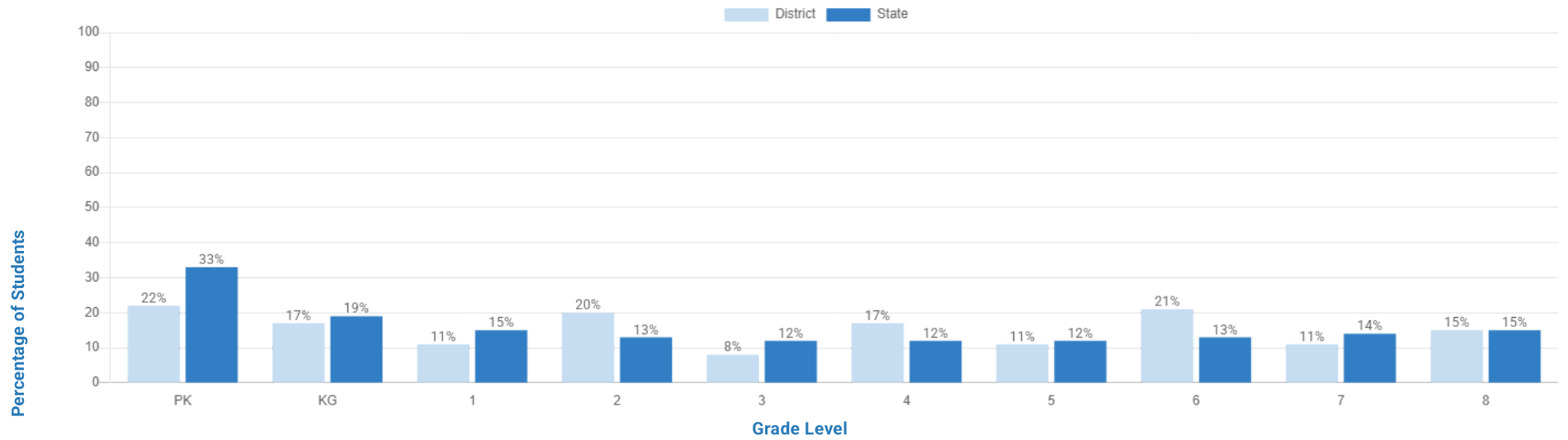

Staff

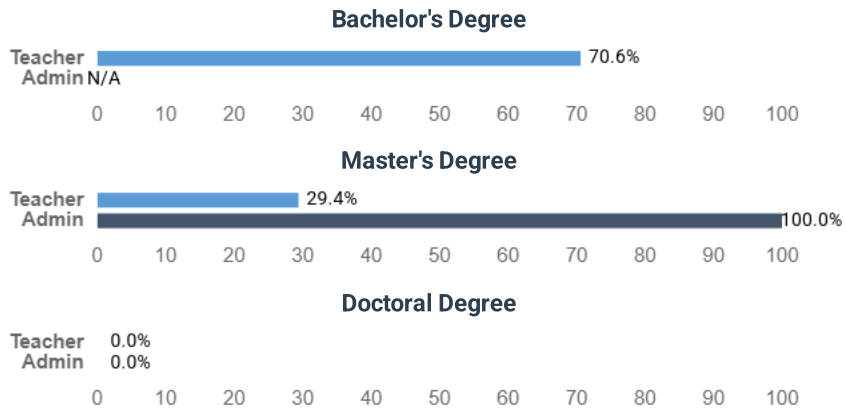

Our district is part of the CRHS Curriculum Consortium to ensure our students are prepared for high school. The consortium works collaboratively to share resources, professional development opportunities and curricula (when possible) to ensure that students are "on track" when they transfer to another school within the consortium. For ELA, we use Journeys for our K-5 and novel-based instruction for 6-8. For Math, K-8 uses Big Ideas. To help close gaps of foundational skills, students work an individualized learning path through the iReady program. We offer two advanced middle school math classes: Accelerated Math for grade 7 and Algebra I for grade 8. In addition to the core academic areas, students receive instruction in the following special areas: Art, Health/PE, STEM, Financial Literacy, Performing Arts and Spanish.

Clubs and activities are offered after school for students in grades 1 - 8. DTS offers Academic Lab, an after school tutoring program, to any student who wishes to receive the additional support. YMCA provides a before and after school care program on site for all students.

Teachers work collaboratively in PLCs weekly to build capacity and increase student achievement. Our district collaborates with the CRHS Consortium to broaden the PD available and offer teachers the opportunity to collaborate with teachers from other districts. Our I&RS Team and CST support students who are having academic, behavioral or social difficulties. We also have a guidance counselor and social worker to assist students in the acquisition and development of social skills. Our staff members provide classroom based character education/health lessons in all grade levels, including instruction in social and emotional learning through the Second Step curriculum and program. Additional services are provided in the areas of behavioral support, speech, OT, and PT. The Barton Reading Program is used in our BSI program to support students in ELA.

A breakfast program is offered to all students. We have a Life Skills Curriculum which is delivered to all students in grades PK-8. SNAP-ED works with the students to share ways to eat healthy, maintain physically active lifestyles, and ways to build a healthier community. This is done through direct instruction and hands-on activities, including recipes based on locally grown produce.



Parent and Community Involvement:

PTO provides activities for our students and their families including, but not limited to: Trunk-or-Treat, school dances, family fun nights, movie night, family paint night, and field day. Our PTO also holds a Winter Gift Shop and a Book Fair in an effort to raise funds and provide students and parents the convenience and opportunity to purchase low cost holiday gifts and books. Our parents are encouraged to attend special school functions such as concerts, Student Showcase Night, and orientation/registration programs. Families of students in grades K-2, are invited to attend classroom celebrations. Families are encouraged to attend board meetings where we recognize several students each month. We also offer opportunities for parent involvement on committees and advisory groups (i.e. Special Education Parent Advisory Group, Early Childhood Advocacy Committee, School Safety Team, Governor's Educator of the Year and Educational Services Professional of the Year Committee, etc.).

The school has a middle school science lab, library, gymnasium and art room. The preschool and kindergarten wing each have their own fenced in play yard. There are also playgrounds, baseball, and soccer fields for the older students. Continual improvements in technology include building wide updated wireless internet access and in 2021, the district added a complete 1:1 initiative that provided each student with their own chromebook. Central air conditioning in all areas of the school allows for a more conducive learning environment.



School Safety:

Security cameras have been installed in locations both inside and outside of the building to enhance safety and security measures. Visitor procedures and other safety/security measures and procedures are in place. Student drop off and pick up procedures allow for a more structured routine which prevents students from entering busy traffic areas, increases staff visibility, and improves the overall timeliness of the process. The main entrance security vestibule project was recently completed. In 2021, the district added school safety officers to the school during hours of student attendance. These officers are all SRO trained.



Technology and STEM:

Technology STEM: All students have STEM as a special area class. We also have an after school STEM Club/Lego League. We are a 1:1 district that provides every student with their own Chromebook. Every classroom was equipped with a smartboard projector at the end of the 2022-2023 school year.
