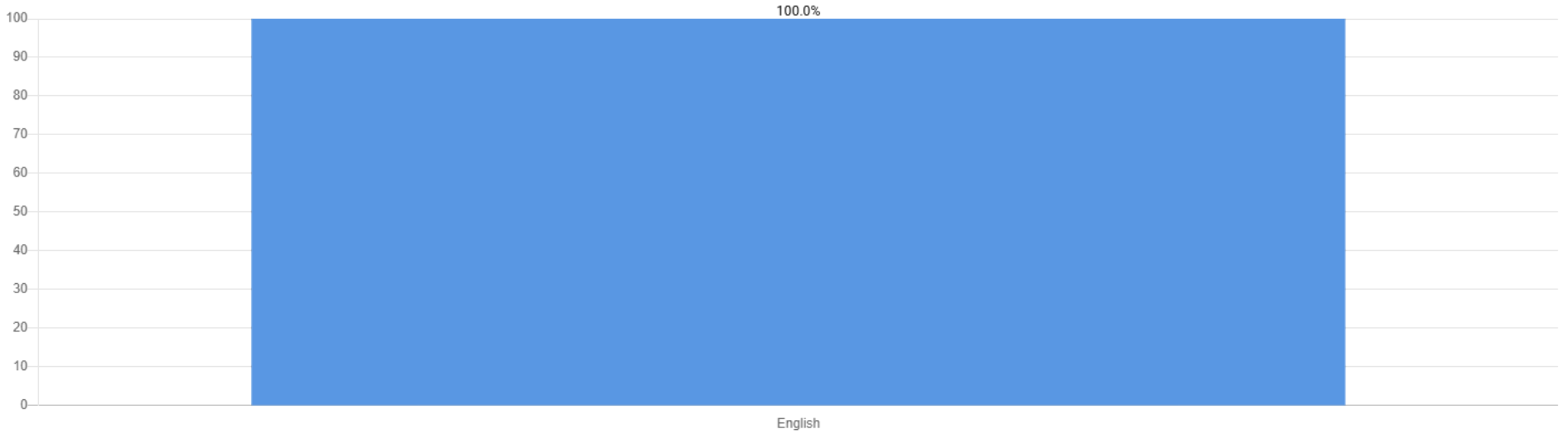

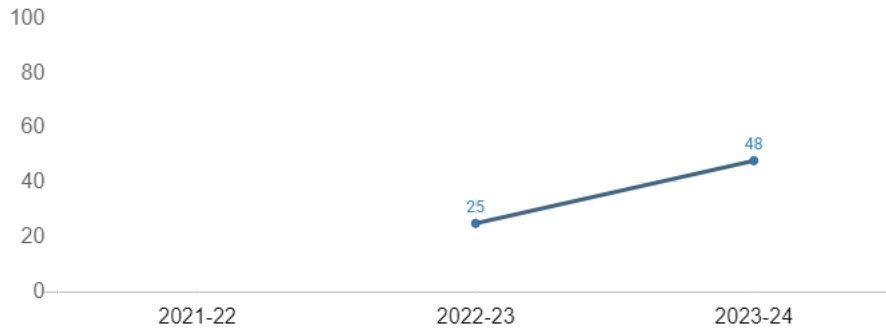

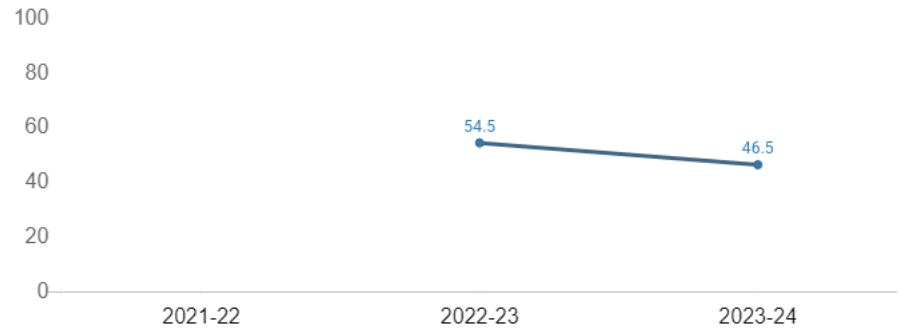

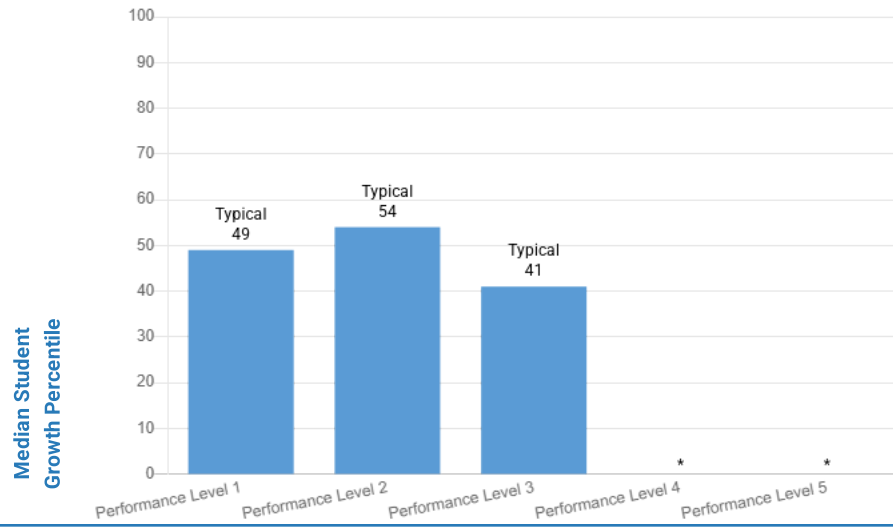

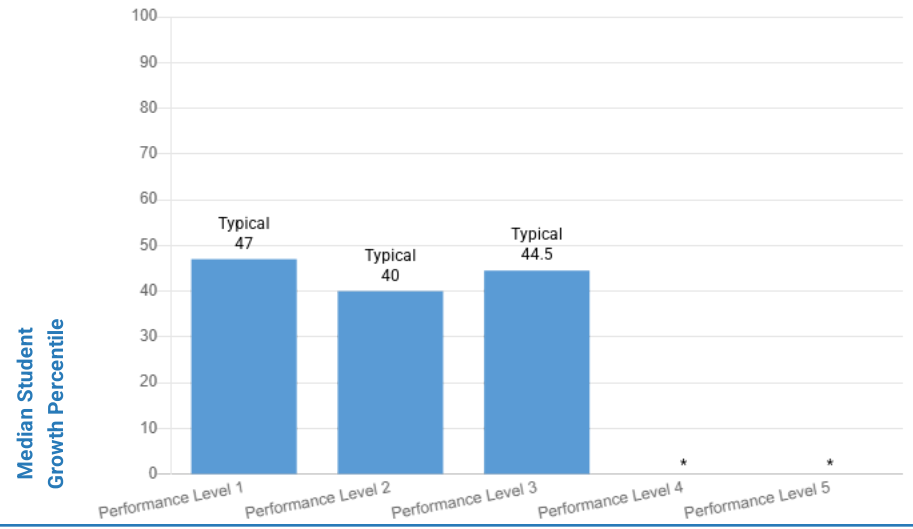

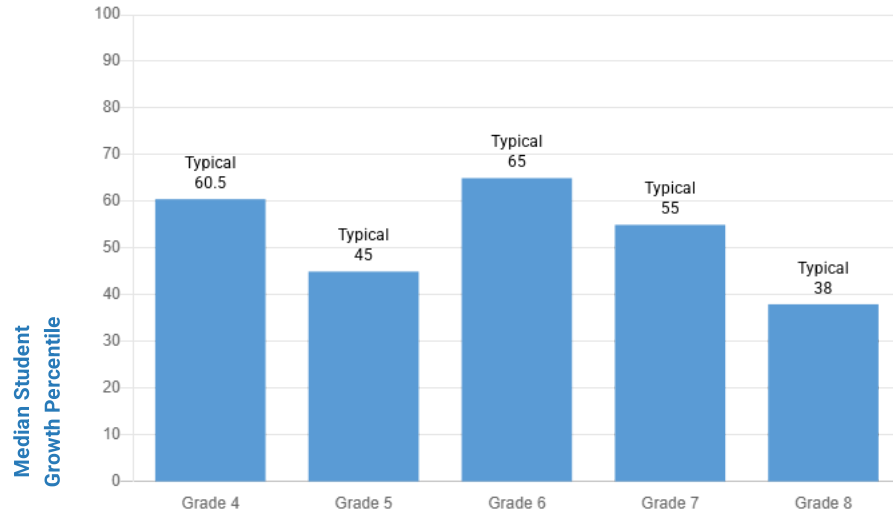

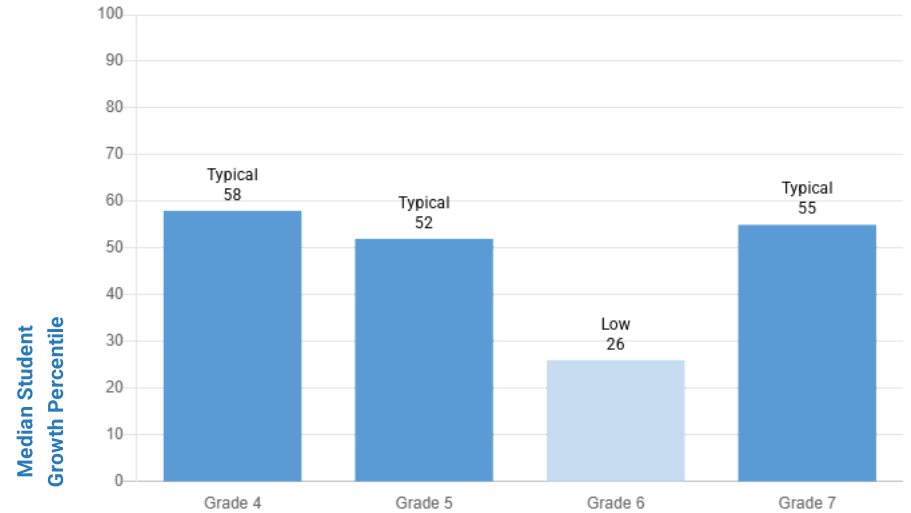

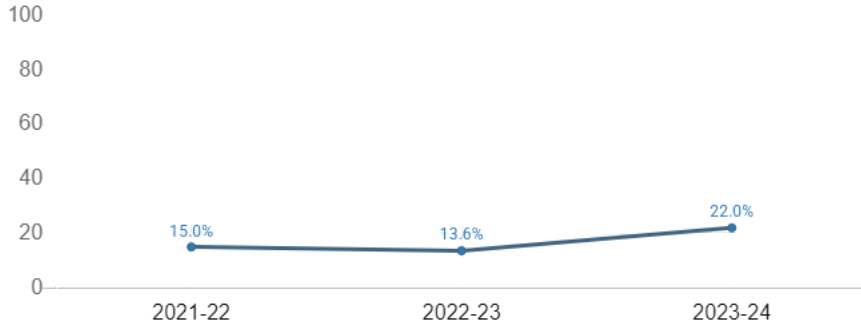

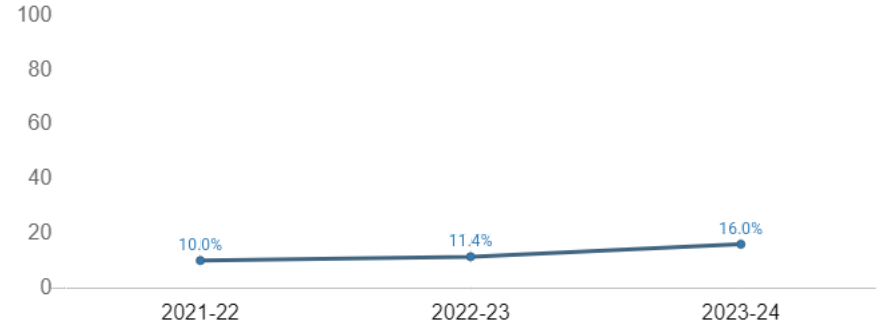
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 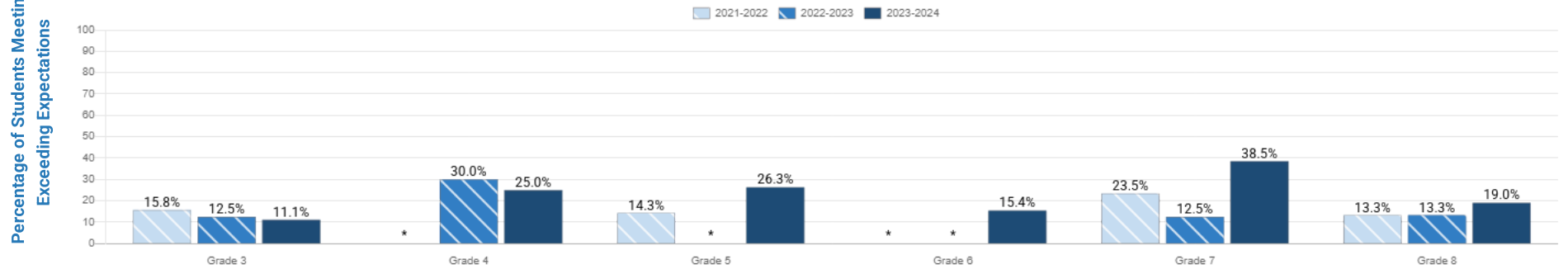

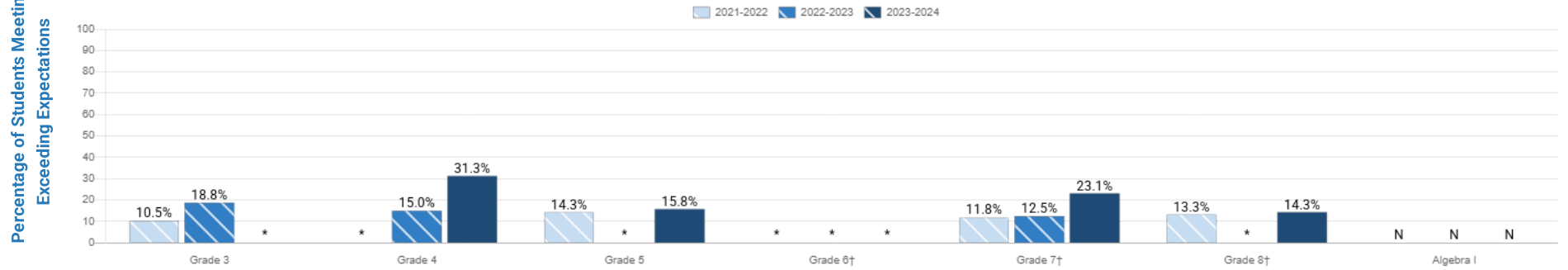

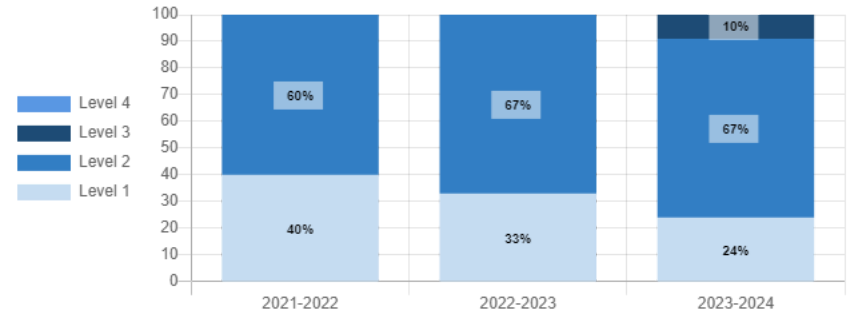
NJSLA Science Assessment: Grade 5 Summary

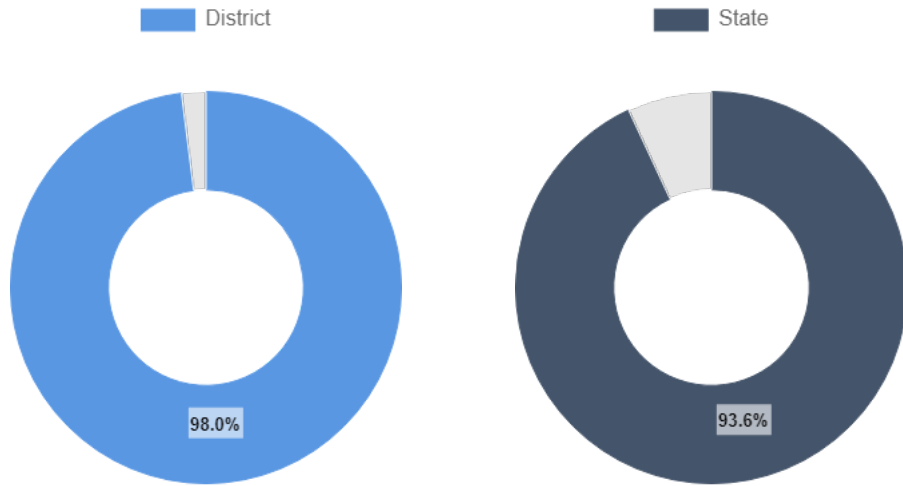

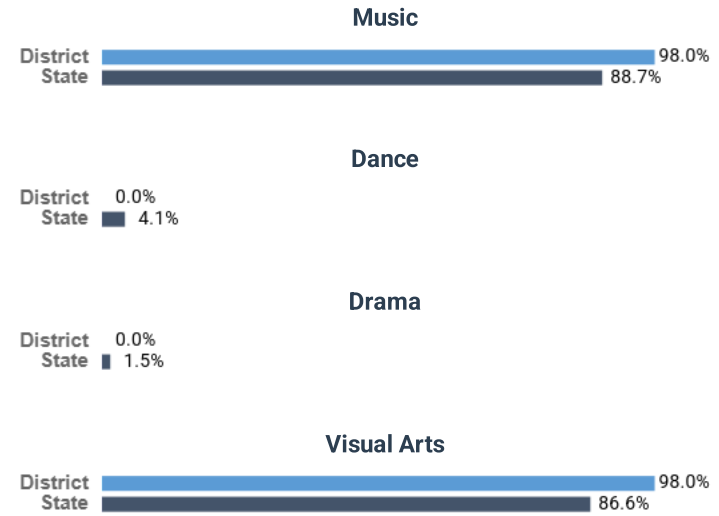

Students enrolled in one or more classes by discipline:



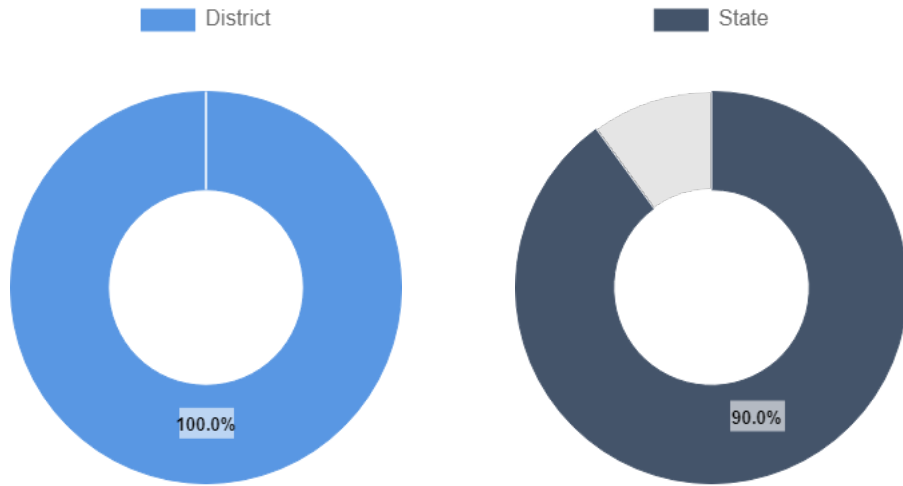

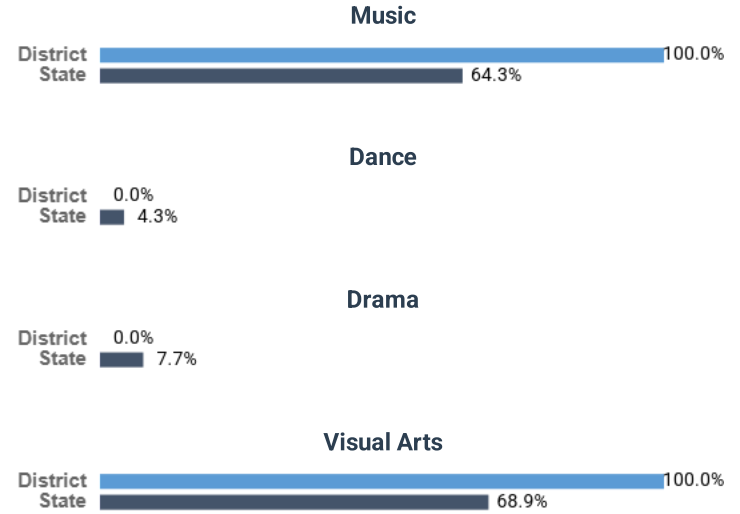

Students enrolled in one or more classes by discipline:

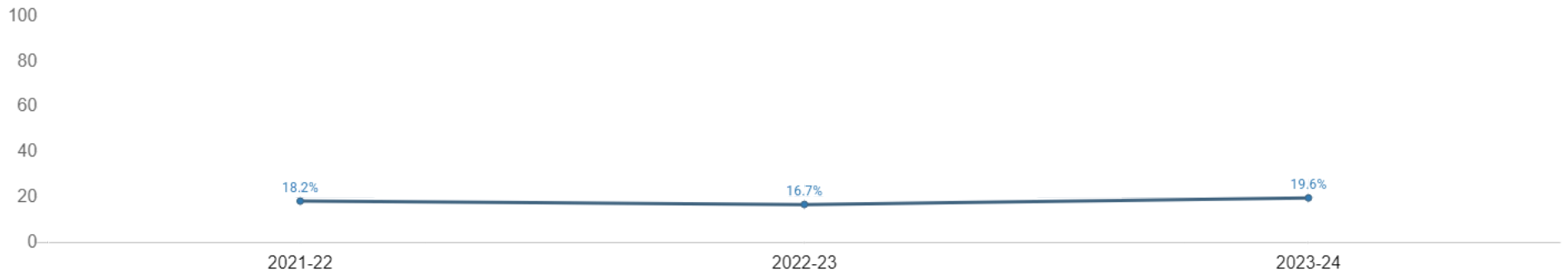

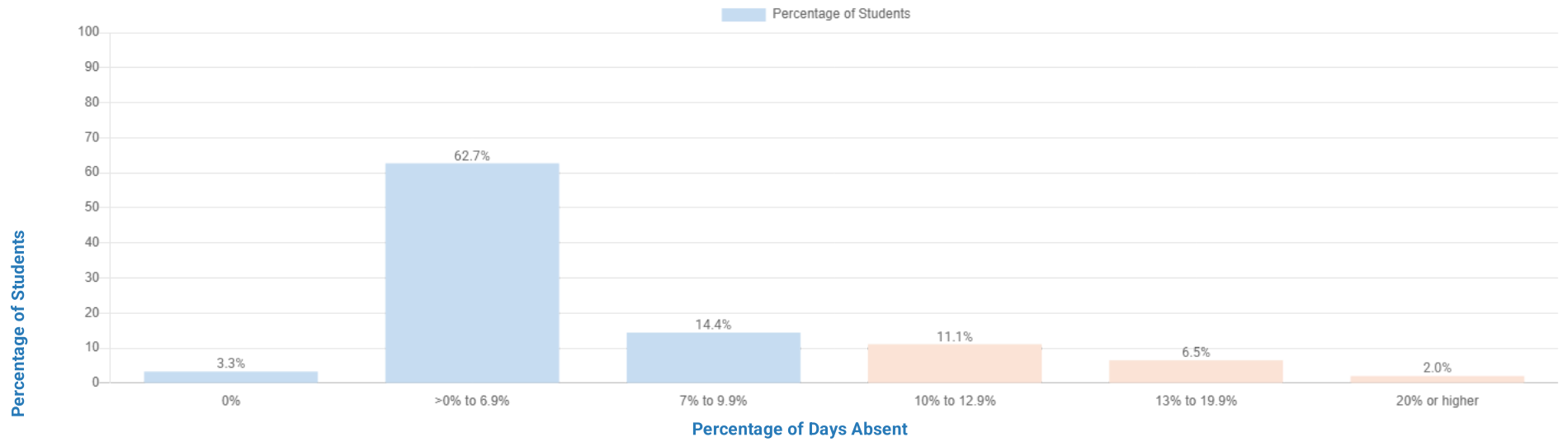

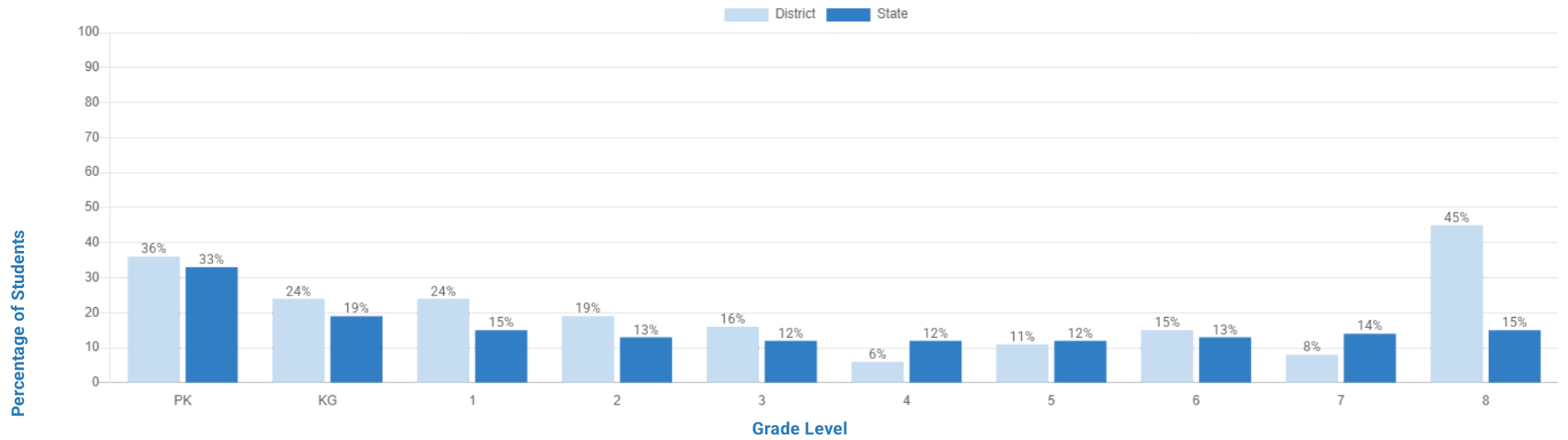

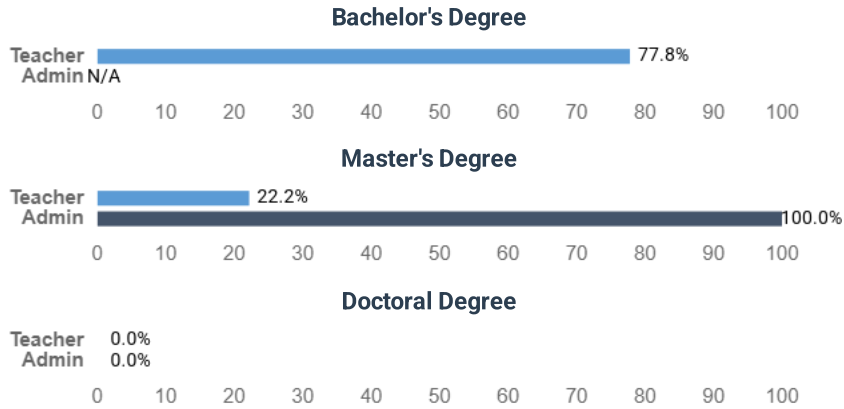

We have held parent meetings. We promote improved attendance by informing parents about the impact of chronic absenteeism. We increased activities and extra curriculars to encourage school attendance. Our attendance policy was reviewed and revised to reflect the updates and revisions by the state.
