







Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.





Staff and Professional Learning:

The Cedar Grove School District fervently supports professional learning that focuses on the needs of each student to promote gains in student achievement; this year, a district goal is to utilize multiple measures of data to inform instruction. Committed to utilizing the Linklt!, staff receives ongoing support and help to diagnose student performance. For the 24-25 school year, an intensive Mathematics PD program was launched to support training in Grades K - Algebra. We continue our partnership with the Montclair State University Network for Education Renewals, and many teachers not only participate in workshops and grant writing, but they have met the requirements to be considered clinical faculty members of the university.



The high school offers dual enrollment programs with Syracuse University, Kean University and Fairleigh Dickinson University including courses in Accounting I, Sports & Entertainment Management, Holocaust & Genocide, Foundations of Human Behavior, Introduction to Criminal Justice and Tomorrow"s Teachers. Cedar Grove Public Schools look to the utilization of a climate survey to understand needs and strengths from the perspectives of students, families, and staff, but will also provide insight into a school community?s relationships, safety, sense of connectedness, teaching and learning, and measures of an equitable and supportive learning environment, including supports for social and emotional learning.



The Cedar Grove Public Schools is in the process of upgrading all compatible HVAC equipment to a district wide central BMS system. The facilities department will be able to increase fresh air into the classrooms and control all compatible HVAC devices with this upgrade, which in return will save on energy costs.



In 2018, the community of Cedar Grove supported a \$2.9 million referendum related to school safety and security. The package included the construction of security vestibules, the installation of video surveillance equipment, the addition of window film, a card access system for all doors, a visitor management system, security motion detection system, upgraded telecommunication system, ADA compliance upgrades, site/drainage improvements and back-up generator power. In 2021, a school security grant was used to purchase additional cameras.

Technology and STEM:

STEAM is flourishing in Cedar Grove. At our middle school, the cycle course in technology and STEM has been thriving and serving as a foundation in non-traditional instruction in which students are immersed in the Engineering Design process. In a collaborative environment, utilize Lego Mindstorm, 3D printers and learning about CAD software. Our high school now boasts a Robotics Club as an extension of the STEM and Engineering Robotics courses coordinating with the STEAM Learning Center. Due to the popularity of STEAM in Cedar Grove, further opportunities were discussed. The STEAM Academy was conceptualized in winter/spring of 2021 and launched in Grade 9 in the 21-22 school year. Students will participate in semester courses in Engineering and Computer Science beginning freshman year. In addition, a capstone Product Design course is being piloted during the 21-22 school year.



The Cedar Grove Public Schools offers a full day integrated preschool program for qualified 3 and 4 year olds. The district also offers a full-day ABA preschool program for qualified 3 and 4 year old.
