





Before and After School Programs:

Tiny Treasures, a local child care facility, has contracted with the Fairfield Schools to provide space for their Before and After School Program for Fairfield students at Stevenson School. This arrangement has allowed children in K-6 to be dropped off at Stevenson School in the morning rather than the Tiny Treasures facility. This has eliminated the need to bus the students from Tiny Treasures facility to school. Grades 3-6 are then bused to Churchill to start their day. At dismissal, students in K-2 report to the Tiny Treasures area, and children in grades 3-6 are bused to Stevenson. This arrangement has been appreciated by parents, students, and staff.



All staff participate in weekly grade level PLC meetings. In-House and Out-of-District professional development is available to all staff in areas of curriculum, instruction, safety and security, special services, social and emotional growth, climate and culture, etc. Special areas such as Speech, ESL, Occupational Therapy, Library/Media, Technology, Art, etc., are encouraged to attend their annual conferences and seminars paid for by the district as professional development.

Monthly safety drills, mandated by the State, are performed each year in conjunction with the Fairfield Police Department, including: lockdowns, active shooter, shelter in place, fire drills, bus drills, etc. Each building has security cameras, a secure vestibule for visitors to enter, and visitor screening. Chromebooks are made available for all students in grade 2 for use in school. Students in grades 3-6 participate in a 1:1 Chromebook Initiative. Each classroom has a dedicated computer, smartboard/mimeo, and document camera. There is a 3D printer, robotics, and virtual reality equipment in each school as well. All grades receive S.T.E.A.M classes.



Fairfield School offers a half-day, tuition-based preschool program for 4-year old Fairfield children. There are preschool disabilities programs for 3 and 4 year old students. There are both half and full-day programs dependent on the IEP requirements.



District funds for salary of teaching staff members for summer skills program to address at-risk students, any learning loss due to quarantining as well as enrichment of all district students. Progress monitoring and assessments of students conducted at start of summer program and end to monitor growth. Funds used for salaries of teaching staff for before school intervention program for at-risk students. Students receive interventions before school 4 days week in academic areas. Benchmarks and ongoing progress monitoring used to monitor student progress. Funds provide vendors to support school counselors in providing group sessions to students identified with social, emotional and mental health needs in school and support at home. Contract with providers to help support Tier II, III mental health interventions. Services from 1:1 consulting, parent support. Students identified through guidance counselors, assessments on social emotional health of students completed and data analyzed.
