







Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.



Partnered with a supportive community, the Glen Ridge Public Schools will provide all students the opportunity to achieve their full individual potential through a dynamic, stimulating and challenging educational program, aligned to the New Jersey Learning Standards, that fosters respect, prepares students for life-long learning and enables students to contribute as citizens in an ever-changing, global society.



Student Supports and Services:

Our school system offers a comprehensive range of support services to meet the diverse needs of all learners & foster their success through a dedicated & professional faculty. Support is provided through multiple layers of services including the Child Study Team, Speech, Occupational & Physical Therapists, Reading Specialists, Gifted & Talented programs, Counselors, Behaviorists, School Nurses & Orton Gillingham certified staff (including regular & special education teachers). We provide individualized, tailored programs for Special Education students, Multi-Lingual Learners & students with 504 & Individual Health Plans. The district provides Intervention Services (PreK-12) & Basic Skills Instruction (K-6). The Guidance Department supports students from PreK-12 & students in Grades 7-12 can access support through the ESS counseling program. Our support staff works collaboratively to integrate differentiated instructional strategies to address each student's unique needs.



The Glen Ridge School system consists of five school buildings; Central School (est. 1927), Forest Avenue School (1929), Linden Avenue School (1911), Ridgewood Avenue School (1900), and Glen Ridge High School (1968). The town approved a referendum in March 2017 for major upgrades and renovations throughout the District. Central School was reacquired and converted into a PK-2 school. The heating system was replaced, and air conditioning was installed at the three elementary schools. Bathroom renovations occurred within all the school buildings. Since that time, the District has continued to invest in its facilities, improving playgrounds, repairing the ventilation system at the high school, upgrading building security, replacing roof portions on various buildings, and renovating instructional spaces.
