



#### **English Language Arts and Mathematics Performance Trends**

# Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

#### Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, of if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

#### Teachers - Experience



Our District offers access to Smartboards in every classroom. Students K-2 may access both a computer laboratory as well as I-pads in the classroom. Students 3rd-8th grade participate in a one-to-one computer initiative. Students at our Broad Street Elementary School have the opportunity to participate in STEAM utilizing a 3-D printer, and students at the Nehaunsey Middle School can take technology and Stem-based electives or clubs.



Our Broad Street Elementary School offers a model inclusive preschool program based on best practices as identified by the New Jesrey Department of Education.



ESSER funding has been utilized for extended learning opportunities, remediation and enrichment activities including a comprehensive summer camp and mental healthcare as well as social emotional supports. Additionally, funding has been allocated to support air quality and purification efforts such as air filtration and HVAC. Finally, funds have been utilized to provide instructional resources, including enhanced technology.
