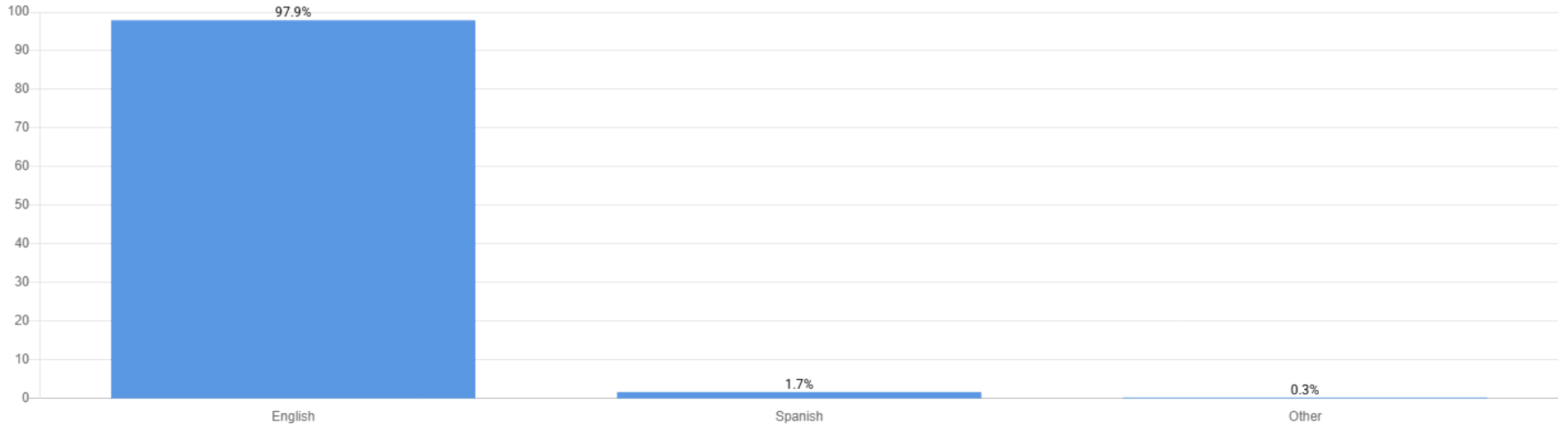

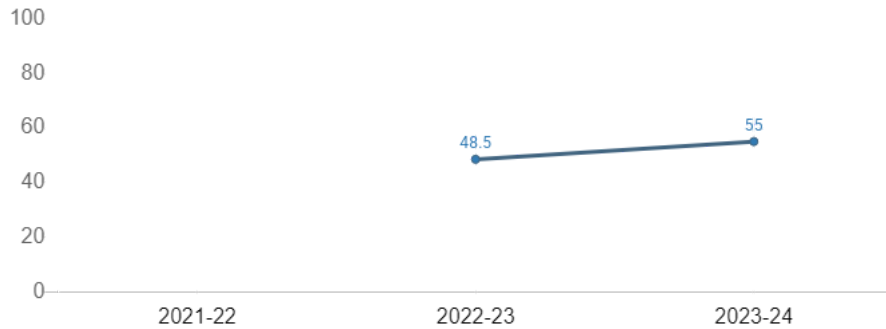

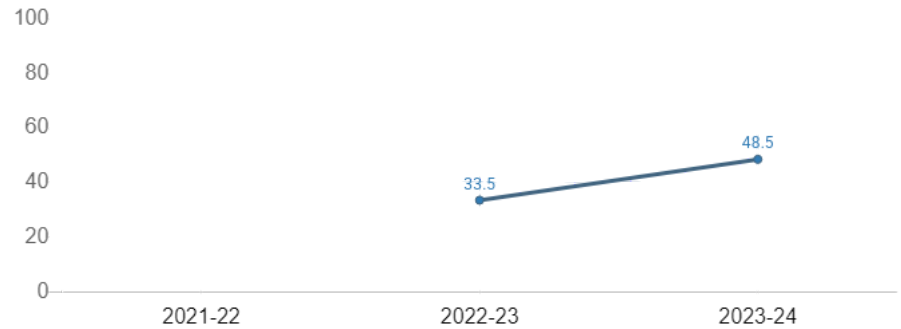

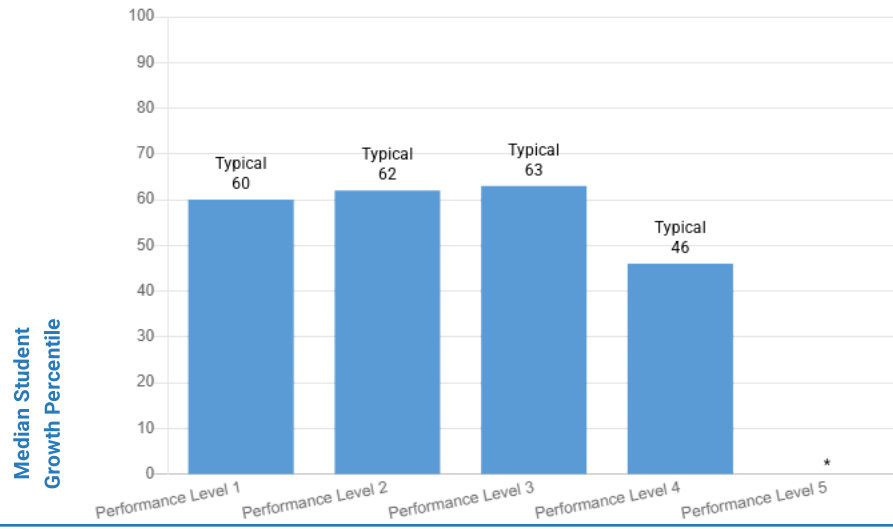

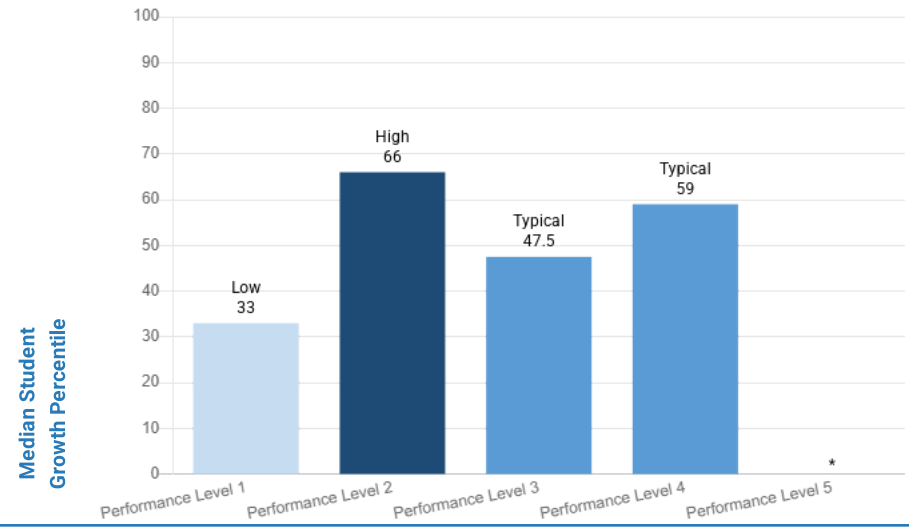

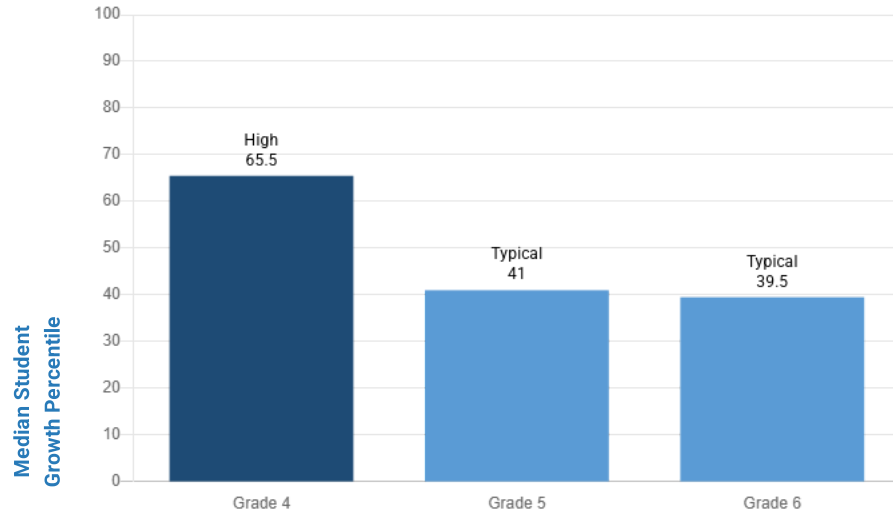

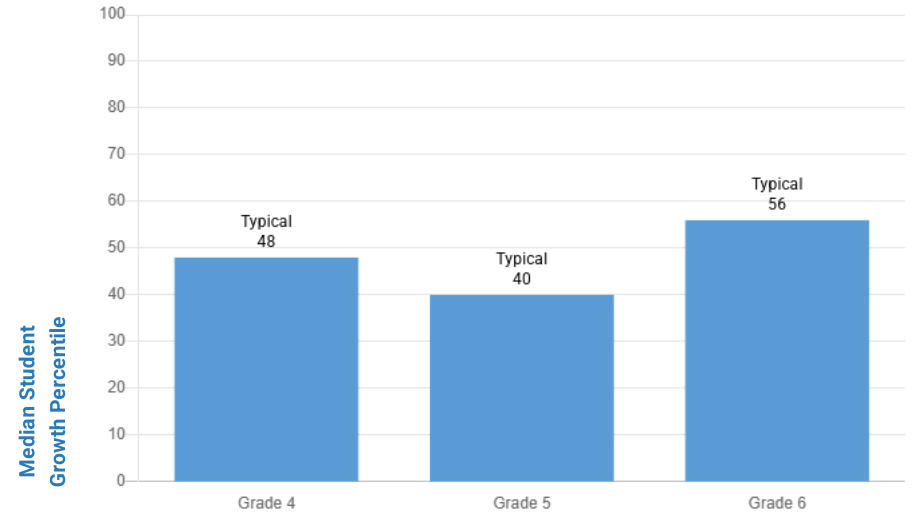

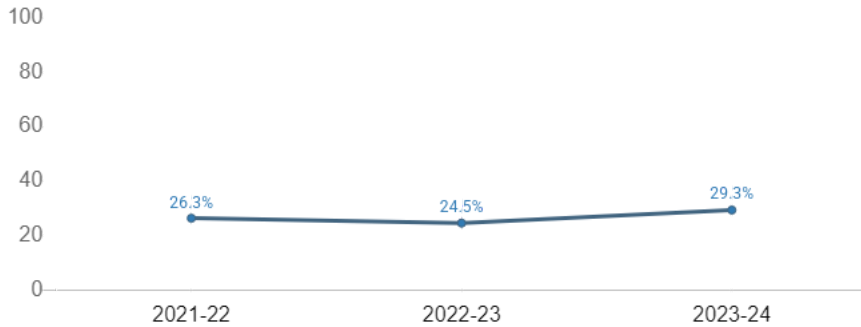

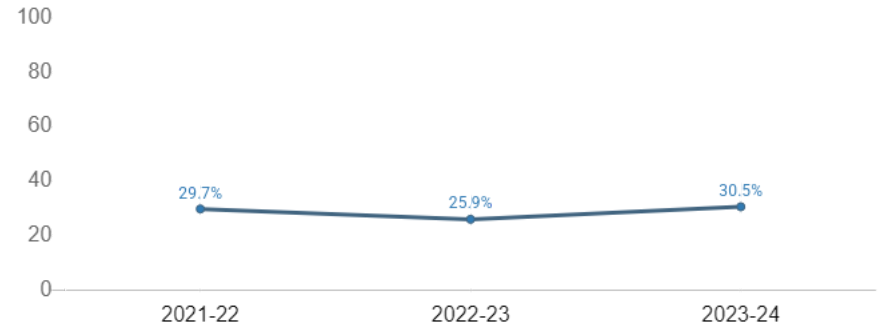
English Language Arts and Mathematics Performance Trends

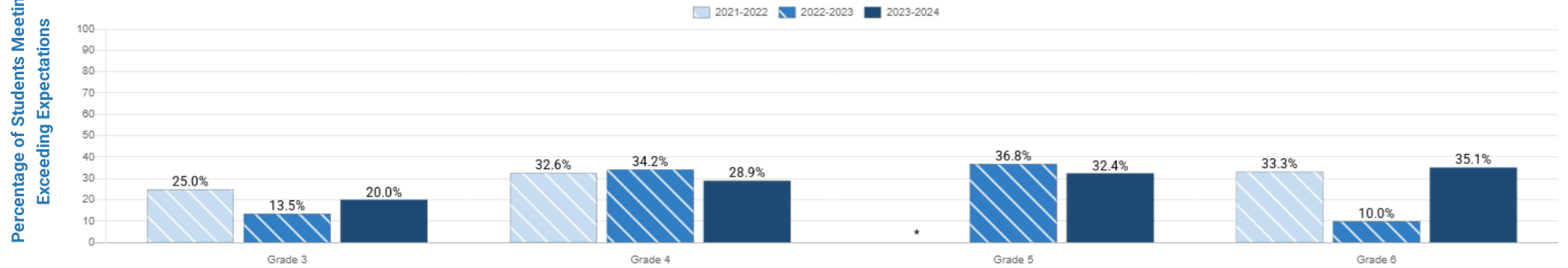

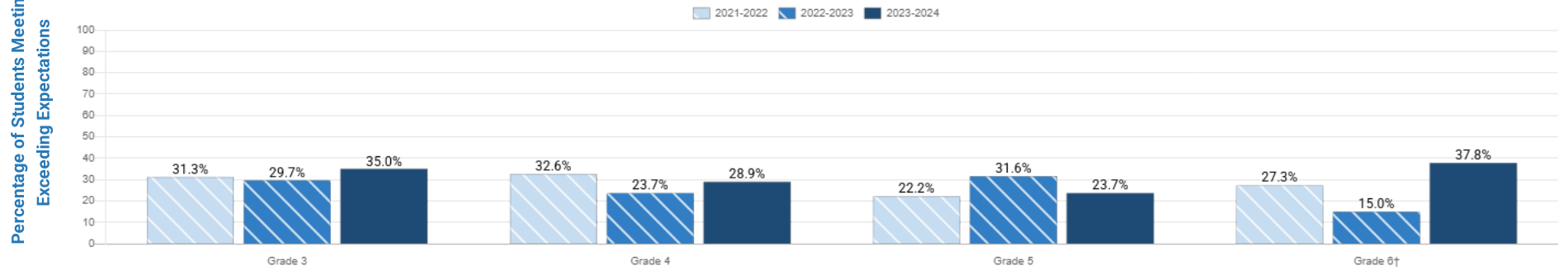

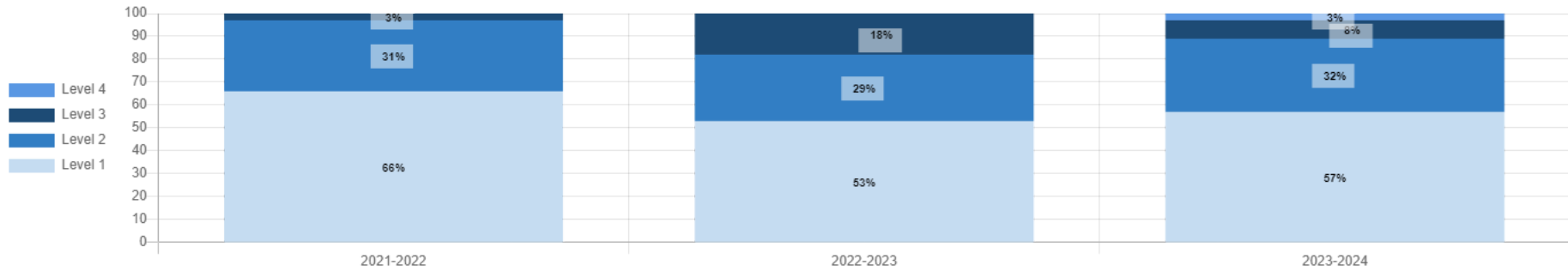

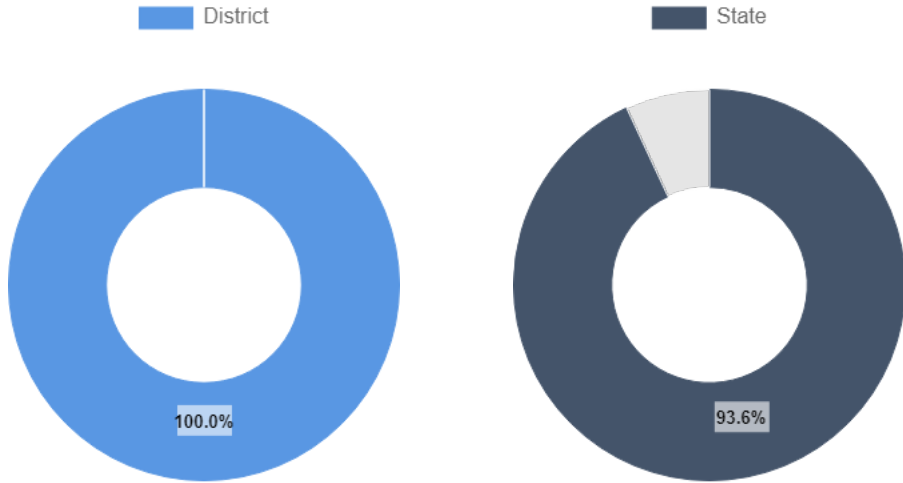

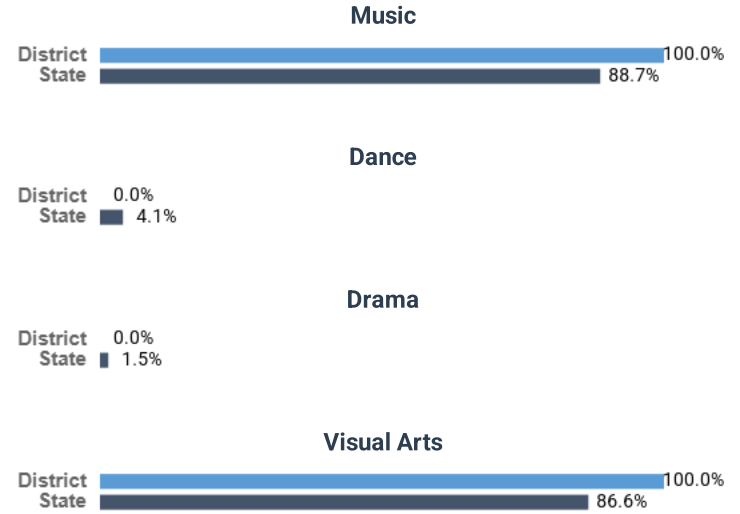

Students enrolled in one or more classes by discipline:



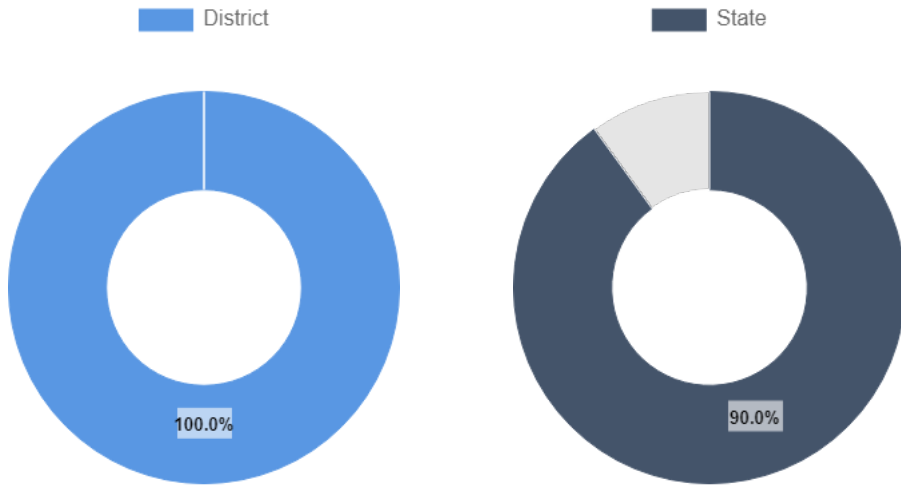

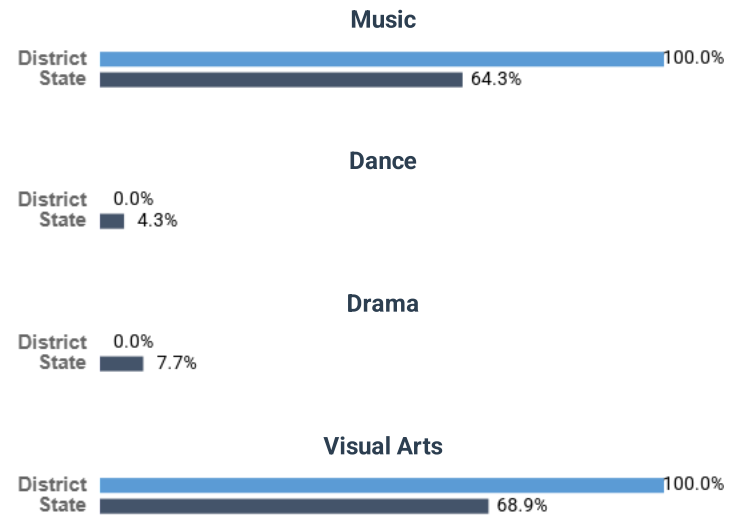

Students enrolled in one or more classes by discipline:

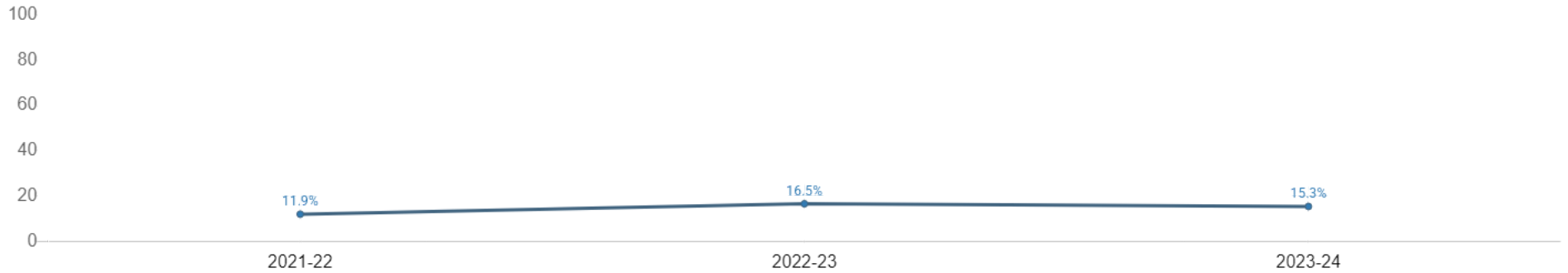

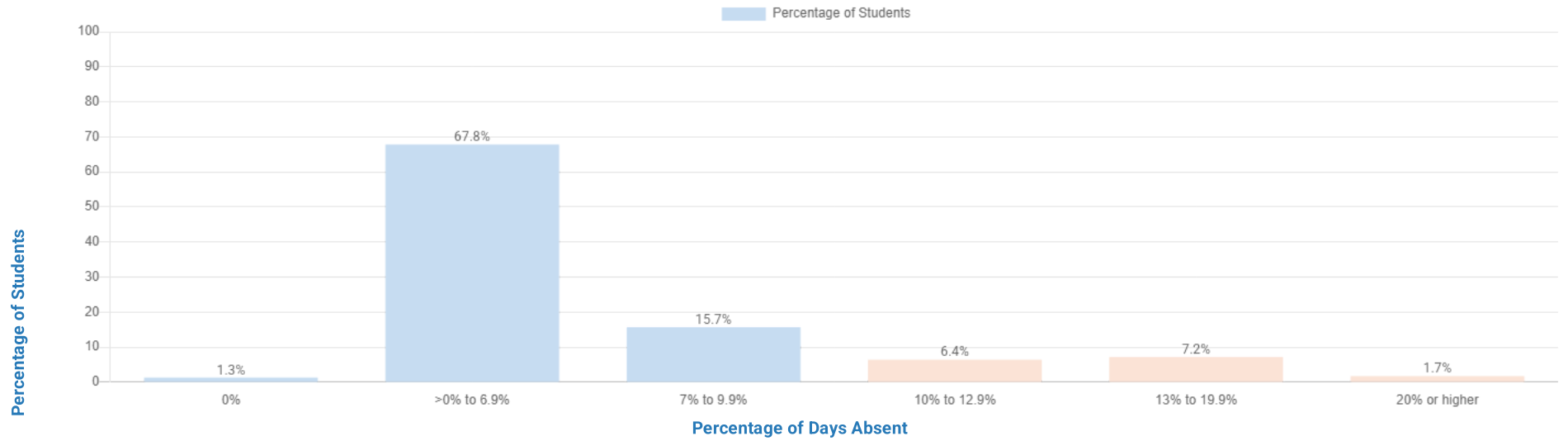

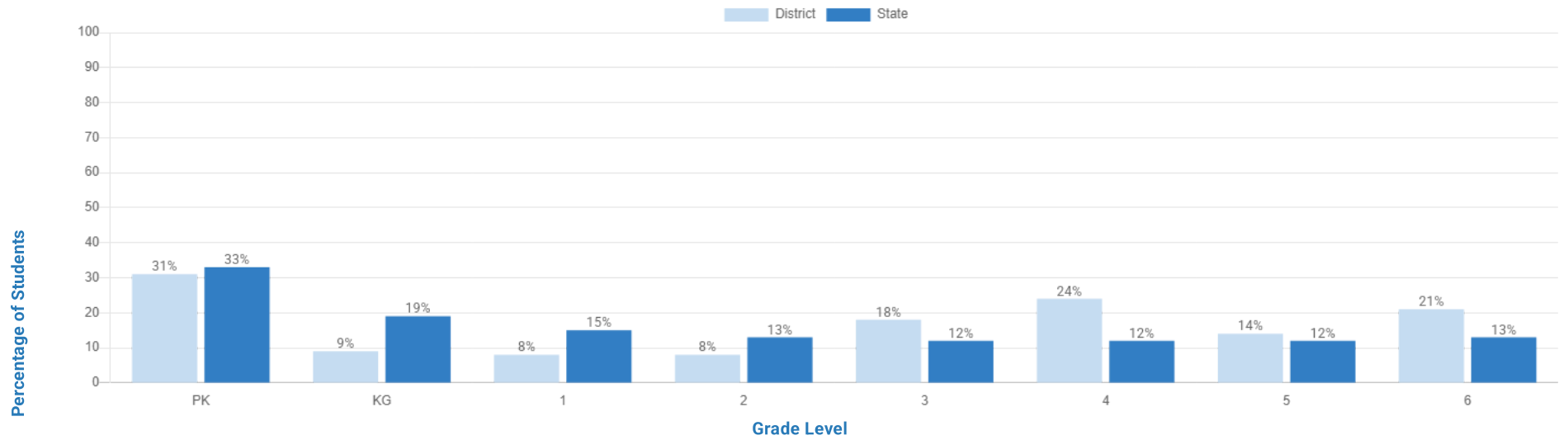

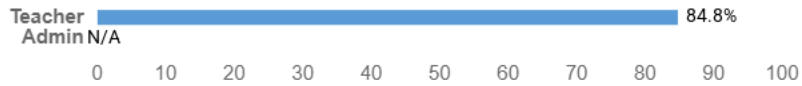

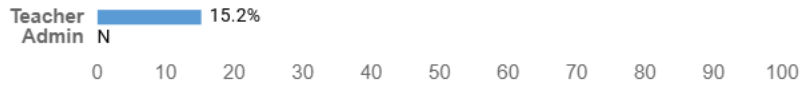

School Safety:

The school is outfitted with more than 50 security cameras within and around the perimeter of the building. Public access is limited to the main entrance of the school and a newly built vestibule provides enhance safety when the public enters the school. We utilize Raptor Technologies Visitor Management System to safely screen and sign in vistors. All staff and vistors utilize color coded lanyards. Monthly drills are conducted to ensure that both students and staff and prepared to respond appropriately in an emergency situation. A West Deptford Police Department School Resource Officer is on duty at all times and the West Deptford Police Department provides support as needed.



Technology and STEM:

We are proud to provide a STEM program to all students in PreK through Grade 6. In our STEM studio, students develop critical thinking skills through problem based learning opportunities in which each area of STEM is expertly interwoven. Chromebooks are provided to all students in Kindergarten through Grade 6. Each classroom has an interactive TV panel and the ability to cast. Use of technology is an integrated part of the learning process at National Park School.



Early Childhood Education:

National Park School offers a full day PreK program for three and four year olds. Special needs students are integrated into this setting. HighScope is used as the primary curriculum and students learn through a variety of play based experiences.
