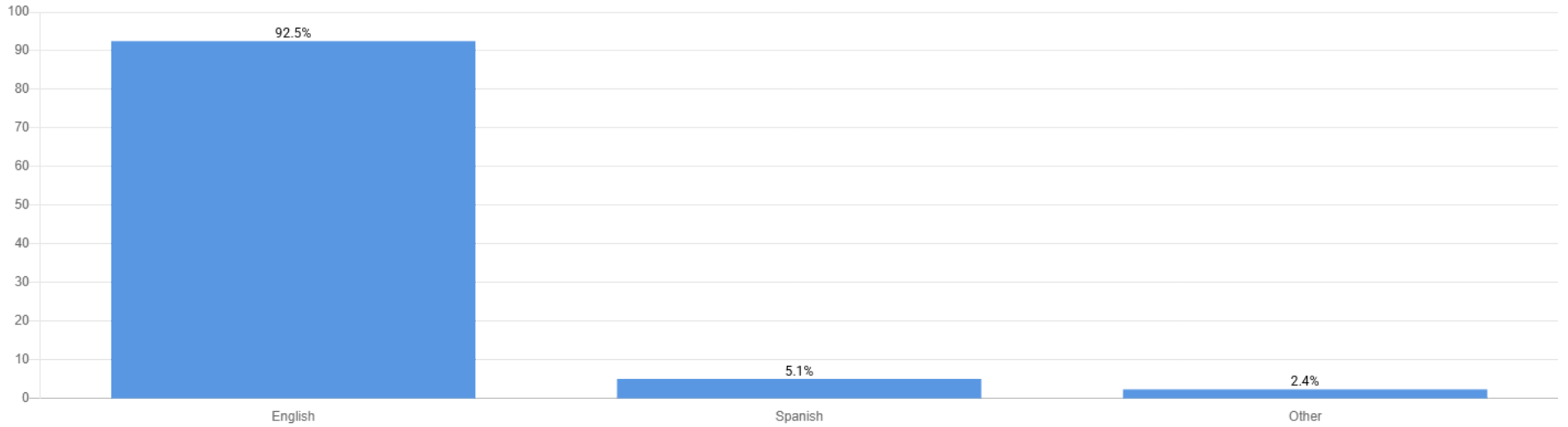

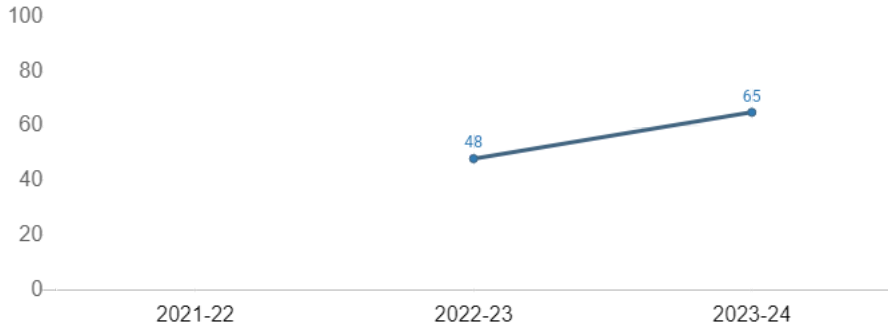

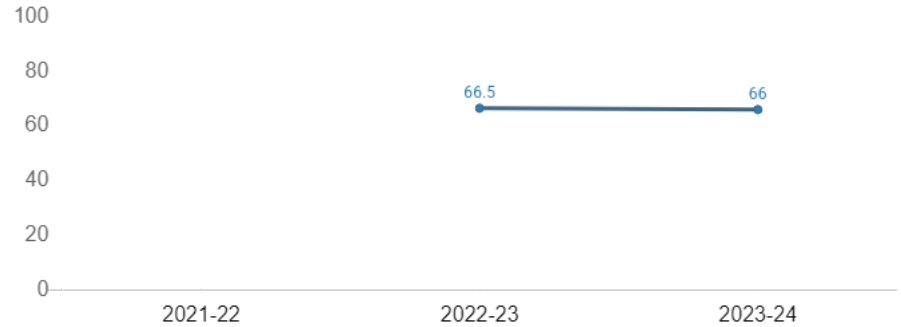

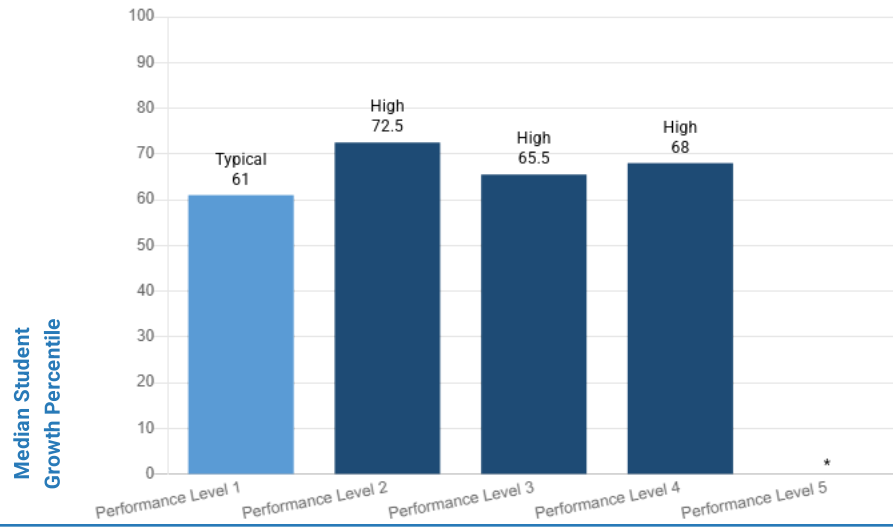

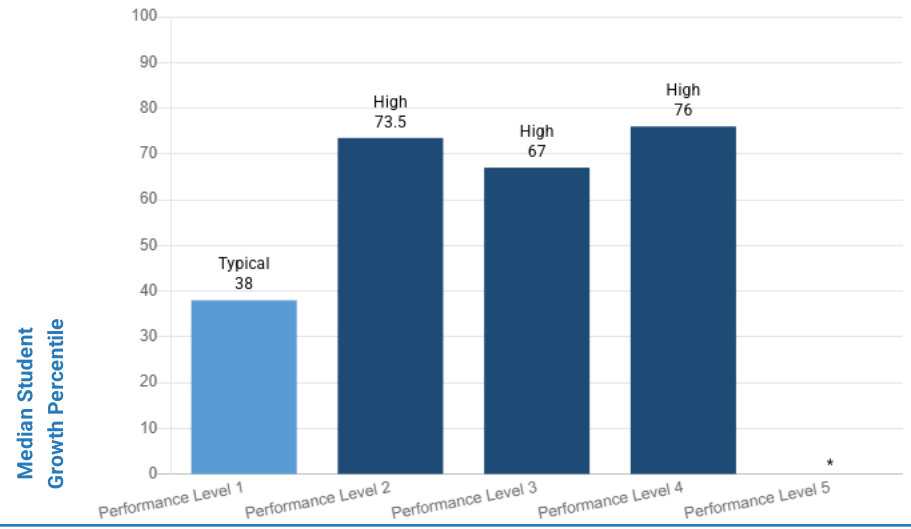

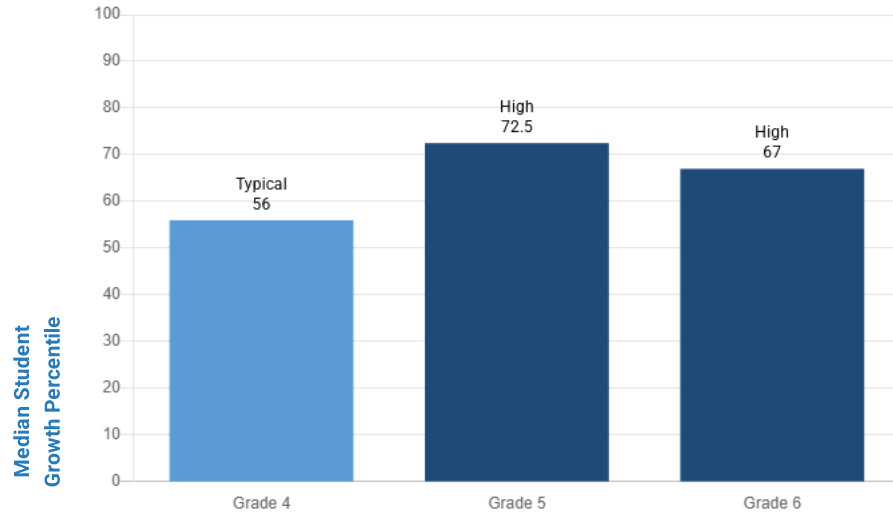

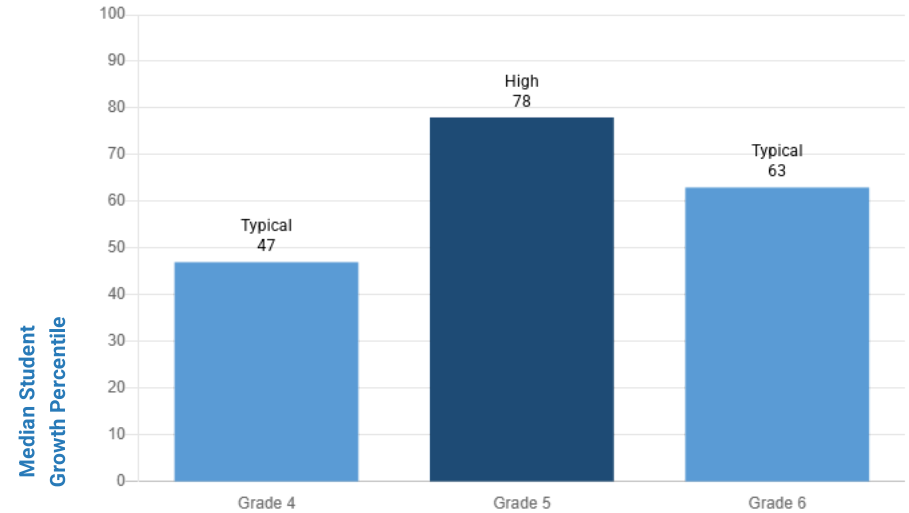

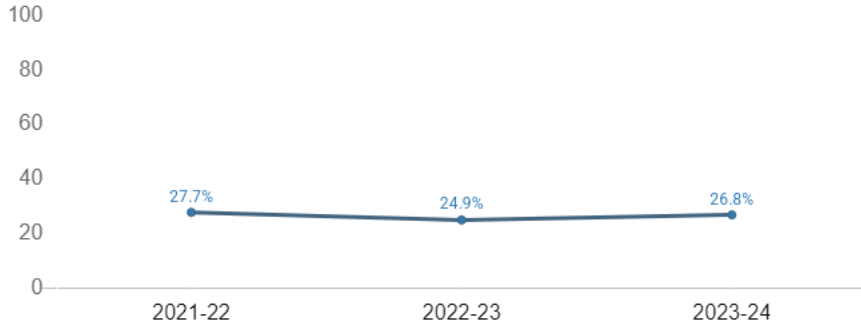

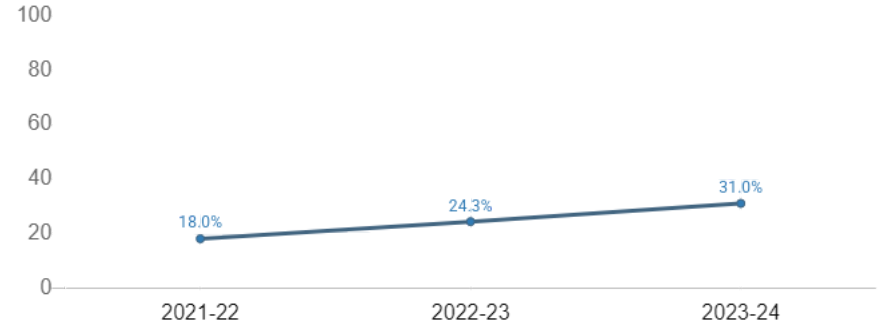
English Language Arts and Mathematics Performance Trends

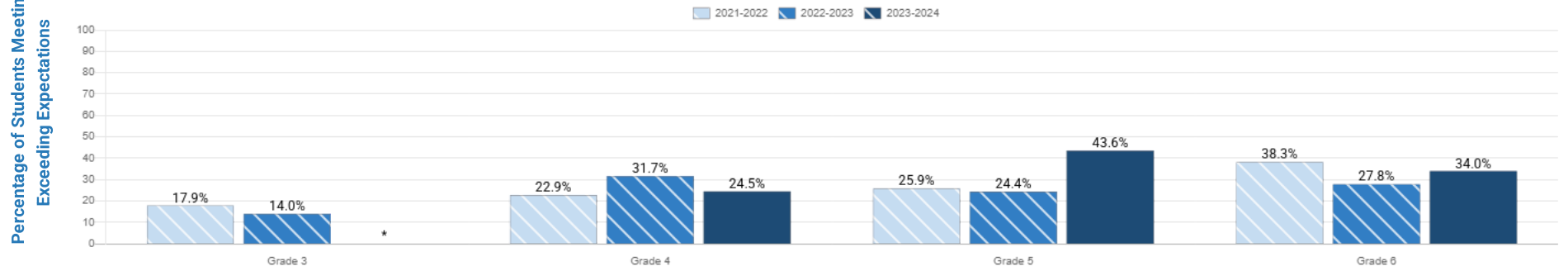

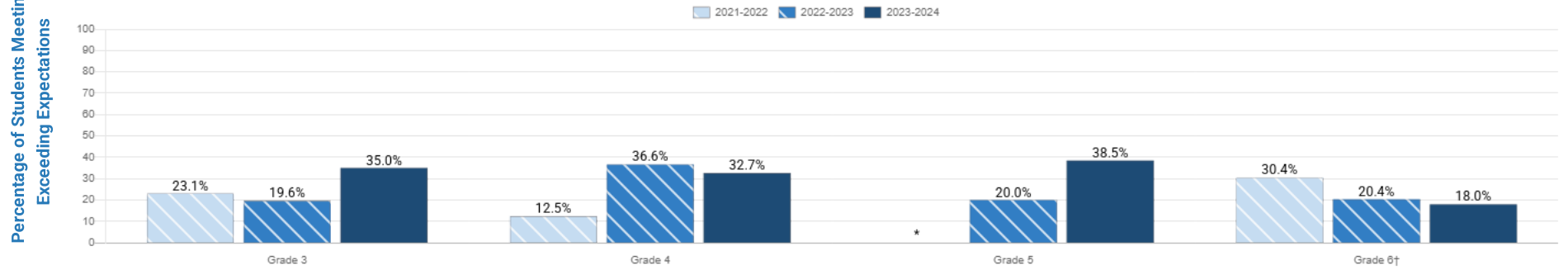

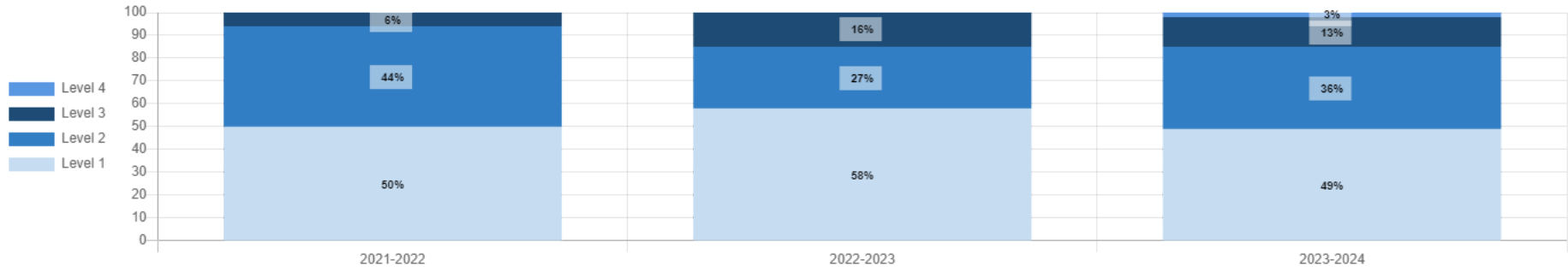

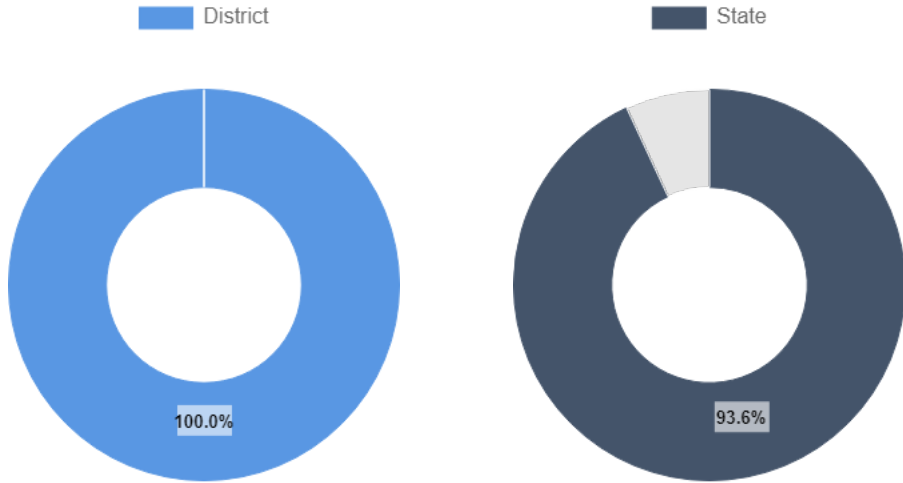

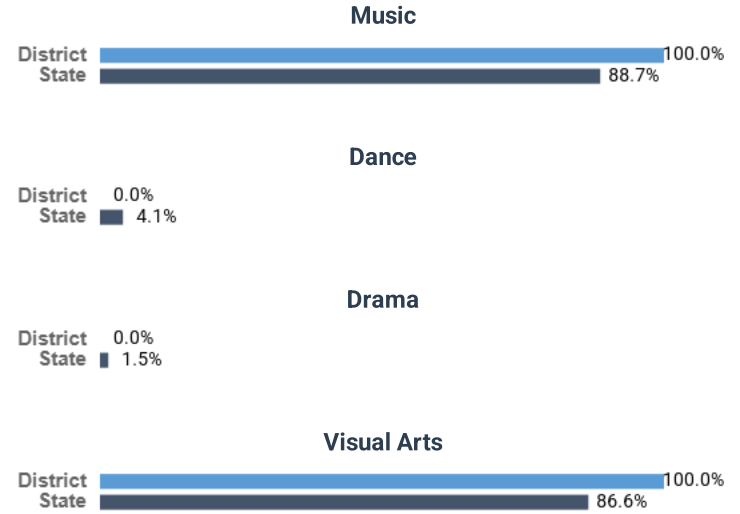

Students enrolled in one or more classes by discipline:



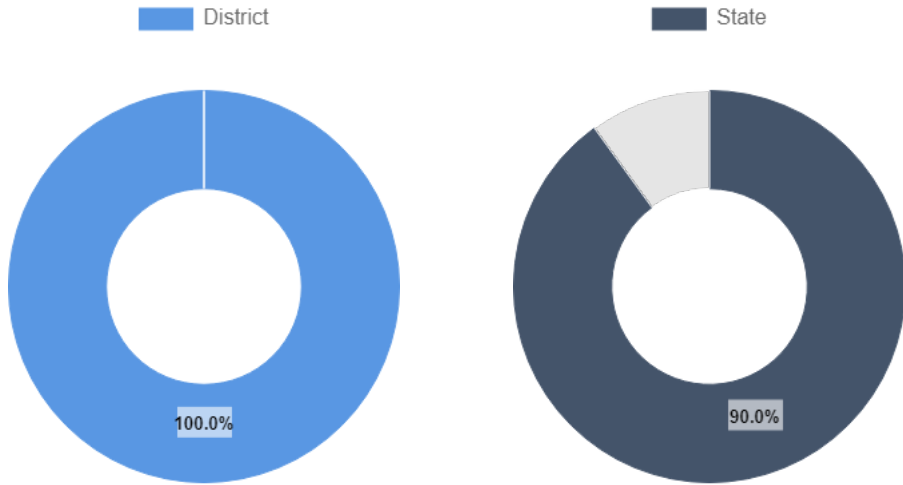

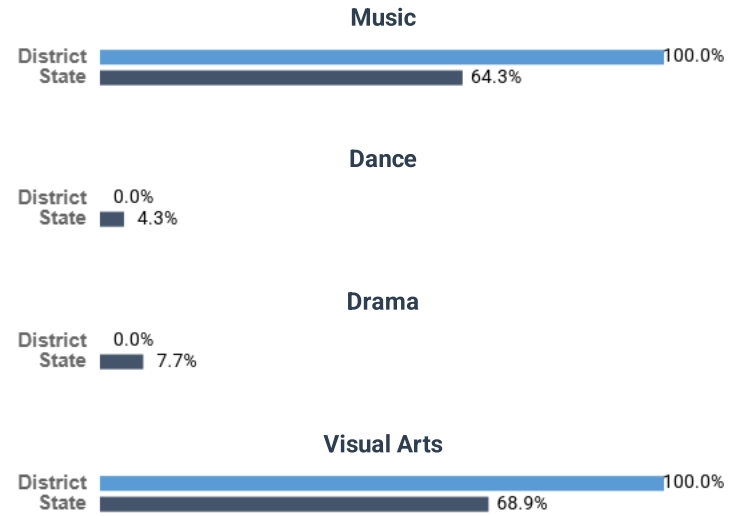

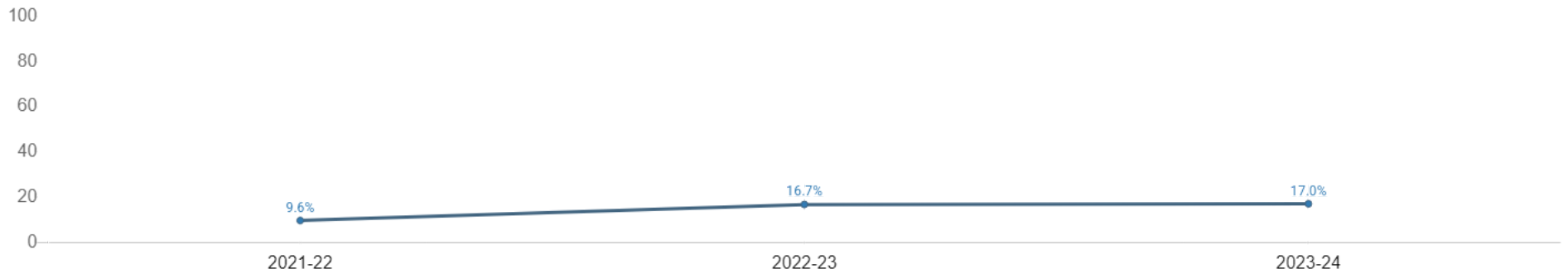

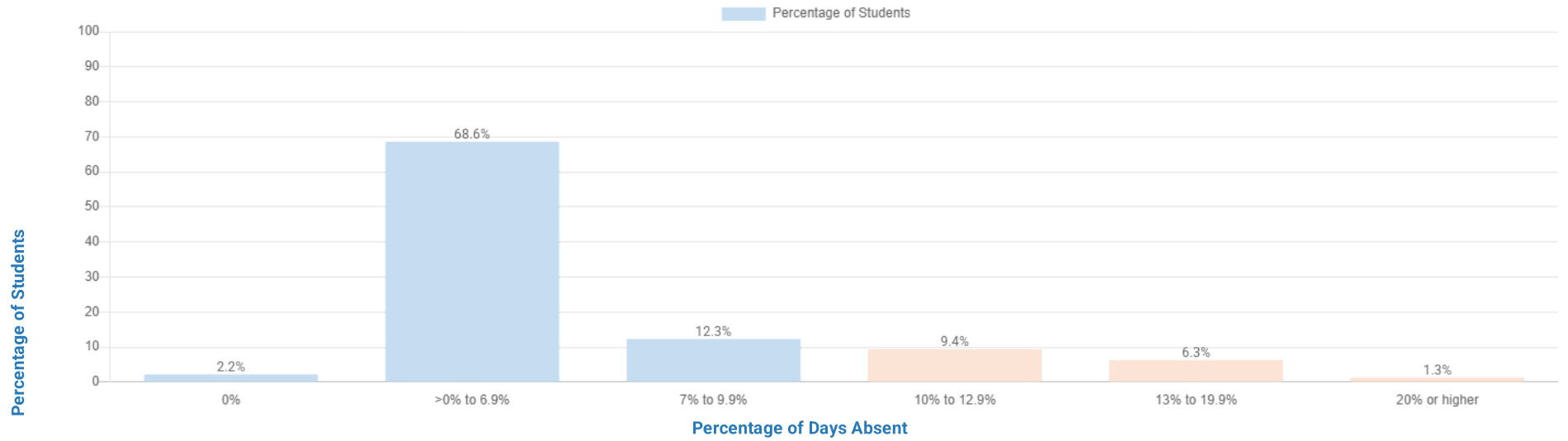

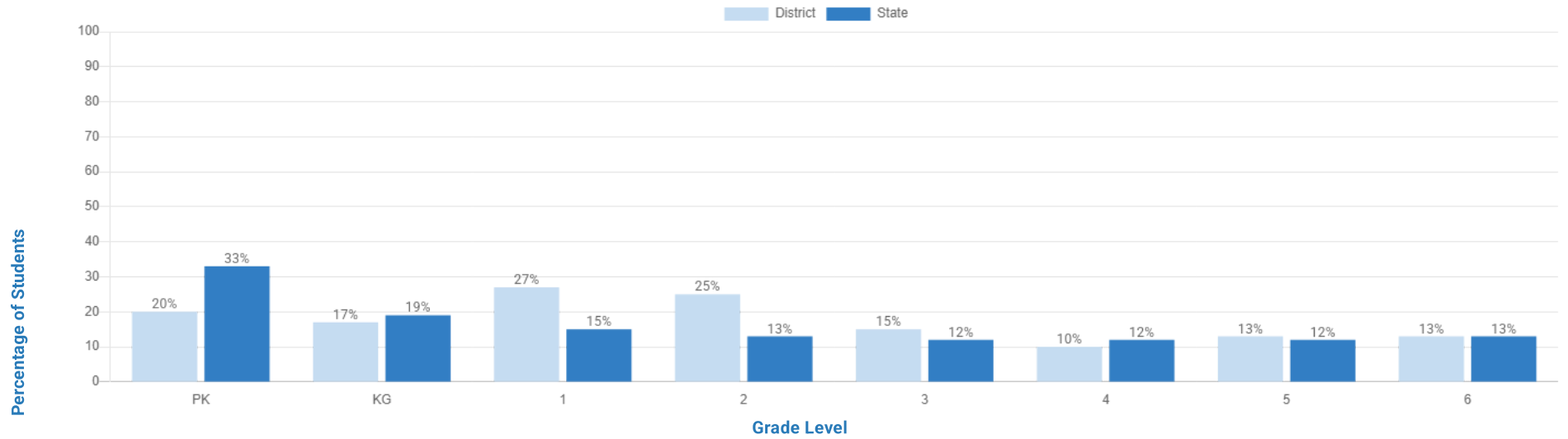

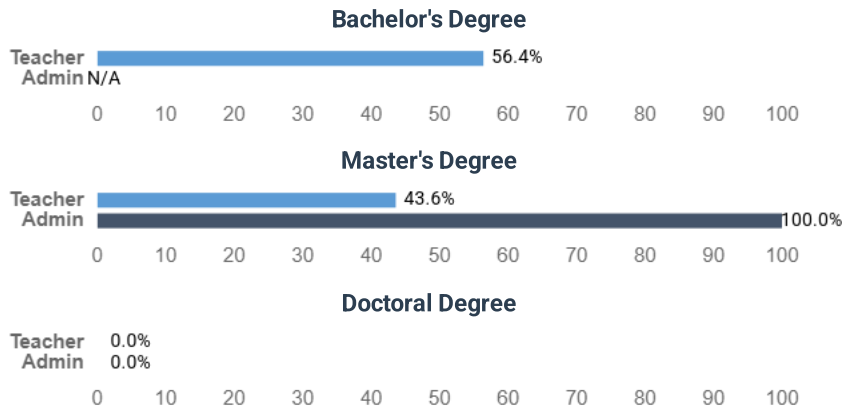

The curriculum is based on the NJSL. ELA places an emphasis on reading, writing, speaking and listening through integrated instructional framework using the Benchmark resource. Our math curriculum utilizes HMH Into Math as a resource. We offer a science program based on the NGSS while using Mystery Science, Mosa Mack and inquiry learning. The Social Studies curriculum is supported by Studies Weekly. Cross curricular learning is embedded across all content areas.



Clubs and Activities:

Our students are able to participate in a number of activities including: Student Council, Yearbook Club, Drama Club, Art Club, Homework Support Club, Library Club, Chorus, DEK hockey Club, Robotics, Primary Engineering and Book Club.

Staff and Professional Learning:

Professional development has focused on the need to advance students and staff in the areas of growth mindset and SEL in order to support academic success and expanded learning experiences. Expanding best practices in the rigor of the curriculum continues to be a focus as we link it to data analysis and standard based teaching. Teacher lead professional development and turnkey collaborative professional development is an asset at Parkview School. Parkview is currently in year 4 of a 5 year Inclusive Practices grant through the NJCIE and in year 4 of a PBSIS grant. We recently received an expansion to our Inclusive Practices grant to expand to our full day preschool teaching and support staff.



Student Supports and Services:

Parkview offers a variety of student supports and services including a Response to Intervention daily block and an Intervention and Referral and PIRT team. Title I programs provide support through primary interventionists, co-teaching programs and extended day tutoring services. Parkview offers full day preschool and kindergarten programs. We partner with the Child Connection Center which provides SEL specialists within the building.
