
















English Language Arts and Mathematics Performance Trends








NJSLA Science Assessment: Grade 5 Summary











Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:











Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have meet state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.









Weehawken HS was ranked #149th Best HS according to US News & World Report in 2024. We are a NJ Silver Sustainable School District and earned the Digital School Award. Our district was named the 2022 Niche.com #1 School in Hudson County and received Silver Distinction on the US News & World Report Rankings List. Weehawken High School, Theodore Roosevelt School, and Daniel Webster School were awarded Digital Schools Star recognition for 2022. Weehawken High School, Theodore Roosevelt School, and Daniel Webster School were recognized as silver-certified schools by Sustainable Schools for Jersey. Weehawken High School had the highest score in the state for this cycle (and ever) in the program. We were also named one of the 2021 and 2022 Best Communities for Music Education in New Jersey by the NAMM Foundation. Our district was also named one of only twelve New Jersey districts designated as an NJ Lighthouse District for 2021-2023.

We believe in empowering parents to be active partners in their child's education. Our standards-based curricula are readily available on our website, providing a clear overview of the learning goals and expectations for each grade level. We have aftercare run by an independent company after school in our elementary schools. An intervention program called WISE runs in the mornings for P-3 students who need additional support.

Our teachers participate in Professional Learning Communities with their colleagues as well as attend in-district professional learning throughout the year and during the summer. Our teachers also participate in workshops and conferences. Each school in the District has a comprehensive English as a Second Language support program, an inclusive special needs program, and a multi-tiered intervention program ensuring that all students are given the support they need to succeed.

Student Supports and Services:

Our administration, faculty, and staff support our students daily. In particular, our growing school counseling department pays special attention to the social-emotional needs of our students and their families but checking in, using a tiered checklist to ensure no one is overlooked, and facilitating interventions when necessary. Our school counselors also connect students and families with available resources to ensure their success and safety.



Student Health and Wellness:

In addition to counseling services and health-related care by the school nurse, the Weehawken TSD offers a breakfast and lunch program. Students engage in Physical Education classes and recess each day. We have launched an expansive Mental Health and Wellness initiative including a universal screener pilot program to assess social, emotional and academic risk factors in students; free and accessible teletherapy for staff and students; and a 24/7 helpline for students in or near crisis.



Parent and Community Involvement:

Each school in the District has a parent volunteer group that raises funds and sponsors student activities. Parents can manage their student's grades and assignments via the Real Time Information System Parent Portal.

Facilities:

The school buildings in the Weehawken TSD are all approximately 80 years old. In 2015, we completed a \$16 million construction bond that upgraded security vestibules, installed cameras, added new lockers, replaced all windows, and installed climate control in each classroom. All classrooms have heat and air conditioning through a bipolar ionization ventilation system. We have wellness centers in multiple schools and many rooms have new furniture and cabinetry. We have a new Aviation Training Center, and a new weight room, a new HS kitchen in the cafeteria and coming soon will be a student-run fully operational bank.



School Safety:

Each school in the Weehawken TSD has state-of-the-art security vestibules complete with a person retention center, bullet-proof doors, cameras, full time security staff, access control, alarmed doors, and a visitor management system that scans the national sex offender database before allowing visitors into the building. All classrooms have bulletproof doors, a computerized security check-in system, and newly upgraded phones. Lockdown, shelter-in-place, evacuation, medical and fire drills are conducted on a regular and consistent basis in cooperation with the Weehawken Police Department.



Technology and STEM:

Every school runs well-funded and high-level STEAM departments. In our elementary schools, STEAM is infused in the Science classrooms and in our Media Technology departments. At Weehawken HS, our STEAM courses include Robotics, Engineering, Drones, Aviation, Architecture, eSports, Game Design, Computer Science and AP Computer Science which are offered to students in grades 7-12.
