














English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 









Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:







Student Supports and Services:

The district offers various student support services such as I&RS committee, social skills groups, inclusive classrooms, character education groups, sensory hallways, peer to peer, individual counseling, English Language Learning services, OT, PT, speech, in-class support, paraprofessionals, special education teachers, Academic Success classes, Learning Academies during the year and during the summer, High Impact Tutoring, contracted BCBA, outside resource services, and a school-wide positive behavior reinforcement plan.



Student Health and Wellness:

The District offers breakfast and lunch programs for all eligible students. Students take part in Physical Education and Health three days per week with 50 minutes per period. Physical Education classes take part both in the school as well as at the local field. Students also have daily recess. Our school nurse infuses health and wellness into the classes through Heimlich Heroes, CPR classes, Optical Academy, Blood Drives, Flu Shot clinics, and presentations by our local police departments regarding drugs, alcohol and bullying. The district has recently installed sensory hallways for faculty and students to assist in preventing anxiety and maintain a calm, relaxed environment.



Parent and Community Involvement:

The district is extremely proud of the strong relationship it has with the PTO & the community. Our school-wide positive behavior reinforcement plan works in conjunction with community members & their involvement in the program. Other events to connect home & school include STEAM night, Teacher Auction, Fall Festival, Holiday Luncheon, Veteran's Day celebrations, concerts, Drama productions, Coding, Art Gallery, Scholastic nights, Kinder Karnival, Student Council events, Mystery Reader, Career Day, Special Education Parent Advisory Groups, Geography Bee, & Spelling Bee. Our live syllabi are accessible to all parents keeping them updated to classroom lessons. Our parent portal and social media platforms such as Facebook, Klassroom app, Google Classroom, Padlet, Seesaw, Canvas, EdPuzzle, ClassKick, PTCFast, Piktochart, Powtoon, ClassDoJo, Thinglink, to name a few, keep parents connected to student academics in real-time.

Facilities:

The Bloomsbury School District is a one building district originally erected in 1936, with an addition in 1969. The most recent renovations were a new boiler in 2024 and air conditioners installed in all classrooms, including mini-splits in 2024. This past summer we completely repainted the first floor and front of the building. We revamped and replaced our entire security system and added additional security cameras to our system with the input of the SRO. Future projects include the painting of the rest of the building and improvements as needed. The building has various specialty classrooms aside from its PreK-8 classrooms. Such specialty rooms include art/World Language/music, Health, CST office, OT/PT/Speech room, Theatrical stage, administrative offices, & all-purpose room.



Technology and STEM:

The District is a 1:1 ratio with brand new laptops and tablets for all students as well as Promethean Activpanels in every classroom. 21st Century Skills are infused into each unit of study. Students use VR goggles for virtual field trips and exploration beyond the classroom. Technology is used in an authentic means to enhance learning rather than simply replacing paper and pencil. Every student from grades PreK-8 has a Google classroom account, ReadingEggs, MathSeeds, Touchmath, Zoom for Edu or Aleks account to support learning activities. All textbooks have online capabilities and are differentiated for students. Teachers foster learning of digital citizenship at a very young age. Special STEAM nights are held for students and community members. All middle school students may participate in the county-wide Junior Solar Sprints and Biztown. Students are building coding and literacy skills.



Early Childhood Education:

The Bloomsbury School District's free, full day preschool is where authentic learning and strong core character build a solid foundation from which all students learn and succeed. Our preschool curriculum centers around Creative Curriculum GOLD with exploration and discovery, Orton-Gillingham methodology, and strong development of math and literacy skills with 21st Century and cross-curricular infusion. Teachers use an inquiry-based, multi-sensory approach to learning while focusing on kindergarten readiness with an emphasis on social and emotional development.

Attendance:

While learning during COVID 19, the district first assessed parent/student needs in order to determine the technological impacts and the wellness of the community. A strong Restart/Recovery plan was written to bring students back safely while also providing a seamless hybrid instruction. Multiple platforms were utilized to provide instruction such as Zoom for Edu, document cameras, Classkick, noredink, vocabulary.com, commonlit.org, GoFormative, graphics tablets, EdPuzzle, ReadingSeeds, MathEggs, Aleks, and Padlet. We ensured wellness for all stakeholders by providing devices, resources and tech support. Social emotional practices, check-ins and meetings were provided. Connections and activities with the community were used through PRIDE grants and PTO participation. Virtual and in-person social distancing celebrations were planned to create a new normal for students. Constant communication with parents and community members was essential to monitor and adjust as needed.
