
















English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 









Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:







Attendance:

The District is using ESSER funds to address and react to the COVID19 pandemic. We have increased our indoor air quality through the purchase of HEPA rated filters for all instructional spaces. We replaced several rooftop HVAC units with UV light components. We upgraded our cleaning protocols and equipment. The District addressed learning loss through a variety of targeted and global approaches. Multiple measures of student performance data were used to identify and support students. Technology was leveraged to track and inform instructional decisions and staffing was designed for maximized individualized instruction. We prioritized small class sizes in the elementary classes and fortified our supplemental educational program during the day, before school and afterschool. We doubled our counseling staff to focus on mental health both proactively and in response to crisis. We are in our second year of additional support and the district is committed to this approach moving forward.
