














English Language Arts and Mathematics Performance Trends




















The Tools of the Mind Standards based curriculum provides individualized academic instruction and play-based learning where students develop citizenship in leadership and cooperative roles. Our pre-school students enjoy widespread success in the primary grades because they are academically prepared and learn as active participant in our community, taking part in school traditions.
