





Our district consists of one building constructed in 1934 with additions/renovations in 1970 and 2010 totaling 71,296 square feet. Franklin Township School continues to review safety protocols for our district. Safety has been a priority for many years. We continually review and update our safety procedures, training and equipment. Franklin Township School also employs a full-time School Resource Officer



Technology and STEM:

The school district provided a one-to-one technology program, Grades K-1 use IPADS and Grades 2-8 use Chromebooks. Google Classroom is utilized for instruction. Students use online computer based programs that promote student learning. Within the Special Education and Elementary classrooms, promethean boards and document cameras are used. In other classrooms, smartboard and interactive boards are used. A STEAM class was offered each week for students in grades PK-8. In middle school, students learn about robotics using items such as Bee Bots, Lego Mindstorm kits, and Nao robot. Students also learn how to create 3D designs and are able to print their designs using a 3D printer. Furthermore, the Makerspace held laptops and iPads that were used by the students.



An integrated preschool program was offered for three and four year olds. The program provided support and services for students referred for early intervention and who were able to become eligible for special education and related services. The preschool program implemented the Tools of the Mind Curriculum. Franklin also has Preschool Coach to support our preschool teachers.
