











### English Language Arts and Mathematics Performance Trends









Students enrolled in one or more classes by discipline:







Students enrolled in one or more classes by discipline:










### Teachers and Administrators - Level of Education

- Frenchtown School participates in the Interdistrict Choice School program.
- Frenchtown School Supports a 1:1 iPad Program for all K-8th grade students who also have the opportunity to engage in activities to support their technological creativity with the use of 3-D printers.



### Mission, Vision, Theme:

Frenchtown Elementary School strives to help each student develop intellectually, physically, socially, and ethically. Our ultimate mission is to produce happy, healthy, creative young adults who grow into life-long learners with a desire to contribute to their society as productive citizens. We offer an intimate educational environment where students are taught to respect themselves, their peers, their community, and the world around them. At the outset of the third millennium, the Frenchtown Elementary School, an intimate educational environment, prepares its students to meet the challenges of rapid globalization. The Frenchtown School District will achieve the aforementioned attributes through the New Jersey Core Curriculum Content Standards and the ten New Jersey Professional Standards for Teachers.



### Awards, Recognition, Accomplishments:

Through its Positive Behavior initiative, Frenchtown students are elected monthly by their peers and staff to receive Kindness awards that recognize students who are caught being kind to others or have exhibited other positive character attributes. Additionally, students are selected monthly by our physical education teacher to receive Sportsmanship Awards. Being a walking school district, Frenchtown collaborates with goHunterdon on establishing and maintaining Safe Routes to School by participating in their Walking School Bus, Winter Walk, and Bike Safety Rodeos on an annual basis. Frenchtown received the 2022-2023 and 2023-2024 Gold Recognition from goHunterdon for Safe Routes to School. The Frenchtown community rallies around the students and walking to school with the support of the teachers, families, and local police. In 2022-23 our Kindergarten class won second place in the county from goHunterdon's annual Winter Walk event to promote pedestrian safety.

### Courses, Curriculum, Instruction:

Frenchtown offers a full-day preschool and kindergarten program that utilizes the Creative Curriculum. The district has revised its middle school schedule to provide dedicated time to work on character development and support for academic achievement. Our instructional programs are aligned with our curriculum incorporating the NJ Learning Standards. Our G&T program is offered in grades K-8. Accelerated math courses and Algebra I are also offered. Course of study includes Library, Technology, Academic and Creative Enrichment, Fine Arts, Financial Literacy, Civics, Music, and Spanish. Curriculum units foster and embed service learning, social-emotional, and 21st Century skills. The district has formed relationships with local businesses (ArtYard, Modern Fossils, Frenchtown Cafe, Studio 29, Sandy's Scoops, and Yoga Loka) to foster some real-life experiences through local "community-based projects."



### Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cross Country (Coed), Soccer (Boys & Girls), Softball (Girls)

Due to our small class sizes, Frenchtown is not able to sustain its own interscholastic athletics programs; however, our students do have the opportunity to participate in a range of sports activities such as boys and girls basketball, cross country, soccer, baseball, and softball through a collaboration with a DVHRS local elementary school. Frenchtown students also have the opportunity to participate in co-ed soccer and volleyball, and boys and girls basketball after-school clubs.



### Clubs and Activities:

Frenchtown expanded its extracurricular activities over the past few years and is proud to offer its students a wide range of afterschool programs including basketball, soccer, volleyball, running club, music club, sketchbook club, German club, homework club, Tutor Time, and Student Council. Additionally, the district has formed relationships with local businesses (ArtYard, Modern Fossils, Frenchtown Cafe, Studio 29, Sandy's Scoops, and Yoga Loka) to foster and engage in real-life experiences. We were extremely excited to offer summer camps that included activities in art, science, and music led by our highly engaged teachers. The programs were well attended and the district is planning to offer them again next year.

### Before and After School Programs:



Staff are provided four full days and four half days dedicated to professional development. Staff professional development focuses on teacher and student needs. The district has partnered with Elevate Educators to provide training to support district initiatives. As needs arise during the year, additional trainings are scheduled on a variety of topics including social-emotional learning, instructional strategies, technology, Multi-Language Learners, math and reading assessments, and character education. Additionally, all staff complete state-mandated Safe Schools training courses annually.

### Staff and Professional Learning:



Frenchtown School's Child Study Team works closely with parents, students, and teachers to ensure a successful learning environment for students with disabilities. Speech, occupational therapy, and physical therapy are also provided to children identified as needing those services, as well as Multi-Language Learners and Basic Skills support. Frenchtown utilizes an I&RS team to identify student needs and implement strategies to aid in student success. Frenchtown has a School Counselor to facilitate Section 504 Plans which are geared toward addressing accommodations needed for students to access the curriculum. The counselor also supports students on a weekly or as-needed basis, as well as offering a daily "Break Room" for student support. Frenchtown School has utilized grant money to fund enrichment and academic support programs during the summer and beyond the school day.

### Student Health and Wellness:

Student health and wellness is a priority at Frenchtown. All students at Frenchtown receive recess time, multiple classes of physical education and health, and instructional classes are held outdoors whenever possible. Students have access to a full-time school social worker/school counselor and the Zones of Regulation are utilized by all staff to support student emotional health and self-awareness. Our character education program targets social-emotional learning by teaching various conflict resolution strategies. Both general and special education students' schedules include regular visits to our Wellness Room which provides the students with time to support their mental health and the opportunity to rest and refocus. This year, in partnership with Yoga Loka, we incorporated an aromatherapy option into the room. Frenchtown School also offers nutritious breakfast and lunch options provided by Maschio's Food Service.



### Parent and Community Involvement:

Frenchtown School greatly benefits from many community partnerships. Our PTO supports our teachers, after-school activities, and assemblies. The district provides theater performance opportunities in partnership with the River Union Stage. A community garden connects the classroom and the community and we have formed partnerships with local businesses through goHunterdon, the Frenchtown Business Professionals, and Sustainable Frenchtown Associations. We have established relationships with ArtYard and Studio 29 which have provided student learning experiences as walking field trips and an after-school club. With Yoga Loka we incorporated aromatherapy into our Wellness Room and are working with Modern Fossils on a Wayfinding community project. Our parents have 24/7 access to the PowerSchool Parent Portal which allows them to closely monitor student attendance and academic performance. Weekly communications are sent to parents and we regularly post on our Facebook page.



### Facilities:

Our school building served as the "Frenchtown High School" until 1959. Due to the age of the building major upgrade projects such as window replacement, roof replacement, toilet room renovations, boiler conversion, playground revitalization, and paving have occurred. In addition, several "in-house" renovations and upgrades were completed: LED lighting, technology upgrade, auditorium sound system, middle school science laboratory, gymnasium floor refurbishment, scoreboard, playground, and cafeteria equipment. Most recently safety fencing was installed around the playground area and stage two of a multi-part surveillance system implementation plan was installed. The building is truly a much-beloved landmark in Frenchtown.

### School Safety:

Student safety is a priority, and Frenchtown is committed to ensuring that students can focus on learning in a secure environment. The school district enjoys a positive relationship with local police and NJ State police departments, the fire department, and rescue squads. It is very common for local police and fire departments to be part of the process of planning and practicing security and fire drills. Monthly security and fire drills are collaboratively planned and executed with local police. The school has also implemented a surveillance camera system to monitor and enhance safety in/on school grounds.



### Technology and STEM:

The District supports 1:1 iPad program for Grades K-8th grade students. Smart Boards can be found in every classroom. Enrichment activities are planned within each grade-level classroom, providing opportunities for students to explore and apply skills to higher-level questioning. Students and staff are able to engage with three 3-D printers to explore and exhibit their creativity. The school prides itself on offering an afterschool STEM Club to all K-4 students.



### Early Childhood Education:

The Frenchtown District believes that preschool educational experiences contribute to later academic success for all children. The Frenchtown School was awarded the Preschool Education Aid in 2023 which allows us to provide free universal preschool to all age-appropriate children that reside in the district. The grant also provided us with the opportunity to open a satellite preschool location in conjunction with the local YMCA. Little Paws Preschool offers a full-day program on a tuition basis with a curriculum consisting of developmentally appropriate experiences that provide each child with individual opportunities to develop positive self-esteem, social/emotional growth, language skills, motor development, and conceptual skill development. It is designed to meet the NJ Preschool Teaching and Learning Standards of Quality, the NJ Preschool Program Implementation Guidelines, and the NJ Student Learning Standards.

### Other Information:

The Frenchtown Elementary School provides a full range of educational services, programs, and activities appropriate for students in grades PK-8th grade, with and without special needs. Our district is located along the Delaware River in beautiful Hunterdon County. We serve approximately 105 students, both resident and choice.
